- 1 Segment.01 Hello. I'm Dr. Jerry Scheidbach, pastor of the
- 2 Lighthouse Baptist Church in Santa Maria, CA—and your brain
- 3 masseur—get ready for your brain massage.
- 4 Warning this brain massage is going to work out some very
- 5 tight knots and that can be sometimes painful.
- 6 [TRUTH]
- 7 A good name! A good name is rather to be chosen than riches.
- 8 What is the value of a good name?
- 9 Conservative/Progressive a conservative wants to, well, conserve
- 10 our American traditions. Liberals have attached the label,
- 11 American traditions, to slavery (a Democrat thing), with Jim Crow
- 12 (a Democrat thing), and the KKK (a Democrat thing) so liberals
- 13 say conserving American values means conserving bigotry as if,
- 14 first, only Americans are bigoted and only Americans practiced
- slavery; but anyway, because conservatives want to conserve
- slavery, they see conservatism as inherently bigoted, and
- 17 Progressivism as, well, progressive, dedicated to leaving America as
- 18 founded by slave owners behind and embracing a future that is
- 19 new and different from the past a future where slavery is, well,
- actually, where it is redefined as the Slave State, the State
- 21 controlling our lives.
- Never mind that it was conservative Americans who hated slavery,
- 23 resisted it, and finally ended it. And it has been Democrats who

- 28 Of course, this is one of those obvious examples of Satanically
- 29 inspired stupidity trust me, it's not you simple run of the mill
- 30 type of dimwittedness this is stupid on purpose and with a
- 31 purpose.
- 32 No one with sense would believe that Conservatives want to return
- 33 to Slavery, especially those who know that it was conservatives who
- 34 fought to end it.
- 35 Conservatives want to CONSERVE the values and principles that
- 36 led this nation to END SLAVERY. Modern day liberals would
- 37 never have ended slavery the Democrats would never have
- 38 ended slavery. They were dragged kicking and screaming into that
- 39 LIGHT of TRUTH. We conservatives won that round, and we will
- 40 win this one too. Once again we are trying to drag Liberals,

- 47 behavior of late.
- 48 So it's a rhetorical war a battle of words! And in their arsenal are
- 49 lies, innuendo, used to accuse, and if none are available, they resort
- 50 to false accusations, character assassination —
- 51 So while they know full well that Conservatives not only do not
- 52 want to return to slavery, they know full well that conservatives are
- 53 the one primarily responsible for ending it they contrive by their
- lies, by deceit, by innuendo, to convince themselves that because
- 55 conservatives want to conserve American traditions, and since
- 56 some Americans owned slaves in the past, that makes slavery an
- 57 American tradition, and therefore conservatives want to conserve
- slavery, while they, on the other hand, want to PROGRESS forward

- 59 into a new era leaving American traditions behind and if you
- 60 cannot see, if you cannot see clearly, without further elucidation
- exactly what is going on here the only conclusion I can make is that
- 62 you are a liberal you are a progressive.
- 63 Because only liberals think like that.
- 64 Conservatives want to conserve the values and principles that led
- 65 the world into a new era of valuing human rights, of cherishing life,
- 66 liberty, and the pursuit of happiness, of FREEDOM, and LIBERTY
- for all, red, yellow, black, or white, whether helpless babies in the
- 68 wombs of their mothers, or babies toddling along, or feeble seniors
- 69 doddering along or approaching their meeting with their Maker,
- and all in between. We want to CONSERVE the value ensconced in
- 71 the Declaration of Independence ALL MEN ARE CREATED
- 72 EQUAL AND ENDOWED BY THEIR CREATOR WITH
- 73 CERTAIN INALIENABLE RIGHTS that's what conservatism is.
- 74 And the left knows it! They are stupid on purpose, and with a
- 75 purpose.
- 76 So, first we must define *stupid*. Gump tells us his mother said
- 77 "stupid is as stupid does." Well, that's droll! The word *stupid*
- 78 actually hails from France Stupide, which adapted it from the
- 79 Latin *stupidus* which is derived from *stupere* and means to "be
- amazed or stunned," with the idea of being made incapable of
- 81 cogent thought. Being *stupid* means to be under the influence of
- 82 something that interferes with one's ordinary ability to reason, or
- 83 think clearly.
- 84 For example, people under the stupefying influence of hatred for
- 85 America as founded are unable to think rationally about it, and so
- 86 accept stupid ideas like conservatives want to return to slavery. In
- other words, it's STUPID ON PURPOSE AND WITH A
- 88 PURPOSE the purpose is to destroy the good name of America,
- 89 the good name of Conservative, and even the good name of

- 90 LIBERAL yeah, those who have stupidly connected the word
- 91 conservative to slavery have also connected another good word,
- 92 *liberal*, to that stupidity.
- 93 In fact, Progressives have taken that good word, liberal, and, lately,
- 94 have attached it to such vile behavior as would make anyone that is
- 95 not under the influence of their irrational hatred-for-America
- 96 induced stupefaction to recoil in horror and disgust indeed, the
- 97 liberal so-called progressive has connected liberal to villainy —
- 98 and it's sad, because *liberal* is a good word we may rejoice,
- 99 however, because GOD has promised us: "The vile person shall be
- 100 no more called liberal" (Isaiah 32:5). Indeed, there is hope the
- 101 context of this verse includes another promise we can make use of
- right now: "The heart also of the rash shall understand
- 103 knowledge..."
- 104 So, all of this to say only those who are stupid believe this
- 105 California Berzerkly Liberal accusing Kavanaugh of attempting to
- 106 rape her back in their High School days 30+ years ago wrote
- 107 her letter of accusation to Feinstein after Kavanaugh was
- 108 nominated to the Supreme Court because she felt it was her duty to

- 121 (we know Hillary stole her nomination from Bernie and the

- evidence is piling up that Hillary, Obama, and the rest of those
- 123 crooks, tried to STEAL the 2016 election from conservatives —
- only the stupid actually think) only the stupid, (ouch—hey,
- don't press so hard on that tight spot in my brain—haha. Okay,
- how about *stupere*?) Only the *stupere* believe her unwillingness to
- testify on Monday has anything to do with anything else but to

- 145 They believe something they know in their heart to be false but it
- serves their purpose. Here is how they think, are you ready for this?
- 147 Stupid people think like this: conservatives want to conserve
- 148 American traditions. Slavery is an American tradition.
- 149 Conservatives want to conserve slavery.
- 150 Come on. You can't call that for what it is? That is willful
- 151 STUPIDITY. That's not a disdainful derogation of a person who
- deserves our pity it's a term of reproach, and rebuke against
- those who are stupid on purpose and with a purpose.

- 154 You know that slavery is not an "American tradition." Slavery is no
- 155 more an American tradition than Abortion is an American
- 156 tradition. Abortion is an American aberration abortion is
- 157 CONTRARY to our American tradition of the sanctity of human
- life. Slavery is the same way. Slavery is something that was going on
- all over the world, and still goes on in many places of the world —
- 160 the American TRADITION is it's honorable record of ENDING
- 161 SLAVERY ending slavery is AMERICA'S TRADITION —
- ending it brought America into alignment with it's TRADITION of
- 163 TRUTH AND JUSTICE FOR ALL.
- 164 The sad truth is that persons of low intellectual capacity are the
- ones most susceptible to this sort of stupidity but they are not
- stupid. They are victims of those who capitalize on their ignorance
- or lack of intellectual capacity the stupid, driven by their hatred,
- the "rash" as the Bible calls them, the rash who rush to conclusions
- and doing so twist reason into a pretzel, take advantage of them.
- 170 The Bible uses another word for this it's the word *brutish*. To be
- brute like is to have the reasoning capacity of a beast, limited. It is
- to be, well, *stupid*.
- 173 A lot of pastors are brutish they don't think beyond the capacity
- of a beast because they are STUPID. Read about them in Jeremiah
- 175 10. They serve their own belly their own interests. To protect
- their own interests they refuse to speak the TRUTH in their
- 177 pulpits; it might offend someone. So, being stupefied by this fear,
- they rationalize their cowardice by believing things like, a pastor
- should not engage in politics.
- 180 But that is exactly what they are doing. They are making a
- politically expedient decision to not speak GOD's TRUTH to the
- cultural sins of our nation by creating an off limits zone for the
- Bible. Politics is off limits from the BIBLE, from the TRUTH?
- 184 Really?

- 185 No wonder we are in such a mess we have a pack of STUPID
- 186 (brutish) pastors whose reasoning is stupefied by their fear of man
- so they use STUPID arguments to justify their cowardice.
- 188 And don't think those of you who attend and support those pastors
- are going to get a pass the Bible exposes you too. It says, "you
- love to have it so." You like the coward pastors because you can
- 191 hide your own cowardice behind their frocks. Coward flocks hide
- in the skirts of coward frocks.
- 193 Okay, let's wrap the first segment. What is the value of a good
- 194 name? Have you noticed how the wicked labor incessantly to ruin
- very good name? There is a natural perversity in human nature
- that drives them to exalt a bad name and ruin a good one.
- 197 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
- 198 at the Lighthouse, your brain masseur, and Paul Revere's lantern
- lighter, lighting the lamps in the church belfry arch, signaling the
- 200 enemy is on the march, an enemy that would steal from us our
- 201 liberty.
- 202 So, let's see ... yeah, let me finish up with the latest Stop
- 203 Kavanaugh circus act.
- I no sooner mentioned my surprise and satisfaction that the left
- 205 could find nothing salacious, or scandalous, on Kavanaugh than,
- 206 what was that, about two or maybe it was three weeks ago after
- 207 Kavanaugh has been vetted by the FBI, what six times, I can't
- remember, and nothing like this came up. And that's back when
- the leadership in the FBI actually cared about justice and truth.
- You know, before certain of the FBI were trying to cover for
- Hillary, and help her get elected, before phony dossier's and
- 212 conspiracy to overthrow a Presidency back in those days. You
- 213 might remember when it was the Federal Bureau of Investigation
- and not INSTIGATION. Before the days FBI came to mean
- 215 Favoritism (they were certainly WITH HER), Bunco, and Illegal

- 216 surveillance. Or, the Fraudulent Buncos of Immorality okay,
- 217 that's enough. I have acquaintances that served faithfully in the FBI
- and it's just sad how the liberals have sullied yet another good
- 219 name.
- I no sooner had indulged, with satisfaction, that the loonies on the
- left had been unable to come up with anything on Kavanaugh they
- 222 thought they could use to ruin his good name what's that? —
- Well, that's true, I said, *yet* and said that with emphasis, you are
- 224 right because the liberals these days are so bizarrely *stupere* they
- 225 audaciously criticize a Juanita Broderick, and embrace a
- 226 Lewdinzky, they ignore Ellison's accuser who has produced hard
- 227 evidence to support her allegations and insist the Kavanaugh
- 228 accuser gets her day in court with ZERO evidence. Thirty years
- ago, she claims, Kavanaugh attempted to rape her, but she cannot
- 230 remember where or when. Feinstein held her letter of accusation
- for something like three months and never brought it up, not even
- discreetly, when speaking with Kavanaugh in two or three private
- 233 sessions.
- 234 So the Palo Alto University professor of clinical psychology has
- 235 decided she will testify but the terms are very fishy. First, the FBI
- refused to investigate the claims. Why? And where is Sessions in
- 237 any of this. That is the most do nothing dead beat I've ever ...
- Anyway, of course this should be vetted by the FBI who have
- 239 something like six files of investigation on Kavanaugh and have
- 240 the best possible resources to run this down. But they won't touch
- it. Why? Well, it just so happens that if they did, they would have
- to question Ford and if she lied to them, well, then she would be in
- trouble. Furthermore, if the FBI get in on this, well, that would
- bring into question the chain of evidence issue the letter of
- accusation, who did write it, when, under what circumstances, and
- then the probe would work it's way into the China spy infested
- offices of Feinstein, and in Mueller like fashion, well, who knows

- 248 what monsters lurk in the California Senator's section of the
- 249 swamp.
- 250 I'm just saying I can think of some reasons Feinstein might not
- 251 think it's the best idea to pursue the FBI investigation angle on this
- 252 one.
- 253 But that is what should be done, and if Sessions would decide to
- 254 BEGIN HIS SESSION AS ATTORNEY GENERAL OF THE
- 255 UNITED STATES that's what would happen. There is NO way a
- 256 MAN in that office sits back and watches this without wanting to
- get in there and get to the bottom of it quickly. Like I said, the FBI
- 258 has at least three or as many a six different files they opened on
- 259 Kavanaugh and could very quickly run this down but of course
- 260 Ford would have to come up with a place and a much more narrow
- time frame for when this occurred, and that could put her in a
- 262 position to perjure herself, and it would also give Kavanaugh an
- opportunity to show proof he was not there, or call up other
- 264 witnesses that would corroborate his story.
- 265 Ford is making demands. She wants Kavanaugh to testify first,
- before he has heard the charges leveled against him. She wants to
- 267 give her testimony without Kavanaugh present. Wait a minute!
- The accused has a right to face his accuser. And how is it
- reasonable to anyone that Kavanaugh be required to answer for
- 270 charges until he hears what those charges are?
- 271 They are concerned about Ford's safety? You've got to be kidding
- 272 me. Have you read any of the emails and other threats Kavanaugh
- has been getting; and not him only, but his family, his wife, his
- 274 daughter. They are receiving death threats, so vicious and hateful it
- 275 literally made me sick when reading some of these things.
- 276 Whatever, whatever you do America do not put these vile, hate-
- 277 filled, vicious people in power over you. You are out of your mind
- 278 to vote for any Democrat in this upcoming election. You might as

- well hand the Devil a whip to beat you with. You have to a
- 280 masochist to vote Democrat in this upcoming election. They've
- 281 gone off the rails the raging has turned vicious. Here is one who
- wrote to Ashley, Kavanaugh's wife, and angrily told her to advice
- her husband to put a bullet in his ugly expletive skull." Screaming at
- 284 the family to eat feces and damning them to burn in hell.
- 285 GOD, deliver us from the unreasonable and wicked.
- Ford's people are saying she cannot testify Monday no
- 287 explanation, just can't do it Monday. They say, "maybe next week."
- 288 Maybe?
- Well, it's obvious that Ford and her partner in this crime of
- 290 character assassination, Diane Feinstein, want to string this out as
- 291 much as possible. I understand the letter of accusation allegedly
- 292 written by Ford and delivered to Feinstein several weeks before it
- 293 was made public, has been redacted the Senate Judiciary
- 294 Chairman, Representative Grassley, Iowa, has asked Feinstein for
- 295 an unredacted copy of the letter she is slow walking that request
- 296 why? That's something a staffer takes care of in minutes.
- 297 Oh, by the way. Juanita Broderick is ready and willing to testify —
- and so is Karen Monahan. Yeah! A Democrat, by the way. A
- 299 Democrat woman, by the way. A Democrat, woman, of color, by
- 300 the way. Has medical records proving her allegations of sexual
- abuse against her by Keith Ellison, Mmmmmsmack Democrat
- Representative from MN, she offered to talk with investigators with
- 303 Keith in the room: she tweeted: "I told the investigator I would be
- happy to talk with @keithellison w/ them in the room. They asked
- 305 Keith if he would be willing & he declined any meeting w/ me."
- 306 The Democrats say, "believe women" when Democrat woman
- 307 of color Karen Monahan was asked if she believes Democrats are
- sincere when they say believe women, she said, "No, they don't.
- 309 I've been smeared, threatened, isolated from my own party. I
- provided medical records from 2017, stating on two different Dr.

- Visits, I told them about the abuse and who did it. My therapist
- released records stating I have been dealing and healing from the
- 313 abuse."
- Isn't it about the "seriousness of the charges"? Look! What is it
- 315 going to take this is not something that is hid from the liberals.
- 316 They know about Monhan's allegations, they know about Juanita
- 317 Broderick's allegations, they know but they don't care because
- those allegations tend toward the destruction of the reputation of
- 319 people they support but if it's against someone they hate,
- someone they perceive to be a threat to their power —
- Whatever you do don't give power to these crazy, hateful, lying
- vicious people. Look what they do with it. Phony dossier's,
- 323 illegally FISA warrants.
- Okay, so what does the Bible say about someone throwing out
- false accusations against another? Yes, the Bible does speak to
- 326 this, and sets forth a very important principle of justice.
- Deut. 19:16-19 "If a false witness rise up against any man to testify
- against him that which is wrong; Then both the men, between
- whom the controversy is, shall stand before the LORD, before the
- priests and the judges, which shall be in those days; And the judges
- shall make diligent inquisition: and, behold, if the witness be a
- false witness, and hath testified falsely against his brother; Then
- shall ye do unto him, as he had thought to have done unto his
- brother: so shalt thou put the evil away from among you."
- 335 This means that whatever the punishment would be for the
- accusation should be meted out to the accuser.
- 337 Character is one thing we talk about "character assassination"
- and I get the idea but the truth is, character cannot be
- assassinated. A person can, and a person's reputation can be
- ruined; but a man's character is etched in his own soul and cannot
- be ruined by anyone except the owner thereof. You are the only
- person that can build or destroy your character.

- 343 But what about our reputation? Reputation is something that others
- 344 believe about your character, but it is not intrinsic to it, it does not
- 345 necessarily fairly represent your character.
- Many have reputations that are far nobler than their character.
- Many have characters that are way below their reputations.
- 348 But a reputation is reflected upon our good name. God values a
- good name: Prov. 22:1 "A good name is rather to be chosen than
- 350 great riches, and loving favour rather than silver and gold."
- 351 If you rob a man of his rightful reputation, if you destroy his
- reputation by lies and innuendo, and deceit the way
- 353 progressives will treat you if you are conservative you have
- 354 stolen something from him more valuable silver and gold.
- You go to JAIL if you steal a man's silver and gold, but nothing
- 356 happens if you steal a man's reputation.
- Ford should pause to consider what she is doing. If in fact she is
- 358 lying, even though she might think she can steal Kavanaugh's
- reputation with impunity, she will be under oath before the Senate
- and the same penalties apply there: up to five years. But according
- to a higher court, the court of final appeal, perjury will bring on her
- 362 the punishment for the crime she falsely accused Kavanaugh of
- 363 committing.
- One of the vicious attacks on Kavanaugh's family was that, I think
- one of them demanded the entire family burn in hell hmmm!
- 366 That's an interesting judgment. Perhaps GOD will judge these
- people from their own mouths the Bible says all LIARS will
- indeed burn in the LAKE of FIRE forever.
- 369 Stealing a man's gold and silver is one thing but stealing a man's
- reputation is an even greater offense.
- 371 So, that's what the Bible has to say about it. Whatever punishment
- the crime of attempted rape would bring, should fall on Ford if it
- turns out she is lying about this.

- Well, I've only got a few minutes here perhaps I can get a one
- 375 minute out there on Eric Holder's statement that for Trump to
- declassify the FISA records, showing what the court was actually
- told, and not told, in order to get the warrant to surveillance
- 378 Trump's campaign (can anyone spell Watergate) was "a dangerous
- abuse of power." It's an "abuse of power" to release information
- 380 the American people. Well, it is, in their way of thinking. Power is
- only to be used to KEEP INFORMATION FROM THE
- 382 AMERICAN PEOPLE, not give it to them. Power is to be used to
- railroad legislation through into law against the people's will —
- power is to be used to cover up Fast and Furious, and Benghazi,
- and ... sending billions to Iran, delivering truck loads of money —
- all hidden from the American people while pretending to be the
- 387 most transparent Presidency ever all I can say is stupid is as
- 388 stupid does you believe these people?
- 389 And Brennan, that's the ex CIA director who is up to his neck in
- Russia-gate, his fingerprints are all over this mess, how does
- 391 Brennan respond to Trump's decision to declassify: it's pushing the
- button on the nuclear bomb well, today Trump pulled back and
- said hold-on, some key people warned this might be construed to
- 394 be interference with the Russia probe the thinking is that there
- will be political backlash on this and it will be made to appear to
- be interference in the probe THIS IS NONSENSE.
- 397 But, be patient. The fact is, our President is NOT the dictator
- 398 Obama was, is, Trump does listen to his advisors, he does try to
- 399 cooperate with his team some he respects are advising him to
- slow it down and let the Inspector General have a look see at the
- 401 un-redacted FISA application. So, here is what Trump tweeted:
- 402 "I met with the DOJ concerning the declassification of various
- 403 UNREDACTED documents. They agreed to release them but
- 404 stated that so doing may have a perceived negative impact on the
- 405 Russia probe. Also, key Allies' called to ask not to release.
- 406 Therefore, the Inspector General has been asked to review these

- documents on an expedited basis. I believe he will move quickly
- 408 on this (and hopefully other things which he is looking at). In the
- 409 end I can always declassify if it proves necessary. Speed is very
- 410 important to me and everyone!"
- In other words, declassification is in the works; Trump is going to
- 412 cooperate with his team and honor those he respects who are
- 413 advising him, to a point.
- 414 So, don't listen to the fake news that says Trump No Longer
- 415 Demands Declassification Of Russia Documents from the likes
- 416 of New York Times. All that has happened is a brief delay it's a
- 417 process thing. Be patient. The nuclear bomb Brennan fears that
- 418 will detonate and wipe out the swamp, will be dropped soon —
- 419 haha.
