

Brain Massage®: Show No. 694 The Assault On American Values From The Left Must Be Answered — *Innocent Until Proven Guilty* Is No Longer Sacred

1 Segment.01 Hello. I'm Dr. Jerry Scheidbach, pastor of the Lighthouse Baptist Church in
2 Santa Maria, CA—and your brain masseur—get ready for your brain massage.

3 The Left's assault on traditional American values has been cutting into muscle and now
4 it's attacking vital organs of the body politic! (The *body politic* refers to the people of a
5 nation taken together as a whole, or, as a body.) You heard the labored breathing of that
6 body politic during the Kavanaugh hearing — unless the body politic called America
7 wakes up and rids itself of these wicked and unreasonable men and women who are
8 strangling the life of freedom out of us — FREEDOM will die in this country.

9 Thank you for joining me today as I reflect on the Kavanaugh hearings, Ford's testimony,
10 Kavanaugh's rebuttal, and the significance of all of this relative to the upcoming election
11 in November.

12 Okay, my friends — it's time for your brain massage.

13 [TRUTH]

14 The structure of the hearings was absurd.

15 I understand why the Republican Senators did not want to give the appearance of
16 attacking a potential sexual assault victim. I had mixed feelings about hiring a
17 professional interrogator whose expertise is ascertaining the credibility of a witness in a
18 sex crime case. They chose Phoenix AZ sex crimes prosecutor, Rachel Mitchel.
19 Nevertheless, I think it is the responsibility of our Representatives to get to the bottom of
20 these allegations.

21 And then to hamstring the professional with warnings against getting too harsh on the
22 witness — imposing rules of engagement that compromise her ability to do the job she
23 was hired to do. Complaints about the open-ended questions are valid; but, on the other
24 hand, sometimes an open-ended question allows for the witness to go into blabber mode
25 in which, often, a false witness will wander from his or her script and let truth slip out
26 from behind the defenses of a prevaricating witness. See, Ford, I know some big words
27 too — haha. More on that in a moment.

28 But interrupting the interrogator every five minutes so some Democrat cheerleader could
29 jump in with — "Go blasey, go — we want you to know — we believe you, you're
30 courageous — go Blasey Go." What was that about? Well, we know what that was about?
31 Who came up with this plan? Let the person hired to examine the credibility of Blasey
32 Ford and then interrupt her every five minutes to trot out the cheer squad to defend her
33 and, effectively, warn the interrogator they had better not get to rough.

34 The fact is, the professional should have been allowed to interview Ford in a private
35 session with some from both sides present, and then a report presented to the Senate
36 hearing — so, what did the sex crime prosecutor from Phoenix conclude: It's a case of

37 mistaken identity: Christine did experience the assault she described but Kavanaugh was
38 not the perpetrator.

39 Friend, the Republicans are crawfishing on this. Well, not all of them. Lindsey Graham
40 certainly came straight at them — but even he dared not question the credibility of
41 Christine Ford.

42 Christine Blasey Ford is the most coddled cockatrice¹ I've ever seen. That she is lying is
43 evident to anyone willing to accept facts into their assessment, as I shall show. But no one
44 is willing to even hint the slightest suspicion of her honesty.

45 So, let's start here, since this is where it started — Ford's allegations.

46 You already know what they are! Christine Blasey Ford accused Bret Kavanaugh of
47 sexually assaulting here back in 1982 — 36 years ago. Let's assemble the pertinent facts of
48 this case before us.

49 First, it was 36 years ago. The obvious question then is why now? If this is not politically
50 motivated, which, of course it is, why does Christine come out with this now? And even
51 more to the point — she tells us she was so traumatized by the event she alleges that she
52 has become claustrophobic — her fear of confined spaces was brought up as a reason she
53 did not want to fly to DC — then it was discovered she actually flies quite a lot — and she
54 explained she knows techniques that assist her — and so why bring that up in this case?
55 But anyway, okay, she does not like to fly. She brings up her claustrophobia as evidence
56 showing how traumatized she was by the alleged event.

57 Hmmm. In her testimony, in order to offer some "evidence" that Kavanaugh and his
58 friend sexually assaulted her, she relates this anecdote: after the event, she went to the
59 grocery store with her mother, a Safeway. Her mother went into one door, and she
60 entered the store through another. This was explained as, you know, typical teenager, did
61 not want to walk into store with Mommy??? Okay. Let's lay that aside for the moment.
62 Christine walks into the Safeway and there was Mark Judge — the friend whose laughter
63 with Kavanaugh while assaulting her was, as she put it, indelibly impressed upon her
64 hippocampus (the part of the brain where memories are, well, let's say, etched) — yeah,
65 one of primary perpetrators of the assault, she comes face to face with this guy, and,
66 according to Ford, she says, "Hi." That's right! Christine Blasey Ford comes face to face
67 with a fellow student who participated in an attempt to rape her, who allegedly joined
68 with Kavanaugh in such evil laughter, at her expense, as to have disturbed her so deeply it
69 was indelibly impressed upon her hippocampus — and, she, does not turn and walk away,
70 she does not start screaming uncontrollably, she does not attack him, she does not run
71 back to the car, she does not scowl at him, she does not rebuke him, she, says, Hi. And she
72 noticed he looked ill, I think she described him as looking ashen — so, on top of
73 everything else this anecdote reveals about her lack of credibility, it tells us she has a very

¹ A cockatrice is a mythical beast, essentially a two-legged dragon or serpent-like creature with a rooster's head. Described by Laurence Breiner as "an ornament in the drama and poetry of the Elizabethans", it was featured prominently in English thought and myth for centuries. (<https://www.youtube.com/watch?v=pYLy2Oioc0>) According to the Bible, liars are described as those that "hatch cockatrice' eggs, and weave the spider's web." Because when these eggs are crushed vipers break out, it is believed the cockatrice is a snake, specifically, a poisonous viper (Isaiah 59:5; see Jeremiah 8:17). In Isaiah 14:29 they are connected to a "fiery flying serpent."

74 selective hippocampus — she can remember this but cannot remember where this
75 occurred or even when — the closest she can come is to the year — and that took some
76 coaching — they needed to make certain Kavanaugh was not in, say, France, at the time,
77 so, they had to do some research to pick a year and a summer they were sure he was there,
78 and his friend, Mark Judge, so — but to identify a house, that's a whole lot more tricky,
79 even a street name could get them in trouble, no, they did not want to identify the general
80 vicinity of any specific neighborhood, she could not take a drive along the area and
81 remember — because any of that could open a door for Kavanaugh to be able to PROVE
82 his innocence — it was very important to this sham that the allegation be UNPROVABLE
83 — they DEPEND upon the UNRPOVABILITY of the charge and the gullibility of the
84 public — but she cannot remember where this occurred, that, apparently, was not
85 imprinted upon her hippocampus — and, equally incredible, she cannot remember how
86 she got home. Someone drove her home, but she cannot remember whom.

87 And now, let's add to this some things we know about Mrs. Ford.

88 Dr. Ford is professor of psychology at Palo Alto University in California. Also, she is a
89 research psychologist for the Stanford University School of Medicine. Oh, now this is
90 interesting: her father works in the Central Intelligence Agency.² There is a rumor that
91 Christine Blasey Ford, whose father works for the CIA, heads up Stanford's CIA
92 Undergraduate Internship program.

93 And this is interesting, some pictures of Christine Blasey Ford, whose father works in the
94 CIA, chumming with George Soros. But wait, that does not even look like Ford — no way
95 that's Ford — this girl looks Slavic and Ford is, well, plain-English looking; you guys who
96 pull this stuff are no better than those you are trying to smear — you are low down liars
97 — and the good book says ALL Liars — that's liars on the right and liars on the left — all
98 of them, have their PLACE in the LAKE OF FIRE.

99 So, just the facts, man!

100 As for indelible imprints upon the hippocampus — experts will tell you that selective
101 memories in a trauma are not without precedent, but certain aspects of memories are
102 very unlikely to be lost — and one of them is spatial memory — the hippocampus
103 especially records episodic and spatial memories. In other words, a trauma generally
104 welds the place with the event in our memory. She had to have known the place where
105 this alleged party took place, or at least enough facts to narrow it down — who invited her
106 to the party, who conveyed her to the party, and who conveyed her home.

107 It appears everyone wants to concede the experience she related was real. I don't think so!
108 I listened to her testimony, and watched much of it, and frankly, she came across as
109 academic and phony.

110 None of the "witnesses" she named believe her story. None! Not one! If she did experience
111 something along the lines of what she alleges, one thing is obvious — she brought it up at
112 this time in order to derail Kavanaugh's nomination to the Supreme Court.

113 So, that's my take on Christine Blasey Ford. I'll need to take a break — I'll be right back,
114 and we'll look at the Dems call for a full FBI investigation that, at this point, is nothing
115 but another delay ploy — but let's look at it, and then we'll take a look at Kavanaugh.

116 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor at the Lighthouse,
117 your brain masseur, and Paul Revere's lantern lighter, lighting the lamps in the church
118 belfry arch, signaling the enemy is on the march, an enemy that would steal from us our
119 liberty.

120 In segment one I offered my take on Ford; in this segment I'll offer my take on
121 Kavanaugh.

122 But first, let's look at the Left's call for an FBI investigation.

123 As you know, early on, I said that's what should be done. Christine Blasey Ford needed to
124 file charges against Kavanaugh, in Maryland, where there is no statute of limitations for
125 this sort of crime, and where the alleged incident took place, and the charge would be
126 sexual assault and battery, or something like that, then the FBI would do an investigation
127 — but, you see, while Christine Blasey Ford is 100% certain, now, that it was Kavanaugh
128 who assaulted her 36 years ago, and she considers it her "civic duty" to bring this out now,
129 when, she and her cohorts hope, it will derail his appointment to the court, she is not
130 sufficiently committed to the memories dredged up in her mind by the electrical impulses
131 carried by the norepinephrine across the synapses along the ridges of her hippocampus —
132 haha, okay. She is willing to destroy his career and his life, to stop him from getting on
133 the court, but she is not willing to bring charges against him for his crime; well, that's
134 another matter — because then she can suffer legal repercussions, because in that context,
135 all of a sudden evidence becomes key. In the present scenario, evidence does not even
136 matter. In the present scenario, the one accused is burdened with the need to prove his
137 innocence — in this scenario she can create any story she wants just so long as she does
138 stipulate any fact that can be proved false. Like, who drove her home. Or exactly where
139 did the event take place.

140 As for why would any woman put herself through all this unless it was true?

141 You've got to be kidding me?

142 Christine Blasey Ford is a zealot for the left — they are already paying her for her
143 "services" — the book deals, the likely movie deal, I mean, our culture makes heroines out
144 of people like this — they are already talking about her being a "profile in courage" — she
145 has no skin in this at all. All her attorney fees are being covered by those who are using
146 her to get at Kavanaugh. She stands to lose nothing, and to gain big time. The only risk to
147 her is spiritual. She has sold her soul to the devil — but a different court will try that case
148 at a later date.

149 Women lie too. Malkin put together an excellent piece on this and brought forward a very
150 good insight. This nonsense that the default should be "Believe the Woman," until she is
151 proved wrong is totally backwards. It makes perfect sense to give someone the benefit of
152 doubt, but there is no way FREEDOM will endure in a society where the accuser is to be
153 believed until the accused can prove his or her innocence. She brought out the incident of

154 Joseph and Potiphar's wife — you know the story. Joseph, the eleventh son of Jacob, was
155 serving in the house of the captain of Pharaoh's guard in Egypt. Potiphar's wife attempted
156 to seduce Joseph, but he ran off. She took hold of his garment and when he fled, it tore
157 and she kept it, then contrived a lie to tell her husband, and used the piece of his garment
158 as "evidence," to support her lie and Joseph ended up in prison for this. Women lie. Men
159 lie and women lie. The default cannot be "believe the woman," the default must for ever
160 be, believe the EVIDENCE — and even that sometimes can be tricky, but it is the best we
161 can do. And in this case, there is no evidence supporting the allegation — none!

162 In fact, there are no provable claims in this allegation.

163 So, what about the FBI investigation angle. As my friends know, that was the first thing I
164 called for. It's frustrating, because now it's obviously nothing but a delaying tactic on the
165 part of the left.

166 With regard to the Kavanaugh nomination vote, the investigation should be very
167 narrowly focused on the question of whether there is any corroborating evidence to
168 support the allegation, period. It should be time limited — one week, and if they cannot
169 find anything in that one-week, it's over, the vote proceeds. If they come back with some
170 claim that they need more time to fish around and maybe find something else they can
171 use to further delay this, too bad, vote. Additionally, separately, another investigation
172 MUST be launched into Feinstein's duplicity and cover up in this. It must be investigated
173 to determine whether persons involved in delaying the release of this information until
174 the last minute were involved in obstruction of justice. That investigation should be wide
175 open, allowing investigators to take their time looking into every crack in every floor of
176 every Senator in one way or another connected to any correspondence related to this
177 letter — the UNREDACTED letter must be released — forthwith — Feinstein must be
178 made to account for her role.

179 The investigation must include looking at every possible connection to deep state CIA
180 operatives in any of this.

181 We know that Trump discussed this with the FBI earlier and it was decided not to call for
182 an investigation into the matter. Not sure who they are protecting or what concern they
183 are trying to cover, but it was decided they would not treat this like a criminal case but let
184 it play out as a political one. The left actually acquiesced to this — they decided they
185 would use it to extend the vote and delay confirmation of Kavanaugh if they needed too
186 after the hearing. They can see they did not get what they hoped for from the hearing, so
187 now they are calling for an FBI probe — it's delay, delay, delay — and yet, it really should
188 have been done right up front. Or, at the very least, the FBI probe into Kavanaugh that
189 would have been done ROUTINELY should have been forwarded to the principal parties
190 as the FBI's conclusion on the matter.

191 In other words, the FBI vets all nominees anyway; so, this was already done. However,
192 they were not looking at this particularly, so, okay, let's reopen the file, and zero in on
193 other classmates, go into Christine's and Kavanaugh's high school behavior more deeply
194 and intimately, run down the "place" where this happened, and at the end of the day, we'll

195 be right where we are right now, and the left will have had another week to threaten,
196 cajole, intimidate, bully, or buy, whatever votes they need to stop the appointment —

197 I'm telling you folks, we are in the fight of our lives for our freedoms in this country and
198 we must win! But we will not fight dirty — we will fight as Christian warriors in prayer
199 and with righteousness and we will prevail — we shall reap if we faint not.

200 Stay strong!

201 I just got word that the Senate has voted to move forward with the nomination of
202 Kavanaugh; but, yielding to calls for an FBI investigation, they put it off for one week
203 allowing the FBI to conduct an investigation — but, now, with the potential that the deep
204 state might have CIA operatives involved behind the scenes — I hope Trump and
205 company will get very aggressive in ensuring we don't have any more phony dossiers
206 being fabricated, or any Mueller drag-it-out strategies going on. Of course, I suppose
207 Sessions will find a way to dodge this one too — what do you think? Let's see if he actually
208 SHOWS UP TO WORK on this one.

209 WHERE IS SESSIONS?

210 Looking at Kavanaugh — Here you have someone that has been vetted by the FBI five or
211 six times and nothing of this nature has come up. The "witnesses" named have not
212 confirmed her story—none of them. She apparently has not one high school friend she
213 confided in. I mean, it's simply unbelievable. Her ties to the Demoncrats and the CIA are
214 concerning.

215 So, let's go to the bottom line here.

216 You might have noticed that the Democrats are very intense about election of Donald
217 Trump — his Make America Great Again is working and this is exposing their own
218 miserable failure, at the same time it's all but totally wiped out their influence with the
219 Independents, and it's even encroaching on their base, especially among Blacks,
220 Hispanics, and women. This nomination and the success of Trump have them going out
221 of their mind. They are exposing themselves at almost every turn.

222 It's about power with them — plain and simple! Graham was right — they are beside
223 themselves over the prospect that they are losing power in government — and, pray GOD
224 these people never get it again. They are vicious, evil, wicked, lying, devilish, conniving, I
225 mean it has become obvious they will do anything — they will destroy this country before
226 they would allow anyone to have power that will take it back to the forms the
227 Constitution outlined for us — and we MUST recruit every Christian to VOTE. You
228 simply MUST VOTE this November.

229 I cannot overemphasize the importance that Christians register and VOTE this
230 November. You cannot sit by and watch this indecent, disorderly crowd continue to
231 deconstruct every precious American value.

232 Look, they have virtually destroyed marriage in our country and look at the ruin it has
233 caused. They have destroyed the value of TRUTH, and JUSTICE — now they are
234 destroying one of the most cherished values of American culture — INNOCENT UNTIL

235 PROVEN GUILTY, and the principle that an accused has the right to face his or her
236 accuser. It's hard to think of a traditional American value that has not been corrupted by
237 these people. Fairness — what fairness has their been for Kavanaugh? Why must we allow
238 the basic concept of fairness to be trodden down by these people — why can't we at least
239 be fair and honest about this — Ford has no proof. That's it! Sorry! If you convince people
240 to begin accepting accusations against people without proof, this nation is ruined. It's
241 hard enough to maintain a sense of honest justice and judgment in an environment
242 where you have officers of the law purposely-tempting citizens to commit a crime so they
243 can get an arrest — when you have the FBI complicit in the fabrication and use of a
244 phony dossier to justify a FISA warrant on false information to spy on American citizens,
245 when you have government officials in high places using the power of government to

258 up to them in Washington DC to stop it. We must rise up and stop it by wielding the
259 greatest power in our government — the VOTE.

260 We must protect the integrity of the VOTE and we must VOTE. If every single Bible
261 believing Christian within the reach of my voice will make certain you are registered and
262 will vote, and allow your vote to be guided by your FAITH — and vote intelligently, and

269 into Washington DC —.

270 I have lit the lamps in the Church belfry arch and now you let me know if you see them.
271 It's LIGHTS ON if you see the LIGHTS ARE ON and you will ride like Revere and spread
272 the warning, (essentially, it means you agree with what I'm saying) or you say LIGHTS
273 OFF -- which means you reject what I'm saying and disagree strongly with me. So, what
274 will it be today, lights on, or lights off?
