- 6 Senate votes cloture — (a cloture vote ends debate and allows the Senate to vote on a
- 7 motion) which in this case ends debate on the Kavanaugh nomination and advances the

8 motion to a vote as early as Saturday (October 6, 2018).

9 What do you think of the strategy to protect Ford?

10 Remember John Paul Stevens? Not many hands. He was nominated to the Supreme 11 Court in 1975 by Gerald Ford, no relation to Christine Ford — hah! He gave Kavanaugh 12 high marks before his testimony regarding Ford's allegations — now he says Kavanaugh 13 not fit to serve on the court because he was too weepy, and aggressive in his testimony.

14 What did you make of Kavanaugh's testimony?

15 One GOP Senator expressed his concern that the tactics used by the left to derail the 16 Kavanaugh nomination to the Supreme Court amount to mob rule and fears allowing this 17 scandalous tactic to succeed will encourage more of the same - hmmm! I agree, of 18 course. But, uh, this started with Bork, it escalated with Thomas, and now it's completely 19 off the rails. Give the devil an inch...

20 But we have November - our opportunity to make our voice heard. Watch the vote, I 21 mean protect the integrity of the vote, and use the vote.

27 Let's see, oh, here you go, "Some see Christian First bias in Trump foreign policy," hah!

28 They never complained about Obama's Muslim first policies. Trump's policies are simply 29 justice first — and he is not afraid to include Christians in the government's freedom

- 30 franchise —
- 31 Joe Biden is worried Trump is going to go nuclear on Iran.
- 32 And Trump speaks out on the "war on men."
- 33 I'll be in South Carolina this October the week of the 14th for the National Intercessor
- 34 Prayer Conference, held at Tabernacle Baptist Church on White Horse Road in
- 35 Greenville — my heart goes out to the family, friends, and colleagues of police officer

- 36 Terrence Carraway who was killed while serving a warrant at a home in Florence, SC. 37 Please take a moment to pray for this family, and the seven other officers who were
- 38 wounded in the stand off.
- 39 Okay, that should set the table for us let's get started. It's time for your Brain Massage<sup>®</sup>.
- 40 [TRUTH]
- 41 The FBI completed it's seventh background investigation of Kavanaugh this one 42 zeroed in on Ford's allegations — Feinstein does not want anyone to see this report?
- 43 I wonder what is in this report that Feinstein does not want us all to see? Many on her 44 side of the aisle are demanding it be released. Maybe she appreciates the sensitivity of the 45 information in this report. Maybe it reveals Ford is a total sham. Maybe it's what she says 46 it is. These reports name individuals who would likely be subjected to harassment if 47 publicly identified. You know, the way the Senator's who supported Kavanaugh had their 48 personal home addresses made public so protestors could mass at their personal 49 residence and harass them. And in these situations, even if you redact the names, 50 information given in the report could be used to identify people. It's better to have a 51 summation of the report made public. Something like, no one corroborated Mrs. Ford's 52 story, or no evidence was found to corroborate her story, which is the sum of it.
- 53 But here is a little something that I picked up lately. I might have missed it earlier; I don't 54 think its something new. But one of the things the FBI ran down was on the question of 55 when and where did this happen.
- 56 Ford tells us she can't remember; none of the witnesses she named remember anything 57 like what she described happened at any of the gatherings or parties they participated in.
- 58 So, Kavanaugh steps up and openly declares that any gathering he attended would have59 been noted on his calendar. Really?
- 60 I'm afraid I did not keep a calendar when I was in High School did you? I was invited
- 61 once to join a class of super smart students total Geeks! Of course, I was rocking out 62 with my band and pursuing another course in life — but I do remember being impressed
- with my band and pursuing another course in life but I do remember being impressed
  with how some of these kids were so into documenting everything journaling, diaries,
  calendars so, okay, I can get my head around the idea of a *high-schooler* assiduously
  notating every gathering he attended on a calendar.
- Anyway, Kavanaugh says any event he participated in would be on his calendar. So they
  pull out his 1982 calendar and find a gathering, a party, or whatever, noted for July 1,
  1982. That's the only gathering that even gets close to Ford's testimony the summer of
  82.
- So they investigate that and check in on the attendees of that party, and none of them corroborate anything remotely answering to Ford's testimony. Ford's attorneys react to this by saying, effectively, well, if they had talked to Ford she would have told them that was not the gathering in question because she can remember which gathering it wasn't but she can't remember which gathering it was. She remembers the people who are listed

75 as attendees to that gathering and could have told the FBI that this was not the party she 76 was talking about.

77 Do you remember me saying Ford's testimony was carefully crafted to avoid this — she 78 purposely crafted her story in a way that would ensure it was unverifiable? Remember, I 79 said she purposely avoided naming any specific date or place because she knew this is 80 what would happen. I'll bet she resisted efforts on the part of her attorneys to get her to at 81 least narrow it down to a year and a season of the year — you do remember she could not 82 remember the year, or even the season of the year — but under pressure she finally coped 83 to the summer of 1982. Well, that gave Kavanaugh what he needed. At least he could look 84 back on a certain summer of a certain years. And in his case, he could go to his calendar

- 85 and show what events he participated in that summer. This gave the investigators a target.
- 86 They ran it down and found — NOTHING corroborating even one scintilla of Ford's 87 accusation.
- 88 So now you have enhanced credibility for Kavanaugh and further erosion of Ford's 89 credibility.
- 90 What do you think of the strategy to protect Ford? I get it! It's all about the optics — 91 which is the reason Ford's handlers insisted she present her testimony in an open public 92
- hearing.
- 93 Hey, did you know that Ford specifically requested a private hearing, and that her 94 "handlers" did not inform her that the Senate offered to accommodate her? That's right.

95 In fact, did you know that a private meeting is usually how this sort of thing is handled? 96 Privately — in closed session and for the specific purpose of protecting the accuser from 97 public scrutiny of the kind that followed Anita Hill. But her "handlers" wanted it to be 98 public, because they knew they had no case, and the only hope they had to make some 99 case out of it was to stir up a wave of emotional support for the "victim." They created a 100 spectacle that they hoped would overwhelm Kavanaugh and either push him out, or 101 provoke his family to pull him out, or to create so much stink, the "powers that be" -102 McConnell, et al — would simply retreat, if for no other reason only to stop the temper 103 tantrum and avoid getting stink thrown all over themselves.

104 Happily, in this instance at least, that has not worked. First, Kavanaugh surprised them by 105 presenting a very human defense. They expected a Spock like response, cold, aloof, 106 distant from the feelings of the people. You know Kavanaugh is taking heat for how he 107 defended himself against this outrageous effrones to decency and order perpetrated on 108 him by the wicked and unreasonable Demoncrats (effrones, latin base for our word 109 effrontery).

110 The Demoncrat leaders these days are wicked and unreasonble and no one who cares 111 about decency and order should ever vote Democrat again; well, at least not until they 112 clean up their act, decide to love America as founded again, and start caring about 113 righteous—reason! Anyway...

114 Remember John Paul Stevens? Not many hands out there. Stevens was the Supreme 115 Court Justice who retired during Obama's term whose seat on the court he replaced with 116 Kagan. Stevens was nominated to the Supreme Court in 1975 by Gerald Ford, no relation 117 to Christine Ford — hah! He gave Kavanaugh high marks — as did the ABA (American 118 Bar Association), but that was before his testimony regarding Ford's allegations - now 119 he says Kavanaugh is not fit to serve on the court because he was too weepy, emotional, 120 and too aggressive in his testimony, and partisan. Thinks he does not have the 121 temperament.

- 122 What did you make of Kavanaugh's testimony? I'm going to come back to this in the 123 second segment. Let's conclude part one —
- 124 The Senate voted for cloture, which ends debate on the Kavanaugh hearing and advances 125 the motion to a vote as early as Saturday (October 6, 2018). Cloture passed 51-49. Yeah, it 126 was that close. That's with one Republican voting against Kavanaugh, and one Democrat 127 voting for him.
- Murkowski, Republican from Alaska, voted against cloture which suggests she intends
  to vote against his nomination. It does not guarantee it, but that is certainly what the
  Dems hope it means.
- 131 There are two other Republicans the Dems hope to sway their way and they are Jeff132 Flake, of Arizona, and Susan Collins of Maine.
- [Note: I was unaware that Susan Collins was giving her speech at about the time I was
  posting this show. Very pleased with her speech! I expect she will fulfill my expectations
  related in this show and vote yes for confirmation.]
- Both Flake and Collins voted for cloture; but it cannot be presumed this means they will
  vote for confirmation. Flake probably will, but Collins is still waffling. It's hard for some
  of these people to stand strong in the political winds stirred up by the likes of blowhards
  like Schumer and his political apparatchiks. (The socialists in the modern Democrat party
  that serve as political hit men in elections to take out opponents.)
- 141 The one, and I mean the lone Democratic who voted for cloture is Senator Joe Manchin 142 of West Virginia. He is one among the three Dems that broke ranks from their party and 143 voted to confirm Gorsuch. But, we don't know how he will vote on Saturday.
- 144 (You know that I prepare and produce the show on Friday for the weekend.
  145 Consequently, while my podcast audience will get this tonight, my radio audience will not
  146 hear the show until after the vote assuming they complete the vote before noon
  147 Saturday Pacific Standard Time, that would be before 3 pm EST.)
- 148 This confirmation is not totally "in the bag." It's actually a bit more precarious than you might think.
- 150 If it goes straight down party lines, Kavanaugh will be confirmed with out the need for 151 Pence to step in and break a tie.

152 That is, in other words, if all other votes go the way the cloture vote went, with one 153 Republican, Murkowski, voting nay, and one Democrat, Manchin, voting yea.

154 However, if Manchin flips — if Schumer is able to bring sufficient pressure on him to 155 press him back into ranks — and Murkowski stubbornly holds her irrational, and 156 politically speaking suicidal position, and votes nay, we will be at a tie and Pence will 157 come in and save the Kavanaugh nomination.

- 158 But what about Collins? I think Jeff Flake reasonably can be expected to vote for 159 confirmation. But Susan Collin's is a democratic hopeful, and many think her support for 160 Kavanaugh is debatable. She has been targeted as a possible vote for the Dems effort to 161 stop Kavanaugh (or, really, any future pick by Trump). Did you know that a Democratic 162 has pledged to give her campaign over one million dollars if she will vote against 163 confirmation of Kavanaugh? While this is going on, another Democratic group has 164 pledged to give over 1 million dollars to her opponent in her next election. Because 165 Democratics believe elections are bought, they have already counted Collins out. Her 166 political career is over, as far as they are concerned, but, according to the Left, maybe she 167 can rescue it by voting with the Democratics? However, get into Maine politics, and you 168 will notice that it appears these efforts are backfiring on the Dems. Maineaics are pushing 169 back — let's pray Collins sees the good guys have her back and does the RIGHT THING 170 and votes to confirm Kavanaugh.
- 171 Okay, my friends. I'll finish this up on the other side of the break. I'll be right back!
- 172 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor at the Lighthouse, 173 your brain masseur, and Paul Revere's lantern lighter, lighting the lamps in the church 174 belfry arch, signaling the enemy is on the march, an enemy that would steal from us our 175 liberty.
- 176 The Senate is scheduled to vote on the Kavanaugh confirmation Saturday, October 6. 177 Most of my audience will hear this show Friday night, or early enough Saturday am to get 178 it before the vote. My radio audience will most likely hear this show after the vote. So I'm
- 179 going to make my prediction—Kavanaugh gets confirmed.
- 180 But it's not a sure thing. I don't have my fingers crossed, but I am praying.
- 181 Most likely it will come down to this.
- 182 Murkowski, R Alaska — she voted against cloture, but will she come to her senses and 183 decide to vote for confirmation after all?
- 184 Manchin, D. W. Virginia — he voted for cloture, but will he follow-through and vote for 185 confirmation also?
- 186 Susan Collins, Republican, Maine — she voted for cloture, but she is under enormous 187
- pressure to vote no to confirmation it looks good right now, because the Demoncrat's 188 strategy to "buy" her vote seems to be backfiring on them. This is good news! It needs to
- 189 backfire on them, this entire charade on the left must be rebuked, they must not be given
- 190
- their way on this they must be defeated. This EVIL must be resisted and reproved: first,
- 191 by confirmation of Kavanaugh, and second, by a red tsunami in November.

- Personally, I think Collins has the character to stand up to the bullies in her state, and Ithink she will vote to confirm.
- 194 Murkowski, frankly, I don't know what to think about her. I can tell you that it was a

195 mistake for the GOP to get behind her in Alaska — they had a much better candidate in

- 196 Joe Miller but that's old news. Anyway, Murkowski cannot be trusted to vote with
- 197 righteous reason we'll see. We can hope —
- Anyway, it comes down to this, I think. The vote to confirm will go along the lines of thevote for cloture.
- 200 If Manchin flips on us, Pence will come in and Kavanaugh will be confirmed.
- 201 That's how I call it.
- Hey, Democrats, YOU'VE GOT TO SEND A MESSAGE TO YOUR LEADERS THAT THEY ARE DEBAUCHING YOUR PARTY AND DRAGGING YOU DOWN WITH IT.
- Every Democrat you should form a committee, Democrats for Decency and you should stomp hard on your leadership by showing them they don't own your vote and that you will not tolerate them dragging your party any farther down this road of indecent and disorderly behavior.
- 208 Senator Grassley expressed his concern that the tactics used by the left to derail the 209 Kavanaugh nomination to the Supreme Court amount to mob rule. He is right! Others 210 expressed fears that allowing this scandalous tactic to succeed will encourage more of the 211 same. I agree, of course. But someone should point out that this is happening today 212 because this kind of behavior was rewarded when they pulled this on Bork. And, by the 213 way, it was for the SAME REASON. Bork was a Constitutionalist who was 214 INDEPENDENT of the Democratic Party. I hope Kavanaugh is an as-written-original-215 intent-Constitutionalist. They knew Bork could not be controlled, or bullied. It's not 216 scandal they have on Kavanaugh that bothers them; it's exactly the opposite it; it's the lack 217 of scandal. He has given them no handles they can use to control him. When we allowed 218 them (by them I mean the wicked and unreasonable) to enter the term borked into our 219 vernacular, we started down this road. We should never have allowed them to win on the 220 Bork nomination.
- Then it escalated with Thomas; the Democrats went to new lows, vicious, despicable; as
  Thomas himself said, it was an effort by the Dems to conduct a "high tech lynching."
  Well, now it's completely off the rails. Give the devil an inch...
- It must stop here! There is no way we can allow this kind of behavior to go unpunished, this indecent and disorderly behavior of these *wicked* and *unreasonable* politicians must be rebuked — Kavanaugh must be confirmed, and everybody with sense must vote red this November.
- A statement must be made, and the only opportunity we have to really be heard without the filter of the *wicked* and *unreasonable* socialists in the so-called main-streammedia, without these yahoos conducting polls they carefully word and target to get the result they are looking for so they can create the illusion that most Americans agree with

- their nonsense but it's like Abe Lincoln told us years ago you can fool all of the
- people some of the time, and some of the people all of the time, but you cannot fool all
- the people all the time. And I pray the Left's time is up. They have a gaggle of foolish
- people that will believe whatever they say all the time, and it's larger than it should be.
- But most Americans are not buying their nonsense. Many want to be nice, and go along with some of this foolishness because it sounds nice or friendly or kind to them — but now the left has ripped off their mask and the vicious, hateful, face of the left is being exposed.
- Do I need to cite the examples? You have seen them with your own eyes. You have heard it with your own ears. Now, do something about it.
- 242 We must stop these *wicked* and *unreasonable* people.
- Paul exhorted the believers in his day to pray he would be delivered from *wicked* and *unreasonable* men (II Thessalonians 3:2).
- The word *wicked* is constructed from a word that means hurtful, calamitous, vicious; it speaks of those who act in malice and whose mischief brings evil (God's ordained correction against sin) into the world.
- 248 It has come to be applied to morally reprehensible people because of the biblical 249 connection between immorality and calamity.
- When morals were defined by biblical standards, we had a whole lot less of everything we despise about our culture today and a whole lot more of what we find honorable and good.
- Now we have come to a place where our culture is shaped mostly by a militantly anti-Bible attitude. Well, let just say, how is that working out for you? By any measurement you want to use, our children are far more vulnerable to calamity today than they were back in the despised fifties.
- The *wicked* are those who promote the immorality that is bringing all this evil upon us; and, ironically, the same people who promote an anti-biblical moral code for our culture are the ones who use some of the evils that come into our culture as a consequence to destroy the lives of others — Kavanaugh did not commit the crime alleged against him. Anyone from your past could decide to tell a story about you without any evidence at all and if certain political people had a reason to, they would use it to ruin your life. This is wicked.
- I'm coming up on my conclusion here, but think about this. The *wicked* include all those who promote immorality in our culture, behavior that brings calamity into our lives. The word *wicked* also is rooted in a word that means to twist backwards, or to turn around.
- One of the most remarkable traits of the wicked is their penchant to turn evil into good,
  and good into evil. They reverse the divinely ordained order. It shows up in all sorts of
  perverse behavior and backwards thinking.

- And this brings me to the *unreasonable* part. The wicked are unreasonable. They cannot reason straight, because their soul is crooked.
- 272 It's difficult for wicked people to get it.

"Innocent until proven guilty": that's a hard one for them. There is no corroborating
evidence to support Ford's claims — this is ignored. Wicked people are bent; they have
crooked souls and cannot think reasonably. It does not matter that there is no proof, not
even any evidence outside the accusation. In their crooked way of thinking, Kavanaugh is
guilty because he was accused.

- 278 If somehow you prevail to the extent at least that they are forced to concede the 279 reasonableness of your argument, if they accept it, the Truth will work like a hammer to 280 straighten out their crooked soul.
- But what most of the wicked will do is they will attack. They become irascible in directproportion to their irrationality.
- 283 Only the "righteous" can "reason rightly."
- 284 If nothing else, ask yourself if the way the Dems handled this Kavanaugh confirmation is 285 righteous?
- If you think it is you have betrayed the depths of the impact wickedness has had on your reasonableness.
- Look, "innocent until proven guilty" can you hear that? A straight soul immediately perceives the reasonableness of that statement. It's sort of like "all men are created equal..." it's just one of those statements that is true on the face of it and every righteous soul will immediately see the truth of it — but a wicked person will quibble over it, hesitate, and violently reject it if and when conceding to the point interferes with something evil they are trying to do.
- We are, right now, in this country, we are overrun with unreasonable and wicked politicians corrupting every vestige of decency and order remaining in this Republic.
- But we have November our opportunity to make our voice heard. Watch the vote, I
  mean protect the integrity of the vote, and use the vote.
- 298 Every Christian has a responsibility to vote.
- Here in California, we have an opportunity to return this State to sanity Feinstein has
  been exposed Brown is finally going to retire to his family ranch John Cox can get in
  if California's Christians will get out there and vote this November.
- 302 And, hey, let's send those yahoos a message and repeal the Gas Tax too. November is your
- 303 opportunity to be heard.
- We need to take our vote and use it like a weapon to strike at the enemies of our liberties.
- 305 Take a battlefield analogy. One soldier firing his weapon at an oncoming battalion will
- 306 not do much, but if every soldier of Christ will stand up and fire his weapon on
- 307 November 6th, you can make a difference. But some of our soldiers have been neutralized

- by prophecy paralysis it's one of the key points in my message for Sunday night; don't
   miss it: Prophecy Paralysis.
- 310 Okay, need to close. Wanted to weigh in on the war on men, but maybe next time.

Christians, you are salt and light. Jesus warned that if you put that light under a bushel, it would not light the house. He warned if your salt loses its savor, its ability to act as a preservative, it would be cast into the street and trampled by men. That's what has been happening in America. So, let's stop it right now. Apply your salt to the politics of our state and this nation. Send your light into those dark places. One way you can apply salt and extend light into the darkness is by VOTING. You've only got till Monday, October 22 to register to vote. DO IT! If you want some help with that, let us know.

- 318 I have lit the lamps in the Church belfry arch and now you let me know if you see them.
- 319 It's LIGHTS ON if you see the LIGHTS ARE ON and you will ride like Revere and spread
- 320 the warning, (essentially, it means you agree with what I'm saying) or you say LIGHTS
- 321 OFF which means you reject what I'm saying and disagree strongly with me. So, what
- 322 will it be today, lights on, or lights off?
