- 20 Oh, looky here, Ohr has testified and contradicted the Dems story about how the dossier 21 worked its way into the failed conspiracy by Democrats to tamper with a US election to 22 23 get Hillary elected and defeat Trump's presidency. My friend, I sense a brilliant insight forming and it's ready to launch — it's time for your brain massage.

- 25 What do you think? Will Ginsberg retire? According to this article in the Santa Maria 26 Observer — she was set to retire in January.

- 42 just bounced back from pneumonia and yet, she has publically declared her intention
- 43 to stay on the court through Trump's presidency.
- 44 But the rumors persist. And, for good reason! We've all seen the pictures of her napping
- in public, and at 85, well it's not a wonder that many are expecting her to step down.
- 46 The fact is if she becomes so ill she cannot perform her duties, the President can
- 47 nominate a replacement. So far, however, she is able to make it to her office and to the 48 bench when needed —

- 60 Remember when Obama nominated Kagan and Soto to rubberstamp his agenda to 61 "fundamentally transform America" ... The left was ecstatic — "Obama gets another 62 opportunity to put stamp on the court."¹
- 62 opportunity to put stamp on the court.
 63 Obama wanted jurists who would support abortion on demand up to the moment of
 64 birth Obama, who would allow doctors to leave a baby that survived an abortion on
 65 the cold steel tables to die there are no words for how calloused the hearts of these
- the cold steel tables to die there are no words for how calloused the hearts of these people have become. "Can a woman forget her sucking child, that she
- 67 should not have compassion on the son of her womb? yea, they
- 68 may forget, yet will I not forget thee" (Is. 49:15). Ever see a

73 What does the left regard as bigoted and hateful?

74 It comes down to this. They view Christianity as bigoted and hateful. They don't like to 75 say this directly, but that is what they are saying. Jesus Christ is the founder of 76 Christianity and it's based on the teachings of the BIBLE. They have difficulty attacking it 77 directly because there are so many of us still around. Besides, there is a clear statement in 78 our Constitution about the protection of religious belief, but there is no clear statement in 79 the Constitution for a right to murder babies in the wombs of their mothers, or the right 80 to chose your gender, or a right to a livable wage, or a right to compel others to make a 81 cake for your wedding if they object to it, or a ... and you get the idea.

- These "rights" are manufactured by liberals and they have to stretch the language of the Constitution to nearly the breaking point to find some way to concoct legal support for them — they have self-divined rights, yeah, they literally *divine* them from the empty spaces between the words and sentences in the Constitution — but the inalienable rights outlined by the Bill of Rights are different. These are universal, and inalienable, equally applicable and DIVINELY ENDOWED.
- 88 So, they've been working hard over the last several decades to erode our inalienable rights 89 and replace them with a set of human rights that are irrationally contrived, contrary to 90 nature and nature's GOD - I mean, not only do they resist the idea of inalienable rights 91 endowed to us by our Creator, many won't even agree that there are natural rights that 92 are inherent to human nature — that the physical fact of the presence of life is itself the 93 basis for an inherent natural right to life. The reason they can't even admit this much is 94 that then they can't murder babies in the wombs of their mothers. Please hear me. This 95 crowd needs death to advance their agenda. It's the tool Socialists have always used to 96 convert an entire nation to Communism/Socialism - call it what you want - those 97 systems where government becomes God.
- 98 Beto ORoark doubts the Constitution is useful to serve as a managing tool for our 99 government going forward — you want this guy messing with your Constitution? Ocacio 100 is chastising "moderate" Dems because they are not pushing the socialist agenda 101 aggressively enough for her — our Governor wants taxpayers in near bankrupt CA to pay 102 for universal health care including all the fugitive illegals hiding from the Law in our 103 Sanctuary state — Becky, Zach and I this week enjoyed the company of David Basket, 104 Airport Board, world traveler, and one of Santa Maria's beloved sons — spends lots of 105 time in Russia — he passed on to us what an ex KGB officer told him after the wall came 106 down. 112 they are not LGBTQ or any other of the 70 different genders invented by the wicked 113 imaginations of people whose natural sense has been distorted by toxic-liberalism.

114 Very earnestly, Cuomo explained, with a pained expression, how tragic it is that the 115 Second Lady of the US would work for such an organization and that the President would 116 condone this and not speak out against it. In his monologue, he paused a moment to 117 rebuke any who would make the issue about freedom of religion — because, as he 118 explained, he too is a man of faith (Really? Maybe he attends church with Chelsea — who 119 recently explained that her Christianity informs her that abortion must remain legal) -120 but Cuomo tells us he would be inclined to defer to FAITH because he too is a Christian 121 — so don't try to accuse him of having a bias against Christianity. He explained ...

- 122 The problem with Mrs. Pence working at this Christian school is that it has policies of exclusion.
- 124 He thinks a real Christian ought to be inclusive, not and exclusionary. He points out that
- 125 this Christian school's policies make some people feel they don't belong, these policies
- 126 cause angst, and anxiety among people who are LGBTQ and he went on in this vein.
- But I've got to take a break I'll pick it up right here when I get back. Hold on! [Trail off:
 Karen Pence a bigot because she ...]
- Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor at the Lighthouse,
 your brain masseur, and Paul Revere's lantern lighter, lighting the lamps in the church
 belfry arch, signaling the enemy is on the march, an enemy that would steal from us our
 liberty.
- 133 CNN's Chris Cuomo's explained why, as a Christian, he objects to our Second Lady 134 working for a Christian school that requires employees to sign a paper that expressly 135 forbids anyone to work on their staff who is LGBTQ. He wants us to know his objection 136 is not against Christianity, or faith, and he scolded any who would attempt to say he is 137 saying Christianity is bigoted — that in fact he is a Christian, and he went on with a 138 pained expression to say however it is in his opinion tragic that the Second Lady of the US 139 would work for such an organization and that the President would condone this and not 140 speak out against it. His power statement was "what we ignore we empower." So, Trump, 141 ignoring the fact that his Vice President's wife works for a Christian school that in his 142 mind discriminates against LGBTQ people is empowering bigotry.
- His problem with Mrs. Pence working at this Christian school is that it has exclusionarypolicies.
- 145 I think it is safe to say he thinks a real Christian ought to be inclusive, not and exclusionary.
- 147 He pointed out that this Christian school's policies forbidding LGBTQ from employment
- 148 make those people feel they don't belong; these policies cause angst, and anxiety among
- 149 people who are non-binary in their gender identification. And he went on in this vein.
- Now, here is the problem with this. He says he is not calling Christianity bigoted but he believes it is bigoted for a Christian school to have such exclusionary policies. For this

reason, the Second Lady of the US ought not to participate in such an organization, and that for Trump to say nothing, to ignore this, is to empower this bigotry in our culture.

154 I will avoid the temptation to go off on Cuomo and Lemon, both of CNN, about their 155 rank hypocrisy — the fact that here they sit scornfully accusing Trump of ignoring what 156 they consider to be a questionable association of the Vice President's wife, when they have 157 for years IGNORED the questionable association of the Left with Louis Farrakhan — and 158 so many on the left who have praised Pol Pot, or Ho Chi Minh, people on the left who 159 praised Stalin — it's enough to make your head explode — however, I actually 160 appreciated the tone they struck, and the reasonableness, on the surface anyway, of their 161 point. It deserves an answer. Here it is.

- 162 First, bigotry is simply defined as intolerance of others. It has been reduced to intolerance
- 163 of those who hold opinions offensive to another. It's rooted in a word that was used to 164 castigate the Normans in France — no one knows for certain where it originated — 165 essentially, it refers to someone who is obstinate and closed minded in his opinions.
- By this definition, Cuomo and Lemon are both bigots, because they are so convinced of the rightness of their own opinions, for example, on the matter of LGBTQ rights, and so forth, that they have little or no tolerance for those who disagree with them.
- 169 The fact is the word *bigot* actually does not apply to someone who has strong opinions. It applies to someone who is closed minded to the opinions of others not that he or she has strong and decided convictions about certain things. The fact is a bigot denies your right to disagree. And who is doing that these days global warming, homosexuality, need I go on?
- Bigotry is not about having firm opinions that form into convictions about the truthfulness or untruthfulness of some position that others take. That would be absurd!
 Anyone with a decided opinion about anything would be a bigot. However, many think this way about bigotry, especially the left, who throw this word around carelessly, often irrationally, and ignorantly.
- Bigotry is not even about intolerance so long as what you mean by intolerance is that
 you refuse to entertain certain points of view so long as by refusing to tolerate you
 refuse to cede any credibility to certain viewpoints. For example, no one with sense would
 argue that Hitler's use of the gas chambers was an interesting opinion but one with which
 they do not subscribe. No! We say, NEVER AGAIN! We unequivocally condemn it, in
 much the same way Lemon and Cuomo want Trump to step up and condemn Mrs. Pence
 working for a Christian ministry with "bigoted" policies. Right?
- However, if by intolerance you mean to say you refuse to allow others to disagree, you
 refuse to recognize the right of others to have another opinion let's go another step —
 you FORCE PEOPLE TO ACCEPT YOUR OPINION, you ATTEMPT TO CONTROL
 THE OPINIONS OF OTHERS, YOU ATTEMPT TO USE LAW TO ENFORCE A
 CERTAIN POINT OF VIEW UPON OTHERS, YOU DEPRIVE PEOPLE OF THEIR
 FUNDAMENTAL AND INALIENABLE RIGHTS IN ORDER TO IMPOSE YOUR
 POINT OF VIEW ON OTHERS that is textbook BIGOTRY. In other words, you force

I don't believe homosexuals have the right to force others to accept their lifestyle, and that does not make me a bigot. I don't believe homosexuals have the right to demand that we hire them to work in our church ministries, or any other church ministry. I don't believe homosexuals have the right to control what I say about homosexuality and me speaking against homosexuality does not make me a bigot anymore than Cuomo and Lemon are bigots for calling us bigots.

- 201 Furthermore, I don't have the right to require homosexuals to hire me to work in one of 202 their bath houses — I don't think I have a right to insist the Metropolitan Church must 203 hire people to work in their ministry who are public about their disavowal of the 204 homosexual lifestyle, or who preach that homosexuality, like adultery, fornication, 205 bestiality, pedophilia, and so on are sins — no one can work in our ministries who lives in 206 fornication, or lives in adultery, or lives in homosexuality, or bestiality, you get the idea. 207 Discrimination is not an opinion it's an action that violates someone's fundamental 208 rights. No one who denies the faith of a Christian school has an inalienable right to work 209 for that school.
- I don't think I have the right to control what homosexuals say about me, or about my lifestyle, or about my beliefs. These are universal rights No one exercising his or her natural rights will ever encroach on the rights of another because inalienable natural rights are universal and they never cancel out one another. When someone claims a right that requires someone else to give up their inalienable rights, they are not asserting a fundamental, genuine right they are asserting a special right special rights always, I said, ALWAYS displace natural, or universal rights.
- 217 This is why the assertion of a special set of rights to protect homosexuals necessarily 218 displaces and finally leads to the abrogation of all sorts of universal rights of others — 219 rights of free association, rights of freedom of thought, freedom of speech —
- A Christian's right to form alliances with persons of like mind and faith that happens to exclude people who are not like minded, or who reject our faith is not discrimination, or bigotry. It's the exercise of our fundamental rights as endowed to us by GOD and recognized by our Constitution.
- Now, here is the problem with Cuomo and Lemon, et al. They think excluding someone
 from any society is bigotry that is, excluding anyone other than CHRISTIANS.
 Christians who think like us are excluded from certain company very regularly. In the
 opinion of Feinstein, biblical Christians ought to be excluded from public office they
 ought not to be allowed to sit on the Bench of the Supreme Court.
- At present, liberals know it goes too far to say to the American people Christianity is
 verboten, Christians are unwelcome, Christianity is bad because it practices bigotry –
 but in fact that is what they are saying.
- Okay, Mr. Cuomo, you have said you are a Christian. What does that mean? You areaware that Christianity is based on the testimony of the Prophets and Apostles who wrote

the BIBLE. The position of the Christian school Mrs. Pence works for is entirely supportable by the BIBLE that is the foundation of Christianity. So, what informs your morals? If it is not the Bible — then what sort of Christianity do you practice?

Jesus was exclusionary — He said, "I am the way, the truth, and the life. No man cometh
unto the Father but by me." Will you call Jesus a bigot? If you reject His assertion, if you
say it's exclusionary to speak that way, you are rejecting the FOUNDER of what you say is
your FAITH.

- 241 You see, the fact is, Christians like Cuomo have invented an entirely different religion 242 that they call Christianity — and that's not a bigoted statement, that's a fact. If you reject 243 Jesus' own exclusivity statement, and reject all that the Bible says on the subject of 244 homosexuality, or other sexual errors — well, you certainly have the right to believe 245 whatever you believe — and I can't stop you from calling it whatever you want to call it — 246 but I think everyone knows that Christianity, as a religion, is derived from its founder 247 JESUS CHRIST, and we agree that the BIBLE is the CHRISTIAN guide book for living — 248 and it can be shown that in fact God condemns various sexual sins, including, but no 249 limited to homosexuality, and so the Christian school is merely practicing their religious 250 faith. They are not violating anyone's personal rights — unless you believe people have a 251 "right" to not be offended, or that no one has the right to do anything that makes 252 someone else uncomfortable — which is patently absurd — because you see real BIGOTS 253 always get disturbed, and many turn violent, when others do or say things they don't 254 agree with. You saw the pro-choice bigot that kicked a pro-life protester, and heard about 255 the trucker that jumped from his truck and punched a pro-life worker in the face — that's 256 bigotry.
- 257 Is it appropriate to brand people as bigots simply because they disagree with you?

Anyway, Lemon and Cuomo are bigots by their own definition, but not by mine. However, it is concerning that the Christianity I believe in is, in the opinion of many on the left today, bigoted. When Cuomo makes statements like he did on this subject, it causes me anxiety, and generates angst in my soul. Haha! (I'm teasing, but there is cause for concern: some lefties are turning violent.)

- 263 Really! The left knows how to play dirty. For example, no Republican would ever pull 264 what Pelosi is trying to pull right now: trying to postpone the State of the Union Address, 265 pretending security is compromised by the partial government shut down. Those 266 responsible for security have stepped forward and contradicted Pelosi, but, no matter! 267 Ted Cruz has an insightful take on why Pelosi does not want Trump to give the State Of 268 The Union address from the floor of the lower house. She knows her position on the shut 269 down is irrational and unsupportable and does not want to give Trump such a large 270 platform to speak directly to the American people. You see; the Dems a short time back 271 voted to fund building a 350-mile wall on our border with Mexico. Now they have shut 272 down the government because they refuse to fund the building of 234 miles of wall on our 273 border with Mexico. How do you explain that?
- I addressed this last week irrational arguments and behavior masks the real rational underlying their behavior. Trump will force the DEMS to admit the reason they have shut

276 down the government is because they don't like Trump, and they don't want him to win. 277 That's why 800k federal employees are not getting their checks right now. The Dems 278 won't do what they already agreed to do and the only reason is they are throwing a fit that 279 Trump won and Hillary lost. Actually, it gets deeper, and darker: the real rational for their 280 position on the borders gets tangled up in the muck of the swamp — if the truth gets out 281 about the connection some of these low life swamp creatures have with the anti-borders 282 crowd, the one-worlders, those whose agenda is to destroy all national boundaries, and 283 the low life scumbags that have an interest in protecting the flow of drugs across our 284 borders, and those who see this as a way to position themselves as champions of the 285 "illegal" vote — it's stuff like that — swamp scum.

 Saved? We've used that word twice, what are we saved from? Saved from the judgment that is coming upon this world when Jesus returns. All have sinned violated God's laws and He will not allow SIN into Heaven; look what it has done here. No one who dies in their sin can go to heaven.
- So, there is only ONE PORT OF ENTRY into HEAVEN and that is JESUS CHRIST. He
 made the door available to us because He paid for our sins. The wages of sin is death, and
 He died to cover our sins, and not ours only, but the sins of the whole world and that is
 why you can come to this door and knock and petition Him to forgive your sins and save

- 319 All.
- 320 I warn you that if you attempt to get in any other way, you will be refused admittance.321 And the only alternative is Hell and that's a whole lot more miserable than Honduras.
- 322 I have lit the lamps in the Church belfry arch and now you let me know if you see them.
- 323 It's LIGHTS ON if you see the LIGHTS ARE ON and you will ride like Revere and spread
- 324 the warning, (essentially, it means you agree with what I'm saying) or you say LIGHTS
- 325 OFF -- which means you reject what I'm saying and disagree strongly with me. So, what
- will it be today, lights on, or lights off?
