1 Segment.01 Hello. I'm Dr. Jerry Scheidbach, pastor of the Lighthouse Baptist Church in
2 Santa Maria, CA—and your brain masseur—get ready for your brain massage.

3 NO COLLUSION, NO OBSTRUCTION — HA. This has been nothing but collusion and
4 obstruction of justice from the beginning — only it's Obama/Hillary doing both the
5 colluding and obstructing of justice. Let's look at the Mueller report, and address the
6 question, should the full text of the report be made public, or at least released to the
7 Congress.

8 Trump recognizes Israeli sovereignty over Golan Heights. WOW! That has ticked off
9 Iran's *Imama* Rouhani — and Russia, and China don't like it either.

10 Trump tells Russia to "get outa Dodge" —
11 The Green New Deal went down in flames — not one Democrat voted for it.

12 I'm looking at my document file and it is literally loaded with information related to the
13 first two topics — I think I'll focus on the Mueller report and Trump's recognition of
14 Israeli sovereignty over the Golan Heights — in the first segment, then continue work on
15 debunking the TRUMP IS A RACIST claim in the second segment — okay, here we go

16 It's time for your Brain Massage.

17 [TRUTH]

18 NO COLLUSION! NO OBSTRUCTION! — friend, this whole thing was collusion and
19 obstruction perpetrated by the LEFT from the beginning to divert attention away from
20 Obama and Hillary's efforts to, first, recruit Ukraine to interfere in our elections on her
21 behalf, and second, conspire together to undermine Trump's campaign, and then third,
22 collusion within the Deep State — aka the SWAMP — to perpetrate a political coup
23 against President Trump and undermine his presidency which involved manufacturing
24 evidence (can anyone say "Russian Dossier"?) This was total collusion within the DNC to
25 affect a coupe against President Trump, and a conspiracy to cover up their use of a phony
26 dossier, paid for by the DNC, to illegally secure FISA warrants to tap Trump Tower and
27 this is so far past Watergate it's unreal. It's time for the wheels of justice to roll over
28 Obama, Hillary, and all the rest of them.

29 We should listen to Lindsey Graham and call for a full investigation into the investigators
30 — you betcha!

31 Rand Paul trumped up his demand for an investigation "into former Obama officials who
32 'concocted' the anti-Trump Russia scandal" — Rand pointed out that now we know that

33 Obama's CIA director, John Brennan, was "the key figure who legitimized the charges and
34 [the] discredited 'dossier' against the President."¹

35 Rand Paul Tweeted: "Time for Congress to investigate. What did President Obama know
36 and when? How did this hoax go on for so long ...?"² Brennan has denied involvement in
37 including the report, but two other top intelligence officials said he did. This is very bad
38 news for Obama — it has become clear that the Obama administration obtained FISA
39 warrants to spy on private American citizens using phony opposition research paid for by
40 his party — to aid the candidate he endorsed. To INTERFERE with an US ELECTION.

41 Now we get a report from Ukraine that Clinton campaign representatives colluded with a
42 Ukrainian official in a conspiracy to interfere with US elections by assisting Hillary in her
43 campaign against Trump.

44 Anyway! Should Barr release the full Mueller report? Why not? I would have to know
45 more about why the full report would not be released to the public before I could answer
46 that definitively.

47 Usually, this sort of thing is done to protect innocent people from being dragged into the
48 crosshairs of the Trump haters shooting at anything that resembles a Trump supporter.

49 Mueller has destroyed enough lives already in his effort to manipulate someone, anyone,
50 to make false statements he could use to indict Trump, or call for impeachment — he
51 failed.

52 So, maybe that's why Barr does not want to release the full report. Federal rules require
53 the AG to redact such reports for public distribution to protect persons named but
54 cleared, and to protect witnesses.

55 But here is what you need to remember to tell your liberal friends when they start crying
56 "cover up."

57 First, the bottom line here is that Mueller's own "summary" conclusion is NO
58 COLLUSION, and NO *DECISION ON OBSTRUCTION*. That's right. Mueller did not
59 unequivocally state there was no basis for an obstruction charge — he left that
60 UNDECIDED. Let's look at this. Because you KNOW, I mean, hey, you KNOW if he had
61 anything like proof of obstruction, he would have gone for it with everything he has. So
62 what's with this UNDECIDED crawfish move?

63 First, that is your clue that the contents of Mueller's report finds NO EVIDENCE OF
64 COLLUSION whatsoever, but that Mueller has done his best to construct a case for
65 OBSTRUCTION —

66 And as you know, Mueller was actually focused more on that, as you saw in his later
67 "indictments" — he tried his best to make the firing of Phony Comey an act of obstruction
68 by the President, and tried his best to find some way to make his Tweets and statements

69 out to be efforts to obstruct, hoping to find someone he talked to in connection with the
70 Tweet that would testify it was his intention to interfere with the investigation; he tried
71 everything he could to find someone who would provide/create evidence that Trump was
72 directly involved in some way tampering with evidence, or with witnesses, and so forth —
73 so my guess is if you read the entire report, it will show Mueller desperately building a
74 case for his suspicion with loaded representations of what amounts to circumstantial
75 evidence, but never able to find the smoking gun evidence he needed to substantiate it, or
76 make it actionable.

77 Which is very unlike the evidence we have on Hillary in her obstruction of justice
78 regarding email-gate and her collusion with Russia in the matter of Uranium One — and
79 her money laundering operation through the Clinton Foundation, and, and, and —

80 So, keep in mind that Mueller could not make his case. That's the bottom line here.

81 The Trump haters will continue on in their denials of reality — they are very adept at
82 creating a fake narrative and so thoroughly immersing themselves into it that it becomes
83 their "virtual—reality."

84 So, don't expect this revelation to change anything there. It's that 9% to 10% in between
85 the Trump haters and Trump supporters that are in play here. And, thus far, it appears
86 they are willing to accept the facts as they are in the real world.

87 The most important FACT coming out of this report is that at the end of the day, Mueller
88 punted — and missed the goal.

89 He failed to MAKE the POINT — he did not recommend action on his report because,
90 well, first, as Mueller specifically said, there is no evidence of collusion — but on the
91 matter of obstruction, Mueller knew all his "evidence" was circumstantial and subject to
92 interpretation —. But, these people are not dumb.

93 Mueller knew he could not establish guilt, SO HE WENT WITH ESTABLISHING
94 SUSPICION INSTEAD.

95 These people are wicked — if they can't find or create evidence to get you, they plant evil
96 suspicions and promote them incessantly.

97 In other words, it's politics as usual, and that is what this was about from the beginning—
98 as we know from Stryck, and Page, et al — they colluded together in a conspiracy to
99 undermine Trump's campaign, and when that failed, to drive him out of office in any way
100 they could find. And Mueller is one of them. And he has set it up to allow this issue to
101 continue to be a POLITICAL attack on Trump —. If we can't undermine him with facts,
102 let's do it with suspicion.

103 Let's pray that it backfires on them.

104 Okay, that's Mueller. Second, those who have access to the full report, namely, Barr and
105 Rosenstein, see no collusion, they see no obstruction, and actually nothing has been said
106 about refusing to release the full report. Barr has only refused to commit to do so. You
107 know that Rosenstein is not a friend to Trump. You don't remember the reports that

108 surfaced about Rosenstein secretly recording Trump and discussing invoking the 25th
109 amendment to have him removed from Office?³ You don't remember how he slow-
110 walked responses to the requests from Nunez for information pertaining to the Mueller
111 investigation? Freedom Caucus members threatened to file articles of
112 impeachment against him. At one point, Trump seriously thought
113 about firing him.

114 The DEMS might dismiss Barr as someone in Trump's corner
115 because he made statements about his opinion that, first, he
116 questioned whether the Justice Department could charge a sitting
117 President, and two, he argued that Mueller had no business
118 questioning Trump about obstruction when he had not yet proved
119 collusion. That's justice, by the way; that's justice the way it usually
120 looks in America. You don't go after someone for, say, collusion,
121 and then snare them up an obstruction charge when they object to
122 being investigated for something they claim the DID NOT DO!
123 Barr said, to Mueller, prove your collusion, then you will have a
124 basis to go after obstruction. So — liberals are having trouble here,
125 because Rosenstein has no record of being a Trump devotee. He
126 saw the entire report, and he agreed with Barr — NO
127 COLLUSION, NO OBSTRUCTION.

128 Anyway, the question is should Barr release the full report, and the Grand Jury material
129 used to indict Russian operatives, all of it, to the Congress? We'll see. Federal rules require
130 the AG to redact such reports for public distribution to protect persons named but
131 cleared, and to protect witnesses. And, as I said, Mueller has ruined enough lives already
132 in his witch hunt, and flushed out a few stinky swamp creatures along the way — too —
133 where he hoped to get some real help but couldn't even get help from fellow deep swamp
134 dwellers — amazing! God had to have graciously intervened here.

135 So, personally, I'm for transparency in this stuff, I mean short of needlessly ruining any
136 more lives, but I think a minimally redacted version should be provided to the Congress,
137 who will then decide how much should be made public.

138 And, you know what, I'm need to go to break — sometimes I wish I had more time for the
139 show. I want to address Trump's acknowledgement of Israel's right to annex Golan
140 Heights, then touch on a few more of the ridiculous reasons Liberals think Trump is a
141 racist. Wow! That's about as laughable as Trump colluded with Russia —

142 I'll be right back!

143 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor at the Lighthouse,
144 your brain masseur, and Paul Revere's lantern lighter, lighting the lamps in the church
145 belfry arch, signaling the enemy is on the march, an enemy that would steal from us our
146 liberty.

147 Trump recognizes Israeli sovereignty over Golan Heights. WOW! That is so huge!
148 Another one of those things one American President after another agreed with and said
149 they would support, and officially recognize — but when it came right down to it, they
150 crawfished away from the issue. Congratulations, President Trump, for just doing what is
151 RIGHT — who was the Navy Captain who said, "damn the torpedoes, full steam ahead"?
152 During the Civil War — who was it? Here it is, David Farragut — yeah, David full of guts
153 — that's our President.

154 Well, he has ticked off Iran. Iran's Rohani — in a statement responding to Trump's
155 action, Rohani called on Iran to "resist, and that way gain victory." In Islamo-speech,
156 *resist* is a call for violence. Another way Islamofascists and modern day Democrats are the
157 same — notice how the Democrat's *resistance* repeatedly breaks out into violence here?

158 Russia chimes in: Trump is acting in direct opposition to the UN Security Council. Russia
159 goes into total diplo-speak — Don't rock the boat, don't do or say things that will polarize
160 the situation between Israel and her Arab neighbors.

161 This is nonsense. It's already polarized — all Trump is doing is recognizing what is
162 RIGHT and JUST.

163 Israel was attacked by Syria, she responded in SELF DEFENSE and WON. An aggressor
164 should not LOSE something after an unprovoked and evil act of aggression? Sorry! It
165 does not work that way. Good for you Israel. It's obvious that the Golan Heights is critical
166 to the security of Israel. The UNs nonsense about Israel "occupying" Syrian territory is
167 hypocritical — every one of the nations in the UN would have to identify themselves as
168 occupiers of someone's territory — it's the rules of war!

169 China throws their penny into the pot: "A Chinese envoy said Wednesday that the Golan
170 Heights is recognized by the international community as an occupied territory. The UN
171 Security Council has adopted several resolutions that demand Israeli withdrawal from the
172 Golan Heights, which it seized from Syria in 1967, Wu Haitao, the deputy permanent
173 representative of the Chinese mission to the United Nations, told a Security Council
174 meeting on the Golan Heights."

175 Nonsense. Taiwan has a right to assert independence from you, China. You can't have it
176 back!

177 So the bear is stirring — Iran, Russia and China.

178 And this, while plans to build a third Temple are moving along. The Temple Movement
179 started in 1987 and in spite of opposition from secular Jews and religious Jews who have
180 abandoned a literal understanding of the Torah, this movement has been busy preparing
181 for the building of a Third Temple, preparing the tools used in sacrifices, working to

182 produce the needed Red Heifer, sort of like David did when he was told God would not
183 have him build the Temple but that his son would build it — so David turned his
184 attention to preparing all the materials that would be needed; that's what the Temple
185 Movement has been doing. But, things are changing — the generation the will rise to
186 build the Temple are beginning to appear.

187 — I'll speak to this a bit this coming Sunday in my Prophecy Bible Class — but now they
188 have progressed to the place where Israel Minister of Housing And Construction is
189 calling for the replacement of the Al Aqsa Mosque with a Third Temple.⁴ Only about 1.5
190 years ago, December 6, 2017, Trump formally recognized Jerusalem as the capital of Israel
191 — Netanyahu, in a dedicatory speech of the completed American Embassy there,
192 mentioned the Temple significantly three different times. He spoke of Solomon building
193 the Jewish Temple in Jerusalem, of the Temple being rebuilt in the time of Ezra, of the
194 Macabees rededicating it — he did not mention its destruction by Titus in AD 70, but
195 skipped over that and said 2000 years later, soldiers of Israel declared "The Temple
196 Mount Is Ours" — The Prime Minister talking like this, an official in the Israeli
197 government openly calling for the Temple to be built —

198 Trump tells Russia to "get outa Dodge" — well, Venezuela. Yeah, Russia sent 100 troops
199 into Venezuela to support the tyrant Nicolas Maduro — hey, my prophecy class students,
200 think about this — Russia, China, and Iran coming together on another international
201 issue: they back Maduro against U.S.

202 Iraq is recently rumbling about "evicting" American troops from the ancient site of
203 Babylon (plucking the eagle's wings) — and the Russian/Iran plus China connection
204 strengthening — rising?? You know that Iran Venezuela connections go way back —
205 Chavez was cozy with Khameni and with Achmadinijihad —

206 Okay, I've got a few minutes here, let's get back to debunking the so-called "Definitive
207 List" of Trump's racist behavior.

208 We are looking at New York Times article written by David Leonhardt and Ian Prasad
209 Philbrick, in Jan. 2018.

210 We covered the New York Years, the Obsession with Dark-Skinned Immigrants, and
211 Obama as Unqualified, Lazy, and Un-American. And we showed that none of the
212 allegations stipulated support the charge. It's typical LIBERAL CONVICTION BY
213 ACCUSATION — So, let's go to the next section in their DEFINITIVE LIST: Urban
214 America As A Hellscape.

215 "He often casts heavily black American cities as dystopian war zones." Uh — are you even
216 aware of a city called Chicago, or Los Angels? Have you ever heard of Watts or Compton?
217 In 2010 it was ranked as the 8th highest crime rate in the US. Now, these areas have
218 gotten better because of excellent police work — thank God, but hey, the sad, sad, fact is
219 — these areas are blighted, and liberals can blame it on race if they want to, but when they

220 do, they are the ones making it about race! I say it's about liberal policies that trap people
221 in their pigpens. It's a character thing — not a race thing.

222 But the point here is, once again, with the liberals, you can't say the TRUTH. They have
223 blocked the TRUTH from getting into these conversations by immediately crying
224 RACIST when somebody simply observes a FACT. When Trump said, "Our inner cities,
225 African Americans, Hispanics, are living in hell because it's so dangerous. You walk down
226 the street, you get shot" — that is NOT A RACIST STATEMENT — it is the OPPOSITE
227 of RACISM.

228 The liberals might have decided, well, that's just the way those people are — and to talk
229 about it is to be racist — BUT WE SAY, NO, I DON'T ACCEPT THAT. I EXPECT
230 BETTER OF MY FELLOW HUMAN BEINGS, I EXPECT BETTER OF THEM AND
231 FOR THEM. And you are not going to get better FOR anyone until first you start getting
232 better FROM THEM.

233 Those places are not war zones because of the color of anyone's skin — IT'S A
234 BREAKDOWN IN THE CONTENT OF THEIR CHARACTER.

235 But these liberals are the ones who view these problems are related somehow to race. Do
236 you see it? Look! That's what they do. You can't cry against the horrible crime that goes
237 on in these communities without being called a racist? What? How does that work? The
238 only way it could be racist is if you have decided they are in the condition they are in, they
239 are living in the circumstances they live in BECAUSE OF THEIR RACE. But that is
240 wicked, evil, racism.

241 Do you not see that saying these people live in the situation they do because of their race
242 is racism. These communities are overrun by evil deed doers — people, many of them, by
243 the way, acting out on the nonsense pumped into them by their RACIST OVERLORDS
244 who think they "own" their vote — Trump is 100% right on to simply say the TRUTH
245 about these things.

246 Until the liberals wake up and face the TRUTH about this, they will only continue to hold
247 people in bondage to generational poverty.

248 These guys argue that Trump "frequently offers false crime statistics to exaggerate urban
249 crime, including about Oakland, Philadelphia and Ferguson, Mo." So, Trump purposely
250 gets statistics wrong when discussing these things. Happily for Leonhardt and Philbrick,
251 they did not offer any specific statistics as an example. Because, let me tell you, if they did,
252 they would be called out for their hypocrisy. There is almost NO STATISTIC about this
253 sort of thing that is not contradicted by someone somewhere or some later study, or some
254 earlier study — there are so many variables. I've got huge notebooks of statistics collected
255 over years in crime and on and on, and I can show you that historically, statistics vary
256 depending on a thousand variables. The point is, every statistic Trump cited has a source
257 to support it. If a newer study adjusted the stats downward, okay, stipulate that and make
258 the correction — BUT DON'T ASSUME WE ARE SO STUPID YOU CAN JUST SAY
259 TRUMP OFFERS FALSE CRIME STATISTICS — and that he does this in order to
260 EXAGGERATE URBAN CRIME — HEY, THE PEOPLE LIVING THERE KNOW THEY

261 LIVE IN A HELLSCAPE — they don't need statistics to know they are afraid to walk their
262 streets at night, or fear for their children every time they send them off to school.

263 And then, finally, under this heading, Leonhardt and Philbrick allege that Trump is
264 "quick to highlight crimes committed by dark-skinned people, sometimes exaggerating or
265 lying about them" and they offer an example, "such as a claim about growing crime from
266 'radical Islamic terror' in Britain." Again, it's the liberals writing this who are exposing
267 themselves as the racists. Trump was responding to what many of us saw in reports
268 coming out of Britain for a period back when Trump made these comments. There was,
269 in fact, an increasing amount of agitation in Britain coming from the "radical Islamic
270 terror" — so I don't know what these guys are referring to specifically. Conveniently, they
271 did not provide sufficient specificity to actually run this down. But I do remember the
272 comment, not in detail, and I was thinking the same thing at that time about what was
273 going on in Britain — and I'll tell you what happens here. These guys get narrowly
274 focused on some specific details in a situation, like this, and because Trump's statement
275 can be said to be too broad, or to be based on an assumption that is not strictly accurate,
276 they dismiss it in this way. This is a trick teenagers use to lie to their parents or to accuse
277 them of being wrong about their accusations. These people, many of them, are like
278 educated teenagers — it's a trick. You can know when this is happening if, 1. they use
279 their ability to deny the perfect accuracy of a statement as evidence supporting their
280 miraculous ability to know the motives of someone, and 2. they don't specify sufficient
281 detail to show this is what they are doing.

282 I'm going to pick it up from here next time — what's this, he is slow to decry hate crimes
283 committed by whites against dark-skinned people, but quick to point it out the other way
284 around. Right! Okay, as the beloved J. Vernon McGee would say at the end of each of his
285 broadcasts, "until next time, may God richly bless you my beloved."

286 I have lit the lamps in the Church belfry arch and now you let me know if you see them.
287 It's LIGHTS ON if you see the LIGHTS ARE ON and you will ride like Revere and spread
288 the warning, (essentially, it means you agree with what I'm saying) or you say LIGHTS
289 OFF -- which means you reject what I'm saying and disagree strongly with me. So, what
