43 Okay — let's see here.

53 AOC tells us Republicans are injecting border babies because they have brown skin. This
54 kind of reckless, feckless, slander with outrageous lies is nothing new to the Democrats —
55 remember? Republicans want to feed grandma dog food?

56 Cortez, like her namesake, Cortes, is busily burning her ships — blocking any hope of
57 retreat from her insane ideas! Her latest gaff: Republicans are injecting border babies
58 because they have brown skin — something like that! Oh, and don't forget her prophecy
59 that the world will end in 12 years if we don't enslave Americans to Democrats (they are
60 the party of slavery, after all) and turn the entire economy over to Socialists/Communists
61 — because, as everybody knows, no one can fix things like the government can!

62 Allie said, "If we killed criminals on death row using the same methods we use to kill

80 on suspicion of being the Bike Ride Slasher, who took a bike ride through LA streets
81 randomly slashing people in the face with a knife — nine victims. I'm wondering if maybe

83 think? Maybe some old-time religion would do you and your family some good. Maybe
84 you would like to live in a community that shares Christian values in common — I don't

86 Ilhan Omar wants the release of a jailed Muslim Brotherhood leader in Egypt. That's
87 interesting! Bridgitte Gabriel, exposes Muslim Brotherhood plans to destroy US. in a
88 5/22/1991 document prepared by the Muslim Brotherhood. The document speaks of
89 Muslim SETTLEMENTS in US. The plan explains to Muslims that the process of
90 settlement is a civilization jihadist process with all the word means. "The Brothers must
91 understand that their work in America is a kind of grand Jihad in eliminating and

95 The last page lists 29 Muslim organizations in the United States with goal to subvert

99 Put that together with the Jihad training camps operating on US soil and I think you can
100 understand why we cannot put this country back into the hands of people who naively
101 focus on the very numerous peaceful Muslims here and around the world and so turn a
102 blind eye to the real threat of Jihadi Islam.

103 We hear this all the time — the vast majority of Muslims are peaceful people, with no
104 designs on advancing Islam by force of arms, or by terrorism. I think, as a matter of fact,
105 that this is true. There are, after all, well over 1 billion Muslims in the world, and 50
106 Muslim majority countries. About 3.5 million Muslims in America — clearly, not all of
107 these Muslims are radical, Jihad-headed terrorists. Those in the Muslim world estimate
108 something like 15% of the Muslim population are radicals — well, you see, that's a
109 problem; because that means there are at least 150 million radical Islamo fascists in the

127 belfry arch, signaling the enemy is on the march, an enemy that would steal from us our
128 liberty.

129 Did you enjoy President Trump's Easter message? You missed it? Bummer. Those who
130 heard it, want to hear it again? You do! Good. Here is President Trump's Easter message:

131 [INSERT EASTER MESSAGE — 1:20]

132 I hope you will stop by any of our Easter services this year — April 21. Sunday morning
133 I'll present what has become a very popular Easter message — 9:30 AM. I'm putting
134 together a chronology of the resurrection appearances and zeroing in on the first with
135 Mary Magdalene.

136 Sunday morning at 10:45 *Does The Resurrection Of Christ Have Any Political*
137 *Ramifications?* It will totally knock your socks off.

138 And Sunday night — *The Mission Critical Command Of Our Risen King.*

139 Hey, let's work some more on my DEFINITIVE PROOF THAT TRUMP IS NOT A
140 RACIST —

141 You might wonder how people could hate a President who has performed as well as
142 Trump has. The most recent jobless numbers are staggeringly good — we have not seen
143 better employment rates since 1969 — another 170,000 jobs added — people are back to
144 work, and AOC can say it's because everybody has two jobs (which is false, by the way)
145 but, well, let's just put it this way; back in the days of Obama you couldn't find one. Now
146 there are so many jobs, AOC, that "everybody has two"? Fact is, most of the new jobs are
147 living wage opportunities. And then you've got some other achievements that some Dems
148 don't like — moving the embassy to Israel's capital, in Jerusalem, acknowledging Golan
149 Heights as legitimately belonging to Israel. They keep saying he is interfering with the
150 Middle East peace process — what Middle East Peace process?

151 You libs have tried your patty cake with terrorists game for decades and you have gotten
152 exactly nowhere — let's try some common sense solutions — and here is the wisdom of
153 what Trump is doing. He is not pretending that he is going to resolve the tensions
154 between two peoples who have resentment going back millennia — yeah, that's millennia
155 with an m — thousands of years! So he simply focuses on a single issue, and does what is
156 RIGHT about it.

157 The Arab nations, six of them, ganged up on Israel back in 64, and tried to make good on
158 their vow to push Israel off the earth and into the Mediterranean Sea. They failed. In the
159 process of a six-day modern miracle — Israel took the Golan Heights from the Syrians,
160 and held it. Jerusalem, too, by the way; and they have held it too.

161 These are spoils of war — this is what happens when a country attacks another country.
162 Besides, Israel requires the Golan Heights as a strategic defense against further attacks.
163 Hey, Syria, you don't get to attack your neighbor and when you lose your marbles, you
164 don't get to say, hey, give me my marbles back. You LOST! Deal with it! And take the
165 lesson! Don't try it again.

166 So the point is, this thing with the Golan Heights has gone on for decades. One President
167 after another has argued Israel's legitimate claim to the Heights, but equivocated,
168 crawfished, and danced around the issue in the UN — so here is a President who says,
169 nonsense. Syria lost the Golan Heights. Besides that, the leadership in Syria is a jerk — so,
170 forget it. It belongs to Israel — our only real Ally in the entire region. Including Iraq —
171 your welcome to your purple finger, by the way — but even Iraq is not a friend to her
172 friends. So, fine, we back Israel! Period! Done! That's it! Next issue!

173 See what I mean. Liberals just don't understand how refreshing this is. Watch! Clinton, in
174 1992, pledged to support Jerusalem as the capital of Jerusalem; but he reneged. In 1995, a
175 Republican Congress and Senate passed a veto proof law called the Jerusalem Embassy
176 Act. Clinton exercised a clause in the act that allowed him to delay implementation for six
177 months and did this repeatedly throughout his term. During his campaign, G.W. Bush
178 criticized Clinton for this, and promised to implement the law — but reneged on that
179 promise. Even Obama referred to Jerusalem as the capital of Israel — after winning the
180 Democratic nomination, Obama said, "Jerusalem will remain the capital of Israel" — post
181 election, "Well, it depends ..." Trump promised he would recognize Jerusalem as Israel's
182 capital and obey the law passed back in 1995 and have the Embassy moved to Jerusalem.
183 He did it!

184 So, you might wonder why the left hates Trump soooooo much. Well, I mean, beyond the
185 fact that he beat Hillary out of "her turn." One pundit cleverly observed: "We have spent
186 the last two years suffering from the rage of the left because Hillary did not get her turn."
187 Something like that! Anyway ...

188 Aside from that, the only justification they have ever offered for hating Trump sooooo
189 much is that he is a racist. What I'm showing in this examination of that claim is not that,
190 oh, what a surprise, Trump is not a racist — I think that is obvious to anyone with half a
191 brain not smoke bombed with Pot.

192 What I am showing is that there is no argument supporting the claim and that honest
193 liberals know this to be true, that in fact they really don't have a real case proving Trump
194 is racist — that this is something they made up after he announced he would run for
195 President, that they all loved him before that, cozied up to him, took his money, and so
196 forth; but when he decided to run against Hillary, he became Democrat enemy number
197 one — in other words, the reason they hate Trump has nothing to do with him being
198 racist, but is essentially that he beat Hillary — and the reason, and this is important, the
199 reason they hate him for beating Hillary is that he is an outsider, someone that is not
200 controlled by anyone—he is free to act according to what he thinks is best for the country
201 and does not owe anyone who can use him to advance their own political agenda.

202 I do wish he had a more clear understanding of the second amendment — but that's
203 something I'll discuss next week.

204 Okay, let's keep working on the Trump is a Racist myth.

205 I'm using a New York Times article penned by David Leonhardt and Ian Prasad
206 Philbrick, Jan. 15, 2018, titled "Donald Trump's Racism: The Definitive List," and another
207 article published by USA Today penned by Christal Hayes August 14, 2018, titled "Here
208 Are 10 Times President Trump's Comments Have Been Called Racist."

209 The Definitive List article is the one I'm focusing on at present, and we are a little better
210 than half way through it. It's laid out as follows: The New York Years, An Obsession With
211 Dark-Skinned Immigrants, Obama As Unqualified, Lazy and Un-American, Urban
212 America As A Hellscape — that's where we left off.

213 "He is slow to decry hate crimes committed by whites against dark-skinned people, but
214 quick to point it out the other way around." But the fact is each time he addresses any
215 crime, he points out the horror of the crime and not the color of those who committed it.
216 When talking to specific areas where crime is rife and egregious, he, again, speaks to the
217 crime going on — only a racist will assume if he is talking about an area where crime is
218 out of control that he is thinking about race — he is thinking about CRIME —It's a
219 culture problem not a color problem.

220 There is a culture problem where people refuse to cooperate with the police and it does
221 not matter if they are black, white, brown, or whatever. There has to be a willingness to
222 cooperate with the police, no matter what color they are, if you are going to get this under
223 control — and then, included with that, the culture of those communities needs to
224 fundamentally change.

225 The heart of a culture is expressed in its art — if the rappers, and it does not matter if they
226 are black rappers, white rappers, brown rappers — you get the point — if they are singing
227 about raping women, demeaning them, if the music of a culture is calling for cops to be
228 killed, it's obvious there is a sickness in that culture of that community.

229 There is no denying that racists come in every color and the acts of violence perpetrated
230 by a white against a black enrages me exactly as much as when it's the other way around.
231 We've heard Trump denounce white hate — but what some of these people want is for
232 him to pull the Obama thing, and every time a black on white crime occurs, go out of his

233 way to bring up white on black crime — as if that's the point! But there is a huge problem
 234 with this, because THAT'S NOT THE POINT. It's not about white on black, or black on
 235 white — it's about crime! And anyone paying attention to Trump will notice he does not
 236 cast it in terms of race — he speaks to these issues in terms of CRIME. But the racists
 237 always interpret his comments immediately as about race. That's because everything is
 238 about race to these people. And that, my friend, is because they are the racists.

239 Okay, let's move to the next heading in this article: Minorities As Uppity And Ungrateful.

240 "He frequently criticizes prominent African-Americans for being unpatriotic, ungrateful
 241 and disrespectful."

242 Then they provide an example: "He called Puerto Ricans who criticized his
 243 administration's response to Hurricane Maria 'politically motivated ingrates.'"³

244 By now you have had your ears opened. Think about this! He sent massive relief to Puerto
 245 Rico to assist them in the effort to recover from Hurricane Maria. The MSM, of course,
 246 runs into the streets and baits the Puerto Ricans with questions, set to find someone to
 247 criticize Trump — okay, it's what they do!

248 So they play these over here for American consumption — and so you hear Puerto Ricans
 249 dissing the President, or America, or the current Administration — and Trump is so
 250 wonderfully honest in his responses, and so un-political, so UNAWARE OF RACE — by
 251 the way — totally unaware that he is talking about Puerto Ricans — he is reacting to
 252 politically motivated ingrates, which is what they are, the ones interviewed, and so that's
 253 what Trump calls them. It's refreshing! Because it's so honest.

254 You see, for this statement, in that context, to be taken as racist, you'd have to hear
 255 something like, "well, what do you expect from those brown skinned people ..." Now,
 256 THAT would be racist. But this is simply NOT a case of RACISM — it's not RACIST to
 257 respond to what is perceived by someone to be politically motivated ingratitude with a
 258 comment like, they are politically motivated ingrates — do you see it? There is simply
 259 NOTHING racists about that. And now, let's see if you are beginning to totally wake up
 260 to what's going on here on the left.

261 Think it through. The only people who could construe that as a racist statement would be
 262 someone who thinks that calling someone a politically motivated ingrate has something
 263 to do with their race.

264 Okay, we'll continue with this next time, and as promised, when I've gotten through the
 265 DEFINITIVE LIST, I'll create an audio file you can give your liberal friends and challenge
 266 them to prove Trump is racist. Tell them that if they prove Trump is racist you won't vote
 267 for him and then given them the file and challenge them to prove Trump is racist.

268 I have lit the lamps in the Church belfry arch and now you let me know if you see them.
 269 It's LIGHTS ON if you see the LIGHTS ARE ON and you will ride like Revere and spread
 270 the warning, (essentially, it means you agree with what I'm saying) or you say LIGHTS
