- 32 33 So now this group boasts they have 10 million signatures calling for Trump to be impeached. Yeah! They probably got them from the same place Hillary got most of her
- 34 votes — probably from the same place Newsome got his votes here in California — about
- 35 100,000 came in across our border over the last month or so — and you understand what

38 39 Here is an example of how stupid these people are. I'm trying to find any chargeable offenses that would lead to impeachment: here is something from a left wing group called 40 The Action Network — " We have reached this point already - articles of 41 impeachment need to be drawn up against President Donald Trump. And we all know this process would have already started if 42 43 Trump had been successful in firing special prosecutor Mueller, as it's now clear he tried to do in June of 2017 and again in 44 December 2017."¹ You can't impeach a President for exercising his 45 46 powers under the Constitution.

What has become CLEAR is that Mueller SHOULD HAVE BEEN
FIRED. Bits and pieces are surfacing that when put together paint a
picture that is deeply disturbing. We knew it was bad, but I'm

51 Evidence is surfacing that suggests Mueller involved Steele and 52 Fusion GPS in his attempt to find collusion between Trump and 53 Russia. In one case, in a footnote, Mueller slips in a 56 reference to a text Cohen received from a Russian business man 57 suggesting support for the allegation that Russia had 58 "compromising tapes" of Trump with Russian hookers — that 59 business man is Giorgi Rtskhiladze, an American from Georgia, Russia, has directed his lawyers to demand a retraction of that 60 footnote because Mueller left out a little something from that text. 61 The fact that Girogi stipulated in the text that HE DID NOT 62 BELIEVE ANY SUCH TAPES EXISTED, which is corroborated by 63 the fact that no evidence of their existence has ever surfaced. 64

80 Mr. Mueller was using the Steele Dossier as a road map for his 81 investigation. And that makes sense if you understand what is 82 going on with all of this.

Mueller needed to find a way to substantiate the Steele Dossier that was the basis for the FISA warrants and, now we learn, it was the basis of Mueller's investigation. Yeah! The debunked dossier — Mueller desperately needed to manufacture support for that dossier to save Hillary and Obama from getting tangled up into this mess — Mueller was the fixer, the cleaner — and he could not get it done.

But members of the house intelligence committee have seen 98% of the 112 report — and he has offered to allow some bi-partisan committee to see all of it — you 113 cannot get more cooperative than Barr has been.
- 114 I mean, not without breaking the LAW now, here is the dirty little secret. Adam Schifty 115 knows there is nothing under the color coded black out sections that proves Trump
- colluded with Russia or that proves he obstructed justice, or even tried to obstruct justice.
 This is a ruse.
- 118 They need to keep the suspicion alive into the 2020 election they desperately need their support base to keep on believing Trump obstructed justice or they will simply have no voter base in 2020.
- 121 That's one part of this. The other part is they need to under any remotely plausible 122 pretense, keep up the attack. They cannot allow Barr to get too concentrated on his 123 investigation into the origins of the investigation — I'm telling you folks, only one thing 124 makes any sense out of how ridiculously OCD the Democrat leadership is about this 125 Mueller report and the whole obstruction issue — the truth exposes Hillary and Obama. 126 I'm growing increasingly convinced of that the more crazy the Dems act about all of this.
- Look, even one of their own, a liberal law professor, considers the effort to build a
 contempt case against Barr is ludicrous, at best, and self-defeating for the Democrats.
 Jonathan Turley, Law Professor and champion of Progressive causes is at least willing
 to be honest about this.
- He said, "Barr promised to release as much of the report as possible, and he has delivered." He tries to explain to his Progressive counterparts in the political arena that this could backfire on them in a big way. He explained to them that Barr "is not expressly given the authority to release the confidential report." But Barr released it anyway. Turley, Progressive Law Professor, went on to explain that "the key obstruction portion of the report is virtually unredacted." He tries to tell his Progressive friends that only 8% of the

- public report was redacted," and "the sealed version of the report given to Congress only
 had 2% redacted." The only material redacted is grand jury material that's it.
- 139 Do the Democrats, like Adam Schifty and the rest really believe the smoking gun they are 140 looking for is in the redacted Grand Jury testimony?

141 The Law Professor is incredulous — befuddled by his fellow Progressives obtuseness — 142 obtusity — that's obesity of the brain — their fat headed unyielding obsession to continue 143 this charade — now, you should know, that's my description of what I'm reading here — 144 the Professor seems bewildered by the inanity of it all: "So Congress now will ask a court 145 to find civil contempt for Barr refusing to release grand jury information." In other 146 words, the irony is this — the Democrat controlled Congress is asking a court to rule Barr 147 in contempt for OBEYING THE LAW. Barr is in contempt for OBEYING THE LAW. 148 This is the new Democrat party for you. If you OBEY THE LAW, they hold you in 149 contempt.

- Mr. Turley, law professor, remembered what the Democrats were trying to do to Barr during the confirmation hearings. He remembers trying to explain to them than that Barr cannot promise to break the law in order to get their confirmation for his nomination but that is what they were trying to do. He said, "I testified that they were asking Barr to commit a potential criminal act to secure his own confirmation."

- 170 And the point is, as I prepare to take a short break — the point is the Democrats know 171 full well there is nothing redacted that gives them any thing — they know this — but 172 Adam Shifty, along with Pelosi and the others, keep kicking up dust about Barr's refusal 173 to release an unredacted report — when they know he CAN'T by LAW do that. It's Mother's Day this Sunday — and I can't begin to imagine 191 what the Mother's in that town are feeling right now.
- Our hearts are heavy with the news from Colorado another school shooting. This time 193 1 was killed and 8 wounded. The shooters are students of the school one is 18 and the other is 16, she is a transgendered girl-to-boy thing going on there. There is much we don't know yet — what was their relationship, why they decided to target the charter school there in Colorado — except we do know that the tranny-kid posted an "I hate Christians that hate gays" thing on social media. I looked at it, and it appears to me she believes all Christians hate gays — .
- However, we don't know whether the two would be Columbine copy-cats were going to go from student to student asking, "are you a Christian," and then shooting them is they said yes — because, some brave young men charged the shooters before they could begin any planned executions.
- 203 Brendan Bialy (Bi-al-le) and Kendrick Castillo - 18. These two were sitting near the 204 classroom door when a student walked in late and pulled a gun. Castillo rushed the 205 gunman immediately, and pinned him against the wall. - that school, especially of every student in that classroom will be eternally grateful for the courage of these young heroes, and for the sacrifice of Kendrick Ray Castillo.

The presence of the armed guard, and the willingness of Brendan Bialy and Kendrick Ray Castillo to put their own lives at risk and stand up to these killers saved lives — and I appreciate the effort on the part of media to avoid reporting on this in a way that brings a lot of attention to the killers, and dramatizes their actions as if they did something warranting significant mention.
