- 2 Lighthouse Baptist Church in Santa Maria, CA—and your brain
- 3 masseur—get ready for your brain massage.
- 4 Now Ukraine-gate! Just know one thing. Each of these obscene
- 5 attacks is about covering up crimes committed by Demoncrats.
- 6 Actually, know two things. It's all going to blow back on them!
- 7 Get ready for your Brain Massage!
- 8 [TRUTH]
- 9 Would you vote for a Communist to be President of our country?
- 10 That sounds incredible to the ears of anyone over the age of 40 -
- 11 but do you realize that a significant number of our younger 12 generation are prepared to vote away our liberties?

- My friends, there are so many like references from our Founders it 127 128 is remarkable how Satan has succeeded to rewrite our history so 129 dramatically as to have convinced an entire generation, 1. That 130 America was not founded as a Christian nation, 2. That the Founders were not sincerely Christian, 3. 178 Now, why did Joe want the Ukrainian investigator fired? Times 179 had tipped him off that the Ukrainian investigator was preparing 180 to file charges against a company his son worked for. and you ended up winning easily. It's a fantastic achievement.
Congratulations."

- President Zelensky: "You .are absolutely right Mr. President. We 242 243 did win big and we worked hard for this. We worked a lot but I 244 would like to confess to you that I had an opportunity to learn 245 from you. We used quite a few of your skills and knowledge and were able to use it as an example to our elections and yes it is true 246 that these were unique elections. We were in a unique situation 247 248 that we were able to achieve a unique success. I'm able to tell you the following; the first time you called me to congratulate me when 249 250 I won my presidential election, and the second time you are now calling me when my party won the parliamentary election. I think I 251 should run more often so you can call me more often and we can 252 253 talk over the phone more often.
- The President: [laughter] "That's a very good idea. I think yourcountry is very happy about that."
- President Zelensky: "Well yes, to tell you the truth, we are trying to work hard because we wanted to drain the swamp here in our country. We brought in many many new people. Not the old politicians, not the typical politicians, because we want to have a new format and a new type of government. You are a great teacher for us and in that."
- The President: "Well it is very nice of you to say that. I will say that we do a lot for Ukraine. We spend a lot of effort and a lot of time.

Much more than the European countries are doing and they 264 265 should be helping you more than they are. Germany does almost 266 nothing for you. All they do is talk and I think it's something that 267 you should really ask them about. When I was speaking to Angela Merkel she talks Ukraine, but she doesn't do anything. A lot of the 268 European countries are the same way, so I think it's something you 269 270 want to look at, but the United States has been very, very, good to 271 Ukraine. I wouldn't say that it's reciprocal necessarily because 272 things are happening that are not good, but the United States has 273 been very, very, good to Ukraine."

- 274 President Zelensky: "Yes you are absolutely right. Not only 100%, 275 but actually 1000% arid [and?] I can tell you the following: I did 276 talk to Angela Merkel and I did meet with her. I also met and 277 talked with Macron and I told them that they are not doing quite as 278 much as they need to be doing on the issues with the sanctions. 279 They are not enforcing the sanctions. They are not working as much as they should work for Ukraine. It turns out that even 280 281 though logically, the European Union should be our biggest 282 partner but technically the United States is a much bigger partner 283 than the European Union, and I'm very grateful to you for that 284 because the United States is doing quite a lot for Ukraine. Much 285 more than the European Union especially when we are talking about sanctions against the Russian Federation. 286
- I would also like to thank you for your great support *in the area*.
  We are ready to continue to cooperate for the next *set* of defense
  steps. Specifically we are almost ready to buy more Javelins from
  the United. States for defense purposes."
- The President: I would like you to do us a favor though because our country has been through a lot and Ukraine knows a lot about it. I would like you to find out what happened with this whole situation with Ukraine, they say Crowdstrike... I guess you have one of your wealthy people... The server, they say Ukraine has it.

296 There are a lot of things that went on, the whole situation . . . I 297 think you are surrounding yourself with some of the same people. I would like to have the Attorney General call you or your people 298 299 and I would like you to get to the bottom of it. As you said yesterday, that whole nonsense ended with a very poor 300 performance by a man named Robert Mueler, an incompetent 301 302 performance, but they say a lot of it started with Ukraine. 303 Whatever you can do, it's very important that you do it if that's possible." 304

305 President Zelensky: "Yes it is very important for me and everything that you just mentioned earlier. For me as a President, it is very 306 307 important and we are open for any future cooperation. We are ready to open a new page on cooperation in relations between the 308 United States and Ukraine. For that purpose, I just recalled our 309 ambassador from United States and he will be replaced by a very 310 311 competent and very experienced ambassador who will work hard 312 on making sure that our two nations are getting closer. I would also like and hope to see him having your trust and your 313 confidence and have personal relations with you so we can 314 315 cooperate even more so. I will personally tell you that one of my assistants spoke with Mr. Giuliani just recently and we are hoping 316 317 very much that Mr. Giuliani will be able to travel to Ukraine and 318 we will meet once he comes to Ukraine. I just wanted to assure you once again that you have nobody but friends around us. I will make 319 sure that I surround myself with the best and most experienced 320 321 people. I also wanted to tell you that we are friends. We are great 322 friends and you Mr. President have friends in our country so we 323 can continue our strategic partnership. I also plan to surround myself with great people and in addition to that investigation, I 324 325 guarantee as the President of Ukraine that all the investigations will 326 be done openly and candidly. That I can assure you."

The President: Good because I heard you had a prosecutor who was very good and he was shut down and that's really unfair. A lot of people are talking about that, the way they shut your very good prosecutor down and you had some very bad people involved. Mr. Giuliani is a highly respected man. He was the mayor of New York City, a great mayor, and I would like him to call you. I will ask him to call you along with the Attorney General.

- Rudy very much knows what's happening and he is a very capable guy. If you could speak to him that would be great. The former ambassador from the United States, the woman, was bad news and the people she was dealing with in the Ukraine were bad news, so I just want to let you know that.
- The other thing, there's a lot of talk about Biden's son. That Biden stopped the prosecution and a lot of people want to find out about that so whatever you can do with the Attorney General would be great. Biden went around bragging that he stopped the prosecution so if you can look into it. It sounds horrible to me.
- 344 President Zelenskyy: I wanted to tell you about the prosecutor. 345 First of all I understand arid [and?] I'm knowledgeable about it, 346 the situation. Since we have the absolute majority in our Parliament; the next prosecutor general will be 100% my person, 347 my candidate, who will be approved, by the parliament and will 348 349 start as a new prosecutor in September. He or she will look into the 350 situation, specifically to the company that you mentioned in this issue. The issue of the investigation of the case is certainly [?] the 351 352 issue of asking us to restore the honesty. So we will take care of that 353 and will work on the investigation of the case.

On top of that, I would kindly ask you if you have any additional information that you can provide to us, it would be very helpful for the investigation to make sure that we administer justice in our country. With regard to the Ambassador to the United States from Ukraine as far as I recall her name was Ivanovicli. Actually last 374 time I traveled to the United States, I stayed in New York near 375 376 Central Park and I stayed at the Trump Tower. I will talk to them 377 and I hope to see them again in the future. I also wanted to thank you for your invitation to visit the United States, specifically 378 Washington DC. On the other hand, I also wanted to ensure you 379 that we will be very serious about the case and will work on the 380 381 investigation. As to the economy, there is much potential for our 382 two countries and one of the issues that is very important for 383 Ukraine is energy independence. I believe we can be very successful and cooperating on energy independence with United States. We 384 are already working on cooperation. We are buying American oil 385 386 but I am very hopeful for a future meeting. We will have more time 387 and more opportunity to discuss these opportunities and get to 388 know each other better. I would like to thank you very much for your support. 389

390 The President: Good. Well, thank you very much and I appreciate

- that. I will tell Rudy and Attorney General Barr to call. Thank you.
  Whenever you would like to come to the White House, feel free to
  call. Give us a date and we'll work that out. I look forward to
  seeing you.
- 395 President ·Zelensky: Thank you very much. I would be very happy 396 to come and would be happy to meet with you personally and get 397 to know you better. I am looking forward to our meeting arid [and?] I also would like to invite you to visit Ukraine and come to 398 399 the city of Kiev, which is a beautiful city. We have a beautiful 400 country, which would welcome you. On the other hand, I believe that on September I we will be in Poland and we can meet in 401 402 Poland hopefully. After that it might be a very good idea for you to 403 travel to Ukraine. We can either take my plane and go to Ukraine or we can take your plane, which is probably much better than 404 405 mine.
- 406 The President: Okay, we can work that out. I look forward to 407 seeing you in Washington and maybe in Poland because I think we 408 are going to be there at that time.
- 409 President Zelenskyy: Thank you very much Mr. President.
- 410 The President: Congratulations on a fantastic job you've done. The
- 411 whole world was watching. I'm not sure it was so much of an upset
- 412 but congratulations.
- 413 President Zelensky: Thank you Mr. President bye-bye.
