- 2 Lighthouse Baptist Church in Santa Maria, CA—and your brain
- 3 masseur—get ready for your brain massage.
- 4 Of course, we'll need to look at the fake impeachment proceedings.
- 5 But our theme is "Choose ye this day whom ye will serve." We will
- 6 be choosing who we will serve coming November 2020. And it's
- 7 apparent the choice is between Law and lawlessness, order and
- 8 chaos, power and principle, liberty and tyranny —
- 9 My friends, it's time for your brain massage~!
- 10 [TRUTH]
- 11 Bible thump alert, BIBLE THUMP ALERT: "And if it seem evil
- 12 unto you to serve the LORD, choose you this day whom ye will
- serve; whether the gods which your fathers served that were on the
- 14 other side of the flood, or the gods of the Amorites, in whose land
- 15 ye dwell: but as for me and my house, we will serve the LORD."
- 16 Joshua 24:15
- 17 "And Elijah came unto all the people, and said, How long halt ye
- 18 between two opinions? if the LORD be God, follow him: but if
- 19 Baal, then follow him. And the people answered him not a word."
- 20 1Kings 18:21
- 21 We will be choosing who we will serve coming November 2020.
- 22 And it's apparent the choice is between the gods our "fathers"
- 23 served leading to the FLOOD or the God of our Founders. It's a
- 24 choice between the LORD and Baal.
- 25 I want to help you understand the distinction before us between
- 26 PERSONALITY and PRINCIPLE. Choose ye this day whom ye will
- 27 serve! We will be choosing who we will serve coming November

- 28 2020. And I said it's a choice between Law and lawlessness, order
- 29 and chaos, power and principle, liberty and tyranny and it's a
- 30 choice between sanity and lunacy. In any other time in America,
- 31 the left would be dismissed as a pack of loons.
- 32 I mean, listen to these candidates and ask yourself who are they
- 33 talking to?
- 34 I received a Bernie fundraising email appealing to his voters by
- 35 offering a sticker that says, BILLIONAIRES SHOULD NOT

- 66 the bums rush out of the stadium. What's with the NBA? Did they
- 67 learn nothing from the NFL experiment with this nosense?
- 68 Here is a grossly overweight liberal who blames Trump for her
- obesity. She complains that she is overweight because we are in the
- 70 Trump era and that her obesity is the consequence of
- 71 circumstances over which she has no control—Trump's President.
- 72 She even insinuated that White-People diets hurt Black people.
- 73 What is she talking about? Eat whatever you want to lady!
- 74 Apparently, that's what you've been doing!
- 75 Warren wants to extend Medicare to cover transgender surgery —
- 76 so that's your tax dollars at work.
- 77 At CNN's town hall for LGBTQ issues. Among other things, the
- 78 town hall featured a "nine-year old transgender American." A nine
- 79 year old! The picture suggests this nine-year old is a girl that
- 80 decided she would rather be a boy. And she, he, is surrounded by
- 81 insane adults who are supporting this. We already know that these
- 82 kids are far more likely to commit suicide—and you can blame
- 83 people like me who reject this insane idea that people choose their
- 84 gender, but I blame you! I blame you for encouraging this sort of
- 85 confusion in our society.
- 86 Why don't brown eyed people simply declare their eyes are blue, or
- 87 green. That's it! Just declare it to be so! And if anyone says
- 88 otherwise, punish them for disturbing the unstable psyche of these
- 89 confused people. That's it! Hey, I have a solution for that Obese

- 90 lady mad at Trump for making her fat! Just declare yourself to be
- 91 skinny! Say, "I'm skinny." And then lobby to pass laws that require
- 92 everyone around you to accept your obesity as skinny then,

- 115 CNN you have erased black trans women for the last time," then

- and I deserve to be here! My black trans sisters that are here! I am
- 119 tired! I am so tired of -- it's not just my black trans women!"1

- Following up on the nine-year-old transgender show and that's
- 147 what it was. My heart breaks for this kid she needs help to
- accept herself as God designed her. But, following up on this, as if
- it was choreographed, the next question, "And senator, a follow-up
- on this. Do you think that religious education institutions should
- 151 lose their tax-exempt status if they oppose LGBTQ rights? So,
- would they lose their tax exempt status?"
- 153 And then the spin-spiders weave their web of deceit: "As you know
- in 27 states, including my state of Florida, LGBTQ people can be
- denied service in restaurants and other public spaces based on who
- they love or who they're perceived to love." Yeah, they *love* to put it
- 157 like that I mean, who would justify being opposed to someone
- based on who they love. Love justifies all things! Mohammed, it is
- 159 argued, loved nine-year old Ayisha and in the minds of many,
- 160 that makes it okay??? Married her at six years of age, and
- 161 consummated the marriage when she was 9. So! What's love got to
- do, got to do with it? Absolutely nothing! It's perversity.
- 163 It's not about who anyone loves it's about violating God's order
- and design for marriage and procreation. God connected sex with
- procreation and as a mechanism by which the male and the female
- 166 come together and become one. God created the man, and from
- 167 the He man made the woman, brought them back together to
- become one through the marriage bond that serves as the means by
- which more men and women come into the world.
- 170 It's unnatural for the woman to behave contrary to her nature, or
- 171 the man to behave contrary to his nature and acting contrary to
- 172 nature, quite naturally, brings all sorts of evils into the world both
- 173 physically, and spiritually.
- 174 I have a list of diseases that are directly associated with this
- 175 unnatural behavior it's insanity that we have come to embrace
- this as part of our culture and it will ruin us.

- 177 So the follow up to this nine-year old tranny, Beto was asked
- 178 whether churches should lose their tax-exempt status if they refuse
- 179 to affirm LGBTQ people: Beto O'Roark says yes! He will go after
- 180 the tax exemption for religious organizations that refuse to cow-
- 181 tow to the political correctness crowd and yield their freedom of
- 182 religion and freedom of thought to accommodate the disease
- ridden and socially destructive agenda of the LGBTQ advocates.
- 184 So far then, Beto has declared he will come after our Defense Rifles,
- and now religious tax exemption the whole outrage over tax
- 186 exemption for churches is a ruse since any number of
- 187 organizations are granted tax exempt status as non-profit
- 188 organizations. Tax exemption should never be thought of as tax
- subsidy for that reason. People who participate in a tax-exempt
- 190 organization don't lose their inalienable RIGHTS as individuals.
- 191 So, don't get fooled into thinking of churches as "institutions" and
- 192 forget they are made up of people individuals American
- 193 citizens who have a right to their own opinions about these things
- and the right freely to associate themselves with one another.
- But there it is! It sort of completes the picture. The Democrat party
- is in favor of whatever is contrary to God.
- 197 Trump is right when he observes that "they" are not after him in
- 198 truth, they are after all of us who acknowledge Christ is KING
- above them, and who affirm that we are all subject to HIS CROWN
- and AUTHORITY.
- 201 And so then there is this "Media Clamor for Impeachment,
- 202 Ponder Death Penalty For Trump." Death penalty? Really? Maybe
- these people really have gone completely over the top. They hate
- 204 Trump politically, I understand, but it goes deeper than your
- 205 typical political hatred. These people are viscerally afraid of
- 206 Trump.
- Okay, let's sum up.

- 208 The Democrat Party today is not even pretending to make any
- 209 effort to appeal to the average American. They are for killing babies
- 210 right up to term, taxpayer funded abortion and transexual surgery,
- 211 welfare for illegals, promoting gender confusion to our children,
- 212 and attacking the churches they are for spurning the sacred and
- 213 encouraging the perverse. That's what you are voting for if you vote
- 214 Democrat today. Wow! Look, either the Dems are depending on
- 215 the main stream American not listening to what they are saying
- 216 right now, and intend after the primary, as they often do, to swing
- 217 toward the center, or they have quite literally gone off, and over the
- 218 rails. Who will Americans' choose to govern America in 2020? Our
- 219 choice is between tyranny or liberty!
- Hold on through the break. I'll be right back.
- Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
- 222 at the Lighthouse, your brain masseur, and Paul Revere's lantern
- 223 lighter, lighting the lamps in the church belfry arch, signaling the
- 224 enemy is on the march, an enemy that would steal from us our
- 225 liberty.
- 226 Impeachment? It's all happening so fast, it's hard to keep up! Behar
- said she thinks the reason so many continue to support Trump is
- 228 that they are busy living their lives, and not paying attention. She
- 229 suggested that they are unlike her, and others in the MSM who
- 230 watch all of this closely every day. She believes that when they stop
- and look at what this President has been doing they will wake up
- and then change their mind about him.
- 233 Another said she believed impeachment would bring the nation
- 234 together.
- 235 Some on The View disagreed strongly. They expressed the belief
- 236 that impeachment would tear the country apart. I'm going to
- 237 remind you about some hard facts concerning impeachment, and
- 238 then show that what is going on right now is not, Constitutionally

- 239 speaking, impeachment. In other words, Adam Schiffty is running
- an illegal play and it's only a matter of time before the referees blow
- the whistle on all this and call FOUL!
- 242 There are all sorts of problems with what is going on right now. I
- 243 think Jay Sekulow provided the best summary and I'll use it to lay
- 244 this out for you. First the LAW, and then the PRECEDENT.
- 245 As you know, Article 1 section 2, last paragraph says, "The House
- of Representatives shall chuse their Speaker and other Officers; and
- 247 SHALL HAVE THE SOLE POWER OF IMPEACHMENT."
- However, according to Article 1 Section 3, impeachment must be
- TRIED by the Senate, with the Chief Justice of the Supreme Court
- 250 presiding the trial, with a stipulation that conviction requires 2/3 of
- 251 the Members present.
- Okay, that's the law. Well, that sort of covers applicable law. There
- 253 is another matter of law we need to look at. According to law,
- 254 whistleblowers must have reasonable basis for their complaint.
- 255 Whistleblowers are required to present information and other
- documents that can back up their claims when filing a dispute. If it
- 257 is found that they are lying, they may be subjected to criminal
- 258 charges. That's why this guy secured Hillary's lawyers before
- 259 proceeding with the complaint.
- 260 The law does not require first hand knowledge; it requires
- reasonable belief in wrongdoing. However, the form used for these
- 262 complaints included a paragraph about having firsthand
- 263 knowledge.
- 264 That form was recently REVISED eliminating the question about
- 265 having FIRST HAND KNOWLEDGE.
- Now, here is where it gets really weird.
- 267 The complainant in this case, used the earlier form and checked
- 268 the box that said, "I have personal and/or direct knowledge of

- 269 events or records involved." The complainant also checked the box
- that says, "Other employees have told me ..." etc.
- 271 Both boxes were checked.
- 272 But then, the complainant form that was released to the public was
- 273 the newer form, and a statement was included saying the
- 274 complainant did NOT HAVE PERSONAL OR DIRECT
- 275 INFORMATION and it was written in a way that is
- 276 embarrassingly like legalese.
- 277 According to the version of the whistleblower form released, the
- 278 Whistleblower said, "I was not a direct witness to most of the
- events described. However, I found my colleagues' accounts of
- 280 these events to be credible because, in almost all cases, multiple
- 281 officials recounted fact patterns that were consistent with one
- 282 another."2
- 283 "Fact patterns that were consistent" really? It turns out the
- Whistleblower is a cohort of Joe Biden, a CIA plant in the White
- 285 House tasked to spy on the Trump Administration.
- The complaint was allegedly filed with Adam Schiffty August 12.
- 287 But we know Adam's office was notified before the complaint was
- 288 submitted. He said, "We have not spoken directly with the
- 289 whistleblower."
- When the transcript of the phone call was released, September 25,
- Adam runs out there the next day and reads a fabricated account of
- 292 the phone call into the Congressional record why did he not
- 293 read the actual transcript? In his fabricated account, he alleges
- 294 Trump asked the Ukrainian president to "dig up dirt on Biden."
- We've read the transcript, we know that is a lie. But many people
- 296 don't bother reading the actual transcript, they hear Adam

- 297 Schiffty's account and it agrees with their bias so they accept it as
- 298 truth.
- 299 Why didn't Adam read the actual transcript into the Congressional
- 300 record?
- Why did they doctor the whistleblower's complaint?
- 302 And then...
- 303 There is the issue of Precedent. According to Sekulow, the
- 304 precedent is that the Congress gives the minority an opportunity
- 305 ask questions and cross-examine witnesses. But this will not be
- allowed by this Congress, at least so far.
- 307 Furthermore, and this is very important the Constitution does
- 308 not invest in a sub-committee the sole power of impeachment. It's
- 309 invested in the House. There should be a House vote on
- 310 impeachment, and it should then be TRIED in the Senate, not in
- 311 the House.
- 312 The reason they don't put the impeachment up for a full House
- 313 vote is they are sure they don't have support for it. Which is
- 314 remarkable since the last election put the House into the hands of
- 315 the Democrats. But they don't have the votes, and don't want to
- 316 risk going to a full vote of the house and failing again,
- 317 remarkable, since it only requires a simple majority and they have
- 318 the majority right now.
- 319 It's possible that the Democrats don't want the matter to go to
- 320 Senate until after they have secured enough support in the Senate
- 321 to get conviction. Or they are stringing this out to make it an
- 322 election issue.
- 323 But let's look at the articles of impeachment we have not seen
- 324 them yet. That's because they are still trying to figure out what they
- are going to be. Yeah; I'm not kidding.

- 326 They hoped the Mueller report would provide what they wanted to
- 327 impeach, it imploded on them. You don't hear anything about
- Russia collusion or Mueller report anymore. The whole thing blew
- 329 up in their faces.
- 330 Then they tried to pin obstruction on Trump in the Russia
- 331 collusion scam. That also blew up in their faces.
- 332 So they came up with this Ukraine conversation but the actual
- 333 transcript was released and so that fizzled it flew around like a
- 334 balloon losing air fast.
- 335 They could not find any substantial argument for quid pro quo —
- 336 So, they are turning their attention away from that, and focusing
- 337 on obstruction again, saying that since Trump refuses to produce
- 338 witnesses they are calling for and documents they want, he is
- 339 obstructing justice.
- Well, we'll see. The fact is, the Constitution provides for the
- 341 President executive privilege in exactly these sorts of situations.
- 342 And the reason for these executive privileges is to protect the
- 343 Office of the President from political assassination attempts such as
- 344 we have right here before us.
- 345 This is political assassination 101. They know the President is not
- 346 obliged by law to produce witnesses or documents to them it's
- 347 like, in some ways it's like the 5th protections against being
- 348 compelled to self-incriminate. I mean; it's similar. The idea is that
- 349 without these protections, what we see happening will happen over
- 350 and over until nothing gets done in government because all the
- 351 time is spent on using these "investigations" to harass the sitting
- 352 President and impede him from doing his job.
- 353 Adam Schiffty is whining about the President impeding a co-equal
- 354 branch of government from doing it's Constitutional duty, but that
- is exactly what Adam is doing the Mueller investigation was a
- 356 fake hit job on the President, the allegations of obstruction in that

- 357 case were proved phony, the Ukrainian call proved to be a red
- 358 herring another fake accusation, in which Adam actually
- 359 invented a version of the phone call that never happened, and
- 360 LIED about not talking to the whistleblower earlier yeah,
- 361 proved, a LIE he said "we" meaning him and his team, his office,
- 362 had not talked to the whistleblower when we know for a fact his
- 363 office did have contact with him so the executive privilege
- 364 President Trump is exercising is being used in exactly the way the
- 365 Founders envisioned it would be used to PROTECT one
- 366 EQUAL BRANCH OF GOVERNMENT from interference and
- 367 harassment from another EQUAL BRANCH OF GOVERNMENT.
- 368 So, it can go to the third branch for adjudication. That's right!
- 369 If Schifty is concerned the President is abusing his power, he can
- 370 do what others have done before him and appeal to the Court —
- 371 but he does not.
- 372 Why? Because this is a political hit job and when you dig into
- this here is what you find out.
- 374 Gotta close, but remember in the transcript of the phone
- 375 conversation between Trump and President of Ukraine the
- 376 Ukrainian President mentions his appreciation for exposing the
- 377 corruption of the former American Ambassador to Ukraine, her
- 378 name is Marie Yovanovich and she is being called to testify before
- 379 the impeachment committee. Want to know why there is no way
- 380 Adam is going to allow the Minority to ask questions? Want to
- 381 know what Trump was talking about?
- Well, it turns out that she was Obama's appointed ambassador and
- 383 she was obstructing justice. That's right! Yovanovich refused visas
- 384 to Ukranian officials who wanted to come to America to provide
- proof of corruption in the Obama Administration.
- 386 Misconduct in relations with Ukraine. Also, to obstruct exposure
- 387 that "A Clinton surrogate made a trip to the Ukraine in 2016 in

- order to get dirt on Donald Trump or members of his campaign."
- 389 Shortly after this trip, they released their fake information
- 390 implicating Paul Manafort in crimes. And we know that shortly
- 391 after Joe visited Ukraine, his son landed a huge 600k per year job in
- 392 a position he has absolutely no qualifications to hold. And we
- 393 know Joe boasted that he got a prosecutor in Ukraine fired when
- 394 he threatened to hold back funding authorized for Ukraine.

- 396 fabricate a case that Trump was withholding military aid to
- 397 Ukraine as leverage to pressure Ukraine to "dig up dirt on Biden."

- 409 LIGHTS OFF -- which means you reject what I'm saying and

- 411 lights off?
