- 1 Segment.01 Hello. I'm Dr. Jerry Scheidbach, pastor of the
- 2 Lighthouse Baptist Church in Santa Maria, CA—and your brain
- 3 masseur—get ready for your brain massage.
- 4 I've been warning that America is moving toward civil war for
- 5 some years now, I've expressed my concern that American politics
- 6 is fast moving from debate, to railing irrational argument, and
- 7 from there to physical violence. O Reilly sees it, too. Recently he
- 8 commented on a poll that says "70 percent of Americans believe we
- 9 are on the verge of civil war." His response? "They are wrong.
- 10 There's no *verge*. A social civil war is in progress."
- 11 Actually, Charlton Heston, may he rest in peace, declared America
- 12 was embroiled in a culture war —
- 13 The foundation for this current assault on our liberties was framed
- 14 in Darwin, and Marx, and hardened in Sanger, the playbook was
- 15 written by Saul Alinsky, and the first team of Hillary and Obama
- 16 ran the ball gaining many yards toward the goal of subverting
- 17 America and transforming the U.S. OUT FROM UNDER GOD to
- 18 become a Communist/Socialist dictatorship under the
- 19 DEMONCRAT PARTY.
- 20 Then God sent Trump Heaven's Whistleblower stirring up
- 21 the smelly swamp and exposing the lies and the lying liars that tell

- 44 impeachment proceedings, and then hearings were conducted, and
- 45 finally vote was taken by the House to IMPEACH. Which sent the
- 46 matter to the Senate for trial. The Senate voted narrowly not to
- 47 remove Clinton from office, that is, not to convict. But, Clinton
- 48 WAS IMPEACHED because he LIED under OATH. That used to
- 49 be considered a bad thing, even when Democrats did it but
- 50 anyway.
- 51 When Republicans advanced impeachment articles against
- 52 Clinton, it was done in the open it was advanced by vote of the
- House each step of the way. The "minority party," at that time, the
- 54 Democrats, had access to witness testimony and were allowed to
- 55 cross examine; the President was allowed to have counsel
- 56 representing him at the proceedings, to cross examine witnesses
- 57 and to call witnesses for his defense. It was conducted in
- 58 accordance with the spirit of our Constitution, orderly, openly, and

- fairly; it was conducted in accordance with the values of our people
- 60 innocent until proven guilty, with representation for the
- accused, and the rights of the accused duly accommodated. When
- Republicans made rules for pursuing impeachment of Clinton, the
- 63 rules were, well, lawful, mindful of our cherished American values
- 64 and ideals of justice and judgment —
- But now the Democrats have the House and they are making the
- 66 rules and their conduct looks like a Soviet style inquisition the
- 67 accused is not allowed to have representation, witnesses are not
- 68 cross examined by those representing the accused, and it's all hush-
- 69 hush behind closed doors.
- 70 Someone likened this to the Benghazi hearings and argued that
- 71 those were closed also, and so they are simply following the same
- 72 rules.
- 73 I KNOW! You are right! They are following the Benghazi hearing
- 74 rules. Which is the REASON a certain little smoking gun was not
- 75 made public until only recently by the dogged efforts of Judicial
- 76 Watch thank you Mr. Fitton did you hear about that? Did
- you hear what was finally exposed? Follow closely class.
- 78 You remember Benghazi got to start there, sadly. Christopher
- 79 Stevens, our ambassador to Libya, who was killed when a "Special
- 80 Mission" facility in Benghazi, Libya, was attacked by militant,
- 81 armed, jihadis, on 9/11/12. The story put out by Obama's
- 82 administration Intelligence Community (IC) was that it was a
- 83 spontaneous uprising of Muslims angered by some D rated
- 84 American made movie, spoofing Mohammed. This document was
- among the Hillary emails that were hidden from public disclosure.
- 86 JW filed an FOIA (Freedom Of Information Act request) for any
- 87 emails mentioning "talking points" or that had as its topic or
- 88 subject or content any mention of Benghazi, or reference to
- 89 Benghazi.

- 90 This particular email was kept back from disclosure. No doubt
- 91 many others also. But Judicial Watch came across information
- 92 informing them of this email so they were able to very specifically
- 93 request it finally, the deep state Obama lap-dog bureaucrats
- 94 were forced to cough it up and what it shows is that Hillary
- 95 KNEW the first report on what happened in Benghazi was bogus.
- 96 She knew it, folks; she knew it when she, under oath, denied it. She
- 97 testified that she did not have knowledge of information

- 102 The judge that demanded release of this to Judicial Watch said the

- 118 doors inquisition of the President is simply following protocol
- 119 regarding Committee hearings you are RIGHT!
- 120 Every time the Democrats have control, and they are trying to hide
- some evil deeds of one or more of their own, yep! It's all "we'll take

- care of it here in this room, while you wait out side. Trust us! We
- are going to get to the bottom of this." And then, behind the closed
- doors, they go to work working out a way to HIDE THE TRUTH

- be pursuing impeachment proceedings without the full vote of the

- 285 part of the Trump-Russia investigation is a target of Durham's
- 286 criminal probe."¹
