- 47 Suddenly, I'm reminded of the videos I've seen of Black Panthers
- 48 preaching—I hate white people, I want to kill all white people, I
- 49 want to kill white babies, I want to smash their heads on the
- 50 pavement—oh yeah! Some of you might remember that; about five
- or more videos got out showing these Black Panther members
- 52 talking about their hatred of white people. Suddenly, I'm reminded
- of a recent BLM march where the marchers were chanting, "what
- 54 do we want? Dead Cops What do we want? Dead cops. What do
- 55 we want? Dead Cops." I'm reminded of the BLM purpose statement

It begins like this. My Daddy was born in Arkansas and my mother was born in Alabama. He grew up in Texas, and my mom grew up living about six months in Alabama and six in Georgia. My dad's family moved to Georgia, and that's where they met. I never heard my mother or my father say a single negative thing about black people. Not once! I did not know about racism! I went on my own at a very young age—my family moved to Florida—I stayed in CA. Several years went by—I spent some time in the Army, got in college, and was not in regular contact with my two brothers and two sisters. Finally, we got together, and I was shocked when I heard racist bitterness come from one of my sisters and my two brothers. I could not believe my ears. They spoke disparagingly of black people in generalized terms. I rebuked them. My sister and my next oldest brother told me I did not understand. And they began to relate stories to me about how they were treated by blacks in the public school where they attended in Florida. One after another—atrocious stories—and not just verbal assaults, or insults and so on, but physical attacks. To survive in their environment they had to band together with other whites, and stay in groups.

- 88 They were fearful for their lives to ever be alone on campus, or on
- 89 their way to and from school.
- 90 It took a while, but they have all come out of that and realized that
- 91 a particular gang had taken hold in their school and that not only
- 92 was it the case that these thugs did not represent all blacks, but that
- 93 in fact the vast majority of blacks in their community did not
- 94 support what was going on in that school.
- 95 So, our way of looking at things is greatly influenced by our
- 96 experiences, which is understandable. But it's also dangerous.
- 97 Because our experience is limited—so we need to be instructed by
- 98 principles and reason. We need to be willing to look past the
- 99 narrow boundaries of our personal experiences, and see the bigger
- 100 picture. As long as my brother and sister were fixated on their
- 101 personal experiences, their conclusions were skewed. But when
- they stepped back and looked at the larger picture, then they could
- see that.
- 104 You've heard of vicarious experiences? It's the sort of thing where
- you have an emotional and intellectual response to something that
- 106 happened to someone else that you either heard about or read
- 107 about or witnessed. These vicarious experiences can have almost all
- the impact on your worldview that personal experiences have.
- 109 Many of our kids are being exposed vicariously to a carefully
- 110 selected set of stories and experiences of others and they are
- personalizing those experiences as if they are their own.
- For example, when I see the video of this man keeling on the neck
- of a baby, I can't help but react to it in a very deeply personal way.
- 114 It makes me angry, and I want to do something but I can't
- because I was not there. If I had been there, I would have interfered
- 116 with this wicked behavior, I would have stepped in and used
- 117 whatever force I had available to me to stop this atrocity. I would
- 118 have spoken up. I would take action.

- But because it's something that I experienced vicariously, that
- made me very angry, but something that I could take no action to
- stop, or do something about I get frustrated.
- 122 If you multiply that in the life of a kid who grows up hearing,
- reading, and being told over and over again about white people
- 124 oppressing, beating, and mistreating blacks—those stories would
- make anyone angry—but now, add the lie—the lie that these stories
- don't bother the white people in your life—the white people
- 127 around you are beneficiaries of the treatment these people
- experienced, and they don't care about this history because they are
- white and so do not and cannot relate to it like you do.
- But, you see, that's a lie. These kids need to be told the stories, and
- read about the stories, and see movies about the stories of the white
- people who led the abolitionist movement here, and around the
- 133 world. They need to be told the stories of the white people who
- don't see the world as black and white, who see men and women,
- and children. They need to hear, read, and see movies about Daryl
- 136 Davis, a black man who reached out to KKK members and won
- 137 something like 20 KKK members to quit the DEMOCRAT Klan,
- 138 and send their robe and hood to Daryl as a token of their
- 139 repudiation of the KKK. Indirectly, Daryl is responsible for over
- 140 200 DEMOCRAT KKK members leaving the Klan. I reposted
- 141 Daryl's story on my FB page, check it out.
- 142 My point here is that what we are dealing with is the result of
- purposed indoctrination that's been going on in our Public Schools
- 144 and media in this country for decades. Only lately is the TRUTH
- 145 beginning to come out about the DEMOCRATS, the SLAVE
- 146 PARTY—the Party that hated Civil Rights for Blacks—who
- 147 changed their strategy when they saw they were loosing. The
- 148 DEMOCRATS who did not want Blacks to have the vote. They
- 149 fought it—man, it's in their PARTY PLATFORM throughout, from
- 150 emancipation, which they opposed, through the 60s, the

151 Democrats OPPOSED the idea of allowing Blacks to vote in this 152 country. But when they saw they were losing, they switched tactics and decided they would work to own the votes of the Black 153 154 community. And they did it by buying their votes with government 155 handouts. They did it by turning the blame for their own 156 oppression of Blacks against their political opponents. They corrupted the Black leadership by buying them—oh yeah! God 157 158 hearing my prayers, all of this is going to come out into the open.

How they bought Sharpton, and Jackson—these men destroyed the great legacy of Martin Luther King. They have sold out to white Democrats. They bought in to the idea that blacks needed handouts from government, they saw that cash cow and latched on to its nipple — the DEMONCRATS are clever DEVILS — very wily, like Satan. - 184 political correctness, then the State will enforce political
- 185 correctness and in fact it's already happening.
- 186 There is a law in Ohio right now that requires those officiating
- marriages to provide their service to same-sex couples regardless of
- the person's personal beliefs and religious convictions. Why don't
- the homosexuals get their own officials to perform their weddings?
- 190 The point is to FORCE THEIR IMMORAL VIEWS ON OTHERS.
- 191 The STATE cannot enforce such policies without violating
- inalienable rights of others.
- 193 The Constitution is in their way. It's an impediment. They want to
- 194 bring it down. That's what this is about. And Blacks and
- 195 Homosexuals are tools in the hands of these unreasonable and
- 196 wicked people to destroy our liberties. Mark my words. Once they
- 197 succeed no one's liberty will be safe. Freedom will be gone from
- 198 the earth.
- 199 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
- at the Lighthouse, your brain masseur, and Paul Revere's lantern
- 201 lighter, lighting the lamps in the church belfry arch, signaling the
- 202 enemy is on the march, an enemy that would steal from us our
- 203 liberty.
- 204 In the last segment, I mentioned that the Democrat Party is the
- 205 PARTY of ACCUSATION. Have you noticed that? All those
- 206 people do is accuse—constantly, they attack with accusations.
- You can't have a discussion, or even a genuine conversation with
- the Left today—because all they want to do is accuse.
- 209 You might have noticed that lefty types are showing up on your
- 210 social media making their accusations. It's usually a sort of hit and
- 211 run, or as Rush says, drive by shootings. They throw in an
- 212 accusation then disappear.

- I see it all the time when I'm looking at a string of comments when
- 214 Trump is speaking. There will be twenty successive positive
- comments, then suddenly a leftie jumps in with some "accusation"
- against Trump. It's usually something like, "Yeah, right, the liar in
- 217 chief." Or it will be "there he goes again, talking about himself." Or,
- 218 "Supporting Trump is supporting racism," and so on. And then, if
- 219 you jump on and reply with something like, please provide an
- 220 example of Trump's racism." You'll get Another Trump lover,
- 221 racist." In other words, ACCUSATIONS! That's it.
- No conversation! I told you about this guy who attacked a friend's
- 223 post about BLM, pointing out that it's a cover for advancing a
- Marxist agenda. The guy mocked my friend, and in a demeaning
- and condescending tone derided him saying BLM is about Black
- 226 Lives Matter. Sarcastically dismissing my friends comment as
- 227 conspiratorial, and suggesting he did not care about cops killing
- blacks. That leaders of the movement have said all the movement is
- 229 about is to advance the peace and safety of Black people. So I
- 230 jumped in and made a statement to the effect, yeah, and Stalin said
- 231 a chicken for every pot. So being against Stalin means you are
- against people getting food! Let's not talk about the 20 million he
- 233 murdered You know, I can't find anything in the history I've
- 234 read where Stalin put out a slogan that said, "Vote Red—20 million
- 235 Russians Dead" right? You never see a slogan used by Socialists
- or Communists that says, VOTE RED or BE DEAD.
- 237 I rebuked the guy I called him out. I said no one supports cops
- 238 murdering people. And further, I said, and you know that. You
- 239 know that we don't support cops murdering people no matter what
- 240 their skin pigmentation. So how about we stop with the baseless
- 241 ACCUSATIONS and have a real conversation.
- He did not answer me, but continued his attack on my friend. So
- 243 my friend politely brings out the fact that in the purpose statement
- of the BLM leadership they declare as their number one goal the

- 245 end of the nuclear family—they declare the nuclear family as a
- racist construction organized to perpetrate oppression.
- 247 My friend gave a link to the BLM document declaring this.
- 248 The Lefty responded by attacking my friend for his position on
- 249 health care. Yeah! Health care became the focus. And again, it was
- 250 an ATTACK an ACCUSATION that he did not care about
- 251 people's access to health care. Always accusing, accusing, accusing.
- I weighed in again, and told the guy, effectively, hey, you did not
- 253 respond to the purpose statement of the BLM. My friend did
- 254 likewise. And this guy refuses to address the point! He will not
- 255 have a conversation. All he wants to do is attack you with
- accusations.
- 257 You've got to understand that we have not been able to have a
- 258 genuine conversation with the LEFT in this country for a few
- decades now. It's gotten worse since Obama became President, and
- 260 now it's totally impossible. With Trump in office these people have
- 261 gone hysterical and it's nonstop attacks with unfounded
- accusations 24-7. If you attempt to engage them in a conversation,
- 263 be prepared to be attacked with outrageous accusations. Lately, a
- 264 black lady accused me of being a slave owner.
- Now, the temptation is to attack back! But you need to resist the
- 266 temptation. As soon as they get you going back and forth with
- 267 attacks, you've lost and, I know it's weird, but they won! Because
- 268 that's a scenario where they never have to prove their allegations—
- 269 they can just throw them at you, you throw one at them—and they
- 270 end up taking complete control of the conversation, and I'll tell you
- 271 right now, you will not want to stoop as low as they do, and they
- 272 will out do you in attacking you with outrageous unfounded
- allegations. So, here is what you do.
- You say, hey, you don't get to attack me with some unfounded
- 275 statement. Prove what you just alleged. Make them prove their

- 276 allegations—and here is what will happen. They will call you names
- 277 and disappear.
- But maybe, just maybe you'll find some that will actually enter into 278
- 279 a conversation with you. And like Daryl, you might win SOME.
- 280 So I do encourage you to enter into conversations with liberals—
- 281 but remember the rules of engagement. One topic at a time!
- 282 Honesty, humility, and how about some holiness-purity in
- 283 language. We don't need to use foul language to make our point,
- 284 and we don't need to become hateful. That does not mean we don't
- 285 hold them to account — and reprove them when they throw out a
- 286 baseless accusation and refuse to provide evidence supporting their
- 287 outrageous allegations. By all means, hold them to account; but do
- 288
- it with some dignity, and grace. You don't need to get into a
- screaming match with morons—all you need to do to totally 289
- 290 destroy their argument is present well REASONED statements.
- 291 Like, hey, I asked you your opinion on a statement made by BLM
- 292 leaders and you have responded by changing the subject. You don't
- 293 get to do that. You don't get to throw out an accusation without
- defending it, or just change the subject without an honest response 294
- 295 to a legitimate point or question.
- 296 Essentially, you hold them accountable for their statements! Stuff
- like, you just said that I don't care about cops murdering people. 297
- 298 That is an insulting accusation. In order for us to have an honest
- 299 conversation, I'm going to require you to apologize for such rude,
- 300 and ill-mannered behavior. Or, use what I call clarifying questions:
- 301 Did you actually mean to say that I don't care about Black people?
- And follow this up with something like, based on what you just 302
- said, I accuse you of being rude, and impolite. Well, you get the 303
- 304 idea.
- We are not in a conversation with liberals today. We are in a war— 305
- 306 it's a rhetorical war that is fast devolving into physical aggression.

- 307 So let's not feed the fires of violence. And one way to do that is to
- 308 engage their conscience. When they behave badly, point it out. Not
- 309 by screaming at them about what jerks they are. But by clearly and
- 310 plainly pointing it out, like I illustrated earlier.
- 311 But understand. They accuse in order to weaken their opponents
- 312 socially, and intimidate them personally, and then move in for the
- 313 "kill."
- 314 And the ACCUSATION party is at it again. Pulling a Kavanaugh
- on Tucker and other conservatives at Fox. The case against Tucker
- 316 is already falling apart. The Democrats are the party of
- 317 ACCUSATIONS but run away from any conversation that
- 318 requires them to support their accusations with more than
- 319 superficial, and supercilious anecdotes, and more often, not even
- that. They just want to say, "Trump's a liar." If you say, "Oh, really?
- 321 Tell me about one. Just one will do for now. Name a lie that Trump
- 322 told." They will almost always change the subject, or ACCUSE you
- of being a TRUMP LOVING LIAR yourself, or something like that.
- 324 Okay, gotta wrap it up! But, quickly:
- 325 In the Modern-Liberalism-destroys-everything-it-touches
- department: I don't have time to get into this one, but a language
- 327 professor is saying grammar is racist. So, there goes grammar.
- 328 Spelling takes a hit.
- 329 AP (Associated Press) has decided on a new spelling policy. The
- word Black will be capitalized when used in reference to "race" but
- 331 the word white will not. The reason: it will help address systemic
- inequality. I kid you not. So now spelling has been impacted by the
- 333 left's lies about race. This is supposed to bother us pink skinned
- 334 folks. But it's actually a symptom of something deeper and more
- 335 sinister. You might remember a show I did a while back where I
- 336 explained that the current so-called social-justice mantra is about
- desire for revenge, and has nothing to do with justice? I don't have
