60 bureaucrats" who are so steeped in the world they take their cues

88 Barr's testimony — the Dems treatment of Attorney General
89 William Barr has set the bar of civil governance at a new low.

109 he was doing in that meeting—he was not there as the AG to testify
110 as a witness in a legal proceeding.

111 As you probably saw, or heard, the Demoncrats refused to allow
112 AG Barr to actually answer for himself. It was a *hearing* which
113 ostensibly is called to *hear* what the government official has to say
114 about concerns the oversight committee might have. But, as Barr
115 repeatedly pointed out, and as is obvious to anyone watching this

129 You see, folks. If a Demoncrat is in control of government, the
130 minority party is IRRELEVANT. That's what you do when you
131 vote for Democrats. You vote for fascist dictators to govern and
132 what they do is shut you down — they attack you with accusations
133 — remember last week, the ACCUSATION PARTY — and then
134 they shut you down when you try to answer the accusations.

135 The Demoncrats have set the limbo-bar of civil government so low,
136 even the DEMONCRAT SNAKES can't slither under it. We must
137 rid ourselves of these devils! We have one hope remaining —

181 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
182 at the Lighthouse, your brain masseur, and Paul Revere's lantern
183 lighter, lighting the lamps in the church belfry arch, signaling the

184 enemy is on the march, an enemy that would steal from us our
185 liberty.

186 Even before President Trump mentioned the efficacy of
187 Hydroxychloriquine for treatment of the China-virus-19, to
188 differentiate it from China-virus-09. The Communist Party in
189 China IS a virus. But, anyway...

190 But since President Trump mentioned Hydroxychloriquine as a
191 treatment for the China-virus the liberals have gone to such great
192 lengths to dissuade the American people from believing it you have
193 to wonder — wow! What's the danger of this drug? Why is
194 EV*ER*Y ONE so hyped out trying to stop AN*Y ONE from using
195 this drug for the CHINA-Virus? No! Think about this. What
196 exactly is at stake here?

197 I have a knack for getting at the real question in things like this.
198 You've listened to me for many years, you know that what I'm
199 talking about.

200 What is SOOOOOOOO dangerous about Hydroxychloriquine that
201 the establishment doctors are literally PANICED over doctors
202 recommending it as treatment for the China-virus?

203 Wait. Let me set this up better. Okay, phony Fauci (he has proved
204 himself to be a phony—come on! Mr. American's don't need to
205 walk around wearing masks, to every American must wear a mask,
206 Mr. you can't play sports if you are in college or high school but I'll
207 throw the first pitch for the Nationals MLB team, Mr. hey, gotta
208 close down Salons, and openly supports closing down church, but
209 can't find the words to say PROTESTS are a bad idea—Mr. Phony
210 Fauci) tells us Hydroxychloriquine is not an approved treatment
211 for the China-Virus and cites studies that he knows were rigged to
212 fail by using TOO HIGH A DOSAGE — beyond what every doctor
213 knows is the appropriate dosage — and the question is actually not
214 whether Fauci recommends Hydroxychloriquine (HCQ) or

215 whether it actually works—the question is the old medical
216 governing adage — DO NO HARM!

217 When HCQ is recommended by doctors, and there are hundreds, I
218 think it's getting into the thousands, that recommend it as early
219 treatment for the China-virus, all the establishment doctors, I
220 mean bureaucrats like Fauci, and Birx, and all the health
221 department types actually freak out. I mean, they don't just yawn
222 and say, yeah, well, some people! you know, with an eye roll, or
223 something. No! They FREAK OUT! They go crazy.

224 They attack these doctors, viciously, they fire them from their jobs,
225 they accuse them of DANGEROUS counsel — yes, that's the word.
226 DANGER! Twitter, Facebook, Instagram, the CORPORATE
227 LIBERAL CONTROLLED PC police of the Democrat Party go
228 out of their minds with FEAR, PANIC, using words like
229 DANGEROUS — and pull down their posts, attack their character,
230 pull down their web pages, scrub their statements from any social
231 media and attack them at every turn in virtually every MSM outlet
232 — it's like a highly intense full court press attack to STOP THAT
233 INFORMATION FROM GETTING OUT THERE — at all costs.

234 There is no expression quite like OH MY GOD to adequately
235 represent the level of fear, anxiety, terror that strikes the soul of a
236 liberal if you say the words hydroxychloroquine and China-Virus,
237 or, well, okay, COVID-19 together. AAAAJAAFAJRECLSRLEPS
238 — Oh no! Stop them fast.

239 It's DANGEROUS —!

240 Really? *Dangerous?*

241 Dangerous why? Dangerous How? Go to <https://americasfrontline>
242 [doctorsummit.com](https://americasfrontline)¹ and download the white paper² (a *White Paper*
243 is an authoritative report on a subject, usually, a complex subject in

244 which persons with credentials in the area of enquiry offer a
245 summary explanation to inform readers about the subject.

246 This White Paper is very well done! It's written well, and the
247 documentation is excellent. I mean by that the writer obviously is a
248 professional in her field. Written by Dr. Simone MD, JD — that
249 means she is both a medical doctor and a Juris Doctor — or, a
250 Doctor of Law. A fitting combination for her present calling!

251 Anyway!

252 You should get this and read it! Let me summarize it for you. But
253 first: when I study something like this, I like to run down
254 corroborating support, you know, check other resources, and the
255 credentials of authorities cited. I'm only going to comment on the
256 points in this documentation that I have verified to my own
257 satisfaction.

258 Rheumatologists are cited because these doctors make the greatest
259 use of the drug called Hydroxychloriquine (HCQ) and so have the
260 greatest amount of experience using it. Cardiologists are cited
261 because the claims against use of HCQ are based on heart issues
262 that supposedly arise from its use. And Ophthalmologists are cited
263 because visual impairment is another objection that has been
264 raised against use of HCQ.

265 The undisputed authority representing Rheumatologists is an
266 organization called ACR — American College of Rheumatology.
267 I've read the statement of ACR on the use of HCQ and agree with
268 Dr. Simone's assessment. "In other words the professional society
269 of the physicians who prescribe this drug the most, for years have
270 said the following: 1. Serious side effects are rare. 2. Visual changes
271 can happen in people taking high doses for year. And 3. heart
272 rhythm changes are so uncommon that there is no monitoring pre-
273 use."

274 The backdrop to these conclusions is several million patients
275 suffering from Rheumatoid issues treated with NO REPORTED
276 DEATHS from use of this drug.

277 The only instance in which problems occur is when it is used in
278 high dosage, or used over prolonged periods of time.

279 As for the claim that it triggers heart arrhythmia — let's ask
280 Cardiologists. Here is a study published in 2018 that revealed that
281 out of the millions of those prescribed Hydroxychloriquine over a
282 period of over 60+years (FDA approved this drug 65 years ago)
283 there have been only 50 cardiac deaths attributable to HCQ."

284 Conclusion: Heart rhythm problems are so rare that it is common
285 accepted practice not to do an EKG prior to starting the
286 medication.

287 Okay, so what about the allegation that using Hydroxychloriquine
288 can impair your vision? Let's ask an Ophthalmologist. How about
289 Dr. Richard Urso, in active practice for 30 years, affiliated with
290 multiple hospitals in Houston, Texas said "I have had several
291 thousand patient visits to specifically discuss the toxicity of this
292 drug over my last 30 years. It's a super safe drug. It's safer than
293 Tylenol, aspirin, Motrin."

294 There is ZERO visual risk for short courses of HCQ. A "short
295 course," would be one or two months. But wait! CDC website says
296 "The risk of retinal toxicity at five years of continuous use is
297 ZERO." The risk increases to 1% after ten years of "continuous
298 use."

299 Folks, this drug has been used billions of times all over the world. It
300 is an over the counter drug in most of the world. It is the number
301 one most often used drug in India with a population of over 1.3
302 billion people.

303 There has NEVER been a single voice warning about the
304 DANGERS of HCQ until — the China-Virus of 2019. And actually,

305 not even then; until Trump mentioned it as a hopeful treatment for
306 this disease.

307 CDC says HCQ can be prescribed without fear or DANGER to
308 adults and children of all ages. It can be safely used by pregnant
309 women and nursing mothers. People with psoriasis should avoid
310 using it. And the recommended weekly dosage is 400mg.

311 CDC recommends that if you use it continuously (as
312 recommended) for more than five years, you should get regular eye
313 exams.

314 So, what is the basis for all the concern about the DANGER of
315 suggesting HCQ as a treatment for the China-Virus (something
316 that is BEING DONE, by the way! Doctors ARE prescribing this—
317 but the panic is so pervasive, some NON-DOCTOR politicians are
318 PROHIBITING the prescription of HCQ—in Ohio, for example. I
319 know CA "cautions" against it, but I cannot find that it has been
320 prohibited as a doctor's prescription. Your pharmacy might block
321 it though, so, yeah! That's a new thing that has come along. Your
322 pharmacist can deny you filling a prescription from your doctor.
323 So!

324 But, my experience with this sort of thing is that such widespread
325 resistance (and in this case it's all coming from the bureaucratic
326 doctors—and then those in the medical profession who are under
327 their control. But the free doctors are speaking up about this!) But
328 nevertheless, guys like Fauci always at least have some argument
329 supporting their actions — something they can use to SCARE non
330 doctor types who have been absorbed into the hive mentality of
331 STATIST-Think — so I have to ask myself, so, what rational is
332 being used to perpetrate this seemingly IRRATIONAL FEAR and
333 PANIC over anyone daring to suggest such a BENIGN drug as this
334 might be helpful in the treatment of — well, anything?

335 Here it is.

336 HCQ is certainly known to be harmless on its own. "The only
337 credible theory as to why there has even been a concern is that
338 since the beginning, possible treatment options of COVID-19 have
339 always included HCQ in combination with the antibiotic
340 azithromycin. Because each medication independently can cause
341 the same rare heart rhythm disturbance, there has been an
342 academic concern whether the two drugs could be risky when
343 taken together." That's because each of these drugs independently
344 are known to RARELY cause a problem called QT prolongation.
345 What's that?

346 What is QT prolongation? QT is a measurement of heart rhythm
347 on an electrocardiogram. The Q wave indicates the initiation of a
348 beat, let's say, or heart rhythm, and the T wave marks its
349 termination — or something like that. The distance is the
350 measurement from the Q to the T. If this is prolonged it indicates
351 the heart is out of rhythm. That's good enough for my purpose.
352 You won't need to read and interpret QTs so; we're good. So in the
353 rare event that the QT is prolonged, in the even more rare event
354 that this condition becomes sufficiently severe, it can lead to a
355 "fatal rhythm problem called Torsades de Pointes."

356 Now, we notice that this is what is called an "academic concern."
357 What that means is academics, not practitioners, not the people
358 who actually treat patients, but academics look at this and say, well,
359 HCQ can *rarely* cause something called QT prolongation, and
360 azithromycin (AZ) can *rarely* cause it, so, what happens if we
361 combine these medications? Does it exacerbate the DANGER
362 exponentially?

363 Well, guess what? The American Heart Association has answered
364 this specific question, and they published their findings on April
365 29, 2020 — fairly recently. Here is what was found:

366 "In the largest reported cohort (this word seems strange used in
367 this way—but it's proper. It refers to a group taken together and

368 treated as a group—so, In the largest reported group of persons
369 treated for) ... coronavirus disease 2019 to date treated with
370 [HCQ+AZ] **NO INSTANCES OF TORSADES DE POINTES OR**
371 **ARRHYTHMOGENIC DEATH WERE REPORTED."**

372 So, I need to conclude here. Harvey Risch MD, PhD, professor of
373 Epidemiology at Yale School of Public Health, who is published
374 with the Johns Hopkins Bloomberg School of Public Health, with
375 39,779 citations on Google Scholar, rolled up his sleeves and
376 looked into this issue. With regard to the safety of using HCQ with
377 AZ to treat COVID-19. He complains that the FEAR ginned up
378 among some in the medical profession is unwarranted and noted
379 that it appears early evidence supporting the safety of using this
380 regimen were ignored, and cites the 405 Zelenko patients, the 1061
381 Marseilles patients, or the 412 Brazil patients. He concludes the
382 negative conclusions drawn by various professional organizations
383 are "not based on science." He said, "It is unclear why the FDA,
384 NIH, and cardiology societies made their recommendations about
385 HCQ+AZ." He said the combination of these in treatment has been
386 "widespread standard-of-care use in the U.S. and elsewhere for
387 decades." He said something else too — that "this use
388 predominantly in older adults with multiple morbidities, WITH
389 NO SUCH STRIDENT WARNINGS ABOUT THE USE GIVEN
390 DURING THAT TIME." In other words — what's going on here?

391 Why all the hype. What is SOOOOOO dangerous about doctors
392 recommending use of a regimen that is virtually harmless, and
393 according to hundreds of doctors helpful?

394 Can anyone spell — I HATE TRUMP? These people's hatred for
395 Trump, rather, their fear that he will totally undermine their
396 globalist agenda and unravel their plan to bring America to her
397 knees — or, rather, their effort to KILL AMERICAN LIBERTY by
398 pressing their wicked KNEE into our NECKS until we CAN'T
399 BREATHE and finally liberty DIES — they are afraid Trump and

400 his supporters are going to rush these Chauvin's and knock them
401 off liberties neck — so — we — can — BREATHE!

402 I have lit the lamps in the Church belfry arch and now you let me
403 know if you see them. It's LIGHTS ON if you see the LIGHTS ARE
404 ON and you will ride like Revere and spread the warning,
405 (essentially, it means you agree with what I'm saying) or you say
