

- 38 The nature of EVIL—. I've got a surprise for you! Wait for it!!!
- We'll begin with the attack of the Trotskyites
- 40 [TRUTH]
- 41 My Dove—a term of endearment I use for my wife—is a culture
- 42 war hawk. Haha. We have been shopping regularly at Trader Joe's
- 43 for decades—I think we discovered the quaint but cool tropical
- 44 themed store back in about mid to late 70s. We drove into AG to
- 45 walk the aisle and fill our cart with goodies until they opened one
- 46 here in Santa Maria off Bradley at Stowell. The Dove went to shop
- 47 there a few days ago, and dutifully took her place in the line with
- 48 everyone spaced out 6 feet apart. She had her mask ready! She
- 49 knows the rules—wear a mask when you can't social distance—or
- 50 when you enter a commercial or public building.
- 51 Ere long, out came a Trader Joes employee whose task it is to
- 52 inspect the line. It's necessary to enforce the social distancing rule,
- 53 you know. He ordered a few in line to put on their mask. Hmmm!
- 54 That's odd! We are OUTSIDE, and SIX FEET APART—Becky
- 55 thought.

- 56 When he came to Mrs. Scheidbach, he ordered her to put on her
- 57 mask. She refused: I'm outside, and social distancing, I'll put the
- 58 mask on when I enter your store.
- 59 But the rules for mask wearing keep changing—and the changes
- 60 are consistently in the direction of greater and greater
- 61 restrictions—ever tightening the squeeze. (They want you to FEEL
- 62 their power to control you!) Up until recently, CDC said wear a
- mask when you can't social distance. Now they CDC website says,
- 64 "CDC recommends that people wear masks in public settings and
- 65 when around people who don't live in your household,
- 66 ESPECIALLY WHEN OTHER SOCIAL DISTANCING
- 67 MEASURES ARE DIFFICULT TO MAINTAIN." So, what does
- 68 that mean?
- 69 First, it's a RECOMMENDATION, because, of course, the CDC
- 70 can't DEMAND or REQUIRE any such thing. Second, if I am to
- 71 wear a mask in public, but ESPECIALLY so when SOCIAL
- 72 DISTANCING is difficult—then, if SOCIAL DISTANCING is
- 73 reasonably easy to maintain, then, in that case, I do not need to be
- 74 ESPECIALLY CONCERNED ABOUT IT?
- 75 Nevertheless, we certainly believe in private property and respect
- 76 the right of proprietors to "refuse service to anyone" so if a
- 77 storeowner wants go all mask Nazi—well, okay! So, the Trader Joes
- 78 line patrol employee says, "well, I guess you can talk to the
- 79 manager." And Mr. Scheidbach said, sure! So, the Trader Joes
- 80 manager comes out and instructs Mrs. Scheidbach to put on her
- 81 mask. Becky explained to the manager of Trader Joes in Santa
- 82 Maria that she was social distancing, and OUTSIDE and had
- 83 difficulty breathing through the masks, and that she would put it
- 84 on before she entered the store.
- Now, here is where the manager should have paid closer attention.
- 86 You see, CDC recommendations include an exception for people
- 87 who have trouble breathing. Some people have issues in masks—

- 88 they get faint is they have to wear them for a long time. My wife is
- 89 one of those people.
- 90 The manager said, "well, I guess you can shop ELSEWHERE." Mrs.
- 91 Scheidbach said, "That I can do!" So-Trader Joes is off the
- 92 shopping list for the Scheidbach household. After I heard the story,
- 93 I remembered the many conversations I had with Russian believers
- 94 after the fall of the Berlin wall—this is how they lived every day.
- 95 Communist party neighborhood spies would police their
- 96 communities. Walking lines to make certain everyone was IN
- 97 COMPLIANCE. The self appointed and government encouraged
- 98 Communist Compliance Constabularies spying on their
- 99 neighbors and sometimes policing them. So I called Trader Joes,
- 100 Trotsky Joes in honor of his efforts to impose conformity on
- 101 Russians—everyone dress the same, talk the same—Trotsky Joes —
- be careful what you say, be careful what you wear, a Trotskyite will
- report you and you'll be disappeared. Oh, wait, that's a China thing.
- Well, Communism you know, same thing! In fact, I think China
- learned it from Lenin.
- 106 The Democrat party is divided between the Alinskyites and the
- 107 Trotskyites.
- 108 Trotskyism as a political/economic philosophy named after Lev
- 109 Davidovich Bronstein, aka, Leon Trotsky. His given name betrayed
- 110 his Jewish ancestry and that made some Bolsheviks uncomfortable.
- 111 Yeah, Trotsky, another Jew that embraced a social movement that
- 112 hates Jews. Trotsky was a Communist/Socialist leader of the
- 113 Bolshevik Revolution. His brand of revolution included elements
- of anarchy: the use of violence to advance Socialism. So, hmmm?
- 115 Maybe Trotsky Joes is not quite right—anarchy is supposed to be a
- 116 movement against law or rules—whereas Nazism is all about
- 117 conformity to the imposed rules from heir Hitler—der Fuhrer—
- 118 you know, the Pope, Newsome—you know, divine right of kings
- 119 and all of that.

- 120 So, Nazi Joe well, an American soldier is called G.I. Joe and the
- 121 Germans were called Jerrys (now, that's a weird one. Developed in
- 122 WWI—most think it was a sort of patronym from the national
- 123 name German—a "gerry." Some think it was taken from the helmet
- 124 the Germans wore, because it resembled a chamber pot, called a
- 125 Jeroboam. Now, that's weird! But I can't go on with this). So,
- 126 Trader Joes is an American store, okay, so, American Nazis —
- 127 yeah, that works.
- 128 But the fact is, although Trotsky advocated for promoting his
- 129 socialist agenda through violent overthrow of the existing order—
- 130 the aim was to replace it with a new ORDER with all sorts of
- 131 ORDERS and Trotskyites were well known for ORDERING
- 132 PEOPLE AROUND—subordinating the individual to the
- 133 COLLECTIVE and so TROTSKY JOES.
- Now, I tell you this little story because this mask thing is getting
- out of control—and it's all about control. Fauci never has told us
- what he learned about masks that he did not know before. He told
- 137 us Americans don't need to go around wearing masks, and he told
- us masks are "mostly symbolic," and admitted that essentially they
- serve to remind you there is a pandemic, and admitted the efficacy
- 140 of the masks CDC is recommending is questionable, that for all
- 141 their talk about masks effectively blocking "particles" in EVERY
- 142 SCIENTIFIC study I've read the surgical masks are ineffective
- 143 against nano-particles. FRIEND, THE CLOTH COVERING
- 144 RECOMMENDED BY CDC WILL NOT PROTECT YOU FROM
- 145 TRANSMITTING OR CONTRACTING COVID-19. Anyone who
- tells you otherwise is a LIAR or a Troglodyte.
- I can't take the time now to repeat all the research I've already done
- 148 debunking the efficacy of masks to protect you from something
- that is so small it moves through a cloth mask like a grain of sand
- 150 through a chain link fence—nor do I have time at present to
- 151 discuss ongoing struggle in the "underground health workers

- 152 rebellion" against the LIES being used to push us toward a
- 153 communist/socialist state where Governors can declare a crises and
- 154 then usurp your inalienable rights—or how the MASK IS
- 155 SYMBOLIC OF OPPRESSION. But hey, here is where this is going.
- 156 In Idaho, three citizens were arrested because they refused to put
- on a mask when outside. Here is story about a mother who refused
- 158 to put on a mask, and when she resisted being arrested she was
- 159 tased.
- 160 So now they are tasing people, and arresting people, and
- storeowners, at least Trader Joes in Santa Maria, are telling you to
- 162 SHOP ELSEWHERE.
- 163 Friend, someone needs to stand up to these mask Nazis! And I
- think it would be unfair to suggest all Trader Joes are Trotskyites
- but the manager in the Santa Maria store certainly is.
- Okay, my friend. Hold on through the break. I'll be right back.
- 167 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
- 168 at the Lighthouse, your brain masseur, and Paul Revere's lantern
- lighter, lighting the lamps in the church belfry arch, signaling the
- 170 enemy is on the march, an enemy that would steal from us our
- 171 liberty.
- 172 Andy Caldwell for Congress—he has the much-coveted
- 173 endorsement of the Brain Masseur! Hehe. But really! Andy
- 174 Caldwell is a good man, a sold conservative; I believe we can trust
- 175 him to represent us faithfully in the Congress and support Trump
- in making America great again, again!
- 177 And Jordan Cunningham! He has my vote! Did you hear the ad
- that lib chic is running against him? She represents herself as a true
- liberal, and Cunningham as, well, not! After describing herself as
- 180 being pro-abortion, and anti-business, and explaining that
- 181 Cunningham is pro-life and pro-business—she says, in her drippy
- sort of liberal condescending tone, that "this does not make Jordan

- 183 Cunningham a bad person. It only means that Jordan Cunningham
- does not represent our Central Coast Values. So, she wrote the
- book on Central Coast Values? She is the arbiter of Central Coast
- 186 Values. If you want to know what Central Coast Values are, you
- 187 will to ask her—because apparently, she is the embodiment of
- 188 those values. This is so typical of liberals. Arrogant! What an
- arrogant presumption! There are a great many conservatives on the
- 190 Central Coast—I'm among them! How dare she suggest that my
- moral values are outside of what she calls "Central Coast Values."
- 192 I'm so sick of these people, and their arrogant presumption that
- 193 they are the measure of goodness—promoting the murder of
- 194 infants in the womb is not a VALUE of the Central Coast. It's
- something Liberals embrace and conservatives reject. Both liberals
- and conservatives live on the Central Coast.
- 197 Liberals think the world is defined by their opinions and those of
- 198 their friends. What makes her think she gets to decide what are
- 199 CENTRAL COAST VALUES? Here is the thing. I want the values
- of a Jordan Cunningham representing us, not hers.
- 201 DEMS make course adjustment on mail in ballot thingy. Why? All
- 202 along the Dems have been driving hard on the mail in ballot
- 203 scheme—I mean, it was a major part of their campaign strategy. I
- 204 have prayed about this fervently, and so have many of you! I've
- been praying God will reveal any effort to steal this election by
- voter fraud. Right after we started praying, one story after another
- 207 popped up exposing the vulnerability of mail in ballots to fraud. I
- 208 mean Democrats are going to jail over this. I've also been praying
- 209 Trump's team will tool up in preparation for this and of course,
- 210 Trump is smart and he could see this coming and I learned
- 211 recently that he has taken steps to prepare.
- 212 Trump and the Democrats know this election is very likely going to
- 213 end up in the Court and his team is ready to challenge the election
- in court if the Dems go forward with their mail-in ballot scheme.

- 215 But the Left knew that anyway. I mean it's not news to them that
- 216 Trump was preparing to litigate—in fact that was the plan! The
- 217 Dems wanted to foul the ballot in order to push the election into
- 218 court. If they could stack the ballots sufficiently to win in the
- 219 Electoral College, Trump would litigate—. And if they lost in spite
- 220 of their fraud attempts—using all those government paid teachers
- 221 working hard to fill in ballots shipped in from China, and Russia —

- Barrett or Lagoa? It appears it comes down to these two. Why? Has
- there been a leak? Did Trump even say these two were on his short
- list? Actually, no! We will find out Saturday who he picked. Trump
- 236 has finally figured out who he can trust in the WH—another
- 237 something I've been praying fervently about. So it's 100%
- 238 speculation—but it seems to me well founded, except, I think the
- 239 Left is pushing for Lagoa and the lesser of two conservatives.
- 240 (Which, of course, the left equates with evil. and I'm looking at
- 241 my time and, yeah, probably not going to get to that.)
- 242 The LEFT is targeting Amy Coney Barrett. They are saying nothing
- 243 about Lagoa.
- 244 Lagoa was confirmed to the 11th circuit by 80% of the Senate—that
- 245 means a whole lot of DEMS were happy to confirm her. Feinstein
- 246 gladly endorsed her confirmation. By contrast, Amy Coney Barrett

- 247 was confirmed to the 7th circuit by a vote of 55-43, which is a
- virtual party line vote. Only 3 Dems voted for her. But Lagoa's
- 249 appointment to the 11th circuit court received the support of all
- 250 the Republicans, 26 Dems, and the liberal Independent.
- Of course, this does not mean Lagoa is liberal—it just means she
- 252 has a lot of liberal support. Like John Roberts—who was appointed
- 253 to the Court by a vote of 78-22. Very interestink!
- 254 Many would think Lagoa's ability to garner liberal support would
- 255 be a good thing in another world! But not in this one! Liberals
- are Communists today! That party is gone! It's sad, but it's true that
- 257 Democrats don't vote for conservatives on the court unless they
- smell some liberal sympathies in them—like Roberts.
- Notice that right now all Left media is saying Lagoa would be a
- 260 tough customer for the Democrats to attack, hard to attack a
- 261 Latina, etc. (These people are liars. Don't believe a word of this.)
- 262 Barrett, on the other hand, is getting all the attention from the
- 263 LEFT. We are being told she is a member of some Christian cult—
- 264 that she is the inspiration for a book titled A Handmaiden's Tale—
- 265 and, what's that about? —
- Well, here is a synopsis: "A religion-based autocracy has taken over
- 267 most of the United States, renaming the country Gilead." Where
- 268 "women are second-class citizens."— by Grantss
- 269 Kenneth Chisholm says The Handmaid's Tale is "set in a dystopian
- 270 future, a woman is forced to live as a concubine under a
- 271 FUNDAMENTALIST THEOCRATIC DICTATORSHIP."
- 272 The left is already prepping for their attack—a warning to Trump
- and to Barrett of what they'll get? While at the same time sending
- the message, "oh, but Lagoa, now, she will be a tough customer for
- 275 us to handle." What bunch of Jeroboam bucket stuff! Barrett is a
- 276 WOMAN and that's supposed to be sacrosanct among Liberals,
- 277 right? Clarence Thomas is Black—remember what they did to him?

- 278 It's not about color or gender—it's about one thing! POWER TO
- 279 ADVANCE THEIR AGENDA TO FUNDAMENTALLY
- 280 TRANSFORM AMERICA INTO A VENEZUELA TO
- 281 SURRENDER AMERICA TO CHINA TO FOLD THE US
- 282 INTO A ONE WORLD ORDER UNDER THE POWER OF THE
- 283 MAN IN THE SHADOWS THAT CONTROLS SOROS.
- All right! I need to move toward a wrap! So much to talk about, so
- 285 little time. Trump finally agrees to concede the election. (Haha)
- Headlines soon to follow: Trump Agrees to Concede the Election.
- 287 Media response to Trump's refusal to make a promise to concede—
