Brain Massage[®]: Show No. 805 The Adonijah Coup / Evidence & Proof—Are "They" Are Trying to Steal This Election?

- 1 Segment.01 Hello. I'm Dr. Jerry Scheidbach, pastor of the
- 2 Lighthouse Baptist Church in Santa Maria, CA—and your brain
- 3 masseur—get ready for your brain massage.
- 4 Well, well! It's TRAITORS versus PATRIOTS. THEY versus
- 5 WE THE PEOPLE! But all is WELL with my SOUL! God threw His
- 6 boulders at the enemy of liberty. King Jesus set His grip upon HIS
- 7 SWORD and turned it upon the WICKED! They are scattering. I'll
- 8 explain!
- 9 As we talk about "servers" and treason! About Georgia exploding!
- 10 About Never-Trumpers crawling on their knees to Trump
- 11 Supporters NO GOP without TRUMP!
- 12 Trump wins America wins but the BATTLE FOR AMERICA
- 13 WILL CONTINUE! The Adonijah conspiracy will fail because the
- 14 KING will PREVAIL.
- 15 Democrats call Thanksgiving a myth! They hate God, and
- 16 Thanksgiving is one of the godliest holidays on our calendar, so I'm
- 17 not surprised. The children of disobedience rose in great force to
- 18 overwhelm us and cower us, and STEAL OUR LIBERTIES. But,
- 19 don't despair. KING JESUS RULES!
- 20 Okay, we probably won't get to the newest revelations, the latest
- 21 scientific studies showing masks are not only ineffective as a
- 22 preventative of air-born virus infections, but actually HARMFUL
- 23 to our health, and likely to INCREASE exposure rather than
- 24 decrease it. I'll cover that in a VISIT but today, I want to do my
- 25 best to help you understand what Dominion does not want you to
- 26 know about their voting machines.
- 27 It's time for your Brain Massage.

28 [TRUTH]

- FIRST: Dominion refused to appear before the PA congress to 29 testify. They were invited to offer an explanation for the anomalies 30 31 discovered in the vote. Stuff we've been hearing about—well, that is 32 if you listen to REAL NEWS—if you are hiding in the FAKE 33 NEWS BUBBLE you probably don't know anything concrete about 34 any of this, and have been programmed to simply repeat to 35 yourself over and over—no voter fraud—no voter fraud—nothing to see here—no evidence of voter fraud—and not enough voter 36 37 fraud to change the outcome—no hard evidence—and you can 38 trust the results because "robust safeguards" are in place to insure a 39 fair and honest election—(or something like that. I noticed FB is 40 not posting that one, at least after looking about twenty posts 41 where I would expect to see that notice. I found only the one that takes you to a page where BIDEN is the PROJECTED WINNER— 42 43 with articles headed *How Biden Won!* and so forth).
- 44 So—why did Dominion at first agree to testify before the PA 45 congress, to answer questions about the integrity of their voting machines, and then at the last minute bail out! Actually, run and 46 47 hide. Yeah! They are turning tail and literally fleeing the 48 jurisdiction — meaning they are removing themselves from the reach of the LAW. They are lawyering up! They are closing offices 49 and moving out! Reports are of some fleeing the country. 50 51 Dominion is on the run. (The KING has pointed His SWORD at 52 them—He poked them—their eyes opened to SEE the JUSTICE COMIN FOR THEM. 53
- 54 Sidney Powell tells us some Dominion employees have sworn
- 55 affidavits testifying to corruption of Dominion Election Systems.
- 56 Those of us who do not have our heads stuck in the shifting sands
- of FAKE NEWS are getting the TRUTH, and the truth that sets you
- free keeps you FREE!

- 59 So, by way of introduction to my discussion of how these voting
- 60 machines were used to steal the election—first, did you hear about
- 61 Dominion agreeing to testify before the PA congress, but then
- 62 cancelled and now they are no where to be found? Why would they
- do that? If Dominion has nothing to hide, why are they hiding?
- 64 SECOND: The scuttlebutt has been that Dominion voting
- 65 machines, along with the others that use software called
- 66 Smartmatic, send our votes to an offshore server. The votes are
- 67 stored on that offshore server, and tabulation results are kicked
- 68 back to the American machines. That was scuttlebutt! Rumors!
- 69 Those rumors have been verified. The servers have been seized. It
- 70 was discovered that the CIA owned these servers. Yep! These
- 71 servers that were kept in Frankfurt, Germany, were CIA servers.
- 72 You know these servers were put in place by CIA, under guys like
- 73 Brennan, during the OBAMA years! That's who I mean by
- 74 "THEY." They are TRAITORS—who violated their oath to defend
- 75 the Constitution, you know, that old outdated document drafted
- 76 by dead white men. These are the BAD GUYS. "WE" on the other
- 77 hand refers to "WE THE PEOPLE," PATRIOTS, lovers of America
- as founded, defenders of the Constitution—protectors of liberty.
- WE are the good guys.
- 80 Earlier, when this rumor rolled out, my friend and fellow
- 81 PATRIOT Matt Morgret informed me it was at that time a rumor
- 82 and said if it's true, we don't know whether the good guys in our
- 83 government got them, or the bad guys. Then Sidney Powell was
- 84 asked whether such a server existed and if it had been seized. She
- 85 verified the servers were seized but expressed concern that at that
- time she was unsure whether THEY got them, or WE got them.
- 87 Today we received confirmation that WE GOT THEM. They are in
- 88 the possession of our DOJ and under the provenance of our
- 89 President—America friendly forces have them!

90 Included in the earlier scuttlebutt, the rumor circulated from 91 highly reputable sources, according to Louis Gohmert about a 92 week or so ago, included revelations about this election found on 93 the servers. The data from the servers show that TRUMP won by a 94 Tsunami — 400+ Electoral Votes. This is not yet confirmed! WE now know the servers exist, that they were part of a CIA plot to 95 96 control our elections, and that they are under the control of 97 AMERICA FRIENDLY FORCES — but the contents of the servers 98 is not yet made public. If this part of the earlier leaked report 99 proves true, it will prove that what is going on in America right 100 now is a COUP by election FRAUD, an effort to STEAL our 101 ELECTION — to disenfranchise the American voter — to take 102 away our RIGHT TO CHOSE OUR LEADERS — to turn us into a 103 Venezuela — to bring WE THE PEOPLE under a socialist dictatorship, you know, like what we have in CA under Newsome 104 (haha. Well, that's not far off!) 105

So, first, the questions raised by the impossible anomalies we have 106 107 found in PA, MI, WI, GA, NV and possibly also AZ, related to the Dominion voting machines used in these states were supposed to 108 be answered by Dominion officials—they were scheduled to testify 109 110 before the PA congress—but at the last minute cancelled and 111 scattered. They are emptying offices, no doubt trying to destroy as 112 much evidence as they can, and running to hide. If they have nothing to hide, why are they hiding? 113

114 Second, we now KNOW for a FACT that our votes were sent to be 115 stored on an offshore server. (These are kept, no doubt, to secure leverage over the politicians they PUT INTO OFFICE.) We know 116 that these were CIA owned servers, meaning the OBAMA CIA -117 the DEEP STATE CIA were involved in this operation. And now 118 119 we know that WE got the servers from THEM. America has seized 120 the COMMUNISTS servers where the true election results are 121 stored.

- Now we wait for the confirmation that the real election results
- verify what WE all know intuitively, what WE all know from every
- 124 empirical witness to this election that TRUMP WON IN A
- 125 LANDSLIDE and that the DEMONCRATS tried to STEAL this
- 126 election—tried to STEAL AMERICA. Tried to STEAL FROM US
- 127 OUR LIBERTIES.
- 128 And THIRD: The Adonijah conspiracy will fail because the KING
- 129 will PREVAIL. I Kings 1 at the transition of power at the time of
- 130 king David's passing. The throne was promised to Solomon, but
- one of his older half-brothers decided to declare himself king. He
- 132 hired fifty men to run before him declaring ADONIJAH is KING,
- 133 he succeeded at getting Joab, general of the Army to side with him,
- and almost all other key people in the government to get behind
- his effort to pull off a coup but Nathan the Prophet went to
- 136 Solomon's mother, Bathsheba, and warned her, explaining that if
- 137 Adonijah succeeds, it will mean her life and the life of her son,
- 138 Solomon. He advised Bathsheba to go in to king David and inform
- 139 him of what was going on. And when she did, Nathan came in
- behind her and confirmed that Adonijah had attempted to steal the
- 141 THRONE. Virtually all the kingdom thought Adonijah had been
- 142 dutifully anointed to be king until king David declared
- 143 SOLOMON would be king. And that ended the COUP and they all
- scattered in fear.
- 145 Biden has been DECLARED President by the AP (when I read that
- 146 I laughed out loud). Biden has the backing of almost all the
- "leadership" in the government, all the DEEP STATE supports him.
- But the prophet of God has alerted the BRIDE of the KING and the
- 149 BRIDE of the KING has gone before HIS THRONE and petitioned
- 150 Him to RULE on the MATTER and the people of GOD have
- 151 cried to the KING our KING is JESUS and JESUS is the
- 152 ultimate authority who sets up kingdoms and brings them down,
- 153 He is the ultimate authority who appoints over the kingdom

- 154 whosoever He will And KING JESUS is the authority over the
- 155 SWORD of CIVIL JUSTICE ordained by HIM to execute WRATH
- 156 upon EVIL DOERS and His CHURCH has pled for MERCY —
- and with it JUSTICE, JUDGMENT and EQUITY to PREVAIL.
- 158 And no sooner did we pray JESUS would step in and RULE in this
- 159 matter, and take the SWORD that is HIS and point it at the evil
- 160 doers trying to steal this election than suddenly it comes out
- 161 that in fact the WICKED HAVE BEEN SERVED NOTICE TO
- 162 THEIR EVIL CONSCIENCE THAT JUSTICE IS STIRRING,
- 163 JUDGMENT IS COMING.
- 164 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
- at the Lighthouse, your brain masseur, and Paul Revere's lantern
- lighter, lighting the lamps in the church belfry arch, signaling the
- 167 enemy is on the march, an enemy that would steal from us our
- liberty.
- 169 The voter machine scandal is centered on a company called
- 170 Dominion Election Services. There are other companies involved
- 171 in this, but Providence has ordained that the scandal will be
- 172 centered on a company that is almost always referred to by one
- 173 word—DOMINION.
- 174 Those who have read my book, God's WAR: Why Christians
- 175 Should Rule the World the case for Christian involvement in
- 176 every sphere of civic and social life understand why that is
- interesting. It's all about a battle over *the dominion* which in the
- Bible is defined as control of the resources of this planet, and the
- power of the SWORD—the power to enforce LAW. The wicked
- 180 want to control the resources of the Earth and they want the power
- 181 of the SWORD to use FORCE and VIOLENCE to hold it, and
- bring all mankind under their power.
- 183 DOMINION voting machines were designed specifically to TAKE
- 184 kingdoms by VIOLENCE (violation of law) to gain power over the

- 185 SWORD to use it to OPPRESS THE PEOPLE and CONTROL THE
- 186 RESOURCES OF THE EARTH to SERVE the interests of the
- 187 ELITES.
- 188 So, let's talk about how this works. Understand that my
- presentation is purposely not technical—it is a summation of the
- 190 technical information available right now explaining how these
- machines are used to steal elections.
- 192 But before we get started, you need to understand the difference
- between evidence and proof. PROOF in a court of law should not be
- 194 confused with what is called *PROOF* in a scientific study.
- 195 When speaking casually, we will often confuse these things.
- 196 Evidence provides compelling support for a conclusion in a legal
- matter, and it is not required to carry the burden of what we would
- 198 call scientific PROOF. Let me explain.
- 199 In science, you begin with a reasonable hypothesis, and contrive an
- 200 experiment to test it. If the experiment verifies the hypothesis, and
- 201 the experiment can be replicated with consistent results, this is
- then regarded as proved.
- 203 In legal matters, it's different. What is required is not the sort of
- 204 "proof" you must demand in a scientific study. What is required is
- 205 EVIDENCE that is first and foremost TRUTHFUL and then
- 206 evidence that compels any reasonable mind to accept a certain
- 207 conclusion as TRUE.
- 208 In other words, we have a former General in the Venezuelan Army
- 209 that swears an affidavit that he heard and saw Chavez make a deal
- 210 with smartmatics to create voting software that would manipulate
- 211 the votes to insure victory for Chavez—or any candidate, or other
- 212 matter put to the vote in his country. We were not there! So his
- 213 testimony is not PROOF. But if you were there, your testimony
- 214 would not be proof either. But it is EVIDENCE. What has to
- 215 happen is the EVIDENCE must to be tested for its veracity, which

- often comes down to three things: 1. the veracity and integrity of
- 217 the witness; 2. the absence of any other evidence contradicting his
- 218 testimony; 3. the presence of corroborating evidence supporting
- 219 the testimony. So, friend, all these affidavits ARE EVIDENCE!
- 220 This is not a scientific experiment attempting to prove masks are
- 221 effective in preventing viral infection (haha uh, by the way, there
- are NONE!). We are talking about EVIDENCE that DEMANDS A
- 223 VERDICT.
- No one with any sense at all can look at all that we are discovering
- in the way of FACTS and conclude there is nothing to see here. On
- the contrary, it's OBVIOUS there is SOMETHING GOING ON
- and it must be looked into.
- 228 Doing this, we take TESTIMONY from people who are first hand
- 229 witnesses to the sorts of things that EXPLAIN the weird stuff that
- 230 we KNOW happened.
- 231 That evidence must be measured for veracity—are the witnesses
- 232 persons of integrity? Is there any evidence that contradicts the
- 233 testimony and does it come from a reliable witness or established
- facts? Is there any evidence that corroborates the testimony in the
- 235 way of FACTS or further TESTIMONY of WITNESSES? That's the
- 236 difference between evidence and proof. Only an unreasonable
- 237 person would demand scientific proof before any verdict could be
- rendered on a preponderance of EVIDENCE.
- 239 By the way, plausible deniability is something the wicked use all the
- 240 time to skirt justice but when the EVIDENCE is overwhelming,
- 241 when it reaches something called a preponderance of evidence, it
- becomes increasingly clear the plausibility of their denials collapses
- 243 and the TRUTH is seen CLEARLY. A preponderance of solid
- 244 evidence overwhelms plausible deniability and makes it an
- implausible denial. That's what we HAVE!

- However, now that we have the servers, this can provide hard evidence supporting the testimony. But, you do realize this is not
- 248 "PROOF" unless we can replicate the whole thing, and then how
- 249 do you PROVE who contrived to do all this? And then ... you get
- 250 the idea. It will be done on the basis of witnesses, whose testimony
- 251 is corroborated by facts. In other words, we have witnesses, then
- 252 we have in our possession a machine we can show has stored in it
- 253 all the original voting data, and from that data we can show that
- 254 Trump won the election—it's still not the same level of PROOF
- 255 demanded in a scientific study—but it's very close to that—it
- 256 provides an preponderance of EVIDENCE that ALOWS for only
- 257 ONE REASONABLE VERDICT—someone tried to steal this
- election, TRUMP WON BY A LANDSLIDE. From here, the DOJ
- 259 has to go to work finding all the scoundrels that participated in this
- 260 effort to steal our election and prosecute them.
- But that's a separate thing. We don't have to know everyone who
- 262 participated in the fraud to know fraud occurred, we only need a
- 263 preponderance of solid EVIDENCE that convinces a REASONBLE
- 264 mind to demand: 1. Declare Trump the victor; 2. Hand count every
- 265 disputed state; 3. Redo the entire election.
- Now, let's look at the evidence that the machines used in America
- are prone to abuse by bad actors, and evidence that they were in
- 268 fact used to steal an election in America.
- 269 FIRST: Dominion makes the voting machines used in 28 States in
- America. All the states where the election is disputed are Democrat
- 271 run states that use these machines. The software used in these
- 272 machines comes from Smartmatics. Without following the
- 273 intriguing twists and turns in the origins and the history of
- ownership of these companies, let's summarize:
- 275 Smartmatics created an Election Management System (EMS)
- 276 software for the former Venezuelan president, Hugo Chavez,
- 277 which was designed to guarantee he would never lose another

- 278 election. Chavez used it to steal every subsequent election and used 279 his usurped power to destroy that once great country. We refer to the software as Smartmatics—it was designed to steal elections. 280 281 The software sends the data to an offshore server, where the original data is stored. During the early years of operation this 282 283 server was kept in Barcelona, Spain. But our CIA deep state 284 operatives placed the servers in Frankfurt, Germany. This was 285 insurance, allowing whoever held this data control over the 286 persons in office who benefited from what is next. Back to the 287 voting machines in America. These machines using this software 288 were designed with certain features that allowed the DNC to steal 289 our elections. One of their special features was vote flipping taking a vote from one candidate and giving it to another. There 290 291 are other vulnerabilities, but I have to summarize, so, we'll look at 292 vote flipping.
- Smartmatic is now owned by "a company whose Chairman is Lord
- 294 Mark Malloch-Brown. He sits on the House of Lords in England
- 295 and on the BOARD OF GEORGE SOROS' OPEN SOCIETY
- 296 FOUNDATIONS. He has been with Soros for a while before this
- 297 gig, he was "vice-chairman of Soros' Investment Funds." (IBID).
- 298 This is the software that is used in the Dominion voting machines
- in America.
- Now, let's talk about the company that makes machine in question:
- 301 Dominion.
- 302 We know Dominion was founded in 2003 by a company in
- 303 Toronto, Canada, and that in 2009, headquaters were set up in
- 304 America, in Denver, Colorado. This company was founded to
- 305 make machines that count votes.

- 306 These machines are made with components made in China. Just
- 307 saying!
- 308 Before the midterms in 2018, Dominion was acquired by a New
- 309 York based hedge fund company called Staple Street Capital. "A
- 310 former ambassador named by former President Barack Obama sits
- 311 on the board."²
- 312 The vulnerabilities of Dominion voting machines are well known
- and documented. Anyone taking the time to give just a little bit
- 314 more than a casual look into this company and this machine, with
- 315 its software, would see the red flags raised about the multiple
- 316 vulnerabilities of these machines to abuse, to be used to perpetrate
- voter fraud. It's as obvious as the vulnerabilities of abuse inherent
- 318 to mail in ballots.
- 319 But really, Democrats are on record having raised red flags
- 320 concerning Dominion voting machines as early as 2016. Experts in
- 321 the field have written extensively exposing the problems with these
- machines. But in 2018, apparently, the DNC decided to make use
- 323 of these machines to re-secure their power over America by
- 324 stealing from the PEOPLE their RIGHT TO CHOOSE THEIR
- 325 LEADERS. Because in 2018, an Obama operative was put in
- 326 charge of the company that acquired Dominion: Staple Street
- 327 Capital.
- 328 At least Texas did due diligence when looking at this machine and
- 329 because of the irregularities and voting problems associated with
- 330 the vulnerabilities of these machines they declined to use them.
- 331 Trump won Texas handily.
- When we explore the question, why would any state use Dominion
- voting machines we find that very intense pressure from top DNC

- operatives in Blue States, together with bribes and intimidation,
- 335 were used to get these State election boards to look the other way
- 336 and deploy these faulty machines in their states. And
- 337 EVERYWHERE we have a problem it's where THESE MACHINES
- 338 were used.
- 339 Then we come to the sworn testimony of Russ Ramsdale—on the
- 340 management team of Allied Security Operations Group, LLC, a
- 341 company that specializes in cyber security. The people that deal
- with hacking issues, and protecting digital data, and stuff like that.
- 343 In November of 2018, his group was approached by Dallas, Texas
- 344 with concerns about a company that uses Smartmatics based
- 345 software in their vote counting machines built by ES&S (Election
- 346 Systems & Software.) They found problems, and showed that the
- 347 vulnerabilities of the software were exploited. This led to various
- 348 legal challenges against the election and the flipping of some
- 349 contests.
- Ramsdale's company decided to look more deeply into this matter,
- and conducted an 18 months study into the Election Management
- 352 System services used in Michigan, where they used the Dominion
- 353 machines. They looked at the machines used for the 2020 election
- and verified they still had the same vulnerabilities noted before.
- 355 They documented that these systems contain a large number of
- 356 vulnerabilities to hacking, tampering allowing hackers to
- 357 manipulate votes, to switch them, to add votes that then the
- operators have to provide ballots to cover.
- Now, I've run out of time, so let me conclude with this.
- Ramsland provides very disturbing evidence that the 2020 election
- 361 was manipulated by these computers and the offshore server. I
- 362 hope I can explain this in a manner easy to follow; it's better if you
- 363 can see it. But, here goes.

- 364 CNN was reporting on the count in real time as it came in. They
- 365 had their screen set up with their talkers and beside them an inset
- 366 window showing the results as they came in. This was the race
- 367 between Democrat Beshear and Republican Bevin. I'll just say
- 368 Democrat and Republican from here on to make it simpler.
- 369 The window showed the Democrat with 673,948 votes and the
- Republican with 662,235 votes. About 12k vote spread.
- 371 Also along the bottom of the CNN screen you could see the crawl
- 372 ribbon where the information appears in a ribbon along the
- bottom, and then updates as information changes.
- 374 At this point, the numbers matched—the Democrat number in the
- window matched the number in the ribbon, and likewise for the
- 376 Republican. Got it so far? Good!
- 377 Suddenly, an update occurred, and the window on the screen
- 378 flashed but before you could focus on it, it disappeared and the
- 379 talking head filled the screen. And as he talked, the ribbon was
- 380 updated as he announced the new number for the Democrat —
- 381 vote count increased by 560 votes. Then it went back to the screen
- they had been using, with the inset in the main window, and you
- 383 could see that, once again, the numbers in the window matched the
- 384 updated numbers in the ribbon.
- 385 Ramsdale noticed something—he noticed that the Republicans
- numbers went DOWN? How can that happen?
- 387 So he went back screen by screen to when the updated window
- 388 flashed and then disappeared, and he froze it.
- 389 Amazing! The numbers in the window were updated before the
- 390 ribbon was updated. And because of that, you could see that the
- Republican's vote count in the window no longer matched that
- 392 displayed on the ribbon.

- 393 What???? But, yeah! And guess what? The Democrat gained 560
- votes, and the Republican LOST 560 votes that only happens if
- 395 someone manipulated the machines sending these updates so it
- 396 took 560 votes from the Republican and gave them to the
- 397 Democrat. That's not a "GLITCH" friend! That's a FEATURE of
- 398 Dominion voting machine software that was working exactly
- 399 like it was created to work. The DNC are so panicked about losing
- 400 power right now, for reasons I think you can appreciate, that they
- 401 are willing to DO ANYTHING to regain power. I said
