- 1 Segment.01 Hello. I'm Dr. Jerry Scheidbach, pastor of the
- 2 Lighthouse Baptist Church in Santa Maria, CA—and your brain
- 3 masseur—get ready for your brain massage.
- 4 We had a WONDERFUL time with Pastor Marshal Stevens,
- 5 faithful supporter of the Brain Massage show, and Calvary Baptist
- 6 Church for the Home Missions Conference raised close to 50k

- 10 It's getting increasingly intense as we approach the tape. I
- 11 remember running a Cross Country race and they had a funnel
- 12 that forced the track to narrow down to allow only one runner in
- 13 the lane—as I approached, I was gaining on two runners ahead of
- 14 me and they tried to block me out I had to maneuver cleverly
- and use my elbows and watch my footing to wrestle through the
- 16 blockade and get into the funnel ahead of them. That's where we
- are right now—it's time to throw elbows boys!
- 18 The battle for America is ON! The SMOKING Gun video—the
- 19 SMOKING GUN Truck Driver's Testimony hauling completed
- 20 ballots across state lines—the Kemp shuffle—summarizing and
- 21 making sense of the Dominion scandal<sup>1</sup>—a look at Georgia and the
- 22 hearing held Thursday—the FOLDERS and the SOLDIERS—praise
- 23 God, Trump is a SOLDIER and not a FOLDER!
- 24 And with all of this going on, Trump continues to get his job done!
- 25 Spanks China for "capitalizing" on "slave labor" to are you ready
- 26 for this "pick their cotton." Boom!

- 27 It's time for your Brain Massage.
- 28 [TRUTH]
- 29 The Battle for America is ON!
- 30 See that smoke swirling up over there in Georgia? That's the
- 31 smoking gun!
- 32 Thank you Matt Morgret for feeding me articles and videos that
- 33 keep me abreast of developments, my dearly beloved Dove who
- 34 tracks news all week and feeds articles and videos she knows I'll
- 35 want to see, the Masons who do a great job watching for news the
- 36 Brain Masseur can use and all of these always attach links to
- 37 articles and to documentation that helps me follow up and follow
- 38 through. Of course, I personally check it all out, and research the
- 39 material I bring forward on this show—and lay it all out from a
- 40 Biblical perspective—dedicated to the TRUTH!
- 41 Did you see the smoking gun video? I've watched it several times.
- 42 In case you have not seen it, and to provide context for what
- 43 insights follow—let's take a look.
- 44 Okay, this is a developing story but here is what we know at
- 45 present. Lin Wood obtained the video. He filed suit in the U.S.
- 46 District Court of Northern Georgia on Monday (November 23)
- 47 and he won a subpoena to demand the executive president and
- 48 chief legal officer for the NBA's Atlanta Hawks, whose home court
- 49 is the State Farm Arena in Fulton County one of the Arenas
- 50 used as a polling place.
- 51 The Arena runs security cameras 24/7. I did not have time to read
- 52 the petition for the subpoena, but as my friend suspects, it appears
- 53 someone who works at the Arena knew fraud was going down and
- 54 tipped Wood off on the video. In any case, Wood got the
- subpoena, which forced the surrender of the video. When it was
- reviewed, they discovered the fraud I'll describe in a moment.

57 Once they obtained this smoking gun video, Trump, it appears, 58 changed his earlier plans to have his rally in Georgia to come after the video was released to the Georgia legislature. I watched that 59 60 presentation, and it is STUNNING! However, Democrat state 61 senator Elena Parent — yep, that's her name — dismissed all the testimony of witness after witness testifying under penalty of 62 63 perjury, and the condemning video—as all an Alice in Wonderland moment for her. This snake slithered and slimed about — I mean, 64 65 literally — in her chair weaving her wicked web — I mean, watch her, she is moving her hands about like she is weaving and 66 slithering about in her chair like a snake — dismissing the 67 68 character and obvious objective evidence set before her as 69 something all fuzzy and confusing and distorted like looking through the "looking glass." The testimony offered in that hearing 70 was solid and convincing proof that the DEMOCRATS have 71 72 attempted to STEAL this election by MASSIVE FRAUD.

I got an alert a little bit ago that one of these workers has entered into witness protection. I will assume this witness provides some of the information that helps us understand what we see on the video.

What does the video show? It shows that at about 8 am, November 76 77 3, ELECTION DAY, a lady identified only as "the blonde-braids 78 supervisor" places a long table in the counting room covered by a 79 black cloth. The table was not carried in, set up, and then covered with the cloth. It was dragged in already covered. (That's already a 80 81 bit weird, especially when you notice that nothing was ever placed 82 on this table. The other black tables in the room were being used 83 actively; this one was not. At about 10:25 pm, on ELECTION DAY, 84 blonde-braids comes into the room and interrupts the counting, declaring authoritatively that counting is done for the night. She 85 orders all to go home and return at 8 the next morning. 86

The video shows them leaving, all except four workers and blondebraids. They remain. And after all the observers, and media, and

- 89 other workers were gone, these went to work COUNTING
- 90 BALLOTS.
- 91 Now, here is a little flash back to Election night! On MSNBC
- 92 Rachel Maddow interviewed a witness explaining why after the
- 93 shut down the vote was called at about 10:30 and the workers,
- 94 observers, and media all left the State Farm Arena, five
- 95 REMAINED BEHIND, and when the room was cleared, these
- 96 continued counting. The witness explained that these were
- 97 counting ballots that had ALREADY been processed—suggesting
- 98 to their viewers that count watchers had already vetted them. Then
- 99 Rachel said something very interesting: Chuckling, with a big smile
- 100 remember, at this point in the election, Trump was WINNING
- 101 BIG TIME some Rachel, who practically cried when Trump won
- in 2016, is smiling remarked that the fate of the nation was in
- the hands of five workers; at the conclusion of the interview, she
- says, "Talk about having the fate of the nation in your hands."
- 105 Is she aware of what she said? Think about this. In what context
- would she make a statement like that? If they were merely counting
- ballots, or merely continuing the count of "already opened ballots"
- 108 in what way would THESE FIVE PEOPLE HAVE THE FATE OF
- 109 THE NATION in their hands that is, IN THEIR CONTROL?
- 110 That was the night this went down. Now, add to this, this! After the
- 111 workers were ordered to leave the room, someone from the press
- 112 tipped off some of the workers and told them that COUNTING
- 113 CONTINUED after they were told COUNTING had STOPPED.
- 114 Perhaps they saw this interview. Anyway, they went back and
- arrived about 1 am just 15 to 30 minutes or so after the workers left
- but received eyewitness testimony that in fact it was true.
- Now, fast forward to today! Wood gets the video of what actually
- 118 went on in that room when the FATE OF THE NATION was
- 119 placed into the hands of FIVE ELECTION WORKERS under the
- supervision of blonde-braids. (Actually, we now know their names,

- well, we know the name of one worker, Ruby, and her daughter is
- blonde-braids supervisor the others will soon be identified.
- 123 Did the Maddow interview provide adequate cover for the voter
- 124 fraud operation caught on the video? It might have, except the
- 125 VIDEO reveals what was REALLY GOING ON.
- We know, from the video, that after all but the FIVE cleared the
- 127 room, the five went to work. And they pulled suitcases out from
- under the table that blonde-braids had brought in earlier. (These
- were roller boards, like you put into the overhead when flying, only
- 130 some of these looked somewhat larger.)
- 131 They pulled these out from under that table, and took them to the
- 132 counting machines and began feeding ballots into the machine.
- 133 You should know that this is not the way ballots are brought into
- the counting rooms.
- 135 Sometime between blonde-braids placing that table in the room,
- and 10:30 PM, some how these large suitcases full of completed
- ballots were placed under the table. Those presenting the evidence
- 138 before the Georgia Legislature in the hearing said they have not
- 139 had time to go through the fourteen plus hours of video and that
- 140 as they fast-forwarded through it, did not see when the suitcases
- were placed under the table. It's possible the suitcases were placed
- under the table and tied up so that blonde-braids brought the table
- in with the suitcases already under the table.
- 144 I noticed that the table was not carried in, set up, and then covered
- with the black cloth. She dragged it in already set up and already
- 146 covered it is very possible the cases were already put under the
- table when she dragged it into the room.
- Folks, this is not an "irregularity" and this was not a "worker error,"
- and it was no machine "glitch." They were indeed counting ballots
- that had already been opened —because they were counting ballots
- 151 that had never been in an envelope. They had been pre-prepared,

- placed into the suitcases, secreted into the vote counting room, and
- then, when it was clear Trump was thumping them again, blonde-
- braid did her job, walked in and there is no evidence she even had
- 155 the authority to do this, but she walked in, cleared the room, and
- then she, with her mother, and three others, got busy STUFFING
- 157 THE BALLOT BOX.
- Now, one more thing before I go to break. When I received this
- video, the fact checkers labeled it as suspicious and the notice
- said, "This claim of voter fraud has been disputed." So I thought,
- okay, let's go see what the other side has to say about this video. So
- 162 I clicked the link and it took me to a page with authoritative
- sources, one after the other, that said "Voter fraud of any kind is
- 164 exceedingly rare in the US, election experts confirm." And another,
- 165 "What you need to know: voter fraud of any type is incredibly
- 166 rare in teh US, according to The Associated Press and Reuters."
- 167 (Snicker!)
- 168 And from the authoritative USA Today Non partisan
- 169 investigations of previous elections have found that voter fraud is
- 170 exceedingly rare." Oh, and, by the way: On November 11, "State
- officials from both parties, as well as international observers, have
- also stated that the 2020 election went well."
- 173 Then some more assurances from AP The US election was not
- 174 tainted by widespread voter fraud or irregularities, despite
- 175 President Trump's claims. Trump says some of the votes are 'illegal'
- but he hasn't offered any proof and courts have rejected most of his
- 177 legal challenges."
- 178 And it goes on, and on in this way.
- 179 NOT ONE FORMAL ALLEGATION OF VOTER FRAUD IS
- ADDRESSED. NOT ONE. Not one of the hundreds of affidavits of
- 181 eye witness accounts of voter fraud is addressed.

- 182 They simply DUCK DOWN into their RABBIT HOLE and hide in
- 183 wonderland from the TRUTH.
- 184 Trump is playing 4D chess with people who commit crimes in
- 185 front of cameras. (Thank you Matt!)
- 186 Hold on through the break. I'll be right back.
- 187 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
- 188 at the Lighthouse, your brain masseur, and Paul Revere's lantern
- lighter, lighting the lamps in the church belfry arch, signaling the
- 190 enemy is on the march, an enemy that would steal from us our
- 191 liberty.
- 192 Friend, the amount of information coming out regarding this
- 193 election is overwhelming. It's difficult to keep up with it, and even
- more challenging to sort it all out for you.
- 195 In the first segment, we discussed the latest bombshell that
- 196 exploded in Georgia. A video that shows at the time Trump was
- 197 leading in Georgia by something like 100 thousand votes, the
- 198 counting station was suddenly cleared out by order of someone
- 199 whose credentials to call off the count are in question—and after
- 200 everyone cleared out, five remain behind to continue the count
- 201 unsupervised—and in full view of the security cameras, these
- 202 workers drag suitcases out from under a table filled with ballots
- and start feeding those ballots into the machines. This is FRAUD!
- 204 Lin Wood, who obtained this video, asked could anyone spell
- 205 FELONY.
- 206 Two of the people viewed in the State Farm Arena video show up
- in another one. In this one we see these two obviously attempting
- 208 to hide from those around them what they are doing as they pass
- 209 USB devices and we know that the votes from these machines
- are stored on USB devices, and you've probably heard about foul
- 211 play where in one case, something like 40 of these devices came
- 212 up missing!

- We see smoke rising in another place and it is certain that when we
- 214 track its source, we are going to find another SMOKING GUN. A
- 215 truck driver who is not an employee of the USPS, was hired to haul
- 216 a load from New York to Pennsylvania. Details are still emerging.
- 217 But what we know is as follows: he was hauling completed ballots,
- between 170 to 250 thousand, from New York to Pennsylvania. It
- 219 did not occur to him until later that this is odd. Why would anyone
- be shipping ballots from one state to another state?
- When he arrived to a clearing station where they would off load,
- and so on, he was not allowed to view the offloading of the trailer.
- He had to wait in a waiting room. This was unusual. The amount
- of time, something like 6 hours, was waaaaaayyyyy too long and he
- 225 became agitated finally, a high official, someone he said he
- 226 would usually never have had any conversation with, told him he
- 227 could take the truck to the next stop—and when this man
- demanded the slip he needed to verify why he was late with
- delivery, and that would allow him to get paid for his overtime, the
- 230 high ranking official refused and ordered him to take the load.
- The driver was unhappy, but what could he do. He carried the load
- 232 to destination, unhitched and when he went back the next day to
- 233 finish the delivery, his trailer was gone. So you have transportation
- of ballots across state lines and a missing trailer, and consequently,
- 235 missing well over 100 thousand ballots.
- So, this is being run down, and pretty soon we'll find the gun from
- which this smoke is swirling over Biden's head.
- Now, what about the Dominion machine debacle? Well, my friend,
- 239 here is what we now KNOW FOR SURE!
- We know that the vulnerabilities of these machines to be used to
- 241 commit voter fraud has been documented and has been well
- 242 known for many years. Texas rejected them because of these
- 243 problems, but 29 other states bought them and use them. Every

- one of these 29 states KNEW about the problems inherent in these
- 245 machines.
- 246 These machines were used in every state where we have massive
- 247 anomalies in the election counts. Anomalies such as a sudden spike
- in votes for Biden that switched the lead from Trump to Biden, an
- anomaly, by the way, which can only explained by exploiting the
- vulnerabilities built into these machines—of course, we are talking
- about the software used in these machines.
- 252 Which, according to the sworn testimony of a former Venezuelan
- 253 General, the software used in the machines was created for Chavez
- 254 to allow him to control the outcomes of every election in his
- country. He swears under penalty of perjury that the software used
- 256 in Dominion machines was designed to steal elections. And he has
- 257 first hand knowledge of how it works.
- 258 This company, Dominion, uses this software, and in their manual,
- 259 they spell out exactly how to use the machine to commit fraud.
- 260 Obviously, they don't have a chapter on FRAUD and HOW TO
- 261 DO IT. But they explain the features of the machine that allow for
- operators to manipulate the ballots in a manner that would allow
- 263 them to control the outcome of the election. It's complicated, but
- 264 I've gone over it a few times before and I'll do some more of this in
- 265 my VISITS but here is one glaring feature of the machine that
- 266 SHOULD CAUSE EVERY HONEST AMERICAN PATRIOT to
- scream for the dismissal of every "politician" that approved using
- 200 di la la compania di controla di contr
- 268 these machines for counting votes in an AMERICAN ELECTION.
- 269 I remember seeing this quite a while back and wondering what was
- 270 going on. I saw a tabulation of votes from one of these machines
- and noticed that the numbers were not whole numbers. In other
- words, every total was fractionalized. I mean, I noticed the totals
- were, for example, 1,256.25, or .69, and stuff like that. Now, folks, I
- 274 don't know who casts a fractional vote—I thought that went out

- with slavery! Right, when they decided to count slaves as a fraction
- of a whole person for reasons of representation —?
- 277 A vote is a whole number -1. It cannot be a fraction of a number.
- 278 And if you add up a long list of integers you get a whole number
- 279 result you only get fractions is you introduce fractions in the list
- of numbers and I think you see what I am saying.
- 281 This allows these wicked people to weight votes. Each vote for
- 282 Trump can be set to register as having the value of .25 and every
- vote for Biden could be set to register as having the value of 1.25.
- You can see what this would do to the OUTCOME of the TALLY.
- 285 There is hard evidence that this happened. This is another story
- 286 where the details are eking out as it develops. A computer expert
- dude named Garland was able to get a Dominion machine used in
- Ware County, a small county in Georgia. He did what they call a
- 289 forensic analysis (forensic refers to the application of scientific
- 290 methods and techniques to investigate a crime). He is able to
- demonstrate how the Dominion software can be used to SWITCH
- 292 VOTES, and testifies that he discovered 37 votes were switched
- from Trump to Biden in the machine he studied.
- 294 37 votes do not seem like much. But this is a very small county and
- it just so happens that 37 votes amounts to about 2.9% of all the
- votes cast in the county. That's of interest because it turns out that
- is very close to the margin of victory for Biden in this election.
- 298 First, it shows that vote switching is a FEATURE of the Dominion
- 299 software and that it's something that can be done by anyone
- 300 knowledgeable of this vulnerability. Second, the percentage is very
- 301 curious since the accusation is that Dominion calibrates the
- 302 machine to switch votes according to an algorithm that kicks in
- when the target candidate reaches a certain threshold of votes.
- 304 This supports Wood's and Powell's allegation that what happened
- 305 is Trump landslide victory broke the algorithm. Or, in other words,

- 306 Trump was getting so many more votes than Biden that their
- 307 calibrations were insufficient.
- 308 Trump's landslide victory was so powerful, it became obvious he
- 309 was going to win in spite of the Dominion machine outcome
- 310 control feature, and the "widespread" voter irregularities —(listen,
- 311 friend, an "irregularity" done repeatedly, and on purpose is not
- 312 IRREGULAR it's a REGULAR PATTERN OF FRAUD)—
- 313 Trump's votes were coming in at a pace the thousands of dead
- 314 people voting, the trick of re-counting batches multiple times, the
- 315 trick of getting a ballot rejected so the workers can DUPLICATE
- 316 IT and all of this going on while Republican observers are
- 317 ushered out of range to actually see what they were doing, and in
- 318 many cases ordered out, and not allowed to see but, man,
- 319 Trump was winning so big, they had to go big!
- 320 That's why they had to go to the nuclear option, and revert to old-
- 321 fashioned BALLOT BOX STUFFING techniques. This means they
- needed a lot of ballots to stuff! So they had to STOP the COUNT so
- 323 they could scramble to get those ballots from New York to
- 324 Pennsylvania where they were desperately needed. They had to
- 325 activate their back up teams, like the Fulton County Five at the
- 326 State Farm Arena—and they needed to get those Republicans out
- 327 of sight of what they were doing.
- 328 But, by God's grace, someone either did not think to TURN OFF
- 329 THE SECURITY CAMERAS, in the State Farm Arena, or disable
- 330 the one watching this operation, or the security guard tasked to
- 331 cover that got a conscience (something we have specifically prayed
- 332 for)—but the Fulton County Five got caught on CAMERA
- 333 performing their Undercover VOTER FRAUD operation.
- 334 But what does it all mean? We cannot allow this to stand. We
- 335 cannot allow this election to be stolen. The RIGHTS of 74 million
- 336 Americans must not be ignored, dismissed as irrelevant. We will

- do better next time is NOT ACCEPTABLE. This election must be
- set right, and there are many ways this can be done.
- 339 The DOJ can kick it in gear and start LOOKING AT THE
- 340 EVIDENCE because there is plenty to be seen.
- 341 But they are doing the same thing with this they are doing with
- 342 Biden and Ukraine, and Obama, Hillary et al and Russia
- Collusion—and I'm sick and tired of these people who SIT on the
- 344 HANDS OF JUSTICE and let the WICKED PREVAIL. Done!
- I mean, if Billy Barr won't do his job and investigate and prosecute
- 346 these things, if the State Legislatures refuse to step up to their
- 347 responsibility and use their Constitutional power to inject
- 348 themselves into this and straighten it out—you are aware that the
- 349 State legislature has a Constitutional authority to step in and there
- 350 are precedents already in place for this—but if they refuse for
- 351 political reasons—or because they have been bought off, or because
- 352 they are protecting someone, or because they are being held
- 353 hostage by threats—and if all the courts fail to execute JUSTICE
- and JUDGMENT in this matter, and it goes to the Supreme Court
- 355 and ALL CONSTIUTITIONALLY APPOINTED POWERS FAIL
- 356 TO PROTECT THE CONSTITUTION AS THEY HAVE BEEN
- 357 SWORN then it falls to the last line of defense of the
- 358 Constitution and that is the President's power to declare martial
- 359 law—fire all the rascals that refuse to DEFEND THE
- 360 CONSTITUTION FROM ALL ENEMIES FOREIGN (CHINA)
- 361 AND DOMESTIC (CHINA CONTROLLED POLITICIANS AND
- 362 NEWS MEDIA) and imprison for charges of treason those who
- 363 attempt to stop A DULY ORDERED REVOTE WHERE WE
- 364 DON'T USE MACHINES OWNED BY CHINA (They do, by they
- 365 way, own Dominion—400 million was paid by UBS Fund into the
- 366 company that owns Dominion and Smartmatic software, and UBS
- is owned 75% by the CCP—

- 368 If every Constitutional protection set in place by our founders has
- 369 come into the power of DEVILS working for CHINA then let us
- thank God our President has not been bought!
- 371 Let us pray, earnestly, it does not come to this. But friend, if
- 372 virtually every Constitutional provision for defending our liberties
- 373 has come into the power of ENEMIES of this STATE then it's up
- 374 to our President to lead the nation back under it's Constitution and
- it's up to us to SUPPORT HIM in every way necessary.
- 376 Praying God will continue to REVEAL THE TRUTH for as our
- 377 CHIEF CAPTAIN told us the TRUTH will MAKE YOU FREE.
- I have lit the lamps in the Church belfry arch and now you let me
- know if you see them. It's LIGHTS ON if you see the LIGHTS ARE
- 380 ON and you will ride like Revere and spread the warning,
- 381 (essentially, it means you agree with what I'm saying) or you say
- 382 LIGHTS OFF -- which means you reject what I'm saying and
- disagree strongly with me. So, what will it be today, lights on, or
- 384 lights off?
