- 1 Segment.01 Hello. I'm Dr. Jerry Scheidbach, pastor of the
- 2 Lighthouse Baptist Church in Santa Maria, CA—and your brain
- 3 masseur—get ready for your brain massage.
- 4 The LIGHTS are ON!!!!! The principle in focus today: politics
- 5 corrupts, and absolute politics corrupt absolutely. And the answer
- 6 to politics is PATRIOTS passionate patriots will *trump* politics if
- 7 we STAND together against the STEAL!
- 8 Update on the battle for America against the foreign invasion of
- 9 China directly and indirectly through traitor proxies within the US.
- 10 DNI Ratcliffe confirms CCP interference in the 2020 election. This
- 11 is huge. So we'll be looking at Trump's options relative to this
- 12 revelation including his 2018 EO regarding foreign interference in
- 13 US elections.
- 14 This comes on the heels of a joint statement from FBI, CISA and
- 15 DNI on Dominion-linked Cybersecurity attack.
- 16 This takes us to a closer look at the MI Dominion case, if I have
- 17 time.
- 18 The SCOTUS cowards shrink from the Powell case kick the can
- 19 down the road schedules it for Jan. 14th. (However, this just
- 20 might not be as bad as it sounds—hold on!) (By the way, did
- 21 Roberts really say the SCOTUS should not take the Texas case
- because he fears riots will break out?)
- 23 So we'll give a report on the current status of the 2020-CCP coup.
- 24 So much to talk about, so little time.
- 25 I am in the process of transitioning from FB but having some
- 26 difficulty with MeWe can't seem to find a way to *livestream*. So,

- 27 if you want a little more brain massage time during your week, go

- 32 Friends It's time for your brain massage!
- 33 [TRUTH]
- 34 Okay, let me offer what I see as battlefield assessment, or today
- 35 more properly called a Battlefield Area Evaluation, or BAE.
- We are under attack! The Chinese Communist Party is at war with
- 37 America. It has been carried out through an economic attack with
- 38 a political component. The political component has been the
- 39 decades long work of infiltrating Wall Street—working CCP
- 40 members into high levels of influence in Corporate America, and
- 41 buying influence and control through recruiting politicians (like
- 42 Swalwell) and family members of politicians—like Biden. Having
- 43 secured a pervasive amount of influence in America, they have
- 44 been using more aggressive means of controlling their proxies: like
- 45 blackmail, and threats—bullying key people to do their bidding "or
- 46 else" unfortunate things will happen to family members or friends—
- 47 you know, mob tactics! And there is nothing, I mean nothing,
- 48 more dangerous to our liberties than men and women with power
- 49 who do not have the courage or the character to USE it against our
- 50 foreign and domestic enemies.
- 51 Right now the CCP attack is focused on Trump, because he is
- 52 willing to stand up to them. However, to get at Trump they have to
- destroy the Constitution. (Beginning with Obama using the DOJ
- 54 and the FBI and the CIA to spy on Trump, to run a secret
- 55 clandestine operation against his campaign similar to how the CIA
- 56 has toppled regimes in other countries—called a COLOR
- 57 REVOLUTION.)

- 58 The current battle in this CHINA WAR against, well, really, the
- 59 WORLD, but to get to the world they must go through us, so the
- attack right now is an attempt to leverage the pervasive influence
- 61 the CCP has established in America to bring the United States to
- 62 her knees under their power by stealing the 2020 Presidential
- 63 election.
- 64 China wants to make Biden the US President! Biden, will do
- 65 China's bidding! He is quite literally the Manchurian candidate!
- We now have proof that Biden is compromised by his connections
- 67 to CCP money indirectly through his son, Hunter, and there is
- 68 compelling evidence he is directly owned by China: he has been
- 69 identified as "the big guy" that is referenced in email
- 70 correspondence found on Hunter's laptop referring to his father as
- 71 the "big guy" and as the "chairman" that is behind it all; with
- 72 additional proof coming from the first hand testimony of an
- 73 erstwhile Biden insider—a business partner who blew the whistle
- on the Biden CCP connection.
- 75 Presently, the CCP is manipulating thousands of Americans in
- 76 positions of power and that they control by bribery and blackmail
- 77 to literally ATTACK our CONSTITUTION.
- 78 Those appointed to DEFEND our CONSTITUTION from all
- 79 ENEMIES Foreign and Domestic are called upon to stand up to
- 80 this attack. So, let's see where we are!
- 81 So far, Trump has looked to the American legal institutions
- 82 charged with an oath to defend the Constitution against ALL
- 83 ENEMIES foreign and domestic to do their job, and they are
- 84 failing!
- 85 For example, the Constitution says the State Legislatures have the
- 86 power to direct in what way a State's electors are appointed. In the
- 87 key "swing states" the Republican Legislatures failed to provide
- 88 oversight in the elections in their states while Governors, and

- 89 Election Officials illegally changed the voting rules that allowed for
- 90 massive fraud. It's appalling that many of these Legislators did not
- 81 know they had Constitutional authority to intervene in this directly
- 92 and TAKE POWER from the GOVERNORS and ELECTION
- 93 OFFICIALS forbidding them from violating State laws. When
- 94 these egregious violations of the State's laws were challenged in
- 95 State courts, the COURT SYSTEM also FAILED to UPHOLD THE
- 96 CONSTITUTION and supported these violations—paving the way
- 97 for massive voter and election fraud.
- 98 So, at the State level, there was a collapse of three levels of
- 99 DEFENDERS of the Constitution—the Executive, the Legislative,
- and the Judicial branches of these states TURNED AGAINST THE
- 101 CONSTITUTION. Some knowingly, some ignorantly, all
- 102 effectively facilitating fraud on a scale that, so far, has allowed the
- 103 CCP to advance their agenda to bring America out from under
- 104 GOD, and out from under her Constitution, and UNDER THE
- 105 POWER OF CHINESE COMMUNIST DICTATORSHIP.
- 106 So, we turn to the Federal protectors of the Constitution. The DOJ,
- 107 the FBI, the CIA, and SCOTUS. William Barr was appointed as
- 108 Attorney General and we all had great hopes he would assist
- 109 Trump in draining the swamp. But Barr is a political man. He
- makes decisions that are controlled by politics. For example, he
- ordered the DOJ, and the FBI to not announce any investigation
- into the Biden crime family! Neither did he aggressively pursue the
- Obama spy-gate scandal. In both instances, he was controlled by a
- 114 concern for "political fallout." He did not want to involve the DOJ
- or the FBI in campaign politics. And for that reason he did not
- 116 aggressively pursue JUSTICE and so because JUDGMENT was
- 117 not executed JUSTICE was denied to the American people. And
- 118 the reason was POLITICAL. Hey, Barr, if you don't want to
- 119 politicize the DOJ or FBI then don't allow POLITICS to control

- whether or not you move forward executing JUDGMENT upon
- 121 EVIL DOERS in order to ESTABLISH JUSTICE in the land.
- 122 Your job is not to independently decide what this or that action
- 123 might mean POLITICALLY! You rascal! Your job it to execute
- 124 JUDGMENT in service to JUSTICE!
- 125 So that was a failure to defend the Constitution because it
- facilitated the CCP attack on our nation.
- 127 Then we come to SCOTUS. Texas put together a case against GA,
- 128 PA, MI and WI for violating the Constitution and allowing rules
- 129 and laws to be made illegally facilitating voter and election fraud
- that resulted in disenfranchising the voters in the State of Texas.
- 131 Seven other States joined in the suit, and other filed amicus briefs
- in support of the case, and over 100 US Representatives joined in,
- 133 and President Trump also joined in—all demanding their joint
- 134 complaint be heard by the last judicial recourse we have in the US
- and the SCOTUS dismissed the case on STANDING. Alito and
- 136 Thomas both dissented and that means Gorsuch, Kavanaugh,
- 137 and Barrett all BETRAYED us, and failed to DEFEND THE
- 138 CONSTITUTION because that is exactly what this case was
- 139 about. Maybe a report we received from a staffer on the court
- explains how these cowards were bullied into backing off the case.
- 141 We learned lately that Alito and Thomas raised the precedent of
- Bush v Gore in 2000 as argument supporting their plea that the
- 143 court should hear the case, and a staffer overheard Roberts yelling
- 144 at Alito and Thomas saying he does not care about the Bush v Gore
- case, that he did not want to hear about that, that there were no
- 146 riots then. Was the court intimidated by the violent outburst of
- Roberts, and the other liberal justices, so they gathered up their
- skirts and ran away from this case? I don't know! I don't know for
- sure the story is true. But no matter what was the reason, even if it
- 150 was for "standing," Kavanaugh, Gorsuch, and Barrett owe it to us to
- 151 explain their reasoning—because Alito and Thomas are serious

- 152 jurists, and these newbies "conservative," letter of the law,
- 153 Constitutional additions to the court obviously BETRAYED their
- 154 betters!!!! I am disgusted with Gorsuch, Kavanaugh, and Barrett—
- we deserve to hear from them regarding this.
- 156 And add to that insult—Powell's case finally got to the SCOTUS
- 157 docket. They did not dismiss it I guess they could find a way to
- 158 hide their cowardice behind standing, or some other procedural
- issue, so what can we do? They scheduled the case for Jan. 14. The
- 160 case will take some days to present and then some time to decide,
- and that will almost certainly take us beyond Jan. 20th, when it will
- 162 then be "safe" they might think to rule honestly without
- impacting the "election" but the ELECTION is the POINT OF
- 164 THE CASE. So, once again, defiled by politics! The DOJ and the
- 165 FBI and the CIA (which is covertly running this color revolution)
- are compromised by politics, and now the SCOTUS is polluted,
- 167 poisoned, corrupted by "politics." Their decisions are being
- 168 controlled by "politics" and that's not the job of the COURT.
- 169 Their job is to rule on matters of CONSTITUTIONAL LAW —
- 170 PERIOD! But see how politics corrupts, and absolute politics
- 171 corrupts absolutely. Consequently, another bulwark against attacks
- on the Constitution has fallen.
- 173 So, State governors, like Brian Kemp (whom I believe is owned by
- 174 CCP money—whose strategy is to cooperate with the covert op to
- 175 take Trump down while securing a "victory" for his PARTY by
- 176 getting the two Republicans he is backing into the Senate I think
- 177 Kemp made a deal with Dominion to use their machines and got
- 178 some pocket change and a promise to use the cheating machines
- 179 for him—we'll see! Because the LIGHT IS SHINING BABY! You
- 180 have no place to hide—TRUTH IS MARCHING ON YOU ALL!)
- 181 I have sympathy for Lin Wood's position on this matter. No
- 182 Trump, no GOP! That's it! You want to turn your back on the
- 183 CONSTITUTION in order to get rid of TRUMP while you pretend

- 184 to support Trump and his 75 million patriots well, Kemp, you
- are a backstabbing, face-kissing JUDAS. And that goes for the rest
- of you GOPers—if you will not stand for the CONSTITUTION be
- 187 GONE! Hey, Rand, don't you dare talk to me about fixing these
- problems for "next time." NOW IS THE TIME to STOP THE CCP
- 189 from STEALING American's sacred right to DECIDE who holds
- 190 office in this country. Unless they STAND now this "we'll fix it
- 191 for next time" won't cut it! You stand now, or we WALK AWAY
- and start our own party. You had better listen, GOP!
- 193 So far my BAE (battle area evaluation) sounds pretty bad. Well,
- 194 friend, that's the way it is in war it gets real bad sometimes
- before it gets better. And we must have a reality assessment of the
- 196 battlefield.
- 197 So, our battlefield assessment will continue after the break—and
- 198 just so you know, it is not so bleak as you might think! For
- 199 example, many Legislators in the "swing states" have wakened to
- 200 the very real threat to our Constitution and sent a separate slate of
- 201 Electors for Trump it's been done before; it's called dueling
- 202 Electors so what happens is if one or more of these cases being
- 203 pursued in various courts right now actually turns out to RULE the
- 204 election in this or that state invalid, the TRUMP ELECTORS are
- 205 already in place —. Okay, hold on through the break; I'll be right
- 206 back.
- 207 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
- 208 at the Lighthouse, your brain masseur, and Paul Revere's lantern
- 209 lighter, lighting the lamps in the church belfry arch, signaling the
- 210 enemy is on the march, an enemy that would steal from us our
- 211 liberty.
- 212 Quickly, it's not true that that the MSM and Social Media
- 213 censorship of conservative views actually determined the outcome
- of this election. It is evil—but the fact is they don't have that much
- 215 influence. Okay, of course, it's true that many Democrats would

- 216 have voted for Trump or simply stayed home and not voted Biden
- 217 if they had known about Trump's successes and Biden's corruption.
- 218 But how many actually listen to CNN? And Fox did not crawl out
- 219 of the closet for Biden until Election night! This is a first
- amendment issue, to be sure—and they all deserve to be called out
- 221 for their lying—but all they really succeeded at doing is allow the
- fraudsters to get by with fewer fake ballots than they would have
- 223 needed to steal the election. This election is being stolen by
- 224 FRAUD—. Keep the focus right there! All that would have
- 225 happened is that Trump would have had 80 to 90 million votes,
- 226 which would have required the THIEVING DEMOCRATS with
- 227 the assistance of their face-kissing backstabbing JUDAS
- Republicans to come up with 91 million votes instead of 80 million,
- of which probably about half or maybe a third, were fake.
- 230 So, it wasn't fake news it was FAKE VOTES!
- 231 Okay!
- 232 Most of you know about the executive order Trump signed on
- 233 September 12, 2018 that provides for actions to be taken in the
- event a foreign power interferes with our elections, or attempts to
- 235 interfere by the way! If it is proven they did, or attempted to
- 236 interfere actions that may be taken under the direction of the
- 237 President are laid out in this Executive Order.
- 238 The order provides to the President broad powers to act against
- any foreign power that interferes or attempts to interfere with our
- 240 elections, and against all those who participated in the effort,
- 241 whether they are citizens of the US or foreigners. I'll address this
- 242 more in a moment; but that's the idea of the Executive Order.
- 243 The Executive Order assigns to the DNI (Director of National
- 244 Intelligence) the responsibility to prepare and present an
- assessment within 45 days of a national election. The assessment is
- 246 to ascertain whether or not there was foreign interference in our

- 247 election. If it is determined that foreign interference occurred the
- 248 President is empowered by this Executive Order to take the actions
- stipulated in the order. I'm going to add the Executive Order with
- 250 my commentary on the order to my Brain Massage web page along
- with my show notes.
- 252 After the assessment is delivered to the President, the Secretary of
- 253 the Treasury (Mnuchin=Men-oo-chin), the AG (Presently Jeffery
- 254 Rosen), and the Secretary of State (Mike Pompeo). It is then
- 255 circulated among other heads of departments, including the
- 256 Department of Defense, and so on, and these are to make a report,
- 257 and this report is to be completed within 45 days. It is unclear
- 258 whether the President must wait for this last report before he is
- 259 able to take the actions stipulated in the Order. I think it is
- arguable that the President can take action as soon as he becomes
- 261 convinced that intelligence is actionable. However, this Executive
- 262 Order does not limit what the President can do about a threat to
- 263 the Constitution he is sworn to defend, nor when he can take that
- 264 action. Nevertheless, the assessment from the DNI will play
- 265 critically in what action the President might take against CCP for
- 266 interfering in our elections.
- 267 The current DNI is John Ratcliffe. I heard that he has said his
- 268 report will be delayed. But today I heard it was delayed because of
- 269 dispute among some of the Secretaries about whether China
- 270 should be expressly identified as a perpetrator. Other evidence
- 271 points to Russia and Iran—I'm telling you right now. Mark my
- words. That's a red herring! It's a dodge, a diversion! Stay focused
- 273 on CCP that's the threat. No one should be surprised that CCP
- 274 has made some significant purchases among other heads of
- departments in our government. And we need to pray for Trump
- and those loyal to the CONSTITUTION to see through this.

- Now, here is the good news: Ratcliffe has gone "on record" saying
- 278 there WAS CHINA INTERFERRENCE IN THE 2020
- 279 ELECTION." That's huge!
- 280 Further, Ratcliffe, who has access to ALL INTELLIGENCE
- 281 gathered by the US, said "CHINA POSES THE GREATEST
- 282 NATIONAL SECURITY THREAT TO THE UNITED STATES."1
- 283 The POWELL case SHOULD be before the COURT as we speak—
- however, Giuliani and Powell have been able to get their message
- 285 to the Legislators and to much of the public—certainly to the 75
- 286 million Trump voters and a large percentage of the Democrats that
- are bothering to pay attention—whose curiosity has been aroused
- by the bits and pieces of these stories that are breaking through the
- 289 "cone of silence" MSM and Social Media has tried to drop on
- 290 American free speech.
- 291 So, I hope the MI case proving Dominion is implicated in
- 292 facilitating voter fraud in this election, and the proof that has
- 293 become public domain showing that CCP dumped 400 million
- 294 dollars into the parent company that owns Dominion, along with
- 295 the plethora of substantial evidence of voter fraud that Giuliani and
- Jenna Ellis put before the State legislators in PA, MI, GA, and WI.
- 297 And the testimony before the US Senate recently and reports are
- 298 coming in that many Representatives and Senators are beginning
- 299 to show deep concern. More so in the House, but increasingly in
- 300 the Senate too as pressure from Trump's supporters is turning up
- 301 the heat! I'll add my letter to Cruz and Paul to my notes today and I
- 302 encourage you to write something like this to as many Republican
- 303 Senators as you can. I've written to McConnell, Cruz, and Paul so
- 304 far.
- 305 So that pretty much completes my battlefield assessment, or Battle
- 306 Area Evaluation let's talk about what should be done.

307 First, Jan. 6 — two things can happen. If our court will uphold the rule of law and rule the elections in the disputed states are invalid, 308 309 or if the Governors of at least two of the states grew a conscience, 310 for example, if Kemp repents of his collusion with Dominion and 311 comes clean—the electors from those States can be legitimately 312 given to Trump. As I pointed out, they are already in place and ready to go. This could shift sufficient electoral votes to Trump to 313 314 declare him the winner, or block either candidate from getting the 315 requisite 270 and force the election into the Congress. Second, on Jan. 6, if Biden is given the vote and is declared President-Elect, 316 317 one Representative and one Senator can join together to contest 318 the vote. The Congress will then meet to deliberate and then vote 319 on the challenge. If the challenge is upheld, Congress votes for President and the Senate votes for Vice President. Each state gets 320 321 ONE VOTE in the House, and each Senator gets ONE VOTE in 322 the Senate. There are more states represented by Republicans than 323 Democrats. And the Senate will likely still be in the hands of 324 Republicans with Mike Pence being the tie-breaking vote.

- We have multiple House Representatives ready to challenge the Electoral vote, and recently, one incoming Senator has indicated a willingness to join them. Other Senators might also step up like Ted Cruz, or maybe Rand Paul, or Senator Grassley, and others. McConnell has threatened Senators not to contest the electoral certification but he does not have the kind of pull he needs to control the deeply patriotic Senators we have on the Hill.
- The Achilles heel of this plan is the sad fact that the House of Representatives, even as constituted after the new members are seated, has the votes needed to support the challenge, and with McConnell unwilling to support it in the Senate, and other weasel Republicans willing to throw in the towel, it appears unlikely that this will actually work. It's possible! God can do amazing things.
- But it's also possible this is not the method He intends to use.

- 339 So, there is one patriot with the official capacity to DEFEND the
- 340 CONSTITUTION from enemies foreign and domestic and that's
- 341 the President of the United States. Flynn, other generals, and some
- 342 others in high places are calling on Trump to declare Martial Law
- 343 and order a fair and honest election. Or he could order a recount
- 344 that sets aside the illegal ballots, and bypasses the cursed Dominion
- 345 machines.
- 346 The basis for this would be the DNI assessment stipulating that
- 347 China has interfered with our elections, and the witness of so many
- 348 Americans, and forensic testimony, that proves beyond any
- reasonable doubt that this election is irreparably tainted by fraud.
- 350 Trump has the evidence he needs to support such a declaration—
- 351 let's hope and pray it does not come to that, but the options are
- 352 narrowing down quickly.
- 353 I think Trump anticipated something like this, and has planned for
- 354 it. I think he SHOULD take the extreme action to PROTECT THE
- 355 CONSTITUTION from CCP and their proxies operating in this
- 356 government at the highest levels of power.
- 357 It is an insurrection and Trump would be justified invoking the
- 358 Insurrection Act in which he would deploy the military to put
- 359 down any uprising that aims to take over our government in
- 360 violation of the Constitution.
- 361 Interestingly, he has already deployed naval power on the East and
- West Coast of USA and moved many thousands of troops into
- positions within the United States this could be in anticipation
- of an attack from China together with their proxies the ANTIFA
- 365 mobs and others within the United States.
- 366 This thing has gone so far the Left have become so blatant in
- 367 their disregard for our Constitution and the rule of LAW, their
- 368 effort to steal this election was so OPEN, and so HOSTILE and
- 369 the CCP is so thoroughly embedded in our country I fear it will

- take such serious measures to stop this invasion of our Country
- and the loss of our liberties.
- 372 So, I call on Biden to concede! It is obvious his election is based on
- 373 fraud, and that he is an agent of the CCP if he has any
- Patriotism left, I mean, if he ever had any, if anyone surrounding
- 375 him has any love for the COUNTRY at all Biden MUST
- 376 CONCEDE today, or be responsible for pushing America into
- 377 open war with CHINA!
- 378 I have lit the lamps in the Church belfry arch and now you let me
- know if you see them. It's LIGHTS ON if you see the LIGHTS ARE
- 380 ON and you will ride like Revere and spread the warning,
- 381 (essentially, it means you agree with what I'm saying) or you say
- 382 LIGHTS OFF -- which means you reject what I'm saying and
- disagree strongly with me. So, what will it be today, lights on, or
- 384 lights off?
