23 [TRUTH]  
24 VOTER FRAUD UPDATE:

25 There are 254 million living in America that are 18 and above  
26 (THAT'S ROUNDING UP). Not all of these are citizens, since we  
27 don't allow the census to ask about citizenship.

28 There are 153 million registered voters in the US. Judicial Watch  
29 conducted a study and found that 3.5 million of these are ineligible:  
30 you know, dead, non-citizens, people who moved out of their state  
31 ten years ago, stuff like that. So that's 149,500,000 eligible  
32 registered voters in the US.

33 Trump got 75 million and Biden, supposedly, got 81 million.  
34 Hmmmm. We have a problem Houston!  $75+81$  is 156 million.  
35 That's six and a half million more votes that we have voters in this  
36 nation. 6.5 million FAKE VOTES! Where did these FAKE votes  
37 come from?

38 WE know that counting was stopped in several states, and all of  
39 them stopped at pretty much the same time, and all of them  
40 stopped with Trump holding a very significant lead in those  
41 states—600k in PA, and hundreds of thousands of votes in the  
42 other states. Magically, massive ballot dumps appeared in these  
43 states, and they were 99% for Biden.

44 It is reasonable to assume the excess votes went 99% for Biden—  
45 that's what the science would suggest—99% of 6.5 million is  
46 6,435,000—subtract that from 81 million and you get 74,565,000 to  
47 Trump's 75 million, and Trump wins by a few hundred thousand  
48 votes.

49 Folks, Trump won by a WHOLE LOT MORE THAN THAT — but  
50 this exercise proves that it is IMPOSSIBLE for Biden to have gotten  
51 81 million votes. Which makes sense, because it is likewise  
52 impossible to believe Biden got more votes than Hillary, and more  
53 votes than Obama—a guy who has NEVER excited voter  
54 enthusiasm like that in his entire 47 years in politics and who  
55 during the COVID scare could not scare up more than a hundred

56 people at any of his rallies while Trump was regularly attracting  
57 crowds in excess of 10 thousand voters at a time. It's impossible to  
58 believe Biden beat an incumbent President who gained 10 million  
59 votes in his bid for re-election from his win four years earlier.

60 Like it's impossible to believe Biden lost 70% of the districts but  
61 won the election; like it's impossible to believe 1000 Americans  
62 swore affidavits testifying to voter fraud, under penalty of perjury,  
63 are lying; like it's impossible to believe the 6,000 votes that were  
64 flipped from Trump to Biden in Antrim Co, MI was an operator  
65 error, or a computer glitch (by the way, this is not an allegation—it  
66 is an established fact), and like it's impossible to believe this only  
67 happened once, like it's impossible to believe the Secretary of the  
68 State of MI tried to block Deperno's report from being released to  
69 the public because she is an honest politician, because there are so  
70 many of those in MI, a report, by the way, that PROVED the  
71 Dominion machine/software generated a 68% error rate—which  
72 means those ballots were sent to "adjudication" where someone  
73 WITHOUT SUPERVISION and WITHOUT OBERSERVERS  
74 corrected the ballots—using a machine that ALLOWS the  
75 "adjudicator" to actually change the votes—like we watched a vote  
76 counter demonstrate how you can insert a BLANK BALLOT into  
77 the Dominion machine, the BLANK BALLOT gets flagged for  
78 adjudication, and is sent off-site to an adjudicator—the adjudicator  
79 then completes the ballot and it then gets counted—99% for Biden;  
80 like it's impossible to believe because of COVID 19 the Democrat

104 They go on to explain that "A Swiss investment bank's New York  
105 subsidiary, UBS Securities LLC, in October bought \$400 million in  
106 shares of Dominion's parent company Staple Street Capital." Then  
107 it goes on to verify that 3 of the 4 members of the board controlling  
108 UBS Securities are Chinese nationals, and "could represent Chinese  
109 investors," because shareholder information is private, "it is  
110 unknown if China or any other government owns shares."<sup>1</sup>  
111 Further, it CONFIRMS that UBS, the parent company of the New  
112 York subsidiary — UBS Securities, LLC — is in fact a CHINA-  
113 BASED firm, well, *it* did not buy the Staple Street shares, it's  
114 subsidiary did! So, to be "accurate" — here is what we have. UBS is  
115 a CCP bank that has a subsidiary with headquarters in New York  
116 City. This subsidiary headquartered in New York City is run by a  
117 four man board — three of these are Chinese nationals — (anyone  
118 who knows anything about how China operates knows these four  
119 board members are members of the CCP or they would not be

120 allowed to sit on a board of any "subsidiary" that is connected even  
121 remotely to a CCP BANK. And that CCP is planting "operatives" in  
122 the US — well, just go ask Pelosi and her sidekick Swalwell. And  
123 the CCP professor who stated CCP has penetrated the inner circle  
124 of power in the US — or! Well, you get the idea. But if you read  
125 this "fact check" you have to pay close attention as they shift the  
126 shells about while blowing smoke in your face to keep you from  
127 following the marble — I've attached it here for you to read. But  
128 that's the problem when dealing — the bottom line is this. Every  
129 material matter is admitted and verified by the fact-checkers—you  
130 only have to have enough courage to do some independent

137 Oh, and a little on the side—the three Chinese nationals who  
138 controlled the UBS Securities, LLC headquartered in New York have  
139 been replaced — it appears, these fellows were taken home, sort of  
140 like Fang Fang — suddenly disappeared and returned to China —  
141 this happened December 11 — I guess they completed their task to  
142 STEAL the ELECTION for Beijing Biden but saw some storms  
143 developing around Dominion that began settling around Staple  
144 Street, and UBS Securities?

145 The CHINA Invasion! IBM, 3M, PepsiCo and other leading US  
146 firms house Chinese Communists Party units.<sup>2</sup>— An arrest warrant  
147 has been issued to pick up a Chinese operative who worked for  
148 Zoom and on orders from Beijing disrupted a video meeting to  
149 commemorate the 1989 uprising at Tiananmen Square.<sup>3</sup> This has

150 become such a huge problem—we are virtually invaded by Chinese  
151 spies and government operatives conducting sabotage in US  
152 companies on behalf of China—so, you see, IT'S IMPOSSIBLE TO  
153 BELIEVE CHINA DID NOT USE ITS INFLUENCE OVER  
154 DOMINION TO ENCOURAGE USE OF ITS MACHINES TO  
155 STEAL THE ELECTION FROM TRUMP. Hey, friend, Dominion  
156 is well named. Dominion is a tool used by Satan to get his hands on  
157 *the dominion*.

158 Zucker-bucks bought Election officials to facilitate voter fraud.  
159 YEP! I'm not kidding. Dinesh put a few ten thousand into an  
160 election and went to jail for, what was that, six months or  
161 something—but Zucky puts hundreds of millions into buying  
162 Election officials and nothing happens? Why? Well, it's because  
163 Zuck bought his influence through charities—so, it's okay!

164 Alright, after the break I'm going to address the VP option, the  
165 Pence Card play to stop the steal. Hold on! I'll be right back.

166 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor  
167 at the Lighthouse, your brain masseur, and Paul Revere's lantern  
168 lighter, lighting the lamps in the church belfry arch, signaling the  
169 enemy is on the march, an enemy that would steal from us our  
170 liberty.

171 I've seen this floating around "out there" for a while now, but lately  
172 it has picked up circulation. It's referred to as the Pence-Card! The  
173 idea is that Vice President Pence as President of the Senate,  
174 moderates the Electoral vote count and has the authority to decide  
175 what Electoral votes he will include in the count—and so, it is  
176 believed, Pence can either refuse the Electoral votes from states  
177 where the Constitution was violated in the appointment of their  
178 electoral votes, or elect to count those he accepts as valid. That  
179 seems a bit "out there," but; let's take a closer look. Can the VP save  
180 us from a stolen election? 27.22, 23, 24

181 First, when I *first* came across this notion a few weeks back, I  
182 thought it must be some contrived manipulation of the language  
183 from Article II in the Constitution. I mean, how would this sound  
184 to you if the Democrats used their VP to simply declare a State's  
185 election invalid and decide to not count their Electoral votes?

186 But this thing kept coming back, and so I decided maybe I should  
187 take a closer look at this.

188 Let's start with what the Constitution says, in pertinent part: In  
189 Article II section 1, "The executive Power shall be vested in a  
190 President of the United States of America. He shall hold his office  
191 during the term of four Years, and, together with the Vice  
192 President, chosen for the same term, be elected as follows:

193 Each state shall appoint, in such Manner as the Legislature thereof  
194 may direct, a Number of Electors, equal to the whole number of  
195 Senators and Representatives to which the State may be entitled in  
196 the Congress ..."

197 There follows an insertion set off in brackets elaborating the  
198 procedure for the counting of the Elector ballots. After the State  
199 electors have made their ballots, and sealed them, they — that is,  
200 the electors — are to certify and seal the ballots, and send them to  
201 the "seat of government" directed to the Vice President, who is  
202 President of the Senate. (It is noteworthy here that the executive of  
203 the various States is NOWHERE mentioned. He is not a  
204 CONSTITUTIONAL part of this process. So far, we have the  
205 LEGISLATURES indicating in what manner the Electors are to be  
206 appointed, and then, once appointed, it is the ELECTORS who  
207 vote, certify, seal, and the transmit the vote to the President of the  
208 Senate — in this case, Mike Pence.)

209 From here it describes what happens if neither candidate receives  
210 the requisite number of Electoral votes and provides for the  
211 Congress to then vote for President, with each state receiving one

212 vote, and the Senate to vote for Vice President, each Senator casting  
213 one vote. The number of votes is not relevant — but only that the  
214 winner receives a simple majority of the votes.

215 Now, here is a catch! In this system, whichever candidate receives  
216 the second most votes will be Vice President. This means while  
217 Trump would likely become President, Biden could become the  
218 Vice President. Of course, he would soon thereafter be impeached  
219 for high crimes and misdemeanors, removed from office, and ...

220 So, in a sense, what those pushing for this are asking Pence to do is  
221 turn his job over to Biden.

222 But, let's look at this! Does this really mean that the Vice President  
223 can independently decide whether or not to accept the electoral  
224 votes of a state? That gives the VP extraordinary power!

225 It would be assumed, of course, that the VP would have sufficient  
226 grounds to support his decision to reject the Electoral votes of a  
227 state, but before we go there, we need to ascertain whether or no  
228 the Constitution actually provides for this. What is the argument?

229 First, it does not arise from any express statement to that effect. In  
230 other words, nothing is said about a case like the one that is before  
231 us. No provision is given, specifically, for rejecting the Electoral  
232 votes of a state, or at least there is nothing said about that  
233 eventuality. The eventuality of a tie in the votes, or where neither  
234 candidate gets a majority of the Electoral votes is directly  
235 addressed. But the Framers did not, it appears, expressly address  
236 the possibility that one or more states would send up  
237 FRAUDULENT ELECTORS — therefore, we have to ASSUME the  
238 Framers envisioned only a case where the ELECTORS sent to cast  
239 their votes were GENUINE. And that provides an argument  
240 supporting the idea that the Vice President would be the only  
241 person with official capacity to receive the ELECTORAL VOTES to  
242 protest against fraudulent electors.



243 So, let's look at this! According to the Constitution, the only  
244 ELECTORS the VP is authorized to receive are those  
245 constitutionally appointed. According to the Constitution, only  
246 Electors that are appointed in accordance with the manner directed  
247 by the Legislatures in each state can be accepted as duly appointed  
248 Electors. Otherwise, anyone can send up electors — so if there is a  
249 question about whether this or that slate of electors are authentic, it  
250 should be decided upon by the Constitution and not by the  
251 Governors, or Secretary of States, or any judge — with the  
252 exception of the SCOTUS. This is intriguing.

253 It seems to fit well the current dilemma. Our circumstance is this.  
254 GA, PA, MI, and WI conducted their elections in violation of the  
255 laws enacted by their State's respective Legislative bodies. Those  
256 Legislative bodies have responded to this error by choosing  
257 Electors, which is their Constitutional prerogative. In each of these  
258 cases, the Electors sent are in opposition against the Electors sent  
259 by the Executive of each of these States. The Executive, the  
260 Governor, is NO WHERE MENTIONED in the CONSTITUTION  
261 as having the power to DETERMINE in "what manner" electors are  
262 to be appointed. The Constitution gives that power to the  
263 Legislature—the only body in our system that creates LAWS.

264 Neither the Governor, nor any other officer in the Administration  
265 of the government of any State has the power to make laws.

266 Since the Constitution gives to the Legislature the power to  
267 determine in what manner electors are to be chosen, if the electors  
268 were chosen in violation of those laws duly enacted by the  
269 legislature of these named states, they are without the force of law.  
270 The Legislature has the duty to correct for matters of this sort, and  
271 they did! They rebuked the Governor, and the Secretary of State,  
272 and the courts that supported their unlawful behavior by acting in  
273 their Constitutional legislative capacity to *determine in what*  
274 *manner electors are to be appointed.*

275 So, it follows, reasonably, and justly, that the President of the  
276 Senate can, and should, reject those electors chosen unlawfully, and  
277 either, 1. request the State send Lawfully appointed electors, or 2.  
278 accept those sent by the Legislature as the lawful electors for those  
279 states —

280 In this case, Trump wins, and Pence is looking for employment.  
281 But, no worries — we will remember his bravery, and how he saved  
282 this government from a Chinese takeover — and we will reward  
283 him with the Presidency when Trump finishes his second term.

284 As for the vain report that Pence has been suspiciously silent about  
285 the election fraud situation, well, let me just say there is a reason I  
286 don't follow National File. I've heard Pence say, repeatedly, EVERY  
287 LEGAL VOTE MUST BE COUNTED — and encouraging all  
288 patriots to stay in the FIGHT for this election and to continue to  
289 STAND FOR TRUMP. To suggest Pence is intending to betray  
290 Trump and then run off to Israel is only more insulting than it is  
291 absurd.

292 As to what happens in the event Pence pulled this off—it will surely  
293 end up in court and would probably have to be taken up by the  
294 SCOTUS—as for how they will rule on the matter it's anyone's  
295 guess at this point. Maybe they'll say latches, or standing, or —  
296 hehe. In any event, it will certainly add to the drama of 2020.

297 I'm sure Trump and Pence both are in hopes one of the other  
298 strategies will succeed to correct this travesty. Giuliani continues to  
299 fight in the courts — and has lately begun to take the Powell  
300 approach more seriously—Trump too! Trump is looking into  
301 options to seize all Dominion machines, and Giuliani is looking for  
302 some damning evidence coming out of Georgia related to the  
303 Dominion debacle. You don't hide evidence and obstruct every  
304 effort to gain transparency unless you are trying to hide something  
305 and obstruct justice. Kemp, Raffensperger, in GA, and their  
306 counterparts in PA, MI, and WI are all doing everything in their

307 power to stall discovery of the truth—no doubt they hope they can  
308 keep enough smoke and mirrors operating to hide what they've  
309 done long enough to get Beijing into the White House.

310 GA is the worst of the offenders! You know Secretary of State  
311 Raffensperger made a deal with the DNC behind the backs of the  
312 Republican Legislators to violate Election law in order to facilitate  
313 fraud. Some fact checker will say, well, that's not accurate —  
314 Raffensperger did make a back room deal with the DNC that  
315 involved changing election rules that violated the Laws of Georgia,  
316 but the motives of all these men are a matter of private record and  
317 we cannot know the reason was to facilitate voter fraud. (hahaha.)

318 We know Kemp is sweating it out — hoping Republicans come out  
319 in sufficient force to elect Perdue and Lauefler so the Communists  
320 don't totally take over the Senate. And we know he made a deal  
321 with Dominion in full knowledge of the vulnerabilities of those  
322 machines—vulnerabilities that served the purpose of the  
323 Communists and their cohorts in the face-kissing backstabbing  
324 Judas-Republicans — who, like little Cherub-faced Barr, kiss you  
325 on the cheek while stabbing you in the back — ever notice how  
326 many of these devils look like little cherubs? (Haha — no wonder,  
327 Satan transforms himself into an angel of light) — Like their father,  
328 the "covering cherub" they are servants to the mystery of iniquity  
329 — Nimrods all — who when they feel pressure flee toward iniquity  
330 and not from it — lies, cheating, stealing — that's their answer to  
331 getting their way. That's the Democrat way! Well, there are plenty  
332 of Kemp Republicans in on it too — so, better to say, that's the  
333 DEEP STATE WAY.

334 Did Kemp make a deal with Dominion similar to the one  
335 Raffensperger made with the DNC? *Help us dump Trump and we'll*  
336 *help you keep power in Georgia and your Party keep the Senate?*

337 Anyway, I've got to close. Listen, it ain't over till it's over. It's true  
338 the options are narrowing as we approach January 20th. There are

339 viable cases working their way through the judicial system, any one  
340 of which can turn this thing around so the cheaters will see the  
341 handwriting on the wall and fold—and to protect themselves start  
342 pressuring Biden to concede. Biden might get served an indictment  
343 and make a deal to avoid jail time. (I say, no deals!) If the cases  
344 start falling our way, it's possible the States will instruct VP Pence  
345 that the Trump Electors to be counted for their states.

346 Then there is the Pence-Card — and if that does not work, we have  
347 several in the House who have declared they will contest the vote  
348 on Jan. 6, and some Senators have indicated a willingness to join  
349 them—maybe by then, the CANNONS will be SMOKING strong  
350 enough all these jackals can see they have been EXPOSED—and  
351 will run for cover by going into mock outrage over such travesty  
352 and call on Biden to concede or they will vote with Republicans —  
353 I mean, you know! Yeah! Anyway, the Insurrection Act continues  
354 to be a viable option — I can't find anything in the COVID relief  
355 bill that changes the law regarding that—but, as usual, I'm out of  
356 time and cant' go into that option right now. Hey, GOD is on the  
357 SIDE of RIGHT — He knows how the People voted — He has  
358 graciously answered our prayer to expose all this evil so I think that  
359 should encourage us to believe He will hear our cry for HELP in  
360 this situation.

361 So, to conclude: remember George Washington's Christmas at  
362 Valley Forge.<sup>4</sup> My sources are all footnoted in my show notes—  
363 from History.com and from a page featuring Friberg's famous  
364 painting the prayer at Valley Forge.<sup>5</sup> I'm quoting and adding  
365 comments and so forth—

366 Things could hardly have looked bleaker for Washington and the  
367 Continental Army as 1777 came to a close.<sup>6</sup> The British had

368 successfully occupied Philadelphia, leading some members of  
369 Congress to question Washington's leadership abilities. No one  
370 knew better than Washington that the army was on the brink of  
371 collapse. In view of his armies desperate condition, he defied  
372 Congress' demand that he launch a mid-winter attack against the  
373 British at Philadelphia. Instead he fell back to Valley Forge to rest  
374 and refit his troops.

375 Congress had left him destitute. That Christmas Eve, the troops  
376 dined on a meal of rice and vinegar, and were forced to bind their  
377 bleeding frost-bitten feet with rags. "We have experienced little less  
378 than a famine in camp," Washington wrote to Patrick Henry the  
379 following February.

380 The General described men marching without clothes, blankets or  
381 shoes—leaving bloody trails in the snow—who displayed "patience  
382 and obedience which in my opinion can scarce be paralel'd."

383 On top of all this, Washington faced the displeasure of traitors and  
384 turncoats and cowards in Congress and rumors of **plots to replace**  
385 **him. He faced it all down** with his typical stoicism and composure.

386 On December 31, he wrote to the Marquis de Lafayette of his  
387 resolve to stay the course "regardless of the Tongue of slander or  
388 the powers of detraction." He expressed his sentiment that if  
389 Congress could find someone better suited to lead the army that he  
390 would be more than happy to resign and return to private life at his  
391 **Mount Vernon** estate.

392 The winter at Valley Forge might have signaled the end of the  
393 **American Revolution**. Fortunately for the Continentals,  
394 Washington did not give up. Fortunately for all of us, 240 plus  
395 years later, Washington knew where to turn for sustaining  
396 strength, for divine guidance and help in times of great distress. A  
397 Quaker, name of Potts, lived in Valley Forge when George

398 Washington quartered his troops there that auspicious Winter in  
399 1777. He relates this story.

400 "I never believed that America could proceed against Great Britain  
401 whose fleets and armies covered the land and ocean. But something  
402 very extraordinary converted me to the good faith." He was telling  
403 a friend the story of when he saw Washington on his knees in the  
404 snow praying. He said, "Do you see that woods, and that plain?  
405 "There laid the army of Washington. It was a most distressing time  
406 of ye war, and all were for giving up the ship but that one good  
407 man.

408 "In that woods," he pointed to the place, "I heard a plaintive sound,  
409 as of a man at prayer. I tied my horse to a sapling and went quietly  
410 into the woods and to my astonishment I saw the great George  
411 Washington on his knees alone, with his sword on one side and his  
412 cocked hat on the other. He was at Prayer to the God of the  
413 Armies, beseeching to interpose with his Divine aid, as it was ye  
414 Crisis and the cause of the country, of humanity, and of the world."

415 Such a prayer I never heard from the lips of man. I left him alone  
416 praying. I went home and told my wife, 'I saw a sight and heard  
417 today what I never saw or heard before', and just related to her  
418 what I had seen and heard and observed. We never thought a man  
419 could be a soldier and a Christian, but if there is one in the world,  
420 it is Washington. We thought it was the cause of God, and America  
421 could prevail,"

422 Mr. Potts became a Whig and joined Washington's army.

423 I have lit the lamps in the Church belfry arch and now you let me  
424 know if you see them. It's LIGHTS ON if you see the LIGHTS ARE  
425 ON and you will ride like Revere and spread the warning,  
426 (essentially, it means you agree with what I'm saying) or you say  
427 LIGHTS OFF -- which means you reject what I'm saying and

428 disagree strongly with me. So, what will it be today, lights on, or  
429 lights off?
