- 24 My friends it's time for your Brain Massage.
- 25 [TRUTH]

- 26 George Washington said, "Truth will ultimately prevail WHERE
- 27 THERE IS PAINS TAKEN TO BRING IT TO LIGHT."
- We need men—Christian soldiers—who will "endure hardness."
- 29 But most politicians are averse to struggling upstream against the
- 30 flow, or against the wind—they are more like wind vanes that
- 31 change direction with the wind!
- 32 It's the "pains" the SCOTUS loathes. It's the "pains" associated with
- 33 taking a stand against the militant left today—the pains the
- 34 tyrannical Democrats will surely inflict, the "pains" hassle,
- 35 trouble, attacks, and threats—that's why they want to "make nice"
- 36 with the bullies, they want to "find common ground" to make
- 37 "friends" of our enemies. What they don't understand is making
- 38 friends with a snake only ends up feeding the snake.
- 39 It requires doing a lot of uncomfortable things—it involves
- 40 exposing people as liars, and cheats; it involves sometimes
- 41 provoking the ire of powerful men and women who can hurt you,
- destroy your career, cause "pain" to you and your family.
- 43 But that's sometimes the "pain" that must be endured to BRING
- 44 TRUTH TO LIGHT. And that is why we need MEN, not wussies
- 45 (by the way, do you know what that word means? It was
- introduced in the 70s and no one knows how it originated. Yes, it is
- 47 a word, and it's used as a noun and a verb. As a noun it identifies
- 48 an ineffectual person. But it's use as a verb actually clarifies its
- 49 meaning when used as a noun. A wuss is someone who fails to do
- 50 something as a result of fear or lack of confidence). In this hour of
- 51 distress, we need MEN!
- Most politicians are driven by a need to be LIKED! It's what wins
- 63 elections—it's also what corrupts them. They want their political
- 54 opposites to *like* them. They want the MSM to *like* them. For these,
- success is getting others to *like* them.

- 56 In every encounter, if it concludes with you liking them, they
- 57 derive a sense of fulfillment, and they will go away believing the
- 58 encounter was successful.
- 59 This is McConnell, and his buddy Thune, and to a lesser degree,
- 60 Lindsey Graham, and others. They are convinced that getting
- 61 things done is about getting people to like each other.
- 62 Being liked is fine, except when you are dealing with snakes—
- 63 wicked men and women. Never trust the affection of a snake.
- When you are dealing with wicked people, they will attempt to
- 65 "win" you in order to blind you. The only way to remain safe from
- 66 seduction by the wicked is to understand and embrace the natural
- 67 *enmity* that GOD has placed between the wicked and the righteous.
- 68 Remember? In the garden, God said to Eve that He would put
- 69 ENMITY between her seed and the seed of the Serpent. The
- 70 reference to her "seed" is to the incarnate SON OF GOD—
- 71 something we just celebrated at Christmas. Those who receive the
- 72 SON OF GOD are birthed to God—by the incorruptible seed we
- 73 are made children of God. These are called the children of
- obedience, because they obeyed the GOSPEL command to repent
- and believe on Jesus Christ to be saved from the WRATH OF THE
- 76 LAMB when He COMES to JUDGE THE EARTH.
- 77 The seed of the Serpent refers to the children of Satan—called the
- 78 children of disobedience because they refuse to repent and believe
- on God's Son.
- 80 God put ENMITY between these seeds. Why would God put
- 81 ENMITY between the seeds unless it was His purpose to set them
- 82 at odds with one another? He does not want the righteous to "get
- 83 along" with the wicked. He is not interested in encouraging His
- 84 children to come under the spell of Serpents. And if you are paying
- 85 attention, that is exactly what happens. We send good men to

- Washington DC and soon they begin trusting the false affection of
- 87 the snakes—and before long, they are gone.
- 88 Remember that while all men are sinners, not all sinners are given
- 89 over to the impulse of their sinful nature. I differentiate it this way;
- 90 all men are sinners, but not all men are wicked. The wicked are the
- 91 enemies of God, the enemies of righteousness, the haters of truth.
- 92 Not all sinners are haters of truth, not all sinners are dedicated
- 93 opponents of truth.
- 94 But any sinner, or saint, for that matter, who makes friends with
- 95 the wicked, will begin to see their convictions and their courage to
- 96 break down—their resistance to the seduction of the snakes will
- 97 break down until they are under the control of the snakes. From
- 98 there, all sorts of fleshly desires will begin to gain control of them
- and over time, they will succumb to the darkness. It is not too long
- before all the ideals that might have at first inspired them to aspire
- 101 to public service are gone, and all that's left is a Gollum like soul
- 102 haunting the dark caverns with only one all consuming passion:
- 103 protecting his ring of power.
- 104 What we need are MEN! Men of courage and conviction—men
- 105 who are not afraid of the "pains" necessary to bring TRUTH TO
- 106 LIGHT.
- 107 I put out a call for MEN on Wednesday night—check it out! I'll
- abbreviate the message here as I conclude the first segment.
- 109 Israel was in trouble. The army was sandwiched between two large
- 110 batteries Israel was outnumbered, and virtually surrounded.
- 111 They could not leave without exposing their rear to the enemy,
- 112 which would have meant certain destruction. We are in such a
- case. We are surrounded! Children of disobedience, who hate God,
- 114 hate Christ, hate His true CHURCH, and hate biblical Christians
- 115 mass before us and behind us. Many silly wussies on the Right
- 116 think we should "negotiate" with snakes—they think we should

- 117 yield and run—they are unwise—they do not have the
- 118 understanding of MEN—they don't realize that these enemies of
- 119 our liberties will never willingly yield and we will NEVER be
- stronger than we are today to resist and defeat them. Yielding only
- 121 increases their strength and diminishes ours. WE MUST NOT
- 122 LISTEN TO THE WUSSES. WE need MEN right now, not wussies.
- WE NEED men like Joab, who was captain of the host and here is
- what he said to his men.
- 125 "Be of good courage, and let us play the men for our people, and
- 126 for the cities of our God: and the LORD do that which seemeth
- 127 Him good" (II Samuel 10:12).
- 128 Joab did not whine, he did not throw up a white flag to the enemy,
- 129 he did not accept the oh, I did not tell you how this fight got
- 130 started. The king of Ammon had befriended David, and when that
- 131 king died, David sent an 'embassage to the king's son to extend
- 132 condolences and honor the friendship. The king decided David's
- 133 embassage were spies and cut out their garments exposing their
- buttocks, and shaved their beards. Realizing this effrontery would
- certainly provoke David, they hired the Syrians and set their army
- in the field—when David heard of this, he sent Joab and the mighty
- men to meet them. We have been insulted by the open and flagrant
- manner of the Democrats in this election—they have belligerently
- defied law, trampled on the Constitution, and used COVID as a
- 140 cover to commit FRAUD in this election—and treasonously they
- 141 have colluded with China to steal the election for a China puppet:
- Joe Biden. But the "PAINS" to bring this into the full light of DAY
- 143 is too much for the wussies and they wont make the sacrifices
- 144 necessary to expose it!
- 145 When Joab found himself surrounded, he called for MEN he
- 146 said, "be of good courage, and let us play the men ..." It is
- interesting that the words translated courage and play the men are
- 148 from the same root—actually, they are the same word, and it

- means to GRIP, to TAKE ON, with resolve—and so it is a Hebrew
- 150 word that means courage. The different is that play the men has an
- 151 added prefix—and the point is—the expression play the men
- means act the part of a MAN and the fact that the word for *play*
- 153 the man here is the same word that means COURAGE tells us that
- 154 the primary characteristic of a MAN is COURAGE. And
- 155 COURAGE is the resolve to DO WHAT IS RIGHT no matter what
- 156 the CONSEQUENCE. Joab committed the consequences of their
- actions to WHAT SEEMED GOOD TO GOD. He challenged the
- 158 MEN to be MEN that would FIGHT to protect their PEOPLE, and
- 159 the CITIES OF OUR GOD no matter what happens as a result
- 160 the RIGHT THING must be done.
- 161 The wussies say, oh, come on man trying to challenge the
- 162 certification of the electoral votes is, how did wussie Thune put it?
- 163 Republican Senator is "going down like a shot dog." He added,
- 164 "And I just don't think it makes a lot of sense to put everybody
- through this when you know what the ultimate outcome is going to
- be." What a jerk! It's not about "what the ultimate outcome is going
- 167 to be." That's in GOD's HANDS! What is in your hand is to DO
- 168 ABSOLUTELY EVERYTHING YOU CAN DO TO OPPOSE THIS
- 169 TRAVESTY OF JUSTICE. The THEFT of our BALLOT BOX —
- 170 you coward is NOT something MEN can sit down for.
- 171 This could well turn into the tale of four boxes. We tried the SOAP
- 172 BOX, the JURY BOX, and the BALLOT BOX if you take away
- the ballot box, there is only one box left and that's the AMMO
- 174 BOX. I grew up hearing, all my life I grew up hearing the old
- 175 maxim, we settle our differences in America with ballots not
- bullets. Well, you take away the ballot, and all that's left is bullets—
- 177 STOP THIS NOW! Real men must STAND UP AND STOP THIS
- 178 NOW. Looks like I'll be continuing this on the other side of the
- 179 break. Hold on! I'll be right back.

- 180 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
- 181 at the Lighthouse, your brain masseur, and Paul Revere's lantern
- lighter, lighting the lamps in the church belfry arch, signaling the
- 183 enemy is on the march, an enemy that would steal from us our
- 184 liberty.
- 185 The captain of the LORD's host in the days of David was Joab. His
- 186 army was in a pickle enemy in front of him and enemy behind
- 187 him. He could not attempt to maneuver out from between the two
- armies without exposing his read or retreating and allowing both
- armies to pursue them—he had to either surrender or FIGHT.
- 190 Joab new that surrender would expose Israel to plunder, and
- 191 pillage, to mayhem and oppression. He chose to FIGHT even
- though the odds were decidedly against him.
- 193 He told his men, "Be of good courage, and let us play the men for
- our people, and for the cities of our GOD." His response was not
- 195 governed by the odds of victory, the reasonableness of any hope for
- 196 victory—his determination was governed by the MANLY
- 197 understanding that this enemy would bring Israel into oppression,
- 198 this enemy would make the people into slaves to defend the
- 199 RIGHTS and LIBERTIES of the CITIES OF OUR GOD we must
- 200 have MEN that will stand up against the WICKED who would
- 201 oppress us who would take from us our liberties.
- 202 The Bible is full of stories like this. David ran out to meet Goliath—
- 203 he was not thinking about the probabilities of success for a kid with
- a slingshot to go out against a giant that stood nine feet tall with a
- sword and shield—he had one thing on his mind: The GLORY
- 206 AND HONOR OF HIS GOD and the DEFENSE of RIGHT and
- 207 FREEDOM OF HIS PEOPLE from the oppression of the
- 208 Philistines. We need MEN who will jeopard their lives—who will
- 209 TAKE THE PAINS to STAND FOR TRUTH.

- 210 The wussies will run up the white flag at the first sign of pains—
- 211 they will say, David, you can't win against Goliath—not
- 212 understanding that for MEN winning is not what shapes the WILL
- 213 TO FIGHT. RIGHT does! What is RIGHT makes MIGHT! A
- 214 MAN will STAND to FIGHT when its RIGHT against WRONG.
- 215 But wussies waffle and quibble over practical concerns, because
- 216 they are so smart! But they are fools. They are yielding to the
- 217 WICKED and giving them strength while weakening those whose
- 218 will is to FIGHT. They discourage the effort to STOP THIS
- 219 WICKED EFFRONTERY TO OUR RIGHTS AS AMERICANS—
- leave the "out come" to GOD, take COURAGE and FIGHT ON.
- 221 But the wussies will always be there to criticize the FIGHTERS—to
- demoralize them, to compromise them, and even work behind the
- 223 scenes against them. Many of these wussies are conspirators
- dedicated to serve the enemies while pretending to be on our part.
- You heard me describe them as face-kissing backstabbing Judas
- 226 Republicans. That's a different level—those guys are traitors! Some
- 227 of them bought and paid for with the same money that has
- 228 purchased Biden. China has it's plants scattered everywhere doing
- 229 its bidding—a CCP Professor said as much in a speech a bit ago.
- 230 So, you need to ignore them! Stay focused on the Battle that is
- 231 immediately in front of you. If some wuss comes at you waving a
- white flag—spit in his face and keep on fighting! (I don't mean that
- 233 literally.) If you see a white towel drop down in front of you in the
- 234 rink while you are in the fight, kick it back into the face of the wuss
- that tossed it, and KEEP ON FIGHTING.
- 236 I can't stand those weasels on the right who are throwing in the
- 237 towel, running up the white flag I'm in a fight! And a MAN
- 238 fights to the end: his own or his enemies. And this is the sort of
- 239 fight that we cannot afford to lose but win or lose LET's FIGHT
- 240 for what is RIGHT!

- So, let's talk about the FIGHTERS! First, the thousands of citizens
- 242 who swore out affidavits testifying to their eye witness accounts of
- 243 FRAUD and "irregularities." Some of these people have exposed
- 244 themselves and their families to grievous attacks and threats from
- bullies on the left. These are men and women willing to endure the
- pain necessary to BRING THE TRUTH INTO THE LIGHT.
- 247 And then there are captains in this fight: Giuliani and Jenna, and
- 248 Powell, and Woods, and DePerno, Allied Security Operations
- 249 Group (ASOG), and now the latest Jovan Hutton Pulitzer
- 250 (sounds like a made up name for a novel or something). Turns out,
- 251 Jovan was originally named Jeffery Jovan Philyaw changed it to
- Jovan Hutton Pulitzer. I have his official bio if you want to peruse
- 253 it—very extensive. His credits are impressive! Jeffery Jovan
- 254 Philyaw: a first generation German Jewish American, a brilliant
- inventor, and author, and something of a history aficionado, holds
- over 200 patents related to the interface between people and paper
- 257 with the internet. Probably every day, multiple times a day, you
- engage the Internet on a platform that is using Jeffery's technology.
- 259 We know him as Jovan Hutton Pulitzer because, as I suppose,
- 260 like many from immigrant families, he found his given name a bit
- 261 clumsy in day to day discourse—so he changed it to Jovan Hutton
- 262 Pulitzer—perhaps it's somewhat optimistic, or perhaps it is an
- 263 homage to the famous Joseph Pulitzer of journalism fame in the
- 264 opening of the twentieth century. So, what is Jovan Hutton
- 265 Pulitzer doing in the FIGHT?
- 266 The Georgia State Senate hearings are proceeding and Jovan
- 267 Pulitzer is shining the bright LIGHT of truth on what happened in
- 268 this election. He is an expert a brilliant expert in the field of
- 269 paper and computer interaction. When you scan something at the
- 270 store, or with your phone scan a QR code and all that, you are
- 271 using technology he invented. He makes clear what is otherwise
- 272 mysterious to us non geeky-types. For example, he explains the

- significance of the bar codes on the ballots. He explains how those
- 274 markings on the paper of the ballot are the only "code" we need to
- be concerned about. The machine merely reads the code and does
- so according to hard rules, so if the "code" on the ballot is incorrect,
- it triggers a rejection by the machine.
- He illustrated it by putting a dollar bill into a vending machine—if
- 279 the reader scans the dollar bill and cannot recognize it, the
- 280 machine kicks the dollar bill out. You have to smooth it out, and
- 281 unfold the corners, and so on, and try again. But until the machine
- 282 can identify the dollar bill, it will not accept it. The same thing
- 283 happens with a ballot. If it cannot "read" the bar code, it rejects the
- ballot, only in this case, the ballot gets sent to adjudication—where,
- with these machines, an operator can manipulate the ballot.
- 286 Jovan shows that in fact, the markings on the ballots were
- purposely made to trigger rejection by the machine which required
- 288 the ballot to be sent for adjudication in adjudication, without
- any oversight, an adjudicator can manipulate the ballot any way
- they choose. In MI the ballots were rejected at a rate of 68%. A 68%
- 291 error rate is totally unacceptable. The law sets the threshold at
- 292 .0008.
- 293 And he showed physical evidence that the ballots were not
- 294 consistent in Georgia. Some had bar codes and other DID NOT.
- Now, why would some ballots not have the barcode? Well, you see,
- 296 the barcode connects the ballot to the envelope the bears the
- 297 signature of the voter. If you don't have a voter you don't want
- there to be any traceable connection to any envelope!
- Now, if the left plays their favorite game of plausible deniability
- 300 and says, well, that's printer error then we have to redo the
- 301 election because that printer error created a situation where we
- 302 cannot verify that ballot was filled in by a legitimate eligible voter.

- The whole point of keeping the ballots for 20 months is in order to
- 304 provide for audit. Any company, as Jovan pointed out, that did not
- 305 keep their records for audit purposes during the requisite period
- 306 required by law, would be PUNISHED SEVERELY CEOs could
- and up in jail, the business would be SHUT DOWN.
- How is it possible for business finances to be more important than
- 309 the sacred right to VOTE?
- 310 So Jovan wants the State to deliver 500,000 ballots to him to run
- 311 through his machine that will examine them. He says he is able to
- 312 identify whether the paper they were printed on was from China,
- 313 he can tell you if the ballot was completed by a machine or by a pen
- 314 in the hand of someone, he can tell you if a mail-in-ballot was
- 315 actually mailed at all. He tells us he can run a million ballots
- through his analysis in a matter of a day or so.
- 317 Then, Jovan did another amazing thing! You remember Dominion
- 318 CEO John Poulos testified, under oath, that the machines are not
- designed to be online. He told the MI State Oversight Committee
- on December 15, 2020, "Additionally, voting systems are by design
- 321 are meant to be used as closed systems that are not networked
- meaning they are not connected to the internet."
- Well, guess what? Jovan opened up his computer, right in front of
- 324 the Georgia Senate judiciary committee and connected to a
- 325 Dominion machine right there before their eyes. Yep! This past
- Wednesday, Jovan did a LIVE HACK JOB on the DOMINION
- 327 MACHINE in full view of the panel. He PROVED for these
- 328 Georgia Senators that the runoff going on right now IS
- 329 CONNECTED TO THE INTERNET. He established two-way
- 330 communication from a polling pad in a voting center in Georgia.
- Well, now, that's not supposed to happen, Mr. Poulos.
- 332 And the huge I came across this liberal who said the only thing
- anyone is going to find in any audit is that Biden won a free and

- fair election and I say, well, I wrote that he had to be kidding,
- because no one with sense can believe Biden got 80 million votes—
- but, laying that aside for the moment—I said, great! So there is no
- reason to object to a complete signature audit of the ballots, right?
- 338 Crickets!
- 339 As Jovan pointed out, we must have access to the hard evidence,
- 340 what he calls the artifact of record the empirical paper ballot
- that was completed by the voter.
- 342 On what grounds does the "State" refuse to make these ballots
- 343 available? What possible argument can be made against allowing
- 344 the ballots to be examined forensically? There is no reasonable
- objection! The same thing is true with regard to these machines.
- 346 There is no reasonable objection to allowing the machines and the
- 347 ballots to be forensically examined. Well, actually, there is one!
- 348 And the one reasonable excuse for not allowing access to the
- 349 ballots and the voting machines is to COVER UP THE FRAUD
- 350 that occurred in this election.
- 351 So, what MEN do we need next!
- 352 Congressional certification of the Electoral votes is coming Jan. 6—
- 353 what MEN must do! Gohmert is "the man." Only, I think it is a
- 354 mistake to go to the courts. The courts are full of wussies! They are
- 355 ducking for cover and hiding during this fight. The SCOTUS is a
- 356 worthless pack of gutless cowards—with the exception of Thomas
- and Alito. Gorsuch, Kavanaugh, and Barrett are wussies—hiding
- 358 behind Robert's fear of "interfering in politics." I'm so sick of these
- 359 self-righteous liars who allow POLITICS to INTERFER with them
- 360 DOING THEIR DUTY. Their job is not to make decisions
- 361 controlled by whether or not their decision might have political
- 362 consequences CONSEQUENCES again YOUR DECISION IS
- 363 CONTROLLED BY YOUR DUTY. It's your duty to rule on
- matters of constitutional law and that's what is at stake here.

- 365 So, Gohmert, I hope you don't allow yourself to get stopped by any
- 366 coward court. If you find a court with courage to rule according to
- 367 JUSTICE and JUDGMENT in defense of the CONSTITUTION —
- 368 good.
- 369 But if not! What is RIGHT is RIGHT and what is WRONG is
- 370 WRONG.
- 371 It was WRONG for those states to proceed with certification of
- 372 electors that were appointed CONTRARY TO THE MANNER
- 373 DIRECTED BY THE LEGISLATURE OF THOSE STATES. THAT
- 374 IS WRONG. Period! It should never have happened.
- 375 The Legislatures in those states appointed alternate electors in
- 376 order to address this error (of course, they were hoping the
- 377 COURT would rule on the matter but let me say something here
- that Styn was trying to say on Rush's show today (It's Thursday,
- have to get the show in early again cause people want to take some
- 380 time off with their families imagine!) But anyway, THE
- 381 COURTS DON'T CREATE LAW.
- 382 THE COURTS DO NOT CREATE LAW. The fact is, the LAW
- 383 SAYS electors are to be appointed according to the manner
- 384 directed by the Legislatures in each state in these states the
- 385 electors were NOT APPOINTED IN ACCORDANCE WITH THE
- 386 MANNER PRESCRIBED by the Legislatures only the
- 387 Legislatures can decide whether they will accept how the electors
- 388 were appointed if those legislatures say FOUL and send
- 389 alternate electors because of their concern about FOUL PLAY —
- 390 Then, the President of the Senate, with the Congress in concurrent
- 391 session, MUST DECLARE THE ELECTORAL VOTES THAT
- 392 WILL BE COUNTED ARE THOSE LEGALLY APPOINTED.
- 393 Then, for ONCE you weak kneed Republicans FOR ONCE
- 394 put those demoncrats on the defensive and let them try to litigate

- 395 that before the COURT and lets see if the lousy COURT will
- 396 THEN, FINALLY decide to DO THEIR JOB.
- 397 Jan. 6 Gathering in DC to support the Constitution—my
