8 Even with all that has gone on, Trump's approval rating is strong at
9 49%. Now, that might not seem like much—but remember after
10 the Media beating Bush II took he left office at 34% and Trump has
11 suffered a beating from the MSM and the entire Democrat
12 establishment that transcends anything in history. Add to that, we
13 all know that the polls are skewed to favor the interests of the
14 Communists in China and their operatives here—so, Trump's
15 support is most likely somewhere upwards of 60%. And unlike
16 Obama's 59% end of term approval rating, Trump's approval is not
17 puff—it's rock solid! Many were afraid to not to support Obama,
18 while in Trump's case, many are afraid to admit they do. This is
19 important—as you shall see!

20 We must start with the riots at the capitol on Jan. 6. We know that
21 ANTIFA websites called for agitators to dress as Trump supporters
22 and "blend in." Many reliable reports have confirmed that ANTIFA
23 and BLM types were present. In one report, the Capitol police
24 warned some Trump supporters "hundreds of ANTIFA were there
25 disguised as Trump supporters" and it was believed they planned to
26 instigate trouble that would be blamed on the Patriots. When the
27 police appeared to stop intrusion into the Capitol, the agitators
28 went to work, provoking the police to respond and when innocent

29 Trump supporters believed the Capitol police was targeting them,
30 they foolishly began to fight back. Exactly what the Marxists
31 wanted. However, what the MSM refuse to report is the Trump
32 supporters who tried to stop the violence, some a risk to their
33 lives—I watched one guy trying to stop the crowd from throwing

35 No doubt, some Trump supporters got caught up in mob fever. It's
36 partly what I feared—the mixture of patriots with the anarchists in
37 a scene like what developed on the Capitol steps could only lead to
38 trouble.

39 The foolish patriots who participated in this made a huge mistake!
40 As soon as the violence began breaking out, patriots should have
41 immediately moved away and separated themselves from the
42 rioters. It's a political coup—and it needs to remain so—trust me, if
43 Trump does come out of this the winner—the real insurrectionists
44 will come out in the open and that's the time to fight in defense of
45 our country.

46 Also, notice the timing of the outbreak! Just as the first objections
47 were being heard on the floor—the outbreak began. I think it was
48 coordinated! I believe these Soros thugs were hired and cued up to
49 STOP THE OBJECTORS—you see, our enemy understands the
50 Republican Party very well. They know that it does not take much
51 to cower them. They know they can manipulate their sensitivity to
52 fair play, and abhorrence for violence. On the other hand, the
53 Democrats have no such scruples. Fair play means nothing to
54 them; like Jordan said, the Democrats KNOW FULL WELL the
55 Constitution was violated in their effort to steal this election, and
56 THEY DON'T CARE.

57 The violence instigated by Soros thugs successfully upset the
58 members of Congress and derailed a clear headed hearing for
59 Cruz's proposal that Congress agree to an investigation into the
60 allegations of fraud in order to show the American People, the

61 MILLIONS of Patriots who believe the election was dirty—to clear
62 the air so we can move forward with at least some hopes of unity at
63 least with regard to the integrity of our elections in AMERICA.

64 I think the proposition would likely have been rejected — but now
65 we will never know! This is important because, it's like I've said so
66 many times, we CANNOT USE SATAN's DEVICES to advance
67 our cause — GOD will never support it! The VIOLENT take by
68 force and farce — we must not get drawn in to his devices! TRUTH
69 is our weapon—and it will MARCH ON!

70 Furthermore, reports are coming out about some Capitol police
71 using excessive force on old men and women and children, beating
72 them with their batons — instead of the per usual creating a
73 phalanx and pushing people back — wicked usurper Joe Biden
74 made a statement — he is sure that if it were BLM activists then
75 "we all know" they would have been treated differently. My wife
76 shot back, yeah, they would have been allowed to besiege the
77 buildings and attack police with Molotov fire bombs while the
78 MSM and Suckerberg "fact checkers" blathered on about how we
79 all must understand the oppression from white people caused this
80 — and how that the protest was, after all, "mostly peaceful."

81 Well, I would say that 500,000 + protestors were "mostly peaceful,"
82 wouldn't you? And I would say the fear that our Constitution is
83 being betrayed is a pretty good reason for Patriots to be very
84 emotionally charged and concerned—and it's not some made up
85 thing—it's a fact.

86 Nevertheless, the rules for Patriots are different from the RULES
87 for RADICALS — I need to write a pamphlet laying out the RULES
88 FOR PATRIOTS and dedicate it to JESUS CHRIST Who defeated
89 Satan on the CROSS. I have a chapter in my book, Rules Of
90 Engagement, that would be a good start! That's God's War: Why
91 Christians Should Rule the World — THE CASE FOR

92 CHRISTIAN INVOLVMENT IN EVERY SPHERE OF CIVIL
93 AND SOCIAL LIFE.

94 I still cannot get clear information on how the reconvened joint
95 session proceeded — but we all know the outcome. I hoped Cruz's
96 petition would have been received, but did not expect it would be.
97 The WICKED must be expected to do WICKEDLY — after all they
98 did to STEAL THIS ELECTION did anyone expect they were going
99 to suddenly have a moment of honesty and agree that it would be
100 better for the nation if the Congress showed an honest regard for
101 their concerns and conducted an open investigation of the
102 allegations of fraud and foreign influence? Of course not! The very
103 LAST thing they want is an examination of what they did in the
104 LIGHT of TRUTH. They must keep it hidden in darkness, and
105 shadows—which is the reason they orchestrated the fake
106 "INSURRECTION" — they wanted to WARN the Representatives
107 and Senators of what's coming if they don't get their way! They are
108 using the tactics of a two-year-old tantrum that screams and
109 stomps till they get their way! YOU WILL HAVE NO PEACE
110 UNTIL YOU GIVE UP AND GIVE IN. But, with these devils,
111 friend, that will not end it. The tantrum will turn into a full court
112 press of oppression to make certain we CHRISTIANS never, ever,
113 try this again! So, like it or not, the culture war has turned into a
114 cold civil war — which I fear can break out into a hot civil war
115 unless LAW AND ORDER ARE RESTORED and the American
116 People can TRUST their ELECTIONS.

117 You see one thing is for certain. The American people will stand
118 down for a clear and honest election. But they will not accept a
119 STOLEN ELECTION!

120 Let me conclude the first segment with a bit of encouragement. I'll
121 be speaking to the issues Sunday morning and evening — GOD
122 spoke through the prophet Isaiah "Thou wilt keep him in perfect

123 peace, whose mind is stayed on thee: because he trusteth in thee"
124 Isaiah 26:3.

125 There are three things that will never change—God is on His
126 throne and rules as Sovereign over all His creation — and HE
127 NEVER CHANGES. He hates oppression, deceit, and violence as
128 much today as He has ever. Second, He always has a remnant that
129 He never forsakes. And Third: Our mission remains the same no
130 matter what else changes. As for His protection of the remnant:
131 consider His promise through the prophet Isaiah: GOD keeps,
132 protects, maintains, watches over, tends, all His own in PERFECT
133 PEACE — not the imperfect kind that might come from vain
134 hopes, and distractions of various kinds—but the kind of peace
135 that will sustain you through even the most turbulent and
136 distressing circumstances. And who are the beneficiaries of this
137 perfect peace? Those whose minds are stayed, fixed, set, rested
138 upon HIM — get your head with your HEAD and your mind will
139 be settled down—and the reason is that those who do this TRUST
140 IN GOD.

141 We cannot trust in MEN! But we can TRUST IN GOD. Pensive
142 Pence turned his back on us, and that's too bad! Pence is right, the
143 legislature is the body that is charged to take care of the fraudulent
144 electors — so my question to Pence is, in that case, sir, why did you
145 ignore the request of the State Legislatures that asked you to delay
146 the electoral certification until they had time to complete their
147 investigation? You see! So, no, Pensive Pence, it's not about the
148 CONSTITUTION and your concern that the LEGISLATURE is the
149 BODY that is directed by it to address the qualifications of
150 ELECTORS. Legislatures from the states of the disputed electors
151 ASKED YOU TO DELAY THE CERTIFICATION UNTIL THEY
152 COULD VERIFY THEIR ELECTORS — and, you, sir, IGNORED
153 THEM so far as I know. I cannot find any response from you to

154 those letters you received — and what argument you came up with
155 to ignore their request.

156 So, my point is that we cannot trust in MEN — we cannot trust in
157 their chariots — or their horses. That does not mean we do not
158 look to these men who are made stewards of the power of the
159 PEOPLE, charged to conduct their business according to the LAW,
160 that we do not ultimately put our trust in men does not mean we
161 do not look to them to DO THEIR JOB and DEFEND the
162 CONSTITUTION from all enemies foreign and domestic — but it
163 does mean that we don't implicitly — without qualification, or
164 absolutely — because, like Jesus, we know what is in man. So while
165 we are disappointed, and sometimes shocked, when men fail us —
166 when the wicked in this nation violate the Constitution and use
167 means to STEAL AN ELECTION and then virtually every court
168 betrays their duty to uphold the Constitution, and when SCOTUS
169 fails to do their Constitutional duty, and when State Legislatures
170 fumble about ineptly in the use of their Constitutional power, and
171 when those with POWER refuse to USE it to STOP THE WICKED
172 — when even our fellow patriots fumble about and make mistakes
173 — and it all comes down to one last official person with the
174 POWER given to him by GOD to CHECK THE RISE OF
175 WICKEDNESS in our land — and even if he, ultimately, fails us —
176 guess what? God never FAILS US! We can TRUST HIM!

177 So, with this as the background, I will talk about the Christmas
178 surprise—and what very well might be STANDARD we have been
179 waiting for the LORD to raise up against the FLOOD—for He
180 promised, that when the enemy comes in like a flood, the LORD
181 shall raise up a STANDARD against him. Hold on! I'll be right
182 back.

183 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
184 at the Lighthouse, your brain masseur, and Paul Revere's lantern
185 lighter, lighting the lamps in the church belfry arch, signaling the

186 enemy is on the march, an enemy that would steal from us our
187 liberty.

188 I'll have to jump right into this if I hope to get enough of the
189 information out there to you so you can know how to pray!

190 Keep in mind—the DEEP STATE is desperate! They control
191 almost every lever of power in the country—BUT THEY KNOW
192 THERE ARE SERIOUS PATRIOTS AT WORK TO EXPOSE

196 Allow me to begin with a court case developing in Rome, Italy
197 where Arturo d'Ello gave testimony under oath regarding his own
198 part in helping the Deep State in America steal the election from
199 the American People. Peoples — this is not one of those Brain
200 Massage teasers—this court case began, I think it was Jan. 6—. And
201 it's something Trump has known was coming since Christmas Eve.
202 I was first apprised of it about a week ago but had to do some
203 research to verify. When I learned the witness had actually taken
204 the stand and gave his testimony—I felt it was time to bring it to
205 the show. Listen carefully.

206 Setting: Leonardo SpA, is the name of a company that specializes in
207 cyber security. This Italian based company was awarded a billion
208 dollar contract for cyber security, intelligence, and other defense
209 contracts by the US in fiscal year 2020. This company is the 10th
210 largest defense contractor in the world and the third largest in
211 Europe. *Leonardo* operates several advanced military grade

212 satellites (think *cyber warfare*) that are owned by Italy and allegedly
213 under the specific provenance of the Vatican.

214 A senior IT employee of Leonardo, one Mr. Arturo D'Elia, since
215 arrested for his own safety, we are told, was the head of the IT
216 Department of Leonardo SpA. He tells a harrowing story.

217 I'll begin by reading his attorney's sworn affidavit testifying to his
218 client's sworn confession:

219 Swearing under oath that this report is a true and faithful
220 statement from the witness: Professor Alfio D'Urso,
221 Advocate/Lawyer, of Via Vittorio Emanuele, Catania, 95131 Italy,
222 testified to the affidavit of facts as conveyed to him in several
223 meetings with a HIGH LEVEL ARMY SECURITY SERVICES
224 OFFICIAL:

225 "ARTURO D'Elia, former head of the IT Department of Leonardo
226 SpA, has been charged by the public prosecutor of Naples for
227 technology/data manipulation and implantation of viruses in the
228 main computers of Leonardo SpA in December 2020. D'Elia has
229 been deposed [*means he was interrogated under oath*] by the
230 presiding judge in Naples and in sworn testimony states[:]

231 "On 4 November 2020, under instruction and direction of US
232 persons working from the US Embassy in Rome, [he] undertook
233 the operation to switch data from the US elections of 3 November
234 2020 from significant margin of victory for Donald Trump to Joe
235 Biden in a number of states where Joe Biden was losing the vote
236 totals.

237 "[The] Defendant stated he was working in the Pescara facility of
238 Leonardo SpA and utilized military grade cyber warfare encryption
239 capabilities to transmit switched votes via military satellite of [the]
240 Fucino Tower to Frankfurt Germany.

241 "The defendant swears that the data in some cases may have been
242 switched to represent more than total voters registered."

243 [Something we can verify—since 153m are registered and there
244 were 158m votes counted.]

245 "The defendant has stated he is willing to testify to all individuals
246 and entities involved in the switching of votes from Donald Trump
247 to Joe Biden when he shall be in total protection for himself and his
248 family. Defendant states he has secured in an undisclosed location
249 the backup of the original data and data switched upon instruction
250 to provide evidence at court in this matter."

251 "I hereby declare and swear the above stated facts have been stated
252 in my presence.

253 DATED this 6th day of January 2021 at Rome, Italy.
254 General Affidavit."

255 This was presented to Trump on Christmas Eve by Mary Zack and
256 her husband in a meeting at Mara Lago set up by Tiffany. This with
257 corroborating testimony has also been delivered to some trusted
258 Representatives, Senators, and to other officials.

259 This news is breaking out in Italy—of course—Leonardo SpA has
260 been apprised of this and they quickly set out to destroy the
261 credibility of the witness. He has been arrested on what he and his
262 attorney claims are false charges of hacking into Leonardo and
263 stealing airplane schematics and some other tools — two things!
264 First, he came forward with his testimony before the arrest and
265 second, he did say he kept backups of the original data—so! Here
266 we go!

267 In other news, Prime Minister Conte is implicated in this
268 conspiracy. And Germany, and Switzerland, there is a China
269 connection with Conte, and a Soros connection—wow! It just
270 keeps getting weirder; but I must work toward conclusion.

271 Look, I understand that Trump has spent some hours in closed
272 session with some serious supporters trying to decide which of
273 several options available to him to use going forward. It is

274 interesting how aggressively Pelosi and company are working to
275 get insurrection charges brought up against Trump—when in fact,
276 the insurrectionists are the Democrats and their cohorts in the
277 Deep State. The hypocrisy of the LEFT has become so
278 commonplace we are liable to miss the method to their madness.

279 They are pressing their advantage right now and pressing it HARD
280 to keep Trump from discovering fully and finally what it is they
281 have been up to—this conspiracy in Rome, Italy, by the way, was
282 hatched something like 8 months before the election.

283 This has been a very well planned international coup with
284 operational headquarters, apparently, and ironically, from a
285 prophecy point of view, in ROME! With the whole Russia collusion
286 thing being a clever color revolution ploy to set us up to dismiss as
287 absurd any allegations of a multi-national hack job on our election.
288 This is serious stuff folks — and a very serious WICKED effort to
289 take the kingdom by violence is underway!

290 We need the sort of evidence we are talking about here, that was
291 put in front of Trump on Christmas Eve — to strip the curtains
292 back and put it all in front of the American people right NOW —
293 so Trump can ACT in DEFENSE of the CONSTITUTION and
294 STOP Obama's planned coup—he said he imagined how it would
295 be, with him in his robe calling the shots to whoever stood as his
296 front acting like the President — and he will have that with either
