- 1 Segment.01 Hello. I'm Dr. Jerry Scheidbach, pastor of the
- 2 Lighthouse Baptist Church in Santa Maria, CA—and your brain
- 3 masseur—get ready for your brain massage.
- 4 Q, sometimes called Q-Anon, is breaking into the collective
- 5 consciousness of the kingdom of man. Hehe! Held by some to be
- 6 an oracle for predicting future events and by others to be a
- 7 gathering place for fools. So what does the Brain Masseur make of
- 8 it?
- 9 The Trump Persona factor! Is hatred for Trump about his
- 10 personality? Why that's a major MISS!
- 11 The Game Stop phenom—I'm sure I wont get to this today, so, I'll
- sum up: to me, this looks like establishment types don't like regular
- 13 guys getting in on their game and disrupting their playground—for
- 14 example, hedge funders disrupted to the tune of 70 BN brought
- 15 their attention to the Reddit raid. Soros does not like competition.
- 16 Okay, my friends it's time for your Brain Massage!
- 17 [TRUTH]
- 18 Q, sometimes called Q-Anon, is breaking into the collective
- 19 consciousness of the kingdom of man. Held by some to be an
- 20 oracle for predicting future events via cryptic messages, dark
- 21 sayings, parables, and secret codes decipherable by white hat
- 22 Patriots involved in a counter conspiracy to save the world from
- 23 the Nimrods (the God defying One-Worlders)—
- 24 By others Q-Anon is a gathering place for fools—a modern Mars
- 25 Hill where babblers babble and tall-tales are spun into webs as
- 26 thick as Shelob's lair and where some looking into this
- 27 conspiracy fun house mirror see the Gollums (conducting a Deep

- 28 State disinformation operation) leading the unsuspecting Patriot-
- 29 Frodos into a trap, where the DEMON Shelob stings them with the
- 30 venomous poison of deceit, so they might dull their senses not
- 31 sufficient to kill them, but to keep them docile and fresh so they
- 32 can from them STEAL THE RING OF POWER!
- 33 So what does the Brain Masseur make of it?
- 34 First off it's Q not properly speaking Q-Anon; it's just Q the
- 35 Anon simply refers to the fact that, 1. Q is anonymous, and/or 2.
- 36 many of Qs "Patriot Team members" post as anonymous followed
- 37 by an id number.
- 38 Q is reputedly a mysterious former, or acting, Intelligence officer,
- 39 but this is never directly stated, so far as I can find.
- 40 Some suspected of being Q are General Flynn, and President
- 41 Trump, but nothing is offered to substantiate the claim.
- 42 Having perused a few hundred posts, and listened to some who
- 43 treat Q like an oracle—and read what the detractors have to say—
- 44 people with the liberal bona fides of The Atlantic, for example, it
- seems to me Q is someone who believes in the conspiratorial view
- of history, is convinced of an international cabal of super powerful
- 47 elites intent on taking over the world and imposing their will on
- 48 humanity—making decisions like how many people should be alive
- 49 at any given time on the planet (Bill Gates), and who should hold
- 50 power in the world under their control—the DOMINION
- 51 machine, and so forth—a universal Socialist dictatorship in which
- 52 the entire world is under their direct CONTROL. By "their" I mean
- 53 the few super rich Banking families, like the Rothschilds, the
- 54 Bilderbergers, and Rockefellers, and so forth. It involves some
- 55 things you have heard of like the Illuminati and key players
- 56 involve the Vatican, the City of London, and, oh yeah, Washington
- 57 DC. And it includes plots like Beijing worming its way in to take
- Washington DC's place as among the CITIES THAT RUN THE

- 59 WORLD—and it involves complex and secret machinations that
- 60 have the ELITE CABAL playing each State against the other to
- 61 further their ultimate purpose, already stated, to RULE THE
- 62 WORLD and control all of its resources and all of its military
- 63 power of force—and it sees as acting behind all of this the sinister
- 64 forces of evil—Satan himself, presiding over the powers,
- 65 principalities, rulers of the darkness of this world and spiritual
- 66 wickedness in high places.
- 67 It appears to me that this fellow, as we all assume it's a fellow and
- 68 not a filla, watches carefully geo-political events, particularly as
- 69 touches the United States, and interprets these events within his
- 70 world view paradigm of a CONSPIRACY to take America down,
- 71 and fold it into the GLOBALIST order under the control of the
- 72 Banking CABAL.
- 73 As to his so-called "failed prophecies" the most famous of which
- 74 is Hillary was to be arrested on October 30, 2017—and his alleged
- dodge when he said this plan failed, and that she was detained but
- 76 not arrested—and the more recent theory that she is cooling her
- 77 heels at Gitmo waiting for the rest of her nere-do-wells to join
- 78 here—well I'm not an apologist for Q but I admit I have
- 79 wondered where she is of late! When was the last time we heard
- 80 from Hillary? I confess I don't follow MSM closely but usually by
- 81 now we would have heard her cackling about Trump losing—or
- 82 opining on what should be done about him! Right? Just saying!
- 83 As an honest observer, while I must say I don't have any
- 84 confidence at all in what the Liberals say about Q and I can
- 85 accept only some of what American loving patriots say about him
- 86 but with what information I have available now I'd say he is an
- 87 astute observer of American politics who interprets events as he
- 88 sees them contributing toward his expectation that PATRIOTS are
- 89 working in the background to deliver America from the clutches of

- 90 the Deep State-Central Bank-GLOBALIST conspiracy to enslave
- 91 the world.
- 92 Among the more enigmatical entries in Q alerts refer to 11.3 and
- 93 11.4 as "markers" indicating certain actions against the
- 94 politicians in America who are working for the Cabal—that is
- 95 using China right now to bring America into the GLOBAL FOLD.
- 96 Well, it just so happens that these seemingly cryptic references
- 97 actually refer to a legal document, published by the DOD, called
- 98 the Law of War Manual and lays out the LAW OF WAR for the
- 99 American Military. I have the latest update of that document from
- 100 the General Counsel of the Department of Defense, Pentagon, June
- 101 12, 2015 signed by then acting General Counsel Stephen Preston —
- 102 chapter 11 deals with THE LAW OF OCCUPATION. 11.3
- describes belligerent occupation as occurring in fact when a hostile
- 104 force occupies enemy territory and takes temporary control of its
- 105 government functions. Section 11.4 describes when and by what
- means such an occupation has come to an end. While this is
- obviously written with a view toward what rules govern our troops
- when occupying territory taken under control in the conduct of a
- war, such as when we took Iraq, the fact is the law is applicable in
- any case where the circumstances meet the descriptions given in
- 111 this law. In other words, it is applicable to any case where a hostile
- 112 force has taken occupation of what by that force is deemed an
- 113 enemy territory and holds it—whether or not the occupation is
- legal, or justified.
- 115 11.4 provides for the termination of a belligerent occupation by
- 116 "friendly" forces overcoming the occupying forces.
- 117 Qs reference to 11.3 and 11.4 are "markers," intended to say when
- 118 you see a belligerent occupation of Washington DC, in this case, by
- 119 foreign powers interfering in our elections and placing a puppet

- 120 President in the Oval Office—this was to be understood as a
- 121 "marker" alerting us that certain expected actions would begin to
- 122 take place.
- 123 Those expected actions include the Military intervention of our
- 124 Armed forces bringing to justice the traitors and criminals who are
- 125 occupying our nation's capital under the power and illegal
- authority of China, together with any other nations involved in
- this usurpation of our Constitution.
- 128 The lack of any such actions materializing has created some
- 129 confusion among the Q crowd and Q himself has been in black
- out for more than 50 days but the hopeful continue to wait for
- the second "marker," which will be release of the incriminating
- 132 information to the general public, followed by the arrests and
- 133 subsequent trials of the perpetrators of this treason, which will
- 134 result in the return of America to her roots—the old pool—and
- reestablishment of America, one nation under GOD.
- Now, it just so happens that I have also been expecting and looking
- for this same thing! I hoped our elections would have been fair and
- honest, but that failed. I had hoped our State Legislatures would
- 139 have taken to themselves their Constitutional authority and
- 140 declared the electors illegally chosen to be called back to their
- 141 respective states, along with firm instruction to the Congress that
- 142 those legislatures, exercising their duly CONSTITUTIONAL
- powers determined the elections in their states in question and so
- 144 they would have considered it a violation of their
- 145 CONSTITUTIONAL POWER to direct in what manner electors
- are chosen if those illegally chosen were counted but they failed.
- 147 I expected, and hoped, our courts would step in, do what is right,
- 148 and provide AN OPEN AND TRANSPARENT HEARING OF
- 149 THE ALLEGATIONS OF FRAUD before the eye of the public so
- 150 as to put to rest any questions about election fraud—but they
- 151 failed. I expected the Secretaries of State and Governors of said

- 152 states to have seen the wisdom of ALLOWING FULL AND
- 153 UNFETTERRED ACCESS TO THE VOTING MACHINES AND
- 154 BALLOTS TO CONDUCT A FREE, AND OPEN, AND
- 155 TRANSPARENT FORENSIC INVESTIGATION as proposed on
- 156 several occasions and as ORDERED BY AT LEAST ONE
- 157 COURT but what we got was obfuscation, obstruction, delays,
- 158 and open efforts to block investigators from conducting the
- 159 investigations. They failed! I expected perhaps Pence would have
- 160 invoked his much touted concern for the CONSTITUTION and
- stood to defend it by agreeing with the Legislative bodies that
- officially requested him to delay certification of the electoral votes
- officially requested fifth to delay certification of the electoral votes
- 163 until they completed their investigation but, alas, Pence was
- 164 more concerned about posturing like he was in defense of the
- 165 Constitution than he was concerned about actually DOING what
- 166 he could do to PROTECT the Constitutional election process in
- 167 this country—and so he failed. Then I looked to the last standing
- person with official capacity to act in defense of the Constitution —
- which would be the President. Only it would require extraordinary
- 170 measures involving the insurrection act and martial law—and
- 171 when he flew away to Mar-A-Lago I thought he decided not to go
- that route—.
- But then I got to looking a bit closer. And I'll offer to you my own
- take on this that is premised upon my own research—so, hold on
- through the break! I'll be right back!
- 176 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
- 177 at the Lighthouse, your brain masseur, and Paul Revere's lantern
- lighter, lighting the lamps in the church belfry arch, signaling the
- 179 enemy is on the march, an enemy that would steal from us our
- 180 liberty.
- 181 Is there any real hope that Patriots will reclaim the government
- 182 from the hands of these usurpers and reestablish the POWER to
- 183 the PEOPLE?

- Well, I've said many times that our trust is not, ultimately, in men,
- or in the machinations of the clever to work out a complicated plan
- 186 to restore to us our LIBERTIES. We trust in the LORD—our
- 187 HOPE is in CHRIST JESUS.
- 188 We understand, however, that Jesus works through us—His own
- people. He promised that when the enemy comes in like a flood,
- 190 the SPIRIT OF THE LORD will raise up a standard against him
- 191 (Isaiah 59:19). The SPIRIT of the LORD dwells in the believer —
- and so it is reasonable to expect He will act through the BELIEVER
- 193 to raise up that STANDARD. I believe that as a matter of fact it's
- down to GOD FEARING PATRIOTS with official capacity to act
- in fulfilling their OATH TO DEFEND THE CONSTITUTION
- 196 FROM ALL ENEMIES FOREIGN AND DOMESTIC. And I
- believe the last standing institution with official capacity to ACT is
- 198 the MILITARY.
- 199 So, let's look at this. And let me explain my own basis for believing
- 200 there is a PATRIOTS plan to DEFEND us from being TAKEN
- 201 OVER BY CHINA through CCP operatives placed in power in the
- 202 US White House, Capitol, and the SCOTUS. Indeed, as I pointed
- 203 out before, the fake news supported a fake election putting into
- 204 office a fake President and this was done with the aide and
- support of the controlling members of Congress and the highest
- 206 COURT of our land.
- 207 We furthermore know that the Establishment Deep State
- 208 operatives of the CCP in this country attempted to conduct a coup
- against our President, which is an act of TREASON! We further
- 210 know that there is such corruption in our government as to
- 211 warrant indictments and prosecution of literally hundreds of
- 212 persons holding office in this country contrary to the 14th
- 213 Amendment.

- We are assured this evidence of foreign interference in our election
- 215 with the assistance of massive numbers of United States office
- 216 holders in this country will be forthcoming.
- 217 And the massive involvement of our government officials with
- 218 Epstein's pedophilia activities will also come out—and all these
- 219 crimes will beg for JUSTICE.
- 220 You probably heard about the evidence trickling out proving
- 221 Obama, Hillary, and Brennan, and the rest all knew the Russia
- collusion scam was a hoax and that they used it to illegally obtain
- 223 warrants to spy on a citizen who was the political opponent of the
- 224 DNC & Judas Republicans THEY KNEW AND WENT
- 225 FORWARD WITH THEIR PHONY IMPEACHMENT AND
- 226 CHARACTER ASSASSINATION anyway because they are
- 227 EVIL and WICKED people. You probably also heard the drip, drip,
- 228 drip, of information about the politicians in America who are
- 229 implicated in Epstein's pedophilia ring—the list of American
- 230 household names who visited his Island includes CLINTONS, and
- 231 Dershowitz is implicated, and well, you name it. ABC Amy
- 232 Robach co-anchor for 20/20 and fills in for Good Morning
- 233 America she was filmed complaining that she had the Epstein
- 234 story, and the goods on Clinton's involvement, three years ago, and
- she is angry that now it's coming out like it's some newly breaking
- 236 news when she had it THREE YEARS ago but her bosses
- 237 would not let her go with it!
- 238 The STORM IS COMING friends.
- 239 So, let me break it down for you.
- 240 First, in 2013, the Pentagon gives notice of its right to intervene in
- 241 times of national emergency independent of authorization from
- 242 the Commander in Chief when authorization from the chief
- commander is impossible to obtain—May, 2013. It stirred a bit of

- 244 controversy with liberals afraid the Military was about to oust
- 245 Obama.
- 246 Then, in 2015 the Pentagon issues a revised version of the LAW
- 247 OF WAR MANUAL and I mentioned the provisions it makes
- 248 for MILITARY ACTION in an ASSUMED CONDITION OF
- 249 MARTIAL LAW when a belligerent occupying force holds
- 250 territory and has temporarily usurped government control In such
- an emergency, the FRIENDLY military (or militia, by the way) can
- break the belligerent occupation and restore the government to the
- 253 SOVEREIGN POWER the original government under civil
- 254 control once the occupation forces have been defeated!
- 255 Then, Trump gets elected and it all breaks loose. Obama, Hillary,
- and company, turn what was a smear campaign during an election
- 257 cycle into a CAMPAIGN TO OUST THE SITTING PRESIDENT
- 258 an internal COUP involving leadership of CIA, FBI, DOJ, and
- 259 some members of the DOD which is an act of TREASON
- against their OATH to uphold and DEFEND the Constitution.
- 261 In December 20, 2017, Trump signs an executive order (I'll discuss
- 262 this more tonight or tomorrow on my live stream VISIT) titled
- 263 BLOCKING THE PROPERTY OF PERSONS INVOLVED IN
- 264 SERIOUS HUMAN RIGHTS ABUSES AND CORRUPTION.
- 265 There are some really interesting elements of this executive order
- 266 including but not limited to, 1. in this eo Trump DECLARES A
- 267 NATIONAL EMERGENCY; 2. in this eo Trump provides for the
- 268 prosecution and the confiscation of all financial or property assets
- 269 of any person involved in human rights abuse or corruption—
- 270 specifically names anyone who is or HAS EVER BEEN involved,
- 271 who is or ever has been in government office oh yeah! This EO
- has teeth baby.
- 273 Then, in September 12, 2018, Trump signs another EO that
- 274 reaffirms our EMERGENCY status, and lays out serious financial
- 275 repercussion against any foreign power that interferes in our

- election, and against any citizen implicated as assisting or abetting
- 277 the same and this one, like the earlier one, it has TEETH BABY.
- 278 Furthermore these Executive Orders provide for the ACTION to
- 279 be SET IN MOTION in other words the actions of these
- 280 orders were triggered they began execution already and only
- 281 a genuinely and legally installed President can change the EO —
- 282 Unlike the Biden EOs that have NO AUTHORITY and are
- 283 MEANINGLESS.
- And then you have the execution order of the EOs in November of
- 285 2020 which actually activates the MILITARY
- 286 And the disclosure order given likewise in November of 2020
- 287 before Trump left office and THERE IS LEGALLY SPEAKING
- 288 NOTHING BIDEN'S PHONY ADMIN CAN DO TO STOP
- 289 WHAT IS COMING.
- 290 So, as it stands right now, the military is AUTHORIZED to step in
- 291 and take out the belligerent occupying force—to initiate the
- 292 EMERGENCY PROTOCOLS already put in place and activated —
- 293 and arrest the traitors put them on trial and restore our
- 294 REPUBLIC!
- 295 That's what IS in place! It's not a conspiracy theory the legal
- basis for all I've outlined is in PLACE.
- 297 Whether it will be acted on I HOPE SO! I pray for JUSTICE —
- 298 please get and listen to my messages Sunday am, pm, and
- 299 Wednesday.
- 300 AM What is GOD waiting for? PM Comforting God!.
- 301 Wednesday the TWO SWORDS.
- 302 Be careful about being brainwashed into a knee jerk reaction to
- anything like this as a *conspiracy theory*. First, you are aware, I am
- 304 sure, that conspiracies are a real issue in American jurisprudence
- 305 in other words, there are LAWS about conspiracies because,

- well, because conspiracies are contrived by men to commit all
- 307 manner of fraud, and illegal activity. So, the word conspiracy does
- 308 not automatically mean something fanciful, or ridiculous.
- 309 Second, you are aware that there are two fundamental views of
- 310 history. One is the accidental view of history that says things
- 311 happen as quirks of accident. The other is the conspiratorial view
- 312 of history this view says there are operators behind the scenes
- 313 concocting schemes whereby they might advance sometimes
