- 218 set up an occupation of Washington, DC. This was in 2015. Then
- 219 Trump got in, and established EOs in December of 2017 and
- 220 September of 2018 that declared America in a state of emergency,
- 221 and that anticipated the discovery of traitors in our government,
- 222 and interference in our elections by foreign enemies and
- 223 treasonous government officials. Then you have the fraudulent
- 224 election triggering these Executive Orders and the eerie sense
- 225 that this thing is not over yet. The odd indications I alluded to

- 229 left a letter for Biden that had one sentence—"Joe, you know I

- 231 PRESIDENT and now the Congress is attempting to impeach
- him, even though he is no longer the President? Do they know that
- 233 in fact he IS the PRESIDENT and they need to impeach him to be
- rid of him?
- 235 It's all very strange. And now, there is this. The impeachment
- 236 declaration from the House actually opens the door to the
- 237 President to reveal all his evidence of voter fraud and foreign
- 238 interference. What is the one thing we have not been allowed to
- do? We have been barred at every turn in every effort to get the
- 240 evidence into the full light of the PUBLIC VIEW! Those who
- 241 believe there is no evidence only believe that because that's what
- their trusted leaders have told them. It's this way all the time with
- that crowd. They simply believe what they are told by their trusted
- 244 sources and don't do any investigation beyond that. You saw it
- 245 hundreds of times over the last four years so, you hate Trump.

Why. And what to you hear? The one-liners, the slurs, the unproved allegations and accusations of the liberal media and politicians. You ask for examples and they either stammer and sputter without offering any coherent argument to support what they believe or they spout the liberal talking points and the minute you start challenging them with facts that contradict them, they dismiss you as a racist or white supremacist, or whatever.

- 288 WERE THE PRODUCT OF WIDESPREAD FRAUD AND
- 289 SHOULD NOT BE ACCEPTED BY THE AMERICAN PEOPLE
- 290 OR CERTIFIED BY THE STATE OR FEDERAL OFFICIALS.
- 291 SHORTLY BEFORE THE JOINT SESSION COMMENCED,
- 292 PRESIDENT TRUMP ADDRESSED A CROWD AT THE
- 293 ELLIPSE [by the way, that's the Ellipse Park near the White House]
- 294 IN WASHINGTON DC. THERE HE REITERATED FALSE
- 295 CLAIMS THAT 'WE WON THE ELECTION AND WE WON IT
- 296 BY A LANDSLIDE."
- What the Dems have done is premise their case on Trump's claims
- 298 of election fraud this introduces these claims into case for
- 299 Trump's defense. The argument can be put forward that in fact, if
- 300 Trump's claims are TRUE, it is the DEMOCRATS with the help of
- 301 their Judas Republic-rats who are guilty of insurrection, not
- 302 Trump.
- 303 It's interesting; because there is nothing else they can point to in
- 304 the speech that they could use to say he was inciting an
- 305 insurrection. Of course, affirming what almost all Americans
- 306 already suspect—I mean virtually all the 74 million that voted for
- 307 Trump and 30% of those who voted for Biden—so, if it's true that
- 308 jackal got 80 million that's another 24 million who believe the

- 312 material to his case, is it not?

- 316 or something of that sort. I hope Trump's attorneys will counter
- 317 that the issue of election fraud is central to the charge since it is

- 320 that matter has no bearing on this case. To which it will be argued,
- 321 that in that case, the Congress has no case, because they have

- 324 team expects to proceed on that line—we will have to see how it
- 325 plays out.
- 326 It's entirely possible, my friends, that the impeachment trial will
- 327 not be the showcase for the evidence of election fraud to come
- 328 forward—I truly hope that it is. I agree that usually in a trial, the
- defendant is given wide latitude in presenting his defense and that
- 330 in this case especially Trump should be able to defend his
- 331 statements regarding the election since the accuser brought it up—

- 333 per usual.
- 334 So, Trump might allow this to go on by—and wait to spring his
- trap a little farther down the road. I sure hope it all comes out
- 336 beginning Feb. 9 I hope at some point in the trial, the SPACE
- 337 FORCE will come in with their SOLID PROOF of foreign
- 338 interference in our election, of the number of Representatives and
- 339 Senators in that room who were complicit with China in the effort

- 340 to steal our government, with the forensic PROOF of all this and
- that it will be put on public display.
- 342 I expect if that happens, the MSM and SM communists will go
- 343 black out and they will scatter to the four corners looking for a
- 344 place to hide.
- 345 I expect much of the shake up going on right now with Amazon
