1 Segment.01 Hello. I'm Dr. Jerry Scheidbach, pastor of the
2 Lighthouse Baptist Church in Santa Maria, CA—and your brain
3 masseur—get ready for your brain massage.
4 It's ALL COMING OUT! I mean — WHEN THE TRUTH COMES
5 MARCHING IN — will be on THE LORD'S SIDE?
6 The Border, Election Fraud, COVID, GUNS, EDUCATION, what's
7 next? The States are taking control.
8 Bongino made a good point — people think in contrasts.
9 America is under attack: first wave—Propaganda assaults, second
10 wave POWER assaults. The enemy is transitioning to POWER
11 assaults (I called this the Rhetoric Wars back in, oh, I don't want to
12 stop and go check so I'll guess, 2010, or earlier).
13 Dr. Rand Paul fences with Fauci—
14 Bartiromo interviews Trump.
15 Biden blunders: calls Putin a killer, stumbles up the stairs onto Air
16 Force 1, and, Oh, this was classic: "It's hard to be what you can't
17 see."¹ — That was surreal, and let me tell you what it means!
18 In fact, let's talk about what all of this means!
19 Friends! It's time for your Brain Massage!
20 [TRUTH]
21 It's ALL COMING OUT! I mean — WHEN THE TRUTH COMES
22 MARCHING IN —
23 The People had sinned grievously, and God told Moses to return to
24 the camp with HIS LAW.

25 When Moses returned, he saw the people dancing around the
26 golden calves — oddly they decided the golden calves of Egypt
27 were the gods that delivered them from the oppression of EGYPT.

28 Americans, many on the LEFT anyway, have come to believe
29 godless Marxism is what delivers from the oppression of tyranny.

30 Moses returned — the TRUTH returned, and DIVINE wrath fell
31 upon the people — the LAW was cast down, and the golden calf
32 was destroyed in the sight of all the people—it was ground to
33 powder, sprinkled on the water and the people were made to
34 DRINK IT — they were made to OWN their SIN. After Moses
35 investigated into the actions of his leadership and saw that the
36 people were made naked before the nations to their own shame—
37 JUDGMENT was SENT FORTH by the HAND of those who were

48 America is under attack by the wicked who rage against the rule of
49 CHRIST in the EARTH. These are the raging heathen who cry
50 against the RULE of CHRIST and desire to break out from under
51 the "bands and cords" of HIS LAW!

52 Propaganda is first wave of the rager's attack. The only power the
53 enemy can get with propaganda is what we give them — and
54 propaganda only works as long as it is believed.

55 (I called this the Rhetoric Wars back in, oh, I don't want to stop
56 and go check so I'll guess, 2010, perhaps earlier).

57 When propaganda begins to fail, they turn to power—that is, force,
58 coercion. And you know who "they" is, right?

59 The weaker propaganda becomes, the fiercer they become in the
60 use of THE POWER WE SURRENDERED TO THEM WHILE
61 WE WERE BELIEVING THEIR PROPAGANDA.

62 The sooner we wake up to their LIES the more strength we will
63 have to fend off their POWER GRAB! They use propaganda to get
64 as much power from us as we will willingly, stupidly, surrender to
65 them. Then, when the people start waking up, they turn to
66 PUNISHING tactics, using whatever power we have given them to
67 punish us — the penalize — to pound us into submission.

68 So, for liberties' sake — WAKE UP NOW!

69 Because, my friend, their propaganda is beginning to break down.
70 It's starting to unravel. It's collapsing all around them. It they know
71 it's happening too soon — they feel it! They know they have not
72 gotten the power they need to turn America into a POLICE
73 STATE. They have tried to push America into a CIVIL WAR status
74 so they can then take up the sword and use it against the
75 conservative Christians and remove them from having any *power*
76 at all!

77 For example, look at what is happening with the border. Trump
78 had the border under good regulation; it was quiet on our borders
79 with Mexico. The Cartels were howling, the sex traffickers were
80 feeling the pinch in their wicked business, Soros human trafficking
81 enterprises were suffering—so it was weeping, wailing, and
82 gnashing of teeth for the wicked—but for the righteous, it was good
83 and getting increasingly better.

84 Now, Biden is in "control." They stole the election, and using Biden
85 as their front man to take the heat for resetting everything to how it
86 was before Trump came in and interrupted their wicked business.

87 So Biden has opened the borders. Of course, the propaganda is that
88 the borders are not open—but the problem is, everyone SEES that
89 Biden has opened the borders. The Cartels are happy, the human
90 traffickers are happy—and as before, they manipulate hoards of
91 people to come to the border and demand entry holding BIDEN let
92 us IN signs — as cover for their child trafficking.

93 So Biden Administration sends out the message — all children who
94 come to the border unaccompanied by adults will be allowed into
95 the country. I hope some good guys are watching this closely and
96 tracking where these children go—make sure they are not simply
97 "disappearing."

98 The Biden administration is hiding what is going on at the border.

99 Jen Psaki — asked about customs and border control gag order.

100 Is admin instructing border control agents to refuse ride along
101 requests from reporters.

102 “Again, I think we’ve seen, watching a number of the reports you
103 all do of a number of border patrol officials who are quoted in
104 them, who appear in them and certainly from the White House we
105 support that, it’s coordinated through the Department of
106 Homeland Security and I point you them for any additional
107 questions about the logistics of press access.”

108 What a bunch of blather!

109 Reporter: But reporters used to be able to get ride alongs during the
110 Trump admin. and you all came in and promised to be the most
111 truthful and transparent administration and you all oversee the
112 DHS so if you all wanted to grant access to the press couldn't you
113 just tell DHS to do it?

114 PSAKI: “Again, we fully support transparency and I would
115 encourage you to talk to the Department of Homeland Security
116 about any requests you have.”

117 REPORTER MENTIONED TRUMP — He allowed reporters to go
118 and see but BIDEN will not allow it.

119 Did you catch that? The Reporter asked Psaki a question in which
120 she clearly contrasted Trump's open and transparent
121 administration to Biden's closed, secretive, and controlling
122 administration.

123 Are the MSM beginning to see? Or, is it the case that the word is
124 out in private circles that Trump is in fact CIRCLING BACK —
125 that it's all about to come out.

126 Let me warn you about something. Anytime a boat starts taking
127 water, the rats are the first to know it and the first to flee.

128 Here is another example. Biden is going to make a deal with
129 Mexico.

130 “The Biden admin is quietly pressing Mexico to curb migrants
131 coming to the U.S., Mexican officials said, a move echoing Trump-
132 era policy.”

133 "A move echoing Trump-era policy"? That's coming from MSM
134 folks. The wind is changing!

135 Why doesn't Biden want reporters doing ride alongs at the border?
136 They will have to report what they see!

137 What do we know is going on at the border right now, what is the
138 Biden admin trying to hide.

139 KIDS in JAIL, in CAGES, people WITHOUT MASKS —

140 Don't look closely, because then you'll see the MS-13 gang
141 members getting across, and other terrorists. Don't look too closely
142 because then you'll see the sex traffickers getting their goods across

143 the border—you'll see the Cartels smiling—and the Soros machine
144 humming again.

145 Why do American politicians want to support this? Well, money is
146 the first reason, and POWER is the next.

147 The Border, Election Fraud, COVID, GUNS, EDUCATION, what's
148 next? The States are taking control.

149 The thing that is particularly interesting to me about what is
150 developing is that the TRUTH is beginning to break through to the
151 OTHER SIDE. The LEFT successfully intimidated reporters who
152 wanted to speak out, so they did not dare. But something is
153 happening. Somehow the Deep State is loosing its grip on media.
154 The word is out — Moses is coming down the mountain! And he
155 has the LAW OF GOD in his hands, and ready to use the SWORD
156 OF JUDGMENT to execute WRATH UPON EVIL DOERS.

157 Watch closely, and you will notice the rats are pouring out of every
158 hole they can find on the DEMONCRAT's sinking ship!

159 The DAM the wicked have created to hold back the flood of
160 TRUTH from the PEOPLE is cracking. And soon — SOON — the
161 wicked will be forced to open the DAM, or it will BURST and the
162 TRUTH will come flooding across the land with LIBERATING
163 FORCE.

164 Hold on through the break! I'll be right back!

165 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
166 at the Lighthouse, your brain masseur, and Paul Revere's lantern
167 lighter, lighting the lamps in the church belfry arch, signaling the
168 enemy is on the march, an enemy that would steal from us our
169 liberty.

170 Dr. Rand Paul fences with Fauci—did you hear the interrogation?
171 Fauci was challenged, I think it was at least three times very
172 directly to SHOW THE SCIENCE that supports masks —

173 especially what science supports wearing the mask after the people
174 have been vaccinated?

175 Not one time did Fauci refer to any RCT (that's a Random
176 Controlled Trial) which details the methodology used to conduct
177 the tests, the masks that are the subject of the tests, the results of
178 each test for each type of mask, down to the number of particles
179 blocked or that passed through the mask during the test, a
180 summary of the findings and recommendations based on those
181 findings.

182 Here is a little trick you need to watch for. It's sleight of hand — it's
183 a shell game with the truth — watch them, they are tricky.

184 Here are 17 RCTs — about 12 before the COVID thing began and
185 five after. Two of the five after are during the time Fauci was saying
186 Americans don't need to go around wearing masks. Three after.

187 Here is the trick. Every one of these RCTs use virtually the same
188 methodology, the same tests, and test the same masks. All of them
189 show the same results—not identical if you are saying one RCT
190 showed that x number of particles pass through y masks and each
191 study showed the identical values for x and y — but the values are
192 statistically identical — in other words, the variation is so slight so
193 as to make absolutely NO DIFFERENCE in the result.

194 So when you compare each of the 17 studies, you see no difference
195 in what is called the SCIENCE.

196 You understand that the summary reflects the opinions of the
197 scientists, and the recommendations reflect the judgment of the
198 scientists — but that's NOT the SCIENCE.

199 The SCIENCE is reflected in the data gathered from the tests.

200 Understand that while the summary and recommendations offered
201 by the scientists is ostensibly premised on the data gathered from
202 the tests, their summary and recommendations are not THE

203 SCIENCE. They are the conclusions offered by scientists. Now,
204 watch the ball as they move it around and around in the shells.

205 Every one of the 12 RCTs before COVID concluded the same way.
206 Masks are not adequate protection against the spread of a particle
207 so small as a virus. And two, masks are not recommended as a
208 viable public policy for controlling the spread of a virus.

209 In fact, many of these studies included a look at the negative
210 impact of wearing masks for prolonged periods of time.

211 Now we come to the pre-mask COVID phase. Where people like
212 Fauci actually played it down, where Dems were echoing the
213 Chinese propaganda on the virus—when Fauci smirked that
214 Americans are not going to go around wearing masks.

215 The studies done during this time showed all the SCIENCE was the
216 SAME as before COVID. The Summaries were also the SAME, and
217 the recommendations were — you guessed it — THE SAME.

218 Then something changed. The politicians began calling on the
219 people to wear masks, and Fauci began calling on everyone to wear
220 masks, then the CDC began recommending masks — and the
221 RCTs began reflecting this new political policy. Not in the
222 SCIENCE. That stayed exactly the SAME.

223 The RCTs prepared during post-mask mandate phase were exactly
224 the same in the SCIENCE part of the study — same methods, same
225 tests, same masks tested and SAME RESULTS.

226 What changed were the Doctors' summary statements and their
227 recommendations. THAT'S ALL THAT CHANGED. Suddenly,
228 from the same SCIENCE doctors were coming to OPPOSITE
229 CONCLUSIONS — now they were saying masks might, maybe, in
230 some cases can, help — and then recommended masks, or at least
231 supported the mask mandates as public policy.

232 All of these studies were conducted by scientists who make money
233 from government research.

234 Those that are independent researchers continued to conclude
235 otherwise—many began speaking out against the mask mandates
236 — they were shut down by government media censorship.

237 Today, when these yahoos say follow the SCIENCE, what they
238 really mean is follow the establishment government scientists.
239 Because, if you actually follow the SCIENCE — you will see that
240 trusting these masks to protect you or others from the spread of
241 any virus is foolishness.

242 The SAME THING holds true of so-called SOCIAL
243 DISTANCING.

244 Now, here is the thing! Finally, a ranking Senator, Dr. Rand Paul
245 takes on Mr. Fauci and asks for the SCIENCE and right in front of
246 God and everybody the only thing Fauci could offer was his
247 OPINION. And his opinion is not trustworthy. Earlier, in the build
248 up to mask mandate mania, Fauci was challenged regarding the
249 science supporting use of masks — he said, "masks are largely
250 symbolic." I read one report from Johns Hopkins that explained
251 where masks are helpful is that they REMIND PEOPLE THAT
252 THERE IS A PANDEMIC going on. In other words, MASKS ARE
253 LARGELY SYMBOLIC.

254 That's what every politician knows about masks. That's why they
255 don't bother wearing them unless they know they are being
256 watched by the PUBLIC. John Kerry does not wear any mask while
257 flying on American Airlines — although American Airlines
258 KICKED me off a flight because the PILOT did not like my
259 TRUMP 2020 mask. He was "uncomfortable" with me being on his
260 plane — and I've taken three flights since then AND WENT OUT
261 OF MY WAY TO AVOID FLYING AMERICAN because I will
262 NEVER be comfortable flying the AMERIKANSKI airline again.

263 That airline is for JOHN KERRY — maskless John — American
264 airline will accommodate phony Kerry without a mask on their
265 airline but not patriot Jerry in his TRUMP MASK. Haha.

266 But, you see, it's all coming out! And when the TRUTH comes
267 MARCHING IN — the liars caught will howl, gnash their teeth —
268 and they are watching with dismay as their control over the media
269 is weakening.

270 For example, regarding election fraud—CNN had the audacity to
271 report another CONTRAST moment exposing the
272 DEMONCRATS.

273 First, remember that WaPO was forced to correct their
274 misrepresentation of Trump's conversation with the GA elections
275 investigator—Frances Watson. They reported that Trump was
276 trying to pressure the investigator to overturn the election results
277 in Georgia. WaPO got this from the Secretary of State's office —
278 but the source was kept anonymous. You know, it was an Anon
279 thing. Hehe.

280 Finally the full audio of that conversation surfaced and it proved
281 Trump did no such thing. It was a LIE! So, who will take the fall?
282 Not WaPO — and not Raffensperger — it fell on Jordan Fuchs,
283 Georgia's deputy secretary of state. She was outed!

284 The rats are vying for the most favorable position they can
285 negotiate so when TRUMP CIRCLES BACK — they won't be in
286 the crosshairs.

287 Now, here is what is interesting. Watch! When I heard the audio
288 recording, and by the way, I heard it a long time ago, and I
289 reported on it a long time ago. And I explained then that someone
290 listening to this can see Trump did not pressure the investigator to
291 "find the fraud" but most certainly DID encourage the investigator
292 to do an honest job and that he was in a very important position.

293 I also pointed out that, however, Trump, being the PRESIDENT of
294 the United States calling someone who was investigating potential
295 fraud in an election involving him in a very direct and personal
296 way presented problems. Personally, I think it was a mistake. On
297 the other hand, it's also too obvious — too well, honest! If the
298 message was intended to be pressure from the President, it would
299 have been far more effective to have been delivered by someone
300 else and in some other way. That's the way it's *usually done*. But
301 Trump really is an unusually honest person. Like his call to the
302 President of Ukraine — it's obvious when you hear it he simply
303 wanted to encourage the Ukrainian President to do what is right —
304 and that's exactly what he did with Watson — do what is right! You
305 have an important job, and it's important that you do it right!

306 So, here is my point. Listen to how this is developing. Washington
307 Post reported what their reporter was told by someone inside the
308 Georgia Secretary of State's office regarding a phone conversation
309 between Trump and their chief elections investigator, Frances
310 Watson.

311 Trump protested the news story as being "FAKE NEWS." I heard
312 the audio recording, as I mentioned, and agreed: it was reported
313 that way in order to make it look like something it was not.

314 WaPO simply held to its guns — let the story stand!

315 A long time after the audio was released—remember, I heard it at
316 least two months ago — all of a sudden, WaPO comes out with a
317 story retracting their article and blaming their source for
318 inaccurate information.

319 Pressure, of course, mounts to "unmask" the source. WaPO does
320 the extraordinary thing of revealing their source — and it was
321 Georgia Deputy Secretary of State, Jordan Fuchs. HmMMM!

322 So, WaPO is looking for a *fall-guy*. A sacrificial lamb! A scapegoat.
323 They throw the light on Jordan Fuchs (Fohks).

324 So Jordan is asked to respond. Will Jordan Fuchs (Fohks) take the
325 fall. No way. She is going to do what you would have expected
326 WaPO to pull—she is going to side step the issue.

327 "The Secretary of State's Office's first reported about its
328 investigator's phone conversation with President Trump relied on
329 the investigator's recollection. Information about the content of the
330 call was never presented as a word-for-word transcript. After
331 hearing the tape, it's clear that the investigator's recollection
332 accurately portrayed the president's assertions that there was fraud
333 to uncover and that she would receive praise for doing so."

334 Now that is what I would have expected from the sidewinders on
335 the left—whether they be DEMONCRATS or JUDAS
336 REPUBLICANS.

337 So, what is going on here?

338 Watch what CNN does in a story about Merrill-Meeks win of the
339 second congressional seat in Iowa. A bit of background — Merrill-
340 Meeks won the race after a heated contest and challenge was faced
341 down. After the duly conducted and certified recount, she won the
342 seat by 6 votes. Her opponent is unwilling to accept this, but rather
343 than go to the courts, she has appealed to Pelosi to invoke a little
344 used rule in the House to block a Representative from being seated
345 if they suspect foul play and so on. Pelosi is actually, seriously
346 considering using this rule to undo the Iowa election and put the
347 Democrat in office instead. So, here is the CNN reporting on this,
348 and it will surprise you.

349 "House Democrats weigh ejecting GOP winner of contested Iowa
350 race, DISMISSING COMPARISONS TO TRUMP'S EFFORTS TO
351 OVERTURN ELECTION."

352 Wow! Earlier we heard from an MSM reporterette taking on Psaki
353 about the Admin policy prohibiting reporters from doing ride
354 alongs with the border patrol—and she actually had the audacity to

355 point out that during TRUMP that was allowed, and even openly
356 challenged the Administration's commitment to honesty and
357 transparency — and compared this to Trump's administration in a
358 way that CLEARLY said he was transparent and Biden is NOT!

359 This is unheard of!

360 Now, CNN points out the contrast between Democrat's objections
