1 Segment.01 Hello. I'm Dr. Jerry Scheidbach, pastor of the
2 Lighthouse Baptist Church in Santa Maria, CA—and your brain
3 masseur—get ready for your brain massage.
4 The Border & GUNS — and the **ABSOLUTE** RIGHT to
5 PROTECT YOU and YOURS. Where is the line for that crosses
6 into infringement of the absolute RIGHTS of man?
7 The COVID Vaccine and SPARS
8 And The PATRIOTs Rising —
9 It's time for your BRAIN MASSAGE!
10 [TRUTH]
11 The BORDER — Did you get your 3200 from the government?
12 Guess what Newsome is planning to give the illegal migrants who
13 lost work during the lockdown? Well, he is going to distribute 75
14 million COVID bucks to the illegals here. But that's nothing
15 compared to what Cuomo is doing in NY. He set aside 21 billion to
16 distribute a one-time payout to illegals of \$15,600 bucks.

18 then they will only get what regular Americans get.

32 FOUNDING documents, particularly the Declaration — that bit
33 about ALL MEN ARE CREATED EQUAL AND ENDOWED BY
34 THEIR CREATOR WITH CERTAIN INALIENABLE RIGHTS.

35 It's the foundation for our LIBERTIES — because if your rights are
36 granted by government you are a slave; but if they come from a
37 power greater than government, you are FREE.

38 Corporate Communism is trampling all over your first amendment
39 rights of free speech, and government fascism is making a grab for
40 your religious liberties—and Joe is trying to get your guns!

41 I understand Joe signed an executive order intended to make it
42 more difficult to build your own weapons of self-defense. These are
43 called "ghost guns."

44 Now, a "ghost" is an immaterial entity that manifests in the
45 physical world. So when you read Holy Ghost in the Bible, you are
46 talking about a manifestation of the Spirit of God. Biden is
47 troubled by ghosts. Gun ghosts — they haunt him! Perhaps he sees
48 them in his dreams — apparitions — moving about his dark mind,
49 haunting his soul — (scary ghost music) — Something you can't
50 grab hold of — something that is threatening, scary, but you can't
51 see where they are, you can't even shoot them — GHOST GUNS!

52 I don't think I've ever seen a "ghost gun."

53 Well, that's what the government calls a gun they don't know you
54 have. That's what the government calls a gun they don't have on
55 their federal registration — Joe-bama does not like you to have
56 guns they don't know you have.

57 And in his speech, he made the very intelligent remark that no
58 rights are absolute.

59 What a wily devil he is. From that perspective, you can argue, well,
60 you don't have an absolute right to free speech — for example, it is
61 illegal to cry "FIRE" in a crowded theatre — unless, of course, there
62 truly IS a fire. But, in other words, you don't have a right to cause
63 harm to others by abusing your right to free speech.

64 So you see how wily the devil plies your mind to compromise your
65 resistance to having your rights taken away by these fascists.

66 Let's start here! I say you have an absolute right to free speech, but
67 this does not give you immunity from the consequences of abusing
68 this right. The same is true of the right to keep and bear arms. It is
69 an absolute right — but no absolute right includes immunity for
70 abusing that right. If you use a firearm to commit a robbery, you
71 cannot argue your right to keep and bear arms protects you from
72 culpability for using a weapon in the commission of a crime.

73 Yelling "FIRE" in a crowded theatre is not an example of exercising
74 FREE SPEECH. It is an exercise in deceit and careless
75 endangerment of others. FREE SPEECH has nothing to do with
76 this action. Do you see what I mean?

77 FREE SPEECH certainly is ABSOLUTE — but no one is exempt
78 from responsibility for the exercise of this or any other absolute
79 right.

80 The RIGHT to keep and bear arms is absolute because it is
81 inextricably connected to our ABSOLUTE RIGHT of self-defense.
82 (And by self-defense, I mean the defense of our LIFE, LIBERTY,
83 AND THE PURSUIT OF HAPPINESS.) So, when does
84 infringement upon this right occur? It occurs at the point where
85 our right of self-defense is restricted and exposes us to danger of a
86 loss of life or liberty, or the freedom to live my life enjoying my
87 liberty—summarized as pursuing happiness.

88 In other words, there is NO ABRIDGEMENT of our RIGHT TO
89 SELF DEFENSE of our LIVES, our LIBERTIES, or of our RIGHT
90 to pursue happiness in the living out of our liberties.

91 Remember that this was written in a context. The context was a
92 biblical understanding of what pursuing happiness would mean to
93 any reasonable person, and a period in history when
94 GOVERNMENT was aggressively interfering with these RIGHTS.

95 So, these RIGHTS were acknowledged as FROM GOD and
96 INALIENABLE (and on those grounds ABSOLUTE) in a context
97 where GOVERNMENT was the ENEMY of those rights — and so
98 the RIGHT of SELF DEFENSE includes DEFENSE against a
99 tyrannical government bent on infringing upon our ABSOLUTE
100 right of self defense. Now, follow along, class!

101 While my RIGHTS are INALIENABLE and ABSOLUTE they are
102 not without PERSONAL RESPONSIBILITY in their exercise.

103 Now, in order to provide for my defense, I require weapons equal
104 to the threat. The moment Joe-Bama comes along and says, the
105 government can have fully automatic weapons, then that
106 necessarily means the individuals' rights to own equal weapons is
107 assured — . And that is exactly what the Constitution recognizes.

108 You see, the dirty little secret the FASCIST/COMMUNISTs don't
109 want you to see is that the bit about maintaining a militia for the
110 protection of the State being necessary — that, on that ground,
111 THE RIGHT OF THE PEOPLE TO KEEP AND BEAR ARMS
112 SHALL NOT BE INFRINGED means that because it will be
113 necessary for the State to have at its disposal men of arms to defend
114 the State — it is essential that the PEOPLE of the State shall not
115 have their personal right to keep and bear arms infringed upon by
116 the government.

117 In other words, because it will be necessary for the Federal
118 government to provide for the COMMON DEFENSE — and

119 therefore have an ARMED ARMY — or MILITIA under its
120 command — or a police force — or whatever — armed men in the
121 employ of the government — because of that, THE RIGHT OF
122 THE PEOPLE (the common man, the private citizen, the
123 individual) to KEEP AND BEAR ARMS shall not be infringed—
124 that is, it shall not be LIMITED in any way so as to make it
125 impossible to defend themselves against a future KING GEORGE!

126 That's the intent — if you trust Joe and Obama with the absolute
127 responsibility to defend you, you have become a slave and not a
128 citizen.

129 Joe-Bama says no rights are absolute — and that's a wily LIE. The
130 truth is ALL INALIENABLE RIGHTS ARE ABSOLUTE. The issue
131 is not whether the RIGHT is absolute. Of course it is. The WILY
132 DEVIL tries to confuse the issue and use INFRINGEMENT UPON
133 YOUR RIGHTS to address issues that are actually related to
134 CRIMES. They want to equate a RIGHT to bear arms with the
135 CRIMES committed by some with arms. In other words, NO ONE
136 HAS A RIGHT TO BEAR ARMS AGAINST THEIR NEIGHBOR
137 IN ORDER TO STEAL THEIR MONEY. NO ONE HAS A RIGHT
138 TO ARMED ROBBERY. But that has nothing to do with the
139 RIGHT TO KEEP AND BEAR ARMS FOR SELF DEFENSE.

140 Do you see who wily is the DEVIL?

141 The fact is, THE MINUTE YOU PUT A RESTRICTION ON THE
142 KEEPING AND BEARING OF ARMS you have crossed into
143 INFRINGEMENT OF THE ABSOLUTE right of persons to hold
144 arms sufficient for their defense.

145 No one has a RIGHT to commit armed robbery — but that is ONE
146 HUNDRED PERCENT UNRELATED to the right to keep and
147 bear arms.

148 If you attempt to address the CRIME OF ARMED ROBBERY, OR
149 ARMED AGGRESSION by infringing on the RIGHT TO KEEP

150 AND BEAR ARMS you are only deceiving yourself and the i-dot
151 bobble heads that don't THINK!

152 The criminal is going to get what arms he can to give himself the
153 advantage over those he intends to victimize. By criminalizing
154 THE RIGHT TO KEEP AND BEAR ARMS you have criminalized
155 SELF PROTECTION —

156 The RIGHT to KEEP and BEAR arms cannot be criminalized
157 because it is an INALIENABLE and NATURAL RIGHT OF MAN.

158 Criminalizing this NATURAL AND INALIENABLE RIGHT does
159 nothing to stop criminals because criminals are, well, CRIMINALS
160 and by definition they are LAWBREAKERS.

161 No one is so smart they can manipulate thousands of people to
162 vote for them and then be so stupid as to think criminalizing a
163 natural right somehow interferes with criminals committing
164 crimes against and contrary to LAW.

165 Therefore, these people trying to infringe upon our NATURAL
166 and INALINEABLE and therefore ABSOLUTE right of self-
167 defense is a CRIMINAL who is preparing to ROB YOU of your
168 LIFE and LIBERTY and take total control of your pursuit of
169 happiness.

170 We must STAND against the WILEs of the DEVIL and his
171 representatives in government — we must STAND AGAINST the
172 wrong-headed nonsense that removing weapons from law-abiding
173 citizens somehow magically removes them from criminals.

174 Parents — take your children away from these devils that
175 indoctrinate them in these and other lies.

176 And, parents, American God-fearing adults — STAND up and
177 LEAD in your communities.

178 ALL INALIENABLE GOD ENDOWED RIGHTS are
179 ABSOLUTELY outside of GOVERNMENT infringement — but

180 that does not make anyone immune from responsibility for
181 criminal actions. You don't address criminal actions by
182 criminalizing INDIVIDUAL, INALEINABLE, and GOD GIVEN
183 RIGHTS. And that, my friend, is the ABSOLUTE TRUTH.

184 I'll be right back!

185 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
186 at the Lighthouse, your brain masseur, and Paul Revere's lantern
187 lighter, lighting the lamps in the church belfry arch, signaling the
188 enemy is on the march, an enemy that would steal from us our
189 liberty.

190 I remember when a child, I thought like a child — but when I
191 became a man, I put away childish things. A little something there
192 from the Apostle Paul — and this — be not children in
193 understanding; in malice be childlike, but in understanding, be
194 MEN: a manly understanding with a childlike faith —.

195 Paul said, in "malice be children" — the word *malice* speaks of evil
196 intent, ill will toward another: in this be immature, unskilled, easily
197 shamed, and persuaded to repent. But in understanding — this
198 word speaks of having discernment of what is fundamental to a
199 thing, you might say, it refers to someone who comprehends what
200 *stands under* — who rightly perceives a matter and whose
201 sympathies and cognitive faculties are rightly aligned with reality.
202 Hehe. But really! In understanding, don't be childlike, rather be
203 manly — mature, skilled, not gullible and not easily deceived.

204 Isn't it remarkable how consistently true it is that people who are
205 manly in their malice are childlike in their understanding? Those
206 who are skilled in deceiving others, skilled in their schemes to work
207 out their evil plans — are so susceptible to being themselves
208 deceived — indeed, deceiving and being deceived as the Bible puts
209 it — foolish — so much so it's hard for Heaven to restrain laughter
210 — it is interesting what makes Heaven laugh and what makes

211 Heaven rejoice — a sinner that repents and a wicked man that
212 rages against GOD and His anointed. Hmmm. Anyway, I must
213 encourage you to be childlike in your malice but mature in your
214 understanding.

215 As a child, I was encouraged to believe in science, to trust
216 "scientists" and to revere them as purveyors of ultimate truth.

217 In my home, the ideal of *science* was to get at the truth about the
218 physical universe, and the rigors of the scientific method were in
219 place to insure this would be achieved. We had laying all about the
220 house Popular Mechanics, Astronomy, and other magazines some
221 more technical than others — my dad was a man of SCIENCE.

222 When I became a man, I realized that scientists are after all men—
223 and susceptible to all the dark motivations plaguing mankind
224 generally, and greedy men particularly. So after about a thousand
225 disappointments, not the least of which was the fake "evidence"
226 supporting evolution—like Piltdown man, and so on, and after
227 being told science says don't eat this or that, only the year next to
228 be told, science says do—well, let's just say I've adopted a trust but
229 verify approach to anything any doctor or other "scientist" tells us.

230 I read this verse in the Bible and thought of how over 2000 years
231 ago, God warned his pastors — "O Timothy, keep that which is
232 committed to thy trust, avoiding profane and vain babblings, and
233 oppositions of science FALSELY SO CALLED." (I Tim. 6:20).

234 Lately, they have pretty much ruined the integrity of medical
235 doctors for me. What a pack of quacks. I'll tell you the only saving
236 grace in this current mess is the large number of real doctors,
237 people of genuine medical integrity, that are bravely resisting this
238 theft of science going on by the establishment medical community.
239 Phony Fauci and his let's reduce the planet population by about 6
240 billion friend Gates have pretty much destroyed vaccine credibility.

241 I have never been an anti-vaxer: good things have come from the
242 work of men like Jonas Salks and Albert Sabin. But I truly am
243 suspicious of anything FAUCI-GATES is peddling!

244 To vaccinate, or not to vaccinate — that is the question! Back in
245 2017, Fauci and friends anticipated, in fact, they planned for
246 resistance to the vaccine—something I'll get into shortly. They
247 were so prescient in their predictions I'm surprised I could not find
248 my own name listed as among those that would decry push to
249 vaccinate everyone against a disease from which almost everyone
250 survives.

251 A fatality rate of only .003% ages 0-19; .02% ages 20-49, .5% ages
252 50-60, and 5.4% 70+. And that does not even take into
253 consideration that the vast majority of those who died suffered
254 other morbidities so that CDC reports only 6% of all who died with
255 COVID died from COVID exclusively; and this does not even take
256 into consideration that the vast majority of the deaths among the
257 elderly occurred in elderly care facilities where Governors Cuomo,
258 Newsome, Whitmer, Wolf, and Murphy knowingly sent COVID
259 positive patients to infect others and kill as many or our elderly as
260 they could — I don't know any other way to explain this. What else
261 would motivate these monsters to do what they did? They had
262 other options, they were given other options, they were told what
263 would happen if they did this. So what could it be?

264 I don't know, but someone needs to investigate this. Because it sure
265 looks like they figured these people were a drain on the medical
266 dole — and on society as a whole, and like the NAZIs they are at
267 heart, they decided to send them to their deaths. A win win, aye!
268 Get rid of a social burden and gin up the COVID death count.

269 So, in light of this, I took interest in a statement recently made by a
270 former Vice President and Chief Science Officer of Pfizer — by the
271 way, Pfizer calls itself the "world's premier biopharmaceutical
272 companies" — a make of one of the more popular COVID vaccines

273 — so this former Chief Science Officer of Pfizer spoke "with great
274 urgency to America's Frontline Doctors (AFLDS) late last week" —
275 let's see, this article was published April 5, 2021, published by
276 Lifesitenews.com — I'm messing this up a bit, but, follow as best
277 you can: Michael Yeadon, former VP and CSO of Pfizer, spoke to
278 AMERICA'S FRONTLINE DOCTORS a few weeks ago and
279 urgently warned everyone listening that in his view the drive to
280 inject the largest possible portion of the population with
281 experimental COVID-19 vaccines is 'madness,' involves 'evil,'
282 includes 'crimes against humanity' and may have the intention of
283 "massive-scale depopulation." I apologize, I'm reading this and
284 thought that was his quote — let's find it — ah, here it is.

285 "Please warn every person not to go near top up vaccines. There is
286 absolutely no need to them ... (ellipsis, so the remark is edited and
287 some of his remarks were left out right here) ... if someone wished
288 to harm or kill a significant proportion of the world's population
289 over the next few years, the systems being put in place right now
290 will enable it. It's my considered view that it is entirely possible that
291 this will be used for massive-scale depopulation."¹

292 His views are similar to those of Geert Vanden Bossche, except
293 Yeadon does not think an alternative vaccine is the answer. Both,
294 however, express concern about "an exaggerated immune reaction,
295 especially when the test person is confronted with the real, 'wild'
296 virus after vaccination." It's complicated, but the idea is that the
297 present vaccines are actually only going to train the virus to get
298 around the vaccine and trigger a natural immune response that will
299 attack the patient instead of the disease.

300 Like so much that is going on with this COVID thing, the vaccine
301 madness has "no medical rationale for it," according to this former
302 VP and Chief Science Officer of Pfizer.

303 Okay, I spent so much time researching today, I simply ran out of
304 time for show production —
