- 54 Another play they are trying is to manipulate the system so the
- audit results will go before a judge they control.
- 56 After the audit is completed, the case will be brought before the
- 57 Superior Court in Maricopa County. The judge in the rotation to
- 58 take this case was Judge Coury. He had prior connections with
- 59 persons who are doing the audit of the election, so he did the
- 60 honorable thing, and recused himself.
- 61 Pamela Gates is what is called the Civil Presiding Judge in
- 62 Maricopa County Superior Court. This means that when a judge
- 63 recuses him or herself Pamela Gates is responsible to select the
- 64 judge who will hear the case.
- Now, it just so happens that Pamela Gates is the wife of Bill Gates
- 66 not the one who wants to depopulate the planet by about 6
- 67 billion people the one who is Maricopa County Supervisor for
- 68 the third district one of the five Supervisors who did everything

- 98 So, the reporter calls the office of Judge Thomason and his office
- 99 said that Judge Thomason did not select Judge Martin. The
- 100 reporter was told that Judge Thomason announced the
- appointment of Martin—but that is what he was instructed to do.<sup>2</sup>
- Where did he get the instruction to name Judge Martin as the
- 103 judge to receive this case? The reporter was told the person
- 104 responsible to decide who would hear the case was PAMELA
- 105 GATES. The office of Judge Thomason said flatly that the name
- 106 came down from JUDGE GATES.
- 107 So there you have it! Super liberal and Democrat loyal Judge

- Absentee ballot cast that were returned on or before the postmark
- 119 date: 22,903
- 120 Double voters: in-state: 157
- 121 Ghost voters: 5,790
- Mail-in ballots cast by voters registered after the registration
- 123 deadline: 150,000
- 124 No address on file for voter: 2,000
- Out-of-state voters who voted in-state: 5,726
- 126 Over-votes: 11,676
- 127 Possible ILLEGAL VOTES: 254,722.
- 128 I mean, if the 2020 election was the most above board and
- 129 transparent election in the history of Arizona, as Governor Doug
- 130 Ducey claims then Arizona might be more messed up than
- 131 California and I doubt that! Good night!
- 132 If the election was done according to LAW—the ballots received
- 133 that were returned ON OR BEFORE THE POSTMARK DATE
- 134 would be rejected—and that accounts for more than 22k votes.
- 135 Let's look at those and see how many were for Biden, shall we?
- 136 Think we might find about 11k? About half, at least, right?
- 137 Besides the 150,000 ballots from voters registered AFTER THE
- 138 REGISRATION DEADLINE. 150k, folks! COME ON MAN!
- How far will they go to stop the AUDIT?
- 140 Hey, I'll be right back!

- taken from the CDC, folks!

- Now, get this. Across all ages, God's designed immune system is
- 173 98% effective to ward off the COVID bug.
- 174 The best synthetic (man made) vaccines can do for this disease is a
- 175 95% effective rate. But that's only if you reduce the threshold of
- 176 what is considered effective to include prevention of MILD
- 177 SYMPTOMS.
- 178 According to the science which every one tells us we must
- 179 FOLLOW according to the science the vaccine manufacturers
- cannot claim their product prevents asymptomatic COVID-19 or
- 181 to last more than one year.
- 182 [As an aside: FDA will not approve these experimental drugs as
- 183 vaccines. This is because they are eperimental. In fact, all who take
- the vaccine are enrolled in a clinical trial, and tracked for two years.
- 185 I don't know if that's routine for all such vaccines, but, wow! I
- wonder if people are being given full disclosure about this?
- 187 As of Jan. 22, there have been 271 deaths and 9,845 adverse events
- 188 following vaccination—most of the deaths occurred within 48
- hours of the vaccination. And hey, "a study shows that only about
- 190 1% of actual cases are picked up" What???
- 191 [By the way, I am aware that adverse events are common to all
- sorts of medical treatments—it's impossible to anticipate how every
- 193 body will respond or to account for a myriad of impossible to
- 194 foresee variables from person to person, from vial to vial, and so
- on. HOWEVER: we are talking about taking these risks to protect
- 196 you from a disease that your own immune system will likely
- 197 protect you better. 98% GOD'S NATURAL IMMUNE SYSTEM as
- opposed to 95% for the science guys.]
- 199 Phony Fauci tacitly admits the vaccines are a waste of time. He
- 200 said, "I would recommend people to not abandon all public health
- 201 measures just because you have been vaccinated." He explained
- 202 why, "Even though, for the general population, it might be 90 to

- 203 95% effective, you don't necessarily know, for you, how effective it
- 204 is."
- I saw a meme here is a guy wearing a seat belt while standing in
- a park—CDC recommends you wear your seatbelt when outside of
- your car.
- We should all wear a helmet; after all, 200 satellites up there might
- break into thousands of pieces and start falling out of the sky.
- 210 Why do they want to keep us in these masks of oppression?
- Oregon is talking about making it a permanent thing. You've got to
- be kidding me. When are we going to start following the science?
- 213 According to the science masks don't protect from virus
- 214 infection or transmission. And, according to an MIT study I read
- 215 recently, social distancing indoors does not offer any significant
- 216 protection either.<sup>3</sup>
- 217 And, hey, where did the flu go? (Roland, I am aware that the
- 218 science says generally only one strain of flu dominates any given
- 219 season.)
- Normal flu rates range from 9 million to 43 million in a season.
- Deaths from flu range from 24k to 62k on the average flu season in
- 222 the US.
- 223 In 2017, we had 45 mill. cases; in 2018, 42.9 million, in 2019, the
- 224 estimate was from 39-56 million but in 2020 there were only
- 225 1,499 cases of the flu.
- Here is a New York Times article in which Dr. Webby tells us
- 227 "generally, there is only one dominant respiratory virus in a
- 228 population at a given time." But such a drastic reduction seems
- 229 implausible. No such dramatic reduction in flu cases accompanied
- 230 the first SARS-CoV-1 outbreak during Obama's administration.
- From September 2020 through the beginning of April, we have had

- only 2000 cases of the flu reported. Usually, during this same time
- span, we would have had 206,000 cases.
- Now, here is another lesson in how to read these things.
- 235 Dr. Webby further explains that, "one tends to keep the other out."
- Apparently, however, this is not an adequate explanation why the
- 237 flu has virtually disappeared!
- 238 The article goes on to credit wearing masks and social distancing as
- 239 possibly contributing to the surprising phenomenon: "As measures
- 240 to stop the spread of the coronavirus were implemented around
- 241 the country in March 2020, influenza quickly disappeared, and it
- still has not returned."4 It is admitted, however, that "scientists do
- 243 not yet know which public health measures were most effective in
- 244 eradicating the flu this season," but conjectures that "if behaviors
- 245 like mask-wearing and frequent hand-washing continue after the
- 246 coronavirus pandemic is over, they could HELP TO KEEP
- 247 INFLUENZA AT BAY IN THE UNITED STATES."5 OH, God
- 248 help us! These crazy people are laying down the premise for
- 249 keeping us in perpetual lockdown, or wearing masks indefinitely —
- 250 . But my point is that natural suppression by one virus over others
- is not an adequate explanation for the sudden disappearance of the
- 252 flu—masks might be, social distancing might be, who knows—Dr.
- Webby said "we don't have a clue" when the flu will make a
- 254 completely but any worth, there also don't have a discount of the second of the se
- 254 comeback—but, apparently, they also don't have a clue what made
- 255 the flu disappear. But one thing they all agree to is that it's coming
- 256 back and possibly with a vengeance.
- 257 Scientists warn that "The lack of exposure to the flu could also
- 258 make the population more susceptible to the virus when it
- 259 returns—and experts say its return is certain"—according to
- 260 epidemiologist Sonja Olsen, CDC.

- 261 The doctors interviewed for this article expressed a concern about
- a decrease in natural immunity. Dr. Olsen said, "Lower immunity
- 263 could lead to more infections and more severe disease." Exactly!
- 264 Exactly what we have always known about the natural working of a
- virus in a population. Exposure helps generate the natural immune
- 266 response and as the virus moves through a population it becomes
- increasingly weaker while the natural immunity of the population
- 268 becomes increasingly stronger.
- 269 The flu has NEVER DISAPPEARED FROM CHINA although
- 270 mask wearing and social distancing are the norms there.
- 271 All the studies on mask wearing show minimal protection from
- 272 any virus, that are far outweighed by the risks of prolonged mask
- wearing. Recently, a perfectly healthy teenager collapsed at the end
- 274 of a run from oxygen deprivation. The masks DON'T work!
- 275 Neither does social distancing—in doors—if the risk of getting
- 276 COVID while sitting at a table to eat your food is acceptable, then
- 277 the risk of getting COVID as you walk to the table is also
- 278 acceptable.
- 279 Be DONE with the Masks, my friends. I'm almost done with my
- 280 booklet explaining MASK-SCIENCE read this MIT study
- 281 exposing the social distancing scam! It's about control!
- 282 It's about realizing the JoeBama dream of transforming America
