- 55 matters. This is not the sort of thing that should be taught in a
- 56 CLASSROOM is anything PRIVATE anymore?

- 57 Adam and Eve became "aware" of their nakedness and this caused
- 58 them to be surprised and "ashamed" I think God intended to
- 59 reveal to Adam and Eve the Knowledge of good and evil but first
- 60 they needed to learn obedience, otherwise, the evil would dominate
- 61 and overwhelm the good. They disobeyed God and got that
- 62 knowledge too soon before they were ready. There is a time and
- 63 a place for children to learn about their sexuality and it should be
- 64 in the PRIVACY of the PARENT CHILD relationship. And it is a
- 65 personal and PRIVATE matter.
- 66 And then CRT Critical Race Theory—another attempt to shape
- our children's souls created in the image and likeness of GOD into
- 68 the image of SATAN himself this is the most devilish thing our
- 69 "educators" have pushed on our children since they began telling

- 91 And now they want to teach the children the philosophical
- 92 rationale for hating white people.
- 93 But there is push back: 834.13.1-THERE are SOME BRAVE
- 94 PATRIOT TEACHERS OUT THERE standing up and speaking
- 95 out, and many parents are rising up like Momma Bears to protect
- 96 their CUBS. Good for them.
- 97 Meanwhile, Hunter Biden's laptop continues to deliver proof that
- 98 the Biden's are White Supremacist racists. Hunter's emails show H.
- 99 Biden using the *N* word repeatedly when talking to a lawyer but
- that should not surprise anyone. His father, like his son, is a racist

- 102 Get a load of this. A meme found on Hunter's Laptop shows
- 103 Obama and Biden in a hug Obama says, "I'm gonna miss you,

- 106 Wow! Hunter Biden's laptop proves what I've been saying Joe
- 107 Biden is a White Supremacist really, they all are in fact, I
- think Biden picked up the baton of Imperial Wizard of the KKK

- 110 First, everyone knows Biden opposed every effort to advance the

- 133 mainstream African-American who is articulate and bright and
- 134 clean." Excuse me?
- 135 2006: Biden, then a senator of Delaware, can be seen in a
- 136 clip talking to a man who appears to be of Indian descent. "In
- 137 Delaware the largest growth in population is Indian Americans,"
- 138 Biden said. "You cannot go to a 7-11 or a Dunkin Donuts unless
- 139 you have a slight Indian accent. I'm not joking."
- 140 What sort of heart crafts statements like these? Perhaps the same
- 141 sort of heart that thinks throwing the *N* word around flippantly,
- vulgarizing an ethnic group within the family of man sort of like
- 143 how so many throw about the F word vulgarizing the sexuality
- of mankind. These are VULGAR PEOPLE! Selah!

- 146 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
- 147 at the Lighthouse, your brain masseur, and Paul Revere's lantern
- lighter, lighting the lamps in the church belfry arch, signaling the
- 149 enemy is on the march, an enemy that would steal from us our
- 150 liberty.
- 151 ELECTION FRAUD UPDATE:
- 152 AZ: The Auditors will complete counting BALLOTS by June 14.

- 196 correct the intentional computer problems that subverted the
- 197 election.
- 198 These logons appear to have escalated privileges at the time of
- 199 logon.
- 200 Again ... REMOTELY."
- 201 [THE PURPOSE FOR THE REMOTE AND ANONYMOUS
- 202 LOGON IS REVEALED BY WHAT WAS DONE and what was
- 203 done is SOS was given ENHANCED PRIVILEGES THE ONLY
- 204 ONES WHO COULD DO THIS WOULD BE SOMEONE FROM
- 205 DOMINION or WORKING FOR DOMINION. THIS MEANS

- 206 DOMINION WAS DIRECTLY INVOLVED IN THE STEAL AND
- 207 THE COVERUP.]
- 208 Deperno continues: 3. "But we were told there was no internet
- 209 connection.
- 210 In an accredited [ELECTION MANAGEMENT] system, an
- 211 anonymous user should not be authorized by the accreditation
- authority, but would instead be required to enter a specific user
- 213 name and password to utilize the system." But the "hacker" did this
- 214 anonymously!
- You see, they can't pass it off by saying, well, yeah, some official
- 216 with access, like Dominion, had to get in there to enhance our
- 217 privileges to we could fix the machine. The machine needed
- 218 "fixing"? HAH! You mean it need to be UNFIXED!
- 219 The LOGON was ANONYMOUS. There is no reason to go anon
- 220 unless you don't want anyone to know who did the deed. There is
- 221 no reason to cover up who did this unless it was done for nefarious
- 222 reasons!
- 223 4. Deperno continues: "We were told there was no internet
- 224 connection. We were told there was no remote access. We were
- told this was human error. ALL LIES. (caps for effect)
- 226 This is fraud. This decertifies the Antrim County election.
- 227 SOS Benson should resign or be impeached."
- 228 BOOM!
- NOW, here is some more from Deperno:
- 230 GET A LOAD OF THIS:
- 231 From another MATT DEPERNO—TWEET, this one in three
- 232 parts:
- 233 Former [(R)] MI State Representative Tristen Cole started
- 234 contacting people in Antrim County asking for county clerk Sheryl

- 235 Guy's personal cell phone. [Sheryl Guy is a Democrat loyalist, she
- 236 is the City Clerk who ordered the deletion of election logs from the
- computers in Antrim Co.]
- 238 2. Deperno explains the reason Tristen Cole wanted the City
- 239 Clerk's private phone number: "Because Senator Ed McBroom
- 240 needed to talk to her ASAP and NOT ON AN OFFICIAL
- 241 TELEPHONE LINE. [Ed McBroom is the Chairman on the
- 242 Michigan Senate OVERSIGHT committee that led the hearing
- regarding voter fraud allegations. This is the guy who dismissed the
- 244 allegations, and who, according to Deperno, buried all the evidence
- and refused to meet with Deperno.
- 246 Then Deperno suggests, reasonably, the reason McBroom wanted
- to talk to Sheryl Guy on a "private" line:
- 248 3. "This phone call on a private line is an attempt to circumvent
- 249 FOIA, violate the open meetings act, and may implicate them in
- violation of other laws and regulations."
- 251 So, the MI State Senator who chairs the "oversight committee" that
- 252 heard evidence regarding election fraud and DISMISSED it —
- 253 suddenly needs to talk to the CITY CLERK who was involved in
- 254 "deleting election log data" in the county where 6000 votes were
- 255 switched from Trump to Biden and suddenly, he needs to talk to
- 256 her ASAP —??? Oh, and on a private line he cannot connect
- 257 to her through the OFFICIAL channels THAT WOULD BE
- 258 SUBJECT TO PUBLIC SCRUTINY!
- 259 And McBroom does not personally try to find a way to contact
- 260 Sheryl outside OFFICIAL CHANNELS, for a private chat —
- 261 apparently, he asked a FORMER RINO REPUBLICAN Tristen
- 262 Cole to find her private number.
- We've been lied to! The Dominion machines are internet capable.
- 264 They are hackable. Comielah said so, herself, in 2019—she testified
- that she watched a company easily hack into the voting machines.

- 266 Flynn offers a status assessment of the Election Fraud exposure
- 267 effort. He believes some real, what did he call them, oh yeah,
- 268 "bombshells" are coming out of AZ and probably also GA.
- Remember what happened in GA? It's actually old news. A GA poll
- 270 manager testified that when counting absentee ballots for the 2020
- 271 election she noticed THOUSANDS OF BALLOTS, PERHAPS
- 272 TENS OF THOUSANDS APPEARED TO HAVE BEEN PHOTO
- 273 COPIED, THERE WAS NO FOLD, THE BALLOTS LOOKED
- 274 PRISTINE —THREE OTHER workers saw it too. They SWORE
- 275 UNDER PENALTY OF PERJURY TO WHAT THEY SAW! But
- we heard about this months ago.
- 277 Some ELECTION watchdogs persisted, and finally got a judge to
- pay attention to these affidavits. That judge unsealed 147k mail-in
- 279 ballots. The ones counted in Fulton—you saw the video. No one
- listened, no one cared to listen. But Trump is out of the way, so
- 281 now they will listen? What's going on?
- The clock is telling me I need to wind down.
- 283 But let me give you a quick update on the PANDEMIC FRAUD.
- 284 FAUCI is feeling the noose tightening around his scrawny neck.
- 285 Like a Chihuahua he is barking and snarling It's very
- 286 DANGEROUS to attack me. To attack me is to attack SCIENCE.

- 288 "I am science, I am truth." This man is losing it! Ingraham gave
- 289 her angle on this: the only Person with the cred to make a

- 292 Who does this guy think he is? I mean, really? He is a Catholic,
- 293 right? He is going all Bishop of Aquila right? "To break faith
- 294 with me is to break faith WITH HIM..." you know, with that quick
- ominous portentous glance upward WITH HIM!

- 296 Break faith with FAUCI and hey, It's DANGEROUS keyword
- 297 here. DANGEROUS! This little man is trying to bully the
- 298 American people like those liberal news anchors I heard with
- 299 voices descended into near guttural tones warning those who
- refuse to take the vaccine that they will have to PAY!
- Hey, NONE of this is working! In fact, it is driving people farther
- 302 away from your needles.
- 303 HAH! Attack Fauci, you are attacking science.
- 304 PRONOUNCEMENTS OF SCIENTISTS ARE NOT SCIENCE.
- 305 I've got a booklet coming out soon, I hope, on the SCIENCE of
- 306 MASKS—this entire nonsense about masks, and social distancing,

- 325 on gain of function research on bat viruses—Shengli is the
- 326 infamous "bat lady."
- The CCP run Wuhan lab lists Daszak's group as a PARTNER. This
- 328 is from National Pulse. National Pulse dug up some speeches from

- 347 At each step of this you move closer and closer to—this virus could
- really become pathogenic in people."
