57 She spoke for us at one of our Brain Massage Banquets a few years 58 ago. We will certainly have her back!

59 Here are four questions Linda and her team has put to the CA

60 Secretary of State Shirley Weber on June 17, 2021. She has not 61 responded. The questions are as follows:

62 Why are there almost 124,000 more votes counted in California's

November 3, 2020 election than voters recorded as voting in that
election? And why is most of the discrepancy driven by 116,000
vote-by-mail ballots with **no apparent voter identified** in
VoteCal's voting histories? She provides a list by county.<sup>2</sup>

67 Why do more than 7,700 voters have TWO November 3, 2020
68 votes credited to their voting histories? These means there are two
69 votes credited to each of 7,700 unique (non-duplicated) registration

70 ID numbers in the state database.

71 Why does California have 1.8 million more registered voters than

eligible citizens and why did this overage rise 72% in the 2020
election cycle? Again, she provides a list by county.<sup>3</sup>

74 Why did California's on-line and DMV registration systems
75 change 33,000 foreign-born voters' birthplaces of record to
76 "California" or "United States", potentially masking non-citizens
77 unlawfully registered to vote? Similarly, why were 76,000
78 birthplaces changed from another U.S. state to California? And,
79 once again, Linda provides documentation, here.<sup>4</sup>

80 Can you believe this? Of course you can! It's a "blue state." These81 sorts of things are common in Blue States.

82 Election Integrity Project is suing the Secretary of State, Shirley

83 Weber, et al, and put it before a lower court where it was dismissed

84 without ruling on the merits of the case. This allows it to go

85 directly to the Ninth Circuit Court of Appeals. It is anticipated that

86 the Ninth will either dismiss, or rule against the case so they will

87 move the case to the SCOTUS.

88 The suit challenges "laws, regulations and election practices that
89 have undermined California election integrity, creating an
90 environment ripe for irregularities."

- Election Integrity Project filed the suit after they collected 700
  sworn affidavits from trained citizen observers who described
  various irregularities during the 2020 general election in CA.
- Paine understands how the Marxists play the game here in this
  state (and, really, in every state). The COMPLAINT "also examines
  how CA laws like ballot harvesting, and last-minute changes like
  privileging vote-by-mail voting over in-person voting,
  disadvantaged minority groups."
- 99 That should put the enemy on defense.

I am, frankly, DISAPPOINTED that Linda is not challenging the
2020 election. On the other hand, her strategy might actually break
ground for a followup suit that will provide that basis for
demanding Weber, et al, conduct an AMERICAN AUDIT of the
CA 2020 election. That's some more good news coming out of Cali.

- 105 Hannity says his lawyers tell him even if election fraud is proven, Trump does not get into the White House. He said unless we have 106 107 access to lawyers smarter than those he has, there is no provision in law for a circumstance like what we face right now. There is no 108 legal path in place to decertify an election that has been certified by 109 110 the Congress. Well the CONSTITUTION sure didn't get in their way when they decided to STEAL from the PEOPLE their right to 111 choose their leaders. 112
- 113 You've got to be kidding me! They can STEAL the election and 114 then smile and say, well, what are you going to do about it.

Well, it seemed to me I remembered some elections being 115 overturned because of fraud, so I did some digging and found a 116 report from One America News back in May from Pearson Sharp 117 that Hannity needs to see, and then he should immediately fire 118 those worthless attorneys he has been listening to, especially if he is 119 depending them to represent him against the power-thieving 120 Demoncrats. I'll be paraphrasing Pearson's report, which you can, 121 and should view, here.<sup>5</sup> 122

- 123 The question becoming increasingly important to us is what 124 happens if fraud is proved and it becomes clear that a sitting 125 president did not LAWFULLY win the election?
- The Constitution does not envision a circumstance like this. If it 126 127 had been caught at the time the Electoral College convened, Mr. 128 Pence, then yes, they could have the rejected **ELECTORS** 129 **UNCONSTITUTIONALLY** appointed and/or 130 invoked Article 12. But nothing is said regarding a situation where the election has been certified fraudulently and a fraudulent 131 132 President placed into office.
- But there are multiple examples of contested elections, specificallyinvolving fraud, that were overturned.
- 135 In some cases, courts have ordered a whole new election to be held136 after a case of fraud has been proved. EXAMPLES
- 137 2004 "The Supreme Court concluded that a new election was
  138 required because the absentee ballot fraud 'substantially
  139 undermin[ed] the realiability of the election and the
  140 trustworthiness of its outcome."<sup>6</sup>
- 141 In an Alabama Mayoral race in 1984, one of four voting machines

142 failed to register any votes cast for one of the four candidates.

Hmmm. Dominion? The state supreme court ordered the entire
election rerun, overruling the trial court's remedy of ordering new
balloting only for the voters who voted on the defective machine."

A 1950s Illinois Supreme Court voided a local election after
concluding that ballot integrity was compromised and ended up
ordering a new election altogether.

149 In an article written by Steven Huefner, Professor at Ohio State University, Moritz College of Law,7 titled, Remedying Election 150 Wrongs, (nd-leading up to the 2000 race).<sup>8</sup> After laying out the 151 evidence supporting what everyone already knows, mail-in-ballots 152 open our elections to increased fraud, and presenting other 153 154 compelling argument showing what any reasonable person should 155 from native sense understand—voter and/or election fraud in any case is injurious to the PEOPLE's right to elect their 156 157 representatives, but it is especially disturbing if it occurs in a 158 national election-a Presidential election. The professor offers two remedies that have been used to correct Mayoral and even state 159 wide failed elections, such as for Congress or Senate. 160

161 FIRST: Once courts identify illegal votes, one remedy is to adjust 162 the votes accordingly. If it's proved that x number of votes went to 163 one candidate that belonged to another, or votes were not counted 164 that should have been, or votes were counted that should not have 165 been, in any such case the vote totals are adjusted to correctly 166 reflect the vote of the people and the true winner is declared.

167 SECOND: The second kind of relief is to void the election, leaving168 the office vacant until a new election is held.

169 Some legal scholars argue that the language in Article II of the 170 Constitution would prevent a Presidential election from being held

after it has already been decided by Congress. That is incorrect! 171 The language of Article two makes no such stipulation—THERE IS 172 173 NOTHING IN THAT ARTICLE that says anything like, the President, once certified by Congress may not be removed. It 174 175 provides for removal by impeachment for treason, bribery, and/or 176 high crimes and misdemeanors. True, it does not address the circumstance in which the person holding the office of the 177 President does so as a consequence of treason, bribery, and/or high 178 crimes and misdemeanors. But, come on, MAN! 179

- 180 This situation has never happened before. This is so important a 181 topic I'm going to continue exploring this question with you on the
- 182 other side of the break. Hold on! I'll be right back!
- Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor at the Lighthouse, your brain masseur, and Paul Revere's lantern lighter, lighting the lamps in the church belfry arch, signaling the enemy is on the march, an enemy that would steal from us our liberty.

188 Hannity tells us Trump is wrong! If a thief steals your wife's 189 diamonds, he does not have to return the diamonds when he is 190 caught. He gets to keep the diamonds. Haha! Of course, when 191 Hannity said his lawyers have told him there is no path to removing a fraudulently — you can't say elected, because he wasn't 192 193 - Congressionally INSTALLED President, he was not talking 194 about the theft of diamonds. No! He was talking about some fare 195 more valuable-the theft of the PEOPLE's RIGHT TO CHOOSE THEIR LEADERS. Hannity needs to get new lawyers. We have 196 197 already shown there is precedent for overturning Mayoral, and even State wide congressional races because of voting fraud, and 198 199 even because of failed voting machines. To suggest presidential 200 elections occupy a special category beyond such court remedies is 201 madness.

Who is with me when I say, you can't VIOLATE the CONSTITUTION on one hand to steal an office, and then turn around and use the Constitution to protect yourself from returning that office TO THE PEOPLE. You can't violate the law by stealing someone's diamonds and then use the law to keep what you have stolen.

John F. Banzhaf, III<sup>9</sup> – a nationally known law professor and 208 209 practitioner of what is called "public interest law." He is "one of the most powerful persons in Washington." This is the guy who went 210 after the Tobacco companies. After he stipulates that the US 211 212 Constitution does not clearly provide for the cancellation of a presidential election once the Congress has met and determined 213 214 the outcome of the Electoral College, he goes on to say this does not mean it cannot happen. 215

216 The question is not whether a *Presidential* election has ever been overturned because of fraud-the question is whether any 217 ELECTION has been overturned because of fraud. Understand? It's 218 about the PEOPLE's RIGHT TO ELECT THEIR LEADERS-219 regardless of whether it's Mayor, Representative, Senator, or school 220 board member. It's about OUR RIGHT TO VOTE! We don't LOSE 221 222 PROTECTION for OUR RIGHT TO A FAIR AND HONEST ELECTION simply because the office happens to be that of the 223 224 President. You've got to be kidding me! So, is there a precedent for 225 overturning ELECTIONS? Yes!

226 The fact is there IS PRECEDENT for overturning ELECTIONS and

the fact that fraud occurred in an election so important as that of

228 President only means IT'S MORE IMPORTANT to ADDRESS IT,

229 not less. The question is, does a President elected by fraud have

230 some special protection from having the election overturned? ANd

231 the answer is ABSOLUTELY NOT!

232 The reverse should be true.

In the context of the question whether a presidential election can be overturned for fraud, Banzhaf explained "new elections have been ordered in local and sometimes even state and congressional races when serious questions have been raised about the outcomes." He cited a compelling and relevant example. In Mississippi, a Judge ordered a new "special election" after "rampant absentee ballot fraud" was found.

- But guess what? A Federal court has stipulated that the FederalCourts have jurisdiction in presidential elections.
- 242 In 1976 a District Court in NY addressed the pertinent question:
- 243 do presidential elections occupy a special category beyond such
- 244 court remedies. They answered, unequivocally, NO!
- This District Court stated clearly that "FEDERAL COURTS HAD
  A ROLE TO PLAY IN ENSURING FREE AND FAIR
  PRESIDENTIAL ELECTIONS ..."

248 The court argued, in Donohue v. Board of Elections of State of 249 NY:<sup>10</sup> "It is difficult to imagine a more damaging blow to public 250 confidence in the electoral process than the election of a President 251 whose margin of victory was provided buy fraudulent registration 252 or voting, ballot stuffing or other illegal means." The court further 253 argued that prohibiting Federal court jurisdiction over Federal elections would "invite attempts to influence national elections by 254 255 illegal means." (IBID.) The court also noted that "Federal courts 256 have not hesitated to take jurisdiction over constitutional 257 challenges to the validity of local elections and, where necessary, 258 order new elections."

This court agreed with my earlier assessment but it's expressed in legalese, so I'll rephrase it: A national election impacts the entire

261 nation, AND SO If a national election requires judicial
262 intervention, it is all the more necessary to recognize THE
263 JURISDICTION OF THE FEDERAL COURTS INCLUDES
264 CHALLENGES TO PRESIDENTIAL ELECTIONS.

- This finding of a NY District Court, in 1976, clearly contradicts the opinion of those who say the presidential elections occupy a special category beyond court remedies.
- 268 You can't separate a PRESIDENTIAL ELECTION from other
- 269 elections and say, effectively, the PEOPLE'S RIGHT TO FAIR

270 AND HONEST ELECTIONS is eclipsed by the importance of the

- 271 office of President. It's the reverse. That office, above any other,
- 272 must be protected AGAINST BEING STOLEN BY FRAUD.
- 273 If it is proved the sitting president occupies the office by virtue of
- 274 fraud, NONE OF HIS ACTIONS HAVE LEGAL AUTHORITY.
- All EOs and all bill signed become NULL of authority, and areautomatically stricken, automatically repealed.
- 277 Justices Thomas, Alito and Gorsuch were RIGHT—Kavanaugh278 and Barrett—we expected better!
- If election fraud is proved, the COURT CAN, and indeed, MUST,
  hear the case and rule according to the evidence. Setting ALL
  POLITICS ASIDE! The court must RULE ON THE EVIDENCE.
  And the evidence supports only one conclusion—Biden is NOT the
  President and must pack his bags and move out of the studio at
  Castle Rock immediately. Hahaha.
- 285 Don't let anyone tell you auditing our elections compromises the 286 integrity of our elections—it enhances confidence in our elections 287 and secures their integrity. Don't let anyone tell you Justice is dead 288 in America. Friend, so long as GOD exists, JUSTICE EXISTS. We 289 are laborers TOGETHER WITH GOD — there is HIS PART and 290 there is OUR PART. We don't need to worry about Him doing His 291 part — it's up to us to step up and DO OUR PART. Call ON GOD

to release JUDGMENT into our LAND against the evildoers! At the same time, DEMAND your government do its duty and execute wrath against the EVILDOERS. Pray God will help us, like he helped David take out Goliath, and Gideon take out the Midianites, and that little prayer band in the early church took out king Herod—

- Has America crossed God's "red line"? I'll address this more tonight during our live-stream visit. The show is produced Friday and some of you get this show Saturday or later. You'll my extended comments on the question on our Face Book page — look for Comfort & Counsel for the Present Distress (309).
- The "red line" is what triggers God to invoke Psalm 9:17 where we are told the "wicked shall be turned into hell, and all the nations that forget God." To be turned into hell is to be delivered over to the power of Satan. The concept of God turning people and nations over to Satan's power is presented clearly in Romans 1:17-31; see also I Cor. 5:5 and I Tim. 1:20. It is illustrated by Sodom, and by her spiritual sister, backslidden Jerusalem—Jeremiah 23:14.
- At what point does God drop a nation into HELL? Israel was never perfect—at no point in her history was she without all manner of wickedness. It was always the case that she was preserved on behalf of a small remnant of believers. So long as there was a remnant with sufficient influence in the culture to keep it from turning fully away from judgment and justice, God would preserve them.
- Believer, you are the LIGHT of this world. Think about it. Theworld has no light without you. Whatever LIGHT is in this world,it comes from you.
- 319 That is the reason lovers of darkness hate you. Your LIGHT keeps
- 320 exposing them and their deeds. As long as you will shine your light,
- 321 you have the power to scatter the power of darkness.

Also, you are the salt of the earth. SALT preserves a home, a church, a city, a state and a nation.

324 If there had been as few as ten righteous in the city of Sodom and 325 GOD would have preserved that city from DIVINE destruction: 326 only ten. We don't know the population of Sodom or we would 327 work out a percentage formula.

- Let's consider America, for a moment. First, it is very important you understand YOU ARE THE LIGHT OF THE WORLD. The world has no LIGHT without you. The world will not be cast into utter darkness until you are removed.
- 332 Second, understand that you are the salt of the earth. We are the333 one's with the influence before God to move Him to HEAL OUR334 LAND. We are the salt!
- 335 It's the remnant's influence over the rest of the world and the earth
- that God measures. All the "lost" people out there, whatever "light" they have, they get if from you. You don't even realize it. But it's true that whatever "light" they have, it comes into the world through believers. Same thing is true of the SALT. It is kept back from total destruction because of our presence. When we are removed, it's over!
- 342 So consider the influence of your light and your salt. When you hear lost people talk about justice and judgment and righteousness, 343 and belief in GOD, and show respect for JESUS CHRIST and His 344 goodness, and you see and hear lost people talk about justice, and 345 many have a passion for it, and a heart's longing for righteousness 346 347 — they are not always clear on what it is, but they know right from 348 wrong and choose the RIGHT over the WRONG — that's because 349 of YOUR INFLUENCE in this world.
- 350 When I look at the 2020 election and see what has been developing
- 351 across our land—I see the prevailing influence of the salt and light
- 352 of the believers in America.

353 The people are standing up for what is RIGHT — more and more

are rising up — Biden was NOT ELECTED by the American
people. Donald Trump was. Biden and the policies he represents
was PUSHED ONTO US, HE WAS NOT CHOSEN.

- 357 The PEOPLE do not go in for CRT. The PEOPLE are kicking back358 against forced injections.
- 359 Oh, there is evidence that our light has gotten dim and our salt has
- 360 lost a significant measure of its savour but it's not so far gone
- that this nation has turned its back entirely on GOD.
- 362 Satan wants you to believe that. But you need to remember, it's the

- 365 of this world.
