



1 Segment.01 Hello. I'm Dr. Jerry Scheidbach, pastor of the
2 Lighthouse Baptist Church in Santa Maria, CA—and your brain
3 masseur—get ready for your brain massage.

4 Biden's Knock, Knock joke is not funny. Biden calls for federalized
5 local officials to come to your door and ask whether you have had
6 the vaccine!

7 In a related story, Witch Gretchen of MI is sending the police after

40 time we yield to this, the government grows stronger, and soon it
41 will be strong enough to PUSH YOU ASIDE AND SAY, WE WILL
42 TELL YOU WHAT TO PUT INTO YOUR BODY. Government
43 will brook no competition for control of your life—FASCIST
44 GOVERNMENT THAT IS! Not AMERICAN govt. Nazi
45 government. A pack of perverted pedophilic Nazis were brought
46 into our country after WWII and put in service to the CIA, and

58 the point. Intimidation tactics are coercive — it's like Reagan said
59 about the nine most frightening words in the English language:
60 "I'm from the government, and I'm here to help." Pseudo-Suki
61 Psaki explained the Federal government is sending "local officials"
62 into areas where there are lower vaccination rates to provide
63 information on where to go get your vaccine. But in the end, "it's
64 up to individuals to decide whether they want to get vaccinated or
65 not." Okay deary, we will hold you to that!

66 Whether or not you have been vaccinated, whether or not you plan
67 to be, you are a fool to yield to this. RESISTANCE to
68 unconstitutional intrusion into your rights is not only your right—
69 it is your RESPONSIBILITY. Intrusive government behavior must
70 be resisted early, before it gains strength through public
71 acquiescence. Please understand that if you cooperate with this,
72 you are FEEDING THE MONSTER.

73 The fact is, the federal GOVERNMENT HAS NO BUSINESS
74 SENDING GOVERNMENT OFFICIALS TO YOUR DOOR
75 ASKING WHETHER YOU HAVE BEEN VACCINATED. IT'S
76 NONE OF THEIR BUSINESS.

77 THIS IS PRIVATE AND PERSONAL MEDICAL
78 INFORMATION.

79 Tell them, go to my doctor and ask him. Oh, you can't, because
80 they can't tell you! That would be against the law. I see! And why is
81 that? Why is it that the government CANNOT COMPEL its
82 citizens to reveal personal medical information? Because it's a
83 VIOLATION of privacy!

84 You are violating my privacy right now! You are a "government
85 official" — and you are here asking me for private and personal
86 medical information. You are asking me to tell you something you
87 have no right to know. Your presence here, with your
88 "Identification" telling me you are from "the government" puts you
89 in a position of AUTHORITY and this is an ABUSE of that
90 AUTHORITY. It's intimidating, coercive, and abusive against my
91 RIGHTS.

92 You might also hand them a copy of the Nuremberg code while
93 you are at it. Or HIPPA!

94 Here is another approach: I am a taxpayer. I'm participating in the
95 payment of your salary and the government has no authority in
96 this matter, right? You have no AUTHORITY in this matter! You
97 don't even have the AUTHORITY to ASK me about my vax status.
98 You are participating in the use of my tax dollars to fund activity
99 that is UNAUTHORIZED by WE THE PEOPLE — why, because
100 the government has NO AUTHORITY HERE. You understand
101 that the government exercises AUTHORITY — that's what it
102 DOES! You have NO AUTHORITY in this matter and so this is an
103 illegitimate use of AUTHORITY.

104 Stop the Government's POWER Grab NOW. Fight them here, at
105 this battle line, now — because if you don't, you will be facing
106 down tanks — Tiananmen baby! Coming your way! Don't feed

108 It has been often said that the Military is the ONLY WAY! I don't

111 Missouri's governor is STANDING UP against Biden's VAX
112 Census—Governor Mike Parson is not laughing at Biden's knock,

115 government employees or agents door-to-door to compel

130 Arizona—Mark Brnovich, Attorney General of Arizona, said, "Our
131 office sent a letter to President Biden yesterday regarding
132 indications that the feds have medical records revealing contact
133 information for unvaccinated Americans. If true, this is a severe
134 breach of privacy and I won't tolerate such intrusions in AZ."

170 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
171 at the Lighthouse, your brain masseur, and Paul Revere's lantern
172 lighter, lighting the lamps in the church belfry arch, signaling the
173 enemy is on the march, an enemy that would steal from us our
174 liberty.

175 So, Biden has initiated the knock, knock, get your vaccine policy.
176 The latest effort to PRESSURE the AMERICAN PEOPLE to take
177 the shot will be federal representatives coming to your door and,
178 clip board in hand, asking you — "So, ave you taken ze vaccine?" I
179 talked about this in the last segment—got carried away! Never
180 happens! But, the fact is the vaccines have not been FDA approved,
181 they have been given EMERGENCY USE AUTHORIZATION
182 only. Many reputable doctors are warning us about this
183 experimental mRNA vaccine, even the guy who invented the
184 mRNA approach is expressing misgivings about this, and add to
185 this all the double talk enshrouding the whole PANDEMIC
186 narrative—using a PCR test manipulated to generate a huge
187 percentage of FALSE POSITIVES — by the way, that's not a
188 conspiracy theory, we know that's what they did. Changing the
189 criteria for counting pandemic deaths to include anyone dying
190 with COVID — and that in an environment where the integrity of
191 tests is compromised. Hey! The inventor of the PCR system said
192 it's NOT A PROPER TOOL FOR DIAGNOSIS. Okay! Hey, the guy
193 who invented the PCR test, a German Dr. named Drusden, is being
194 sued right now for quackery — haha. No, really? Search: Reiner
195 Fuellmich and hang on to your Huff Post T-shirt and keep a New
196 York Times hanky handy. At the end of the day, it's about, who do
197 you trust.

198 So, who do you trust? That's really the question. Do you trust the
199 Fauci medical establishment? Or the hundreds, literally, hundreds
200 of independent medical professionals who have misgivings about
201 this whole mess ranging from having serious questions that need

202 answering before we can trust this vaccine, to no way does anyone
203 with sense who is honestly informed take this shot.

204 So, the MEDICAL ESTABLISHMENT is represented by the guy
205 who is up to his neck in incriminating evidence against him
206 suggesting he has a diabolical hand in the creation of the disease
207 and a sticky-greedy palm out collecting big money for the sale of
208 the vaccines he is a party to.

209 New emails have surfaced that prove Fauci's NIAID was funding
210 gain of function research in the Wuhan lab through grants to
211 EcoHealth Alliance.⁵ Oh, and it's important to note, this funding
212 continued AFTER THE 2014 CONGRESSIONAL
213 MORATORIUM AGAINST USING TAXPAYER MONEY TO
214 FUND THIS RESEARCH. Fauci is a FRAUD — all masks don't
215 work (cause he was afraid you'd make a run on N-95s), then all
216 masks work — (even though IN AN EMAIL HE EXPRESSED
217 WHAT EVERY BODY IN WESTERN MEDICINE KNOWS TO
218 BE TRUE AND THAT IS THE ONLY MASK THAT CAN HELP
219 IS THE N-95, PROPERLY WORN, FOR NO LONGER THAN
220 ABOUT 2 HOURS MAX, AND THEN GET A NEW MASK—SO,
221 Fauci is a phony. So the whole wear a mask and get your shot, and
222 wear the mask even after you get your shot, and wear your mask
223 after you get your second shot — it all centers on the authority and
224 expertise of PHONY FAUCI. You trust him if you want to. I don't.

225 But, many you do trust CNBC, right? Owned by NBC. Well, some
226 of you in my audience do. Of course, NBC got caught deceptively
227 editing video,⁶ lying about Trump, well, almost every day—Russia
228 Collusion, flat out lied about Trump supposedly wanting to
229 increase USA nuclear arsenal tenfold,⁷ NBC reporter lying about

230 sickness,⁸ blowing up a truck with a fake explosion to embellish a
231 story,⁹ and lying about the GEORGE Zimmerman tape — again,
232 editing the evidence.¹⁰ So, take it for what it is worth—but from
233 CNBC (which is NBC's financial news basic cable channel)¹¹ — we
234 find this story headline, "CDC says more than 4,100 people have
235 been hospitalized or died with Covid breakthrough infections after
236 vaccination."¹² 750 of these died. 2,907 have been hospitalized with
237 COVID after they were fully vaccinated. But you know NBC has
238 gotten a bloody nose, two black eyes, and is not slack jaw from the
239 pummeling it has taken over fake news revelations—they must be
240 careful. Here is the caveat — "The CDC doesn't count every
241 breakthrough case. It stopped counting all breakthrough cases May
242 1, and now only counts those that lead to hospitalization or death.
243 A move the agency was criticized for by health experts."¹³

244 So, here is the comforting statistic: you are just as likely to be killed
245 by a meteorite as die from Covid after a vaccine." [IBID.] Really?
246 That's 1 in 700,000.¹⁴ Well, that would be 473 people!¹⁵ But,
247 according to the CDC says there have been 750 who have died
248 already after they received the vaccine. So much for getting our
249 information from Dr. Peter Chin-Hong, infectious disease expert
250 at University of California San Francisco.

251 CDC current recommendations: Schools open fully immediately;
252 vaccinated teachers and students do not need to wear masks. See
253 how nice they will be to you if ONLY YOU WILL SUBMIT TO
254 THE JAB?

255 And notice how hard they are pushing the blacks to get jabbed:
256 Black only dating app pushing hard for blacks to VAX. Why would
257 anyone want to take this shot? Isn't it at least interesting to you that
258 the left PUSH THE SLAVE NARRATIVE OF BLACKS INTO ALL
259 OUR FACES, BLACKS AND WHITES AND BROWNS, AND,
260 ALL OUR FACES, CONSTANTLY. WE HAD a national civil war
261 to address that issue, and years of progress FIGHTING THE
262 OPPOSITION OF DEMOCRATS every step of the way — and
263 today, racism is virtually dead in this country — except, in the
264 mind of RACIST DEMOCRATS who not only OPPOSED EVERY
265 STEP OF PROGRESS TOWARD REALIZING THE DREAM OF
266 MARTIN LUTHER KING, AND THE PROMISE OF OUR CHIEF
267 FOUNDING PRINCIPLE — ALL MEN ARE CREATED EQUAL
268 — but now that we have made such great progress, they
269 CONSTANTLY DENY IT HAPPEN, THEY CONSTANTLY
270 WANT TO THROW US BACK INTO THE TIME WHEN THEY
271 OPPRESSED BLACKS FOR THEIR OWN USES—and they are
272 still doing it, now by DENYING THE PROGRESS we have fought
273 them so hard to achieve in this country.

274 So, if slavery is a history we cannot live down, how is it that the
275 same people, the DEMONCRATS, are the ones ignoring the
276 history of black being used by the government for medical
277 experimentation — remember the Tuskegee Syphilis Experiment?¹⁶

278 Let's bring that up, about now, what do you say, and let's remind
279 the lily white Democrats coming at our people with a needle—how
280 about that black rap group that sang "VAX THAT" — do one that
281 says, REMEMBER TUSKEGEE—a syphilate that! Remember,
282 everybody, of every color — "In the midst of the Great Depression
283 in 1932, the US government appeared to be giving away FREE
284 HEALTHCARE ..." as part of an EXPERIMENT in which the
285 GOVERNMENT DOCTORS — the Fauci Establishment types —

286 made 622 black men believe they were treated for syphilis when in
287 fact they were not, and this was so that these DOCTORS FAUCI-
288 Steins — okay, that might be over the top! But, I mean the guy is
289 implicated in messing with lab creations that KILL human
290 beings—so, maybe that statement is not so far off the mark after all.

291 They wanted to watch what syphilis does to the human body and
292 used 622 black men for their experiment. An experiment run by
293 the US Public Health Service, and that experiment ran from 1932-
294 1972. Several high-ranking members of the Public Health Service
295 were involved—you know, all the best and brightest stars of
296 American medicine. And this experiment was regularly given a
297 pass by the political leaders of the day — the Johnson Admin
298 (Dem), the Nixon administration (Rep).

299 So, it's about who you trust. The weirdest thing to me is the same
300 people who were protesting the government in the 60s and partly
301 over issues like this Tuskegee abomination are now the
302 perpetrators and the supporters of a GOVERNMENT MEDICAL
303 EXPERIMENT PROGRAM being pushed on the people.

304 I'll tell you why they have not already decreed a vaccine mandate.
305 They tried to soften us up with the mask mandates; that was the
306 test to see if the American people would comply, and support
307 infringement upon those who would not. But when they tried to
308 bridge to compulsory vaccines, too many balked, too many
309 bristled! And now they are being beat back on the mask mandates
310 too.

311 So, finally — DR. Hong says you are more likely to get hit with a
312 meteor than you are to die from COVID after your shots. So,
313 percentages of risk is clearly a viable measurement to take in your
314 decision.

315 Okay, how about this. According to the CDC—again, a totally
316 disreputable source—what these people have done to medicine and

317 our respect and even reverence for medical doctors in
318 unconscionable—but, back to the point—according to the CDC
319 the survival rate from COVID, without doing ANYTHING AT
320 ALL — is 99.989% for persons between 18-60. For persons over 60
321 it increases and tops out to 95.78%. Under 18 is so near 100% most
322 people just say death by COVID for children is statistically 0.

323 This is not a stat premised on population—it's a stat premised on
324 the number of cases per number of deaths.

325 Add to this the FACT that we NOW KNOW we have effective
326 therapeutics to treat this disease—treatments that are proved to
327 reduce the number of hospitalizations by something like 85% and
328 deaths by almost 100%. Did you know that you can't even get an
329 emergency authorization for use of an experimental vaccine if
330 there are known remedies for the disease? THIS WHOLE THING
331 IS FAKE.

332 And the reason this is concerning is that we have had some
333 experience with government coming along conducting an
334 EXPERIEMENT with the offer of a FREE HEALTH CARE
335 TREATMENT.

336 I gotta close. But before I do, here is some really good news.

337 Trump is opening a class action suit against Twitter, FB, and
338 YouTube. He is using the tobacco lawyers to handle the case—class
339 action experts. John Coale is the lead atty on the lawsuit.

340 Coale just strongly, and purposely implied, that EVERYONE
341 COULD POTENTIALLY GET THEIR SUSPENDED TWITTER
342 ACCOUNTS BACK: “We will also be filing, in a day or two, a
343 motion for the preliminary injunction—which means we will
344 hopefully get the court to order the platforms to put back, not only
345 Donald Trump, but the people they've taken down ...”

346 Here is an example of why it's worth reading/listening beyond the
347 headline. Bannon asked: What are the logistics? (Specifically, why

348 file in FL?) Coale replied: First, because Trump lives in FL. The
349 circuit court there is “fairly conservative.” And finally, Thomas is
350 the SCOTUS justice that oversees the court in FL — I think it’s the
351 11th circuit. He is favorable toward hearing this case, and if he
352 grants the motion (see above), they are all on notice that their gig is
353 up. It will mean Trump will be Tweeting again, and those
354 deplatformed will be replatformed — it means Trump will have
355 general access to the American people and not marginalized from a
356 significant segment of the Biden demographic — it means Trump
357 can get on the stage with CNN, MSNBC, CBS, ABC, NPR, and the
358 rest and talk directly to the people who really need most to hear
359 what he has to say.

360 You see, Trump could start his own platform, and that would be
361 great for us, but it would also provide a place for the rest of the
362 country to *hide from his message*. In other words, it would provide
363 a place for us to talk to each other; but what we need right now is
364 access to the entire nation. The left is trying to Balkanize America,
365 create separate smaller groups that are shielded from one another
366 so they can better control narrative and information flow.

367 This is huge, so PRAY, PRAY, PRAY!

368 **Hey folks! It's WE THE PEOPLE TIME~!**

369 You've heard about parents rising up against CRT, against Privilege
370 Walks, and the Sex-Ed teacher who taught first graders about
371 masturbation and Jr. high and high school kids being indoctrinated
372 in pornography — Parents are saying, enough! They are saying,
373 "I'm done!" Now San Francisco Gay Men's Chorus takes down
374 'WE'LL CONVERT YOUR CHILDREN' music video claiming they
375 received threats of harm from outraged parents. A GAY MEN'S
376 CHORUS singing, "We'll convert your children."

377 And here is a Christian teacher who spoke out against transgender-
378 affirming policies and was suspended. He said, ENOUGH! Took

379 the wicked, perverted School board and officers of the school to
380 court. The Judge reinstated him pending case review. — The
381 Loudoun County, VA teacher, Tanner Cross is ready to go to the
382 SCOTUS on this one. It's WE THE PEOPLE time Peeps.

383 It's WE THE PEOPLE time — Sheriffs in LA and in Chicago are
384 sending out the message to citizens, be prepared to DEFEND
385 YOURSELF — our response times have dropped to critical lows.
386 Defunding police has that effect, you know! Chicago police praise
387 the intervention of a concealed carry Chicago citizen who stopped
388 a killing spree when he drew his gun and shot the assailant. The
389 Chicago police praised his actions and said, "He saved lives!" How
390 about that! A citizen gun SAVED LIVES and a Chicago police
391 representative gets it!

392 It's WE THE PEOPLE TIME, folks. A couple, in their sixties,
393 enjoying breakfast in their home. An intruder breaks in, attacks the
394 couple. The sixty year old said, IT'S ENOUGH! He said, "I've had
395 enough of what ain't right." — he pulled his own gun, yeah, he had
396 one, and shot the intruder DEAD.

397 It's getting to the place where elderly couples need to eat their
398 breakfast with a pistol nearby! It's WE THE PEOPLE time—

399 I have lit the lamps in the Church belfry arch and now you let me
400 know if you see them. It's LIGHTS ON if you see the LIGHTS ARE
401 ON and you will ride like Revere and spread the warning,
402 (essentially, it means you agree with what I'm saying) or you say
403 LIGHTS OFF -- which means you reject what I'm saying and
404 disagree strongly with me. So, what will it be today, lights on, or
405 lights off?
