- 1 Segment.01 Hello. I'm Dr. Jerry Scheidbach, pastor of the
- 2 Lighthouse Baptist Church in Santa Maria, CA—and your brain
- 3 masseur—get ready for your brain massage.
- 4 Another one bites the dust! About three months BEFORE the
- 5 vaccines were rolled out to the public, the FDA anticipated 22
- 6 "possible adverse event outcomes." What?
- 7 Hey, I can see that this will take up virtually all my time today. Let's

- 27 As "prince of this world" Satan was given all the kingdoms of the
- 28 world and the glory of them. He boasted of this to Jesus in the
- desert temptation. (Notice Jesus did not correct him on that point,
- 30 even though on each of the other points Satan made, Jesus did
- 31 correct him. Besides, why would Jesus, Who CREATED ALL
- 32 principalities and powers, be required to come to earth to SPOIL
- 33 principalities and powers that He created in the first place, unless a
- 34 usurper had taken them out from under CHRIST'S POWER?
- 35 And, also, why would Jesus, after His resurrection, declare, "All
- 36 power is given unto Me in Heaven AND IN EARTH" if He had
- 37 already had that power before He defeated Satan and arose from

- 65 it is not IN THIS WORLD and PRESENT by the SPIRIT OF
- 66 CHRIST. WE as believers are not OF THIS WORLD. But we sure
- are IN IT, brother. And being as we are IN THE KINGDOM and
- 68 IN THE WORLD the KINGDOM is IN THE WORLD and the
- 69 SPIRIT of CHRIST is present to resist and OVERCOME the spirit
- 70 of antichrist and they can't win!
- 71 We must rise up in the authority that is ours and RESIST the
- 72 DEVIL.
- 73 But before we can effectively RESIST the DEVIL and make him
- 74 flee, we must SUBMIT OURSELVES TO GOD.
- 75 So, since JESUS is PRESENT in this world by His SPIRIT in US,
- and since He is the RULER over all mankind, and SOVEREIGN
- 77 LORD OVER ALL HEAVEN and EARTH I stand by Him, and
- 78 by HIM I STAND against the devil, and against his present effort
- 79 to destroy us and take our liberties by any DISEASE. More on this
- 80 at the conclusion—but by FAITH we OVERCOME, and only by
- 81 FEAR can we be overcome. So FEAR NOT! Now!
- 82 Another one bites the dust! one trusted American institution
- 83 after another has fallen into the power of the enemy of our
- 84 liberties. And now we learn the FDA cannot be trusted.
- 85 About three months BEFORE the vaccines were rolled out to the
- public, the FDA anticipated 22 "possible adverse event outcomes."
- 87 What?

- 88 October 22, 2020, at the Vaccines and Related Biological Products
- 89 Advisory Committee meeting, Steve Anderson, PhD, MPP,
- 90 Director of the Office of Biostatistics & Epidemiology (OBD), of a
- 91 department within the FDA called CBER, which is the Center for
- 92 Biologics Experiments and Research) delivered a presentation to
- 93 the Advisory Committee titled "CBER Plans for Monitoring
- 94 COVID-19 Vaccine Safety and Effectiveness." In this presentation,
- 95 Steve Anderson, PhD, MPP, Director of OBE, brought to their
- 96 attention 22 POSSIBLE ADVERSE EVENT OUTCOMES. We will
- 97 take a look at that list today.
- 98 FDA Safety Surveillance of COVID-19 Vaccines lists 22 "possible
- 99 adverse event outcomes." Here are a couple of things you should
- 100 know about this list.
- 101 First, it is a list of "possible" adverse outcomes. What does that
- 102 mean?
- 103 The list was created by CBER in coordination with the CDC after
- they examined the vaccines and the documentation provided to
- 105 them by vaccine producers. Applying their own scientific
- 106 knowledge these medical experts anticipated these adverse events
- were "possible" outcomes from the vaccines that the FDA approved
- 108 for "emergency use authorization."
- 109 Second, the idea of this report was to prepare the FDA to watch for
- 110 these things in reports coming back to the govt. after the vaccines
- 111 were released. (It is NOT the case that they KNEW for a FACT
- these things would occur, but that they had a very good scientific
- 113 based reason to expect the COULD OCCUR and so they were
- 114 prepping to WATCH for these things to appear in the Vaccine
- 115 Adverse Events Reporting System, and other sources that are
- 116 named in this presentation.
- 117 Dr. Ardis uses VAERS for the information he gives, partly because
- it is the most accessible, and immediate gauge of what's happening.

- 119 But there are some things you should know about VAERS.
- 120 (VAERS.hhs.gov is the source. Updated every Friday. However,
- as of July 4, CDC reported they are 2 to 3 months behind!!)
- 122 First, it is a voluntary reporting system available to doctors, and
- 123 patients. The form is accessible online, and anyone can make a
- 124 report. This is important because it means the VAERS data is not
- filtered by doctors, or other medial health officials. At least, it's not
- 126 SUPPOSED TO BE. A whistle blower has come forward alleging
- 127 she has first hand knowledge that the VAERS has been
- compromised by the CDC. So, we will keep our eyes on that. But
- 129 VAERS is a great source for immediate, up to date data on what is
- 130 going on with the vaccine.
- 131 Second, however, an adverse event reported in VAERS is not, by
- 132 itself, PROOF that the VACCINE caused the event reported. The
- medical establishment watches the VAERS for any indications that
- 134 a certain adverse reaction should be looked at more closely. If they
- see a concentration of reports around a particular disease, or any
- 136 reports that demonstrate cases of this or that disease are breaking
- out of the normal range of cases—they know where to zero in.
- But, THIRD, Harvard, a while back, did a study on VAERS in 2010
- and determined that they only receive less than 1% of all actual
- 140 occurrences of adverse events to a vaccine. And, perhaps more
- 141 disturbing, the Harvard study concluded revealing that CDC was
- 142 UNWILLING TO ASSIST IN UPDATING THE REPORTING
- 143 SYSTEM to obtain MORE COMPREHENSIVE data.
- 144 At the top of the list is Guillain-Barre (Gee-YAH-buh-RAY)
- syndrome. It's a rare but serious disorder in which your immune
- 146 system attacks your nerves. It progresses from tingling and
- 147 weakness in extremities to paralysis of the entire body. It is similar
- 148 to Polio in that it attacks the nerves and causes paralysis. But it is

- 149 not polio. There are several points of difference that make a
- 150 difference, see here.¹
- 151 As for the claim that GBS is linked to flu vaccines, go here.² In
- 152 1976, there was a "small increased risk of GBS after swine flu
- 153 vaccination." As I mentioned, according to the CDC, the risk of
- 154 GBS from vaccinations is 1 or 2 cases per one million vaccinations,
- but in 1976 this risk was increased to 1 in 100k vaccinations. That's
- a remarkable increase in risk, from 1 or 2 in a million to 1 in 100k.
- 157 CDC now monitors for GBS during each flu season. Typically the
- 158 risk levels vary from one flu season to the next. Generally, the
- increased risk amounts to double the norm, that is, from 1-2 cases
- per million to 2-4 cases per million.
- 161 So how many GBS cases have been reported to the govt. in the first
- 162 five months after the release of the COVID-19 vaccines? 280, to be
- 163 exact.³ That number is as of May 28, 2021. At that time, 46% were
- attributed to the Pfizer shot, 40% to the Moderna shot, and 20% to
- 165 the J&J jab. (It should be noted that Pfizer and Moderna make up
- almost 80% of all vaccines administered.)
- 167 So, how about the rest of the anticipated "possible" side effects from
- 168 the COVID-19 vaccines?
- 169 Then we have the blood clot related disorders. How many blood
- 170 clots related issues have been reported? This is interesting, because
- 171 after only 6 were reported in media they put a pause on J&J but
- in VAERS there were 156 reports on J&J and over 400 reported for
- 173 Pfizer, and over 300 for Moderna. (Why was only J&J selected for
- media attention, and CDC action? Let's see. J&J 156 reports of
- 175 blood clots, 300+ for Moderna, 400+ for Pfizer but let's PAUSE
- 176 J&J? WHY? So, let's pause this and look more closely right here.)

- 177 ASIDE: Why would the media report only 6 blood-clotting issues
- 178 when VAERS reported 156? Perhaps it's because these six were
- 179 confirmed related to the J&J vaccine. Right? But it seems more
- 180 likely to be because these six families WENT TO MEDIA with their
- 181 concern. Now, why pick on J&J only? Maybe because it just so
- happened that these six were all from the J&J jab. We already know
- 183 they are ignoring VAERS reporting, but it should have gotten
- 184 someone's notice that Moderna and Pfizer each had over 3 times
- the number of blood-clotting adverse reports than J&J. So why did
- 186 they PAUSE J&J and NOT MODERNA and PFIZER. It seems to
- 187 me more likely that it is because ANTHONY FAUCI and NIAID
- has patent rights, they get MONEY in the form of royalties from
- 189 the sale of this vaccine. Pfizer is the EXACT SAME
- 190 TECHNOLOGY as the MODERNA.)
- 191 At present, there are 5159 reports of blood clotting disorders
- related to taking the vaccines. That's less that 1% reporting. ADD
- 193 TWO ZEROS could be 515,900 cases. Over twenty in the week
- 194 of this report, and 40 accounts of heart inflammation in young
- 195 people 12-17. Now, ADD the two zeroes. 2000, and 4000.
- 196 THEN we have Multisystem inflammatory Syndrome in children
- 197 on the FDA list of "possible adverse event outcomes." Surprise:
- 198 THIS CONDITION NEVER EVEN EXISTED AS A DIAGNOSIS
- 199 BEFORE COVID-19.
- 200 The Mayo-Clinic put together a description of what Multisystem
- 201 Inflammatory Syndrome in Children looks like. Some organs and
- 202 tissues such as the HEART, LUNGS, BLOOD VESSELS,
- 203 KIDNEYS, DIGESTIVE SYSTEM, BRAIN, SKIN or EYES become
- 204 severely inflamed. We know these traumas can come from
- 205 exposure to the spike proteins in the virus and also by the spike
- 206 proteins that are being created by the vaccines. We are hearing
- 207 about young people dying from inflamed hearts—What they
- 208 projected IS HAPENNING. Why aren't they stopping this?

- 209 Brain inflammation causes neurological disorders. We are hearing
- 210 reports of people suffering neurological disorders. Why would they
- 211 "pause" J&J for six reports of blood clotting fail to mention that
- 212 156 of these cases were reported on VAERS, and refuse to pause
- 213 Moderna and Pfizer which had three times more reports of blood-
- 214 clotting on VAERS and refuse to "pause" this experiment on the
- 215 human population in view of all this?
- 216 The disparity between VAERS and what the Pharmaceutical
- 217 companies are putting out regarding anticipated possible negative
- 218 outcomes is stunning.
- 219 The list of possible adverse reactions range from dizziness, to some
- 220 pain from the shot, to headache and so on! There is NO
- 221 MENTION of the serious concerns that are being reported on
- 222 VAERS.
- You are being lied to, and information is being withheld from you
- about these vaccines. The American people are NOT being given
- the opportunity to make an HONEST assessment of risk. THIS IS
- 226 NOT INFORMED CONSENT.
- 227 In other words, even those who are consenting to the vaccines have
- 228 not actually given INFORMED CONSENT.
- 229 In other words, for one simple example, the FDA anticipated
- 230 blood-clotting related diseases as a possible adverse outcome of the
- 231 vaccines. Blood-clotting diseases have been reported in VAERS —
- 232 over 300 connected to Pfizer and over 400 connected with
- 233 Moderna. But Pfizer and Moderna do not include blood-clotting
- issues on their Feb. 16, 2021 fact sheets of possible side effects from
- use of their vaccine.
- 236 This is odd, don't you think? Have you heard the medicine
- commercials where at the end they start naming all the horrible
- 238 things that could happen? All of these concerns are very rare. But
- 239 still, almost every time I hear one of these I laugh in amazement —

- 240 but now, here we have an experimental vaccine, that when the
- scientists looked at it said here are 22 categories of diseases, a total
- of over 100 diseases, that MIGHT be caused by these vaccines—
- 243 and rather than give the people one of those FULL DISCLOSURE
- 244 statements we have heard repeatedly on TV commercials for
- 245 medications, they LIE to you and do not tell you about any of the
- really SERIOUS possible side effects of the vaccines. WHY? They
- 247 excluded all the serious concerns.
- 248 I guess at the end of the day it's follow-the-money. But is it that
- 249 simple?
- 250 5165 DEATHS reported through VAERS after the first five months
- 251 of the release of these vaccines under an emergency use
- 252 authorization.
- 253 Remember, Harvard studied VAERS and said it reflects less than
- 254 1% of all events. If you add the two zeroes you get 516,500 deaths
- 255 from this. Now, that's a whole lot more than the 45k revealed to us
- by the whistleblower. So, is the whistleblower actually providing
- 257 COVER for the devastating revelation that the COVID-19 vaccines
- 258 have killed almost as many are reported COVID deaths—and if
- 259 you adjust the reported COVID deaths by the fact they reported
- anyone who died WITH COVID as a COVID death even when
- 261 they manifestly did not die of COVID you have a scenario
- 262 where more people are being killed by the vaccine than were killed
- by the disease it is intended to protect you from.
- 264 Keep in mind that the Harvard study is a scientifically based
- 265 educated estimate—and consider that CDC admits they are way
- 266 behind in updating the VAERS so taken together, let's rough it
- out to 50k people have died from the vaccine—SO FAR! We've
- only been at this for about five months; COVID has had 18 months
- 269 head start. Now, think about this. In 18 months COVID killed
- 270 600k (not adjusted for those who only died WITH it and not
- 271 FROM IT) we've only had five months with these vaccines.

- 272 Do a little math. If they STOPPED the swine flu vaccines because
- 273 of 59 deaths WHAT IS GOING ON RIGHT NOW? Even their
- own reporting shows over 5k deaths occurring within the first 48
- 275 hours of receiving the vaccine. (Like a nurse I learned about today
- 276 from one of our members. This nurse took the jab, afterwards
- 277 came down with the COVID and DIED!
- Look, we know that at least 90% of all 612k people who died WITH
- 279 COVID died with COMORBIDITIES. This is taken from CDC
- data. And it's almost certain that one of the popular treatments
- used by the medical establishment, Remdesivir, contributed to the
- deaths of many, many thousands of those in the COVID death
- count. Dr. Ardis said 22% of those given this drug were proven to
- 284 develop kidney failure, multiple organ failures, septic shock and
- 285 hypotension all of these are FATAL conditions.⁴ These are
- 286 things that were KNOWN problems with remdesivir BEFORE they
- 287 approved it for use to treat COVID. They totally SHUT DOWN
- 288 Hydroxychloroquine, and Ivermectin—PROVEN therapeutics. But
- 289 gave emergency authorization to Remdesivir a drug known to
- be problematic. WHAT IS GOING ON???
- 291 Fauci declared the 2016 Ebola study proved the efficacy of
- 292 Remdesivir but if you actually read that study, it DID NOT
- 293 PROVE THE EFFICACY OF REMDESIVIR. In that study you find
- 294 that Remdesivir was pulled from the study about six month in
- 295 because it had the HIGHESTS MORTALITY RATE than the other
- 296 three experimental drugs being evaluated. FAUCI was engaged
- 297 then in a huge COVERUP —

- 298 Pfizer and Moderna do not allow pregnant women in their trials,
- and they don't allow persons with MS in their trials BUT NOW
- 300 ESTABLISHMENT MEDICINE IS PUSHING THESE VACCINES
- 301 FOR PREGNANT WOMEN AND OTHERS WITH SERIOUS
- 302 IMUNODEFICIENCIES.
- 303 This goes beyond money! Mammon is one of the chief gods in
- 304 service to Satan but there are actually even darker gods that are
- worshipped in the darkness. We've been watching cult like activity
- on the left Steve Hasset is the "cult" expert in the USA today —
- 307 In 2013 he wrote a book titled FREEDOM OF MIND. He
- 308 identified four types of cult: Religious, Political, Commercial and
- 309 Therapeutic. For a political cult to be successful they must control
