- 60 in this country and all that is needed is for the soft breath of
- 61 TRUTH to blow over them and nurture them back into a full and
- 62 roaring flame of JUDGMENT and EQUITY.
- Whatever use the Devil attempts to make of this young man's
- 64 confusion, and desperate efforts to find his way forward through a
- 65 trial that would have brought down many twice his age—this trial
- 66 provided witness to this justice has not entirely abandoned us,
- 67 judgment, though weak, is not entirely inaccessible, and all of this
- 68 mean TRUTH continues to breath in America, even if weakly.
- 69 Take hope in this, that it only takes a spark, and a spark takes only
- one glowing ember and that ember requires only a puff of TRUTH
- 71 to send it off—many sparks were sent out in search of kindling the
- day Rittenhouse was acquitted. Of course, Satan's "firefighters" are
- busy chasing each one, but we must keep blowing the good wind of
- 74 TRUTH upon the embers—keep speaking, telegramming,
- 75 Rumbling, and perhaps we can send some Tweets over Dorsey's
- 76 new revelations right— and remorse over his part in getting
- 77 Biden elected. (A WORD please—the Soros/DS/Globalists
- 78 Dominion machine STOLE the election—all Dorsey and
- 79 Zuckerbucks did is aid and abet the theft!)
- 80 But his handlers are blamed for much of his wobbling . By
- 81 wobbling, I mean his statements to the effect that he agrees with
- 82 BLM, that he sympathizes with their "cause," and supports it. That
- 83 he is a Democrat, and, Rodney King like, he thinks to call all of us
- 84 to be one his soul seems to be crying, in effect, "Why can't we all
- 85 just get long?"

- 86 Anyone thinking to lob on to this young man's current notoriety
- 87 and use it to advance their personal political agendas as child
- 88 abusers.
- 89 But he has turned 18, and has responsibility now for the opinions
- 90 he forms and how he expresses them. He is free! He has the second
- 91 amendment, and he also has the first, and the third and he has
- 92 freedom. Let's pray his mother's shack-up, his affection for his
- 93 mother and sympathy for her feelings, his desire not to disturb her
- 94 happiness, oh, and all the Dolores floating all around them right
- 95 now do not work that well known corruption upon his heart and
- 96 bury his own honest reflections beneath the interests of the bullies
- 97 that surround him at present.
- 98 He is a kid! If he says, *I agree with the BLM cause*, it is not because
- 99 he agrees with it's Marxist origins or objectives—let's hope!—at
- least if that were the case, it seems he would have been there for
- 101 very different reasons than evidence shows—it would be, in my
- opinion, because he believes in the right of people to protest —
- 103 albeit not destroy the property of others in doing so it would be
- because he supports the right to protest, and has sympathy with
- some of their concerns about police brutality. He wants to temper
- the passions, he wants to tamp down the rhetoric, he thinks he will
- 107 be a healer.
- 108 Of course, others around him are clever snakes slithering their
- 109 forked tongues into you young ears carefully working to separate
- 110 him from Christian influences or from clarifying truths —
- shielding him from the truth about BLM founding, fomenting yet
- more division and confusion through his naive efforts to placate
- 113 and unite. There is the word *unite!*
- But Rittenhouse did unite us! We conservatives are strong enough
- in our convictions and wise enough in our understanding to know
- when a young man is confused, and being abused by "handlers."
- But the fact is something the left has been deeply scarred by his

- acquittal and they cannot cover that up. Our RIGHT to DEFEND
- our selves was assaulted in this case, and the assault failed. The
- 120 TRUTH stood firm, and the LIE crashed against it and fell into the
- 121 street. This is good news, my friends; rejoice! And BLOW THE
- 122 WIND OF TRUTH all over this scatter the sparks of truth all
- over the land let the PURGING FLAME IGNITE!
- 124 I need to rest a moment! I'll be right back!
- 125 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
- 126 at the Lighthouse, your brain masseur, and Paul Revere's lantern
- lighter, lighting the lamps in the church belfry arch, signaling the
- 128 enemy is on the march, an enemy that would steal from us our
- 129 liberty.
- 130 What think you? Will the court rule according to LAW or will it
- 131 rule according to LEGALITY? One day, the questions from the
- 132 conservative side of the court tend toward LAW—and then next,
- 133 the questions rising from the liberal side of the court argue
- legalities. Let me explain the difference.
- 135 LAW asks the fundamental questions relevant to the case. What
- does the LAW actually say? And, how does what the LAW actually
- says apply to the question before us? In this case, the LAW itself is
- 138 the basis, the ground upon which rulings are set. Legalities present
- an entirely different basis for law. Legalities actually serve to create
- a basis for a ruling that is outside of what the LAW actually says. It
- is a sort of "spinning" of the LAW into support for statements that
- 142 when viewed in the light of the LAW are manifestly false. But in
- 143 the confusion, the virtual labyrinth of convoluted "reasoned"
- arguments, one small step after another is created to lead the mind
- away from the simple foundation of LAW and shift the premise for
- their conclusion to a basis for support that is manufactured out of
- 147 bits and pieces of actual LAW twisted and distorted to frame
- support for an agenda—for something the LAW does NOT SAY,

- 149 and for something the LAW, in and of itself, DOES NOT
- 150 SUPPORT.
- Heretics do this sort of thing with Scripture. Paul warned about
- 152 those who use the Scriptures "deceitfully" and warned against
- those who use artifice and fraud, and who dull the senses of those
- 154 they deceive by their sophistry, their pretention to "higher
- learning" and their use of crafty mind-controlling-psychobabble to
- 156 mesmerize their hearers and bring their thoughts into subjection to
- 157 their lies.
- But every time, the answer is simple! Shake off the nonsense and
- 159 simply see what is plainly set before you first, in the plain
- 160 reading of the LAW itself, and then, in the clear thinking of
- someone who insists on seeing what is before them, and applying
- 162 the LAW as it is written to the question before them. This cuts
- 163 through all the nonsense and goes directly to the heart of the
- 164 matter.
- 165 My assessment is not yet complete because their deliberation are
- not, so far as I know, complete. I don't implicitly trust any man and
- 167 I have no confidence in any of our institutions—they are all
- 168 corrupt, and corruptible. But the Rittenhouse acquittal does give
- me some hope that TRUTH can blow across these deliberations—
- 170 Thomas, most especially, and Kavanagh, from what I've seen thus
- 171 far, have spoken wisely, and have posited their questions from
- 172 within the context of TRUTH, and of LAW.
- 173 So, in conclusion on this point, for now, understand what the court
- 174 is deciding. It will decide whether a State has the power to regulate
- abortion as it finds fitting, or does Roe-v-Wade preempt the State's
- 176 prerogative and require ongoing support for the murder of the
- 177 unborn.
- 178 At question is, then, first, is there actually any "right to abortion" in
- the Constitution, or even envisioned in the Roe ruling? The honest

- answer is no! There is no such law as mandates abortion be legal —
- it was a ruling on another matter, that of privacy between a doctor
- and his patient.
- 183 In the original decision, the matter of whether abortion is an act of
- 184 the murder of an unborn baby or something else was left
- unaddressed with the court throwing that question into the hands
- of the legislature.
- 187 Surprise there has NEVER BEEN A RIGHT TO ABORTION
- 188 recognized in our laws.
- 189 In the final analysis if the child in the womb is a human child,
- 190 the question is moot. Science declares the matter concluded—the
- infant in the womb is a human being.
- 192 There is only one course LAW can take and that is to declare
- abortion is an act of murder. However, in our corrupted system, it
- is more likely the matter will be settled upon as follows: 1. there is
- no "right" to abortion in the Constitution; 2. the issue falls outside
- 196 the purview of the courts to decide beyond LAW, and where LAW
- applies, it stand against the practice; 3. therefore, the legislatures of
- each state must answer the question for their respective states.
- 199 That's my call, we shall see where this falls. At the end of the day, I
- 200 expect a ruling favorable to our desire to see the end of this
- 201 scourge, but I do not see its end here. Abolition, absolute
- 202 prohibition against the murder of innocent life is the ONLY
- 203 LAWFUL response to this and nothing short of that is an
- 204 acceptable resolution to America's grotesque shedding of innocent
- 205 blood in service to Moloch that has cast a dark shadow of death
- over our nation, and has brought us near to being dropped as
- refuse by GOD into the maw of HELL.
- 208 The current status of the Pandemic fraud: See how every nation
- 209 fares against this attack on our freedom in every country where the
- 210 people long ago abdicated their right to keep and bear arms.

- 211 Particularly those nations most closely aligned with CCP. Specifically, Australia! Australia who has proudly declared itself 212 213 "out from under GOD," and so they are lashed beneath the scourge of their gods — the RULERS of Australia! See what nations are 214 215 most draconian in their measures to control their citizenry by use of the excuse that they, godlike, will "control" a virus—those 216 nations nearest to the Nazi's in their hearts are the most severe in 217 their measures — example: the Nazi spider crawled into the heart 218 219 of Austrians back in WW2 and nested there. See Austria embarrass 220 itself — again! See the Nazi spider crawling out of it's hidden places 221 and devouring the tender flower liberty!
