- 1 Segment.01 Hello. I'm Dr. Jerry Scheidbach, pastor of the
- 2 Lighthouse Baptist Church in Santa Maria, CA—and your brain
- 3 masseur—get ready for your brain massage.
- 4 THEME: Patriots (God and Country Conservatives) & Traitors
- 5 (God hating, America despising Communists) are at war for the
- 6 soul of America! Some self-styled "patriots" are aiding and abetting
- 7 the traitors.
- 8 Trying to find the bottom of the swamp! We have not sounded the
- 9 depths of it yet. Trump sent the sounder and amazingly we are still
- waiting for the return ping!
- 11 Ted Cruz had something to say commemorating the anniversary of
- 12 J-6 protests "We are approaching a solemn anniversary this
- 13 week. And it is an anniversary of a VIOLENT TERRORIST
- 14 ATTACK on the Capitol." Tucker took him to task. Let's take a
- 15 look at this.
- 16 We suspected the J-6 commission had the dual purpose of
- 17 providing cover for the Pelosi-Schumer conspiracy to facilitate and
- 18 provoke a riot on J-6 that they could use as a pretext to accuse
- 19 Trump supporters of insurrection—all intended to divert attention
- away from the real insurrection that they pulled off on Nov. 3. And
- 21 rumors ran about early on that the Traitors wanted to use the fake
- 22 "insurrection" as a pretext to bar Trump from ever holding office,
- 23 by accusing him of inciting their manufactured "insurrection" and
- 24 using section 3 of the 14th Amendment to disqualify him from
- 25 ever holding office in American government. Well, it has come out
- 26 into the open now! Pelosi et al are declaring their intention to use
- 27 this faked insurrection to bar Trump from running for office in the
- 28 future.

- 29 Trump rightly responded that this is what it was all about from the
- 30 very beginning.
- 31 I'm praying this will turn on them, that they will be exposed for
- 32 what they have done and are doing, and they will be forced to step
- 33 down from their office in SHAME and REPROACH. (Pray with
- 34 me that Pelosi and Schumer, and Schiff, and Swalwell, and Nadler,
- 35 and the others will not be allowed to negotiate a face-saving exit —
- 36 they must depart the Capitol in shame and under reproach for
- 37 their betrayal and their crimes against the American people.)
- 38 Hypocrisy is usually just annoying, and insulting! But the
- 39 hypocrisy of the Demoncrats is actually hurtful. I think it crosses
- 40 over into criminal!
- 41 Joe Oltmann held a roundtable discussion on the 2020 stolen
- 42 election with Dr. Shiva and David Clements I watched it with
- 43 interest, and because I have been following all of this closely, I was
- 44 able to appreciate more fully the significance of what Dr. Shiva
- 45 brought out. I'm going to offer a sort of "book report" on Dr.
- 46 Shiva's testimony during that discussion that you will find VERY
- 47 ENLIGHTENING, and that contributes significantly to my theme
- 48 today why are some "conservatives" undermining the interests
- 49 of the American people and, I think some wittingly, and others
- unwittingly, aiding and abetting the TRAITORS?
- 51 Okay, my friends; it's time for your Brain Massage!
- 52 [TRUTH]
- 53 Ted Cruz throws in with the Pelosi scheme I could not believe
- 54 my ears. Ted Cruz referred to the J-6 protests as a "violent terrorist
- attack on our Capitol." He followed this up with a statement that it
- 56 raises the question whether appropriate measures were taken in
- 57 advance of the protest to protect the Capitol, and insinuated that
- 58 Pelosi, et al, are chargeable for failing to do so nevertheless, for

- 59 Ted Cruz to characterize the J-6 protests as a "violent terrorist
- attack on our Capitol" is deeply disturbing!
- 61 To Tucker's credit, he took Cruz to task for this statement and
- 62 certainly did not hold back: when Cruz admitted his sloppy use of
- 63 language was a mistake, and that his characterization was not
- 64 intended for the entire body of patriots there to protest, but was
- 65 aimed at the few who actually assaulted Capitol police and that
- 66 this is consistent with his representation of any assault on police as
- 67 a terrorist act Tucker retorted in a very straightforward manner
- 68 I don't believe you! You told that lie on purpose. He explained
- 69 to Cruz that he has watched his career with interest for many years
- and there is no way Cruz does not contemplate the weight of his
- 71 words before he banters them about that of all people, Ted Cruz
- 72 is not one who speaks loosely, or cavalierly, that throughout his
- 73 career, Cruz has been one to speak very circumspectly, very
- 74 precisely, and so Tucker was not buying the line that Cruz spoke
- 75 loosely, and chose his words carelessly —
- 76 Ted bristled some, and insisted he did not mean to characterize the
- 77 hundreds of thousands of Patriot Protesters gathered at the Capitol
- 78 as "violent terrorists" so, what does the Brain Masseur make of
- 79 this?
- 80 It's an example of something I've brought to your attention several
- 81 times. Often, "our side" steps into the trap of conceding the MAIN
- 82 POINT of the argument in an attempt to make some other, almost
- 83 minor point, in their debate with the enemy. They UNDERMINE
- 84 their own position by GIVING in to a MAJOR FALSE premise —
- 85 Let me explain!
- 86 I think Cruz wanted to set up a sort of "trap" for the
- 87 Pelosi/Schumer crowd to direct attention to the fact that they did
- 88 not do what was necessary to protect the Capitol from a "violent
- 89 terrorist attack." We all know that Pelosi coordinates with the

90 Capitol police, and we all know they were forewarned trouble 91 could break out at the Capitol, and we all know they were offered 92 deployment of the National Guard by President Trump to provide protection of the Capitol building during the Protest, and we all 93 know they declined the offer, and we all know the communications 94 between the Capitol Police chief and Pelosi and or her office, 95 96 include discussion regarding plans for impending trouble on Jan. 6, 97 and we all know these communications are being hidden from 98 public scrutiny by Pelosi-Schumer, et al, and we all know the 99 comparisons of J-6 to Pearl Harbor, and 9-11 are ludicrous — over 100 2000 died at Pearl, and over 2000 more on 9-11 — while only ONE 101 died Jan. 6, and that was an UNARMED MAGA patriot — and we all know that a fellow named Epps at the protest was agitating 102 Patriots to enter the Capitol building, and we all know that some 103 Patriots in the crowd signaled him out as FBI, FBI — and refused 104 to follow his lead - and we know he was featured on the 105 106 WANTED list until it was discovered that, well, what was 107 discovered that caused his face to be scrubbed from the FBI's WANTED LIST? AND on video Viking head-111 dress and war painted Sullivan boasted — "we did it. We got them 112 113 to come into the Building. Let's burn this place down." - 123 three officers supposedly killed by rioters NONE OF THEM
- 124 DIED AT THE HANDS OF RIOTERS! Cruz does not know all
- 125 this?
- 126 Antifa were swarming all over the Capitol grounds that day pulling
- down barriers, planting MAGA apparel for use as disguises, THIS
- 128 IS CAUGHT ON VIDEO these are things WE KNOW! None of
- this is speculation Cruz does not know these things?
- 130 Identify any single genuine MAGA supporting Patriot that actually
- became violent one guy was provoked to grab an officers body
- shield and tussle with that officer and repented deeply for his error.
- 133 The VIOLENCE was instigated by ANTIFA and FBI plants, also
- caught on video, removing barriers to facilitate Patriots to enter the
- building.
- 136 And on the EAST side, Capitol Police were waving Patriots into the
- building, high fives, selfies clicked encouraged to enter these
- 138 might have been instructed to do this by Pelosi via the Capitol
- 139 police command or they might have been participating in the
- 140 Sullivan scheme to get protesters into the building —
- 141 We had members at the protest who watched the Capitol police
- waving people into the building, but they felt uncomfortable with it
- and did not follow them inside.
- 144 WE KNOW FOR A FACT that the DEMS sat on their hands while
- real terrorism went down during the "summer of love" and that
- 146 the May 2020 terrorists that attacked the White House after
- 147 Trump's inauguration have ALL BEEN RELEASED AND ALL
- 148 CHARGES DROPPED and, well, you see, WE KNOW ALL OF
- 149 THIS. Cruz knows all of this so how is it possible a man of
- 150 intelligence, with much experience in government, and
- 151 knowledgeable of the ways of Washington would make such a
- 152 gross miscalculation, and literally THROW MAGA PATRIOTS

- 153 UNDER THE BUS, as they say, and refer to J-6 in THE VERY
- 154 LANGUAGE the left has been trying to stick to that event from the
- 155 beginning of this fiasco?
- 156 This is what the devils are trying to establish this is the VERY
- 157 POINT, the MAIN POINT, and by the way, the ONLY
- 158 ESSENTIAL POINT the wicked devils on the left are trying to get
- 159 firmly established in the minds of the American people regarding
- 160 J-6 and Cruz, one or our own CHAMPIONS, sits there and
- 161 GIVES IT TO THEM, he hands it to them on the proverbial silver
- platter, HE CONCEDES the ONLY POINT THAT MATTERS, he
- 163 concedes to them their MAJOR PREMISE, he legitimizes their BIG
- LIE about J-6 and calls it a "violent terrorist attack on the Capitol."
- 165 So Tucker does not buy in to his explanation, which I've given
- already, and you probably heard. He tells Ted, to his face, I don't
- believe you; you told that lie on purpose, what I want to know is
- 168 WHY?
- 169 Okay first, this illustrates something I've been watching with
- 170 deep concern: the tendency among some of our own to actually
- give their support to the major premise of our enemy's falsehoods.
- 172 IN this case, and listen, believe me, the left does not care nearly so
- much about Cruz accusing Pelosi of failing to prepare properly for
- 174 the Jan 6 protests as it WELCOMES Ted's concession to the
- 175 MAJOR PREMISE of their lie that the J-6 protests were a
- "violent terrorist attack on the Capitol."
- 177 So why did he do this? Only GOD and Ted know for sure! But
- much experience provides a pretty good basis for diagnostics. So!
- 179 Ted wanted to set up an attack on Pelosi, Schumer, and the rest, for
- 180 failing to properly prepare for the J-6 Protest and the very real
- 181 possibility the advance warnings of potential violence would
- accompany the protests. Now, in that context, you can see how
- 183 denying the MAJOR PREMISE of the left would actually

undermine his argument — because if there was no "violent 184 terrorist attack" the question of Pelosi's failure to prepare for it 185 186 would be virtually meaningless — or moot. So to enhance his 187 accusation against Pelosi for failing to be prepared, he CONCEDES that the event was a violent terrorist attack. - 218 FRAUDULENTLY WITHHOLDING EARLY TREATMENT FOR
- 219 COBVID PATIENTS these are facts! Hey, fake FB fact checkers,
- 220 prove me wrong. And don't just report what some other medical
- 221 quack, some other snake oil salesman, like Fauci and Pfizer and
- 222 their bought and paid for doctors and medical professionals and
- 223 their "statements" the "statements" of scientists is not SCIENCE
- 224 like my teacher insisted in grade school math SHOW YOUR
- 225 WORK! SHOW THE SCIENCE THAT PROVES THESE

- 262 I'm going to have to take a short break and do a condensed
- 263 summation of my comments on the status of our battle for the
- 264 ballot box in America I'll be right back!

- Welcome back! I'm Dr. Jerry Scheidbach, pastor at the Lighthouse,

- Nothing threatens them more than losing control of the BALLOT
- 303 BOX.
- 304 SO HERE WE GO AGAIN. The MAJOR PREMISE of the DS liars
- is 2020 election results must be preserved look forward to
- 306 2022, and 2024. You see WHATEVER YOU DO leave 2020
- alone, and don't FIX the broken election system in America.
- 308 But, back to what Dr. Shiva pointed out.

- 309 You might remember how often I warned don't just sit back and
- 310 trust the AZ audit is going to solve everything they will fight
- back, they are fighting back, they are up to something, you need to
- 312 pray God will expose it, whatever it is.

- 327 Refuses to answer for his odd behavior the audit team had the
- 328 ballot images from the Dominion machines for several weeks if not
- 329 months while Dr. Shiva was waiting for them to be delivered to
- 330 him from Dominion who was stonewalling why didn't the audit
- 331 team give these to Dr. Shiva? Remember the routers were never
- presented, and the audit team, it turns out, did very little to put any
- 333 real pressure on the County to get access to these it's was a
- 334 clown show. Smoke and mirrors to deflect attention away from
- their INACTION, and all the while the results they were producing
- were bogus this is a serious problem. The entire exercise wasted
- 337 hundreds of hours and months of precious time they are
- 338 running out the clock on us! But Dr. Shiva and other genuine
- patriots are ready to step in and get us focused on the REAL CASE

- 346 hard to break through this Satanic STRONGHOLD —
- 347 And that brings me to my conclusion.
- 348 Christians are the key! I spoke to this in my Comfort and Counsel
- 349 for the Present Distress visit last night, and will take it up some
- 350 more on Saturday. Please listen!
- 351 Christians vessels in which the SPIRIT OF JESUS CHRIST
- 352 DWELLS, possessors of the power of the KINGDOM OF CHRIST,
- 353 and His CHURCHES in possession of the KEYS OF THE
- 354 KINGDOM, with POWER over devils to tread upon them as
- 355 scorpions, and POWER over Satan himself, when submitted to
- 356 GOD, to resist the Devil and compel him to flee but Christians
- 357 are pathetic today and so weak spiritually.
- 358 Much of their weakness comes from lies they believe. For example,
- 359 they constantly reinforce one another with vanities like I read
- 360 the end of the book and I know we win. Vanity? Of course, that is
- 361 true, and there is great strength drawn from that TRUTH to
- 362 encourage us in our present battle BUT THE FACT THAT
- 363 GOD WINS IN THE END DOES NOT GUARANTEE YOU WILL
- 364 WIN THIS PRESENT BATTLE. Christian YOU CAN LOSE!
- In fact, with all your talk about winning, winning, winning, you are
- 366 going to have to at some point stop and look at the reality that you
- have been and are presently in fact LOSING.
- 368 There is evidence of a moving of GOD, a stirring of His finger
- 369 directing affairs toward JUSTICE, but right now, face it GOD is
- not demonstrating His great power to overcome your enemies
- 371 right now.

- 372 Christians have a remarkable capacity for ignoring chastisement,
- ignoring when God is expressing His displeasure, closing their eyes
- 374 to their own failures and throwing aside their own personal
- responsibility for the judgment that has come upon us.
- 376 The number one quality essential to a proper relationship with
- 377 GOD is honesty, and following that, humility, and following that,
- 378 HOLINESS.
- 379 You had better get honest with God and quite trying to explain
- away the FACT that we are praying for GOD to deliver us from
- 381 these wicked and unreasonable men and women, and yet He is not
- doing that. To say, well, it's not His timing? How do you know?
- How do you know He would not have thrown off these oppressors
- years ago if YOU were living like you ought to and doing what
- your are supposed to be doing. You can't go on in disobedience to
- 386 GOD and carelessness about your own sin, and then pass off God's
- 387 refusal to HEAR OUR CRY I mean, how many times are we
- 388 going to appeal to II CHRONICLES 7:14 to GOD's face that is
- 389 TURNED AWAY FROM US before we finally admit, we have a
- 390 PROBLEM that is bigger than anything going on here we have
- 391 offended GOD. And we must REPENT as His people Pelosi and
- 392 the rest of them need to REPENT to be saved but God's People
- 393 need to REPENT to be HEARD!
- 394 It starts be getting honest. Admit it! Satan has prevailed so greatly
- in our nation because God's people sat back and let it happen.
- 396 One simple example you arrogant so called "Christian" who
- 397 despises the LORD's CHURCHES. I hear it all the time from
- 398 "Patriots" well, the church is not the answer. That's exactly what
- 399 Satan wants you to believe and you serve him well when you
- 400 SUPPORT THE MAJOR PREMISE OF HIS LIE Jesus has not
- 401 forsaken His churches, and there are churches that are standing up
- 402 to the lies of Satan and challenging the strongholds.

- 403 You need to be in church. And you need to quit supporting these
- 404 namby-pamby WORLD LOVING churches and put your support
- 405 behind a real BIBLE believing, CHURCH that understands
- 406 spiritual warfare but look, I've been around long enough to
- 407 know the average believer is lazy, spiritually dull as post, and so full
- 408 of the filthiness of the flesh and spirit they are a vessel unfit for
- 409 Christ's use. They concede to the MAJOR PREMISE of Satan's lie
- 410 it's instinctive for them to aid and abet the DEVIL to broadly
- 411 condemn the only ORGANIZATION CHRIST established in the

- 420 (essentially, it means you agree with what I'm saying) or you say
- 421 LIGHTS OFF -- which means you reject what I'm saying and
- disagree strongly with me. So, what will it be today, lights on, or
- 423 lights off?
