- 213 exacerbate societal friction to sow discord and undermine public
- 214 trust in government institutions to encourage unrest, which could
- 215 potentially inspire acts of violence.
- 216 Mass casualty attacks and other acts of targeted violence conducted
- 217 by lone offenders and small groups acting in furtherance of
- 218 ideological beliefs and/or personal grievances pose an ongoing
- 219 threat to the nation.
- While the conditions underlying the heightened threat landscape
- 221 have not significantly changed over the last year, the convergence
- 222 of the following factors has increased the volatility,
- 223 unpredictability, and complexity of the threat environment:
- 224 (1) the proliferation of false or misleading narratives, which sow
- discord or undermine public trust in U.S. government institutions;
- 226 (2) continued calls for violence directed at U.S. critical
- 227 infrastructure; soft targets and mass gatherings; faith-based
- 228 institutions, such as churches, synagogues, and mosques;
- 229 institutions of higher education; racial and religious minorities;
- 230 government facilities and personnel, including law enforcement
- and the military; the media; and perceived ideological opponents;
- 232 and (3) calls by foreign terrorist organizations for attacks on the
- 233 United States based on recent events."
- 234 And, you are probably thinking along the lines I am AND
- 235 NONE OF THIS APPLIES TO THE BLM/ANTIFA RIOTS
- 236 DURING JENNY'S "SUMMER OF LOVE" that Seattle Mayor
- 237 Jenny Durkan when ANTIFA literally occupied the cities east
- 238 police precinct cordoned off a few blocks of the city, declared it
- 239 CHAZ, the Capital Hill Autonomous Zone—declared it succeeded

- 255 UNCONSTITUTIONAL government policies, like mask
- 256 mandates?
- 257 You know the government CANNOT enforce a mask mandate on
- 258 you the Health departments of our cities and counties DO NOT
- 259 HAVE THE AUTHORITY to enact laws; only our LEGISLTURE
- 260 has that power. A government "mandate" is not a LAW, and when
- your local businesses IMPOSE ON YOU THESE GOVERNMENT
- 262 POLICIES they are CONCEDING TO FASCISM a system of
- 263 government where business is coopted by government to
- 264 ENFORCE public policy.
- 265 It's all in the spirit of you can't buy or sell unless you wear the
- 266 government mark on your right hand, or forehead.
- 267 Take your business AWAY from all fascist managers, and
- 268 businesses. Go LOCAL! Get away from the big national, and
- 269 international chain stores where they are GOVERNMENT
- 270 AGENTS threatening to deprive you of access to their goods and
- 271 services unless you KNEEL TO their fascist policies!
- 272 If you accommodate this, you will become acclimated to fascism,
- and in order to avoid taking a hard stand against these injustices,
- 274 you will go into the affirmation phase and then you are GONE!

- You become the enemy of liberty, the enemy of FREEDOM, the
- 276 enemy of our CONSTSTITUTION and you will have forfeited
- 277 freedom for your children and theirs.
- 278 STAND! Or you will kneel!
- 279 Why are Blue states lifting mask mandates, but leaving them in
- 280 place for our schools? The SCIENCE tells us the children are the
- 281 least vulnerable to serious injury from the virus? The SCIENCE
- 282 tells us masks DO NOT WORK the virion (virus particle) is 125
- 283 nanometers in diameter but the pores of your cloth mask are
- 284 typically 700-1200 nanometers in diameter. So now, everyone

- 299 Depending on the humidity, and heat, the droplet will evaporate
- 300 within seconds, leaving the virus particle free to fly freely into your
- lungs, or to aerosolize and float about for up to an hour, depending
- 302 on air currents, and wind velocity western science has always
- 303 held that masks are not a viable public mitigation strategy for
- 304 controlling the spread of a virus.
- 305 And science has always recognized the importance of EARLY
- 306 INTERVENTION, given trained physicians the liberty to use their

- training to help their patients, real science has always understood
- 308 the greater efficacy of NATURAL IMMUNITY and not ONE
- 309 MODERN SCIENTIFIC STUDY has presented any evidence
- 310 CONTRARY to what we have known for many decades this is a
- 311 SHAM and a SHAME on the American people for
- 312 ACCOMMODATING these liars and letting big pharma line
- 313 their pockets with, what did I read, over 100 BILLION dollars in
- 314 profits so far?
- 315 So some of these blue states, like New York, are lifting the mask
- 316 mandate, under pressure from THE PEOPLE, by the way, but they
- 317 continue to bear down on the children they want to keep the
- 318 children strapped in with these masks any teacher so
- uninformed and full of fear, or full of the spirit of oppression, must
- 320 HATE THE CHILDREN they are charged to teach—the entire
- 321 government education program needs to collapse and give the
- 322 parents the RIGHT TO CHOOSE!
- 323 And finally, speaking of government schools abuse of our children:
- 324 Eighth graders in Connecticut in the Enfield school district are
- being treated to a little hold-over pizza-gate trivia game? Unreal!
- 326 God help us! Quote from Blaze News: "Eighth-grade students in
- 327 Connecticut were given a sex-ed assignment asking them to pick
- 328 pizza toppings describing their sexual 'likes' and 'dislikes' for
- 329 example, olives stood for 'giving oral,' according to Parents
- 330 Defending Education."<sup>5</sup> Perhaps what is even more disturbing, on a
- 331 certain level, is the fact that the School District officials said,
- effectively, Oops! "The assignment was posted by 'mistake." [IBID]
- 333 This happened at the Enfield school, and parents showed up at the
- 334 school's board meeting to raise objections. The School
- 335 superintendent explained that they "sent the wrong document."
