1 Segment.01 Hello. I'm Dr. Jerry Scheidbach, pastor of the  
2 Lighthouse Baptist Church in Santa Maria, CA—and your brain  
3 masseur—get ready for your brain massage.

4 CA Governor lays out what he calls his "post COVID plan." He  
5 calls it SMARTER! But he refuses to yield emergency powers and  
6 has, effectively, declared himself to be DICTATOR of CA. We  
7 breathe at his pleasure, we work at his pleasure, we gather at his  
8 pleasure—NOT! Give up your "emergency powers." Hey, gov. we  
9 have Truckers too! Let's see how smart his SMARTER plan really  
10 is.

11 What's going on with the Canuck-FREEDOM CONVOY-Trucker-  
12 Trudeau-protest? The Canadian PM is a sissy goal-suck, Canadian

29 when it comes to dealing with certain political situations? There is  
30 some history there, you know! Ever seen the list of vocal Clinton  
31 associates who have mysteriously and unexpectedly died? It's just  
32 eerie!

33 And, speaking of Hillary, of course, we need to look at Durham's  
34 latest filing — after all, it got Hillary's attention, and brought her  
35 out into the public making charges that FoxNEWS is  
36 misrepresenting Durham's case against Sussmann. Really? Let's see.

37 Oh, and you might remember that over a year ago, many of us  
38 were circulating information showing that the COVID PCR test  
39 was bogus. Now they admit it! Let's do an update on the COVID  
40 scam. And finally I have the answer to a mystifying question —

54 Let's get started, and we'll begin with an update on what Karl  
55 Schwab's Keener — Schwab, you know him, right? World  
56 Economic Forum, Globalist elite — Mr. "you will own nothing, and  
57 you will be happy" — Schwab's keener — that's Trudeau (by the

58 way, *keener* is a Canadian slang term for a bootlicker, a  
59 brownnoser)<sup>2</sup> — doing the bidding of the GLOBALISTS ELITE,  
60 that owns him — there are allegations of Trudeau being caught in  
61 the home of an underage student by her father whose silence was  
62 bought off by a very handsome pay out — there are allegations he  
63 paid out two million to another accuser to secure a non-disclosure

88 Truckers precisely because he KNOWS they are LAW ABIDING  
89 and will not break out into violence. Of course, the little cutie-  
90 tyrant is making sure no one sees what he is doing — media are  
91 blocked from covering the arrests.

92 So, where does the Canuck Protest go from here? And what do we  
93 learn from this?

94 Well, for one thing, it was productive of some good! It showed the  
95 Liberal Canadians that the FREEDOM loving Canucks are paying  
96 attention and NOT GOING ALONG with this violation of human  
97 rights — this trampling under his soiled shoes the rights of  
98 Canadians. Wiping his feet on their liberties!

99 It has also brought out and put in front some Canadian voices  
100 talking with passion about RIGHTS, and LIBERTY, and  
101 FREEDOM — there are many more FREEDOM patriots in Canada  
102 than you might have thought. That's good to see!

103 This event has caught the attention of the world — it brings  
104 attention to the fact that deep in the HUMAN SPIRIT there is a  
105 CRY for FREEEEEEEEEEEDOOOOOOOOOMMMMMMM! And  
106 it shows that the average, middle-class citizen is AWARE of what  
107 the ELITES are trying to pull. It's EYES ON!

108 It reveals the ugly underside of Trudeau's pretty-boy demeanor! It  
109 shows the devil underneath his boyish smirk. It pulls the mask off  
110 his SUNNY WAYS — what a joke! Definitely clouded up his sunny  
111 ways — eh?

112 It reveals the heart of dictators everywhere! And it offers us an  
113 example to learn from. I think an open public PROTEST is a  
114 healthy exercise in liberty — in today's environment, however, you  
115 must remember to whom we have given the power of government:  
116 UNREASONABLE AND WICKED men and women! In other  
117 words, it's all politicized now — the right to protest in a manner  
118 that totally disrupts the lives of citizens — *exempli gratia* — you

119 know, e.g., by way of example? — the BLM property burning,  
120 livelihood destroying, life taking activities of BLM/ANTIFA during  
121 their SUMMER OF LOVE protests — right! If you are going to  
122 protest in a fashion that disrupts the lives of citizens, it had better  
123 not be the lives of our POLITICAL MASTERS — and it had better  
124 be to make a statement supporting the agenda of our POLITICAL  
125 MASTERS. If you gather in the streets and so much as  
126 inconvenience one of our POLITICAL MASTERS, look out! They  
127 will send out their attack dogs! But I have news for them — I know  
128 this might seem to you old, nevertheless I declare it BOLD: "here  
129 comes the judge, here comes the judge." The KING is COMING!

131 Someone called in to Levin's show with a suggestion that the  
132 Truckers shape their protest a bit differently—just stop driving! Do  
133 a walk out! Part of the problem is that it's not reasonable to clog up  
134 the traffic there at the capitol or anywhere else indefinitely. It's  
135 better to have an end game — and a post-protest statement plan—  
136 in other make your statement, make it loud, so everyone in the  
137 WORLD HEARS IT! But then have a follow-up plan! Otherwise, at  
138 some point, it becomes tiresome — and those with the sword  
139 under their control will use it — and we have Tiananmen revisited.

140 Trudeau takes his cues from Beijing — this was inevitable! BUT  
141 DO NOT LET IT BE THE END! And don't bother staring down  
142 their tanks — so long as we have Beijing Biden in the white house,  
143 dictators around the world are emboldened — trust me, you would  
144 not be seeing any of this nonsense if TRUMP were restored to his  
145 rightful place in the White House.

146 But the most important lesson to take from this is don't go into a  
147 political conflict without spiritual cover — take a lesson from  
148 Israel, a people with a great deal of experience with this sort of  
149 thing. When you find yourself surrounded by oppressors, turn in  
150 repentance toward GOD, read the book of Judges, and faith toward

151 our LORD JESUS CHRIST, for a New Testament application — for  
152 it is only IN THE NAME OF THE LORD, read Psalm 118, that you  
153 will DEFEAT these ENEMIES of LIBERTY — and, by the way,  
154 every enemy of LIBERTY is a champion of TYRANNY and an  
155 enemy of GOD.

156 I have some really interesting updates on the ELECTION FRAUD  
157 front, but it'll have to wait for our visit tonight. Meanwhile — hold  
158 on through the break; I'll be right back.

159 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor  
160 at the Lighthouse, your brain masseur, and Paul Revere's lantern  
161 lighter, lighting the lamps in the church belfry arch, signaling the  
162 enemy is on the march, an enemy that would steal from us our  
163 liberty.

164 Let's look at the Durham indictment. Is Hillary right to say  
165 FoxNEWS is distorting the significance of this filing? Well, let's  
166 look at it. Here is the actual filing.<sup>3</sup> Read it for yourself! Click on  
167 the link below, or copy and paste it into the search field of your  
168 browser.

169 It's possible someone not familiar with such court filings would  
170 read only the first paragraph, and that, superficially, and, I suppose  
171 they might assume that this is limited to a conflict of interest claim,  
172 and that Sussmann need only file a voluntary waiver with “conflict-  
173 free counsel” — but that is absolutely NOT what is going on with  
174 this pleading before the court in which Durham is asking the court  
175 to look into concerns about a conflict of interest on the part of  
176 Sussmann's lawyers. I'll explain that as I proceed — but anyone  
177 attempting to pull that woolen blind over your eyes is ignorant and  
178 ill informed. Hehe! But, really!

179 The idea, as I read this, seems to be that Durham is asking the  
180 court to examine a possible conflict of interest on the part of

181 Sussmann's "counsel" that might be adverse to his interests and  
182 serving instead other interests that are contrary to that of their  
183 client's. We can only guess whose interests Latham & Watkins LLP  
184 might be serving that put them in any conflict with the interests of  
185 their client. We are aware that some of this firm's lawyers are likely  
186 to be called as witnesses in the impending Sussmann trial.

187 To summarize this point — what Durham has asked for from  
188 Sussmann is a written conflict of interest waiver — a signed  
189 statement from him that he is aware of the potential conflict and  
190 waives any concern about it. Why? Durham does not want these  
191 snakes to slither out of a judgment with a conflict of interest claim.  
192 In other words, Durham knows how to handle snakes. He knows  
193 these snakes will position themselves with an escape route if the  
194 trial goes against them — as they suspect it will. Sussmann will all  
195 of a sudden claim there was conflict of interest that compromised  
196 his representation in the case, and call for a mistrial.

197 Read the doc for yourself, but read it carefully. It's posted in a link I  
198 provide in my show notes.<sup>4</sup>

199 However, Durham, very interestingly, made reference to the  
200 original indictment filed in September last year, and tied it in to  
201 this pleading in a manner that brings attention to what are really  
202 the meat and potatoes of this filing. This begins manifesting under  
203 no. 2. So, how about we dig in to the meat and potatoes of this  
204 matter? How about we start spoon-feeding Hillary devotees what is  
205 in this SOUP that really galls Hillarity and her cohorts!

206 The charge/s laid against the defendant is/are as follows:

207 First, making a materially false statement to the FBI. This is the  
208 essential, or leading charge of the indictment. The code violated is  
209 stipulated: Title 18, US Code, Section 1001. This is the  
210 INDICTMENT filed on Sept. 19, 2016.

211 Then, in the material presented that supports the INDICTMENT is  
212 where we begin seeing that Durham is digging Hillary’s “political”  
213 grave, inscribing her headstone, and laying foundation for her  
214 upcoming INDICTMENT — I can hear the sewing machines  
215 whirring, preparing her orange jump suit, and the calls of patriots  
216 all over America: LOCK HER UP!

217 Here you go, a spoon full of meat—

218 Supporting Charge No. 1. Less than two months before the 2016  
219 election, Sussmann, representing the CLINTON CAMPAIGN, met  
220 with FBI General Counsel at FBI headquarters in DC.

221 He provided the FBI with data and “white papers” that purportedly  
222 proved Trump had a secret, or covert, communications channel  
223 with a Russian based Bank. (Alpha Bank—according to Podesta.)  
224 The Indictment alleges that the defendant (Hillary lawyer, Michael  
225 Sussmann) lied in that meeting, representing himself as NOT  
226 REPRESENTING ANYONE OTHER THAN HIMSELF, and his  
227 own private concerns as a “patriot” (that must have gotten a snicker  
228 from the FBI agents that were present then (that’s right, Sussmann  
229 has claimed there were more than one FBI agent in that meeting)  
230 — when, IN FACT, according to information Durham holds,  
231 Sussmann had ASSEMBLED AND CONVEYED the allegations to  
232 the FBI ON BEHALF OF AT LEAST TWO SPECIFIC CLIENTS: a  
233 Technology executive for an INTERNET company and THE  
234 CLINTON CAMPAIGN. (THE TECH EXECUTIVE IS  
235 REPORTED TO HAVE BEEN RODNEY JOFFE<sup>5</sup> — who retained  
236 Sussamann as his attorney in a “matter involving an agency of the  
237 US government” — the “agency, “and the “matter” being  
238 mysteriously withheld.) Joffe was offered the top cybersecurity job  
239 by Hillary—providing she won!

240 From here, in the court filing, Durham lays out the evidence  
241 supporting the indictment.

242 Presenting his second additional charge, Durham writes: "The  
243 INDICTMENT also alleges" — oh, there's more. Beginning in  
244 approximately July of 2016, the Internet Tech executive that  
245 Sussmann was representing worked with Sussmann on behalf of  
246 the Clinton Campaign. Numerous cyber researchers were  
247 employed, along with employees at multiple Internet companies,  
248 tasked with a project TO ASSEMBLE THE PURPORTED DATA  
249 AND WHITE PAPERS that Sussmann presented to the FBI in  
250 September (see above). Oh! So, the material Sussmann presented to  
251 the FBI in that auspicious meeting was material culled out by this  
252 team of Internet experts.

253 Durham goes on to reveal that in connection with these efforts, the  
254 Internet Tech CEO (Joffe) with whom Sussmann worked  
255 "exploited his access to NON PUBLIC AND/OR PROPRIETARY  
256 INTERNET DATA." (Oops, this is ILLEGAL!)

257 Durham further reveals they were using a University and  
258 employing the services of cybersecurity researchers connected with  
259 said University that had a pending federal government  
260 cybersecurity research contract. (Oops, Unethical, and I think also  
261 illegal.) These researchers were receiving and analyzing large  
262 amounts of Internet data provided by Joffe's access, IN AN  
263 ATTEMPT TO ESTABLISH "AN INFERENCE" AND  
264 "NARRATIVE" TYING THEN CANDIDATE Donald J. Trump  
265 TO RUSSIA.

266 The Internet Tech CEO states that he was seeking to PLEASE  
267 CERTAIN "VIPS" — the records show he was referring to  
268 individuals at the Law firm and the CLINTON CAMPAIGN.

269 The third additional charge: Included within the scope of this trial  
270 against Sussmann, Durham will show that the Internet Tech and

271 Sussmann actually hacked into Trump's Internet traffic, and a  
272 healthcare provider snooping about for information damaging to  
273 Trump, also the Trump Tower and the Trump's Central Park West  
274 apartment, and then, after Trump was President, they hacked into  
275 the Executive Office of the President of the United States. (Major  
276 Oops — does anyone else out there remember Watergate, and what  
277 that was all about? — Hillary worked on that case, by the way. And,  
278 by the way, she was fired for faking some paper work!) This they  
279 did hoping to mine DEROGATORY INFORMATION ABOUT  
280 THE PRESIDENT.

281 The fourth additional charge: Durham further shows that  
282 Sussmann, et al, used information they gathered to create an array  
283 of fake accusations against Donald J. Trump.

284 Among the accusations: suspicious Internet searches affiliated with  
285 a Russian mobile phone provider; use of "rare" Russian-made  
286 wireless phones in the vicinity of the WH and elsewhere. Durhams  
287 adds that THE SPECIAL COUNSEL'S OFFICE HAS IDENTIFIED  
288 NO SUPPORT FOR THESE ALLEGATIONS. (As a note: Durham  
289 explains that such activity was COMMON, that between 2014-2017  
290 there were more than 3 million searches of this kind. These alleged  
291 connections between the WH and the Russian Phone Provider  
292 began at least as early as 2014, during Obama's admin. In other  
293 words, there was NOTHING unusual or "suspicious" about this!)  
294 Durham points out that Sussmann and company conveniently  
295 OMITTED these FACTS in his report to the FBI.

296 Following this, Durham lays out applicable law and establishes the  
297 case that if the above allegations in his indictment are proved true,  
298 Sussmann is in SERIOUS TROUBLE. (No doubt, this is intended  
299 to put considerable PRESSURE on Sussmann to come clean!  
300 Durham is offering this culprit every opportunity to redeem  
301 himself.)

302 Durham concludes with a return to the conflict of interest issue —  
303 and it is apparent, Durham desires to avoid any possibility that  
304 after he has NAILED SUSSMANN for his CRIMES, which directly  
305 IMPLICATE HILLARY, Sussmann will not be able to wriggle out  
306 with a claim that his representation was in a conflict of interest  
307 between him, that is, Sussmann, and Hillary, et al.

308 The very Special Counsel Durham wants to CLOSE and lock the  
309 escape DOOR that he has reason to believe Sussman and his  
310 conflicted representatives might attempt to use to evade justice.

311 So that's the truth, the whole truth, and nothing but the truth on  
312 the Durham case against Sussmann, and how it ties Hillary to the  
313 Russia-gate scandal.

314 I have a message for Hillary: "Be not deceived; God is not mocked:  
315 for whatsoever a [Hillary] soweth, that shall [she] also reap,"  
316 Galatians 6:7 (and in case you wonder what version I'm reading  
317 that drops Hillary's name like this — I added it into my reading as  
318 APPLICATION of the biblical principle to that deceitful,  
319 unreasonable and wicked woman.

320 Thus saith the LORD to Hillary Clinton: "Ye have sinned against  
321 the LORD: and BE SURE YOUR SIN WILL FIND YOU OUT"  
322 Numbers 32:23. Thus saith the LORD to Gavin Newsome, "Woe  
323 unto them that decree unrighteous decrees, and that write  
324 grievousness which they have prescribed..." — that turn aside  
325 justice and judgment and, JUDAS like, hide their betrayal of the  
326 PEOPLE of the LORD under a cloak of concern for the poor! You  
327 are a thief and a liar, sir! To all of you, Newsom, Pelosi, Hillary —  
328 REPENT! Humble yourself under the mighty hand of God and  
329 confess your crimes, break off your sins with righteousness, that  
330 you might find some mercy in HIS JUDGMENT!

331 I have lit the lamps in the Church belfry arch and now you let me
