1 Segment.01 Hello. I'm Dr. Jerry Scheidbach, pastor of the  
2 Lighthouse Baptist Church in Santa Maria, CA—and your brain  
3 masseur—get ready for your brain massage.

4 What to do about Ukraine? It's a sort of pull the beam from your  
5 own eye before you go about picking motes from the eyes of others.

6 Biden's Ministry of Truth has been put on the back burner and his  
7 arbiter of all things TRUTH has resigned. Here is a ministry of

25 And CA AB2223 allows for abortion to full term, and language in  
26 the bill opens a loophole allowing for the extension of abortion  
27 protection up to one month after the child is born. The word in the  
28 Bill is *perinatal*, and all pediatricians know exactly what this word  
29 means and you had better become acquainted with it.

30 Let's see, I've got so much on this and on the Ministries of  
31 UNTRUTH these are likely all we will get to on the Brain Massage  
32 show today. I mean beyond a quick touch and go!

33 So, friends, it's time — time for your BRAIN MASSAGE®.

34 [TRUTH]

35 What to do about Ukraine? I've said it's a sort of pull the beam  
36 from your own eye before you go about picking motes from the  
37 eyes of others.

38 The only Republicans who voted against this bill are Blackburn,  
39 Boozman, Braun, Crapo, Hagerty, Hawley, Lee, Lummis, Marshall,  
40 Paul and Tuberville. Notably, Cruz is missing from this list—why?

41 I'm going to address this tonight during my live stream —

42 You heard that Biden's Ministry of Truth has been put on hold and  
43 his "Minister of Truth" — Jankowicz — has resigned? Now we need  
44 to "resign" all the MINISTRIES OF UNTRUTH out there by  
45 finally, and completely, walking away from these "new cart"  
46 churches and start supporting the OLD PATH churches—like  
47 Jeremiah advised: "Thus saith the LORD, Stand ye in the ways, and  
48 see, and ask for the old paths, where is the good way, and walk  
49 therein, and ye shall find rest for your souls." And avoid the fateful  
50 error of Judah on the day they replied to Jeremiah: "But they said,  
51 We will not walk therein" (Jeremiah 6:16).

52 Here is a ministry of UNTRUTH for you: "Christian Church Will  
53 Host Drag Show for Youth Ages 12-18." Florida's Naples United  
54 Church of Christ hosts a "Youth Pride Conference." What is going

55 on in the "CHURCHES" says a lot about just how depraved and  
56 wicked our nation has become, and why!

57 It all goes to what you think about the BIBLE, and even which  
58 version you adopt. Deuteronomy 22:5 and I Corinthians 6:9  
59 together with many other passages, make it clear God made man  
60 MALE and FEMALE and has commanded we respect and  
61 maintain GENDER DISTINCTION in wardrobe and in manners.

62 Registrants to the Youth Pride Conference are asked to enter their  
63 pronouns. Missionary Stephen Benefield told me what are his  
64 children's preferred pronouns: when in trouble, "they," when food  
65 is offered, "me," when asked who did it, "he," or "she."

66 After, by way of caveat, I should point out that this MINISTRY OF  
67 UNTRUTH got some push back; the district refused to allow the  
68 schools to be used as pick-up points, and instructed the event  
69 organizers to remove any notice that suggests the school district is  
70 associated with the event. Then the "CHURCH" put out a  
71 confusing disclaimer on their sign-up page: "Please acknowledge  
72 that you understand this is an event hosted by [Gay, lesbian &  
73 Straight Education Network (GLSEN)] Collier and is not affiliated  
74 with Naples United Church of a [sic] Christ or Collier County  
75 Public Schools." Then they added: "GLSEN Collier is a nonprofit  
76 organization that works to provide a safe and inclusive  
77 environment for our marginalized students, particularly those who  
78 identify as LGBTQ." [IBID]

79 The article<sup>3</sup> informs us that, "Christian congregations are  
80 increasingly supporting gay, lesbian, bisexual, and transgender  
81 culture" and lists six links documenting this statement:

82 The North Carolina Calvary United Methodist held an event called  
83 "Drag Me to Church," yeah, *Drag* — you get it! The brutish pastor  
84 of this "church" said "It brings such good and positive energy,

85 which is really what we wanted this to be about."<sup>4</sup> But the pastor is  
86 sensitive to *family* — so he assured his congregation this would be  
87 a *family friendly drag show*. [IBID]

88 Here is another church that hosted a 'Pride' Drag Show.<sup>5</sup> An  
89 Atlanta house of "worship" — the campus church of Emory  
90 University's Glen Memorial is a Methodist congregation speeding  
91 to hell with their pedal to the metal — the Methodist "Church"  
92 hosted the event parading men in dresses and celebrating *pride*.  
93 Yeah! Pride's a good thing now! Wesley missed that part in the  
94 Bible, right? He got confused with that part about PRIDE being  
95 numbered with the seven DEADLY SINS.

96 But if you look at that organization's website it declares: "Naples  
97 UCC is a congregational church, which means that involvement  
98 and leadership is expected from all our members to do the work of  
99 being the church. As a member of the United Church of Christ  
100 denomination, we accept the challenge and mutual accountability  
101 of being counted as one of many UCC churches that advocate for  
102 personal and social responsibility in living out the Gospel of Jesus  
103 Christ."

104 You see, folks, it is fundamentally a fundamental corruption of the  
105 GOSPEL OF JESUS CHRIST.

106 And "Christian" LGBTQ+ers are beginning to come out of the  
107 closet about that, too. Penny Cost is a Methodist Drag Queen  
108 "pastor" who occasionally "preaches" in DRAG. Here is a video of  
109 one of Penny's sermons admitting he is "uncomfortable with the  
110 story of the crucifixion"<sup>6</sup> — you have to see this video to appreciate  
111 how vile! She went on to complain about the analogies of the cross,  
112 the metaphors, and all that symbology. "Because for me," he said,

113 "it's hard to move past the idea of the cross as anything but a  
114 torturous death trap, a death thing! Uh, a symbol of sustained  
115 harm and insurmountable, painful loneliness": At least until she  
116 read *The Queer Bible Commentary*. She explained, "It transposes  
117 the story of Christ's crucifixion, really of every story in the Bible,  
118 but this one specifically was about the crucifixion, and it transposes  
119 that onto the story of the queer experience. It forces the reader to  
120 wonder whether the story of Christ can be seen through a lens of  
121 queerness, through a lens of Drag, even. ... People will tremble  
122 when sensing the mystery of queer holiness. For me, Drag is a  
123 powerful form of uncovering my own secret — Shouting it on the  
124 mountain tops." The Crucifixion was troubling to her until she  
125 could see it as affirming Queer angst, specifically, loneliness.

126 In an effort to reach out to the Trans community, the Lutheran  
127 Church of Sweden<sup>7</sup> put out a formal declaration in a missive titled:  
128 *Personal Letter to You Who are Trans*.<sup>8</sup> The statement declares that  
129 the Swedish church is Trans. The reasoning is simple: a church is  
130 made up of people, people are different, and some of them are  
131 transgender, because the church also consists of transgender  
132 people, the church could be described as trans. So, there you go —

133 Here you go, and by the way, thank you Alex Parker for assembling  
134 these articles for us, RedState is a great source for news and  
135 views—here is another one: "Church Pastor Claims Jesus  
136 'Transgenders Himself' In the Bible."<sup>9</sup>

137 I guess if we are going to blow the whistle on the Methodists and  
138 the Lutherans, we can't leave out the Baptists—right? Yeah — this  
139 beauty comes from Simon Woodman, of Bloomsbury Central  
140 Baptist Church, invited to speak at a panel gathered to discuss  
141 Queer Theology.

142 However, it's appropriate to point out that this is a United  
143 Kingdom Baptist pastor (Spurgeon moans) — but take heart, as  
144 Parker points out, our Baptist pastors don't wear white collars and  
145 "also, typically, they don't assert the Messiah subscribed to 21st-  
146 century gender theology."

147 Simon's biblical support for his theory is taken from Jesus' lament  
148 that He had sought to gather Jerusalem under His wings like a hen  
149 gathers her chicks, and the humble gesture of washing the disciples'  
150 feet, since in the Bible that practice is consistently something done  
151 by a woman, and so this fellow, or whatever he or it is, explains  
152 that when Jesus did this "Jesus becomes the woman at that point"  
153 — (now, that one might get the seeker sensitive heretic in trouble  
154 with those who identify with *her* and *she* pronouns since it suggests  
155 washing feet is a female thing???) Hmmm! Does this mean that  
156 when I wash the dishes at home I become a woman! Oh my!

157 Anyway, another "pastor" at this conference on Queer Theology,  
158 Angela, just came out with it and said GOD IS QUEER. So!  
159 London's bridge is certainly coming down — an Episcopal bishop  
160 declared God is FEMALE,<sup>10</sup> and the Episcopal Church considered  
161 giving the Creator a sex change.<sup>11</sup> Well, that's been in the works for  
162 a while excising all masculine pronouns from the BIBLE, and now,  
163 horror of horrors, these Episcopos are doing it to the book of  
164 Common Prayer.

165 But the devil has not entirely ignored us—that is, the U.S.  
166 Something that is not news to you, of course.

167 Duke University is a United Methodist college in North Carolina.  
168 In a video<sup>12</sup> from a March service, attendees to the Goodson  
169 Chapel Service of Word, Caroline Camp, the Communications

170 Coordinator for Duke Divinity Pride, greeted the assembly: "Good  
171 morning, the Holy and Queer One be with you." [IBID]

172 So, back to the United Church of Christ in Naples, FL the first  
173 ministry of UNTRUTH that I mentioned at the beginning of this  
174 segment — they attacked their Governor, DeSantis, for not  
175 allowing public schools to use pornography in their curriculum  
176 and/or to teach children their gender confusion nonsense.

177 Here is the statement issued by this MINISTRY OF UNTRUTH:  
178 "This latest attack has already had a chilling effect on LGBTQ+  
179 youth, who already experience victimization such as bullying,  
180 harassment, and discrimination. The 'Don't Say Gay' bill is an  
181 exclusionary curriculum ban that deprives LGBTQ+  
182 communities." etc.

183 Friend, I need to go to a break, but do you get it? Suppose Jesus has  
184 removed the candlestick of these ministries of untruth: Yeah, long  
185 ago. Why anyone would continue supporting and attending these  
186 new-cart, namby-pamby, world loving, WORD despising  
187 ministries of UNTRUTH is beyond my comprehension — except  
188 that, you see, it is in the end the result of a CORRUPTION OF  
189 THE GOSPEL. Hold on, I'll be right back!

190 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor  
191 at the Lighthouse, your brain masseur, and Paul Revere's lantern  
192 lighter, lighting the lamps in the church belfry arch, signaling the  
193 enemy is on the march, an enemy that would steal from us our  
194 liberty.

195 CA AB2223 allows for abortion to full term, and language in the  
196 bill opens a loophole allowing for the extension of abortion  
197 protection up to one month after the child is born. The word in the  
198 Bill is *perinatal*, and all pediatricians know exactly what this word  
199 means and you had better become acquainted with it.

200 The word is *perinatal*, and the meaning is anything that occurs in  
201 the life of a child at or around the time of its birth, defined as 5  
202 months before and 1 month AFTER.<sup>13</sup>

203 From the Free Dictionary by FARLEX, Medical Dictionary, the  
204 perinatal period extends from "shortly before and after birth; from  
205 the twentieth to the twenty-ninth week of gestation to 1 to 4 weeks  
206 after birth." [IBID—from the Miller-Keane Encyclopedia and  
207 Dictionary of Medicine, Nursing, and Allied Health, Seventh  
208 Edition.]

209 Another definition offered in the American Heritage Medical  
210 Dictionary: "Of, relating to, or being the period around childbirth,  
211 especially the five months before and one month after birth."  
212 [IBID].

213 In the UK it's a bit different—in the Segen's Medical Dictionary, it  
214 is defined as "Referring to the period around birth, often defined as  
215 between the 28th week of pregnancy and the end of the first week  
216 of life."

217 In the McGraw-Hill Concise Dictionary of Modern Medicine, it is  
218 defined as "Referring to the period around birth, often between the  
219 28th wk of pregnancy and the end of the first wk of life." [IBID]

220 From the Medical Dictionary for the Health Professions and  
221 Nursing, *perinatal* is defined a "Occurring during, or pertaining to,  
222 the periods before, during, or after the time of birth, i.e., before  
223 delivery from the 28th week of gestation through the first 7 days  
224 after delivery."

225 From Collins Dictionary of Medicine, *perinatal* is defined as  
226 "Pertaining to the period immediately before and after birth. For  
227 statistical purposes, the perinatal period is defined as the period  
228 from the 28th week of pregnancy to the end of the 1st week after

229 birth. Perinatal mortality is the number of babies born dead  
230 together with the number dying during the first week after birth."  
231 [IBID]

232 The Gale Encyclopedia of Medicine defines *perinatal* as "Referring  
233 to the period of time surrounding an infant's birth, from the last  
234 two months of pregnancy to the first 28 days of life." [IBID]

235 The Medical Dictionary for the Dental Professions tells us  
236 *perinatal* means any event "occurring during, or pertaining to, the  
237 periods before, during, or after the time of birth." Oh my God —  
238 this is wide open!

239 Why is the Brain Masseur looking so closely at this word and how  
240 it is defined? What difference does it make if *perinatal* refers to  
241 events, such as death, occurring one month or five months before  
242 birth, and after birth up to 1 week/7 days or four weeks/twenty-  
243 eight days, or one month (up to 31 days), or just "after the time of  
244 birth"?

245 Because, Buffy Wicks has introduced a Bill in the CA legislature  
246 that says mothers, and any participating medical professional  
247 cannot be held liable for the death of a child during this period no  
248 matter by what cause: her bill states: "A critical part of realizing  
249 reproductive justice for people in California is clarifying that there  
250 SHALL BE NO CIVIL AND CRIMINAL PENALTIES FOR  
251 PEOPLE'S ACTUAL, POTENTIAL, OR ALLEGED PREGNANCY  
252 OUTCOMES"—that makes the meaning of *perinatal* of particular  
253 concern: the difference between 7 days and 28 days can mean LIFE  
254 OR DEATH to a new born baby under 29 days old.

255 The bill explains that "(1) Existing law requires a county coroner to  
256 hold inquests to inquire into and determine the circumstances,  
257 manner, and cause of violent, sudden, or unusual deaths, including  
258 deaths related to or following known or suspected self-induced or  
259 criminal abortion" but this would be stricken.

260 The bill would prohibit using the coroner's statements on the  
261 certificate of fetal death to establish, bring, or support a criminal  
262 prosecution or civil cause of damages AGAINST ANY PERSON."<sup>14</sup>  
263 No matter what the coroner found as a cause of death.

264 Furthermore, while existing law provides for an assumed  
265 "fundamental right of privacy with respect to their personal  
266 reproductive decisions," this law removes any culpability for any  
267 occurrence of death that occurs within the *perinatal* period.

268 Under existing law an abortion is UNAUTHORIZED if either the  
269 person performing the abortion is not a health care provider that is  
270 authorized to perform an abortion OR THE FETUS IS VIABLE."  
271 By this law, the state prohibits interference with a pregnant  
272 "persons" right to choose or obtain an abortion even after the *fetus*  
273 *is viable*. (Fetus means LITTLE CHILD.)

274 Buffy's bill would "prohibit a person from being subject to civil or  
275 criminal liability, or otherwise deprived of their rights, based on  
276 their actions or omissions with respect to their pregnancy or actual,  
277 potential, or alleged pregnancy outcome or based solely on their  
278 actions to aid or assist a pregnant "person" who is exercising their  
279 reproductive rights." Disturbingly, this bill expressly allows the  
280 "birthing person" to perform the abortion independent of a "health  
281 care professional." So much for keep them "safe." That's the only  
282 reasonable sense I can take from this absurd sentence I found in  
283 the official abstract for this Bill: "The bill would clarify that an  
284 abortion is UNAUTHORIZED if performed by a person OTHER  
285 THAN THE PREGNANT PERSON and EITHER THE PERSON  
286 PERFORMING THE ABORTION IS NOT A HEALTH CARE  
287 PROVIDER THAT IS AUTHORIZED TO PERFORM AN  
288 ABORTION OR THE FETUS IS VIABLE." Yep — that's what it  
289 says. (This is as messy and sloppy as a monster inserting a scalpel

290 into the mother's womb and dismembering the child there, that we  
291 now KNOW is fighting for its life during this brutal, and violent  
292 attack.

293 The reason this bill got such pushback is that as introduced if any  
294 "state actor" decided to prosecute a "wrongful death" allegation  
295 against a mother, or an abortionist, whether that death occurred  
296 during the *perinatal* period extending up to "viability" and even up  
297 to one month after birth, those "state actors" could be sued in a  
298 civil action. The "state actor" in such a case would have no State  
299 resources to defend them.

300 After examination of the full text of the current version of this  
301 bill:<sup>15</sup>

302 This word, *perinatal*, appears in an awkward place. For example,  
303 under Section 1, f, "Pregnancies can end in a range of outcomes.  
304 Nationwide, as many as one in five known pregnancies end in  
305 miscarriage. In California, as many as 2,365 pregnancies per year  
306 end in stillbirth, MEANING PERINATAL LOSS AFTER 20  
307 WEEKS GESTATION." And this clause ends absurdly: "Many  
308 pregnancy losses have no known explanation."

309 Right~! Which is why an inquest is called for to enquire whether  
310 any of those for which there is a KNOWN cause was due to  
311 criminal negligence on the part of the mother or any of the medical  
312 professionals involved.

313 You see, EVERYBODY knows what *stillbirth means*. You do not  
314 need a qualifier that it refers to "after 20 weeks" unless you  
315 expressly desire to remove the current stipulation against  
316 murdering the child after VIABILITY — generally, 23-24 weeks is  
317 considered the threshold of viability. Premies born after 23 weeks  
318 with care often survive, and the survivability of these infants  
319 outside the womb increases exponentially every week thereafter.

320 At 25 weeks, the viability is upwards of 86-89%. CA law forbids  
321 abortion after viability — Wicks's law expressly allows for abortion  
322 throughout pregnancy, and provides a loophole to allow a mother  
323 and her medical attendants to kill the baby up to one month after  
324 birth without legal or civil consequences; and it does not offer any  
325 sort of qualification—for example, if the mother strangles the baby  
326 within a week after it is born, no "state actor" can move to  
327 prosecute her, no charges can be brought, no inquest can be called  
328 for. This would be true also if she authorized her doctor or nurse or  
329 other person, no matter who, to dispose of the baby — .

330 Nevermind the obvious racial bigotry revealed in this bill — and  
331 the fact that it is inverted bias against the interests of so-called  
332 "people of color" — I thought we were supposed to be "color-  
333 blind." This fool woman, Wicks, thinks civil and criminal penalties  
334 imposed on pregnant women is a "critical issue for Black,  
335 Indigenous, and other people of color..." who, are you ready for  
336 this, "Experience adverse pregnancy outcomes AS A RESULT OF  
337 SYSTEMIC RACIAL INEQUALITIES AND ARE MORE LIKELY  
338 TO BE UNDER SCRUTINY OF STATE SYSTEMS LIKE CHILD  
339 WELFARE OR IMMIGRATION." I don't have time here to unpack  
340 the bias and bigotry oozing from almost every word of that  
341 sentence —.

342 So, if within three days the coroner finds that the child was  
343 strangled, stabbed, burned alive, neglected, or otherwise perished  
344 by the neglect or hands of its mother, or attending medical  
345 professional, and so authorizes this be stipulated on the death  
346 certificate, if it happened within the *perinatal* period, and was  
347 related in anyway to the birthing of the child — meaning the  
348 decision to exterminate the child was authorized by the "choice" of  
349 the "birthing person," nothing appearing on the death certificate  
350 may be used to "establish, bring, or support a criminal prosecution  
351 or civil cause of action seeking damages against ANY PERSON,

352 whether or not they were the PERSON who was pregnant with the  
353 fetus."<sup>16</sup>

354 Section 7 adds Section 123467 which provides for complete  
355 protection against the application of any existing law.  
356 "Notwithstanding any other law, a person shall not be subject to  
357 civil or criminal liability or penalty, or otherwise deprived of their  
358 rights under this article, based on their actions or omissions with  
359 respect to their pregnancy or actual, potential, or alleged pregnancy  
360 outcome, including miscarriage, stillbirth, or abortion, or perinatal  
361 death due to a ~~pregnancy related cause.~~" That was the original  
362 version.

363 After some serious push back, the blood-thirsty drac-souls backed  
364 off and changed it to limit the exemption from legal culpability to  
365 deaths that occur from "causes that occurred in utero."

366 Of course, this means a court COULD elect to read this clause into  
367 a decision to prosecute against any murder of the child from causes  
368 that occur after the baby breaches the womb — HOWEVER!

369 First, it eliminates any protection for the baby in the womb all the  
370 way to birth — and the question becomes what is materially  
371 different between a child that lands in the hands of the nurse, or  
372 doctor and that same baby five seconds earlier in the birth canal, or  
373 in utero?

374 Second, the argument will almost certainly be made for "partial  
375 birth abortion" since in that case, the baby is only partially outside  
376 the Uterus? Or they will develop a procedure where the baby is  
377 brought to the breach and destroyed immediately before, say, by  
378 injecting the baby with some poison while technically in utero, and  
379 then delivering the baby, which is left to die after it is brought out  
380 of the birthing canal. You see what I mean?

381 Third, as we know, liberal courts are adept at reading contradictory  
382 statements in law in a manner allowing them to find wriggle room  
383 to get around the obvious sense of the language—and so it is not at  
384 all hard to foresee some wicked judge using statements made  
385 earlier about protections against incriminating some one for  
386 perinatal destruction of the child earlier in the text as qualifying or  
387 modifying the meaning of the language here.

388 In other words, what can be considered a "cause that occurred in  
389 utero"? How about a statement by the mother that she does not  
390 want the baby, or even after the fact, declaring she does not want  
391 the baby—even if it is because someone offered to pay her ten  
392 thousand dollars for the child to harvest it for organs — IF YOU  
393 THINK I'M KIDDING YOU, YOU HAVE NOT BEEN PAYING  
394 ATTENTION TO WHAT WHAT'S GOING ON OUT THERE.

395 This is bad law. 1. It extends the mother's right to choose to kill her  
396 baby beyond viability to full term, 2. It creates a situation where a  
397 mother, or doctor, or other medical practitioner, or, actually,  
398 anyone whose actions or omissions result in the death of the baby  
399 can NOT BE PROSECUTED by LAW, and I see nothing in this bill  
400 that expressly provides an exception for intentional murder  
401 throughout the *perinatal* period which does extend up to one  
402 month after birth, 3. Because, the language apparently limiting this  
403 provision to things that occurred in utero does not specify the  
404 "occurrence" of the mother deciding ex post facto that she does not  
405 want the baby, so long as the "decision" is argued to have reference  
406 to something, anything, that happened while the baby was in utero.  
407 We've already seen how some courts interpret law in this  
408 ridiculous fashion, and no "state actor" is going to risk being  
409 prosecuted for "violating a woman's reproductive rights," by  
410 attempting to prosecute such a case.

411 Call your state representatives and urge them to vote NO on this  
412 horrible anti baby, anti family, antiCHRIST bill.
