- 1 Segment.01 Hello. I'm Dr. Jerry Scheidbach, pastor of the
- 2 Lighthouse Baptist Church in Santa Maria, CA—and your brain
- 3 masseur—get ready for your brain massage.
- 4 Another look at the Convention of States approach to address our
- 5 problems with the Federal Government! Federal government has
- 6 become the King George of our generation and the tensions
- 7 between government overreach and oppression and the liberty of
- 8 Americans has risen close to the boiling point—will we be pushed
- 9 into a second armed revolution for our rights, or did the genius of
- 10 our Founders provide a way to make the corrections necessary to
- 11 bring government back UNDER THE PEOPLE in Article V?
- 12 But first, an important and related issue—the effort to use
- 13 Transgenderism to complete Obama's call to "fundamentally
- 14 transform America." Beginning with his declaration that "America
- 15 is NO LONGER A CHRISTIAN nation—long and meaningful
- 16 pause—at least not just ..." with his own rail-roading into law
- 17 Obamacare which had as it's primary purpose, or goal, to provide
- 18 government subsidized health care for the homosexual community
- 19 who were being barred from coverage on the ground of their risky
- 20 behavior and pre-existing conditions.
- 21 My friends, one of the most important Brain Massage® episodes is
- 22 about to blow your mind wide open to truth!
- 23 [TRUTH]
- 24 Currently, the LGBTQ community has practically taken over our
- 25 schools and it appears they have conquered natural prejudice
- 26 against their unnatural behavior. Their counter-nature ideology
- 27 has prevailed over man's instinctive resistance to their blatant

- 28 contradiction against nature, and their rebellion against nature's
- 29 GOD.
- 30 But this is an illusion carefully crafted by a small minority of very
- 31 wicked and satanically inspired people. Instigated by the
- 32 radicalized among the so-called gay community not all who
- 33 practice homosexuality agree with the "gay agenda" it's a mixed
- 34 bag of homosexuals and, by the way, I get into issues with some
- 35 of my dearest friends who chastise me for using this word,
- 36 homosexual, instead of what they consider to be the biblical word
- 37 *sodomy*. So, let me address that briefly.
- 38 First, in fact, the Bible does not use the words *Sodomite*, or *sodomy*.
- We get derive these words from the account in Genesis 18 where
- 40 the men of a city called Sodom, demanded to know Lot's male
- 41 visitors—and you know what I mean by know but in case you
- 42 don't, these men of Sodom were demanding Lot deliver his male
- 43 guests to them so they could use them sexually—so we call this
- 44 behavior *sodomy* and those who practice it *Sodomites*.
- 45 Over time it came to refer to one specific sexual act where a man
- 46 uses another man in the manner the Creator designed for a man
- 47 and a woman to come together—so we called this behavior
- 48 sodomy.
- 49 Not all homosexual behaviors are limited to that one act. Biblically,
- it is a SIN for a man to lay with a man in the manner prescribed by
- our Creator for a man to lay with a woman (Leviticus 20:13): "If a
- 52 man also lie with mankind, as he lieth with a woman, both of them
- 53 have committed an abomination...."
- 54 For those who object that I left off the penalty, that both of these
- 55 men should be put to death under the law, I remind them that
- Jesus did not cast stones at the woman taken in adultery although
- 57 Moses law required that penalty, and that nowhere in the New
- 58 Testament are we given such instruction—instead, of they are

59 brothers, we remove them from our fellowship and turn them over 60 to Satan for the destruction of their flesh (I Corinthians 5:5), if they 61 are among the lost, we declare the GOSPEL to them, warn them of 62 the judgment to come and leave their temporal judgment to GOD—this temporal judgment is declared in Romans 1:27, "And 63 likewise also the men, leaving the natural use of the woman, 64 65 burned in their lust one toward another; men with men working 66 that which is unseemly, and receiving in themselves that 67 recompence of their error which was meet." In context, we learn that God declares this condemned behavior is practiced also by 68 69 women—of course they don't commit sodomy in they way we now 70 understand that word, but they "change that natural use into that 71 which is AGAINST NATURE." That's verse 26 of Romans 1. The 72 next verse, the one I quoted a moment ago, where it talks about 73 men with men working what is unseemly, and for this receiving in 74 them, that is, their bodies, the DIVINELY APPOINTED FITTING 75 RECOMPENCE for their error — that is, the recompence was 76 fitted to their behavior — and it begins "AND LIKEWISE ALSO 77 the MEN ... " or, in other words, what these men and women do is 78 UNNATURAL — it's a departure from the natural use — or it's contrary to the DIVINE DESIGN of the CREATOR. 79

- So, the behavior we are talking about is biblically referred to as *men* with men and women with women which is homo—same—sex—gender—attraction. The word homosexuality means same sex relations, and that covers it all, whereas the words sodomy and sodomite are today restricted to a specific behavior that occurs between men only. Anyway!
- Years ago, after some deep research into the movement launched by the raid of a popular same sex bar in Greenwich Village in New York in 1969, called the Stonewall Inn, which was followed about a decade later, 1981, with the outbreak of GRIDs — Gay-Related Immune Deficiency sickness, later, for political reasons under the

aggressive demands of homosexuals, it was dubbed HIV-AIDS — I became concerned about how this disease was spread and so did a deep dive research project. During this research, I learned that a wide variety of diseases were associated with homosexual behavior, some that are unique to that population and others greatly exacerbated by the behavior—the picture that emerged was deeply distressing, it was as if NATURE ITSELF was condemning the behavior. It made me think of Romans 1:27, I quoted it earlier; it says this behavior triggers the revulsion of the Creator and the rebuke of nature.¹

And here is the point—any culture than can willingly embrace this unnatural behavior provokes our Creator and invites nature's rebuke. It is unnatural—and it's a transgression of God's law. Transgression of Divine law opens the door to EVIL—and we are flooded with EVIL in our land that is pouring in through this transgression. And the thing about evil is that it does not touch only the guilty—it touches the innocent also. Furthermore, it corrupts the soul—see this mother holding her child on her lap at a Tranny show where men dressed as women gyrate suggestively and behave unseemly with children placing dollars in their pants—the sort of thing wicked adults do for entertainment—something even one of their own, that is a practicing homosexual said was inappropriate, rebuking these foolish parents who take their child to such an event, rebuking their perverse conscience saying they would not think of taking their child to a strip bar and encourage them to participate in the "show," but they will do it at a gay bar, or

- 117 a venue allowing for this sort of display—SICK, WICKED, AND
- 118 EVIL LOVING PEOPLE drink in their own shame!
- But, it's not enough for their own soul to embrace such perversity;
- they expose their children to it.
- 121 And we live in a society today where child protective services
- 122 would take a child from her home if parents object to her
- 123 recruitment by schoolteachers and other school personnel to hate
- the gender God made her and encourage her to desire to be a man
- instead—but the same would never bother a parent who takes their
- small children to a perverse display of homosexual activity—
- 127 So we've allowed murdering babies in the wombs of their mothers
- 128 since 1973, feeding our children to Moloch, and now we are
- 129 feeding our children to Baphomet the Judas goat the gender-
- 130 and-species blended (male/female, man/animal) homage to
- 131 Alexander the son of Satan, the prince of this world, by whom he
- once gathered all the kingdoms under his power.² Having lost his
- kingdom to JESUS the CHRIST of GOD, Who cast out the "prince"
- of this world" and banished him, so that now he is "prince of the
- power of the air," who now works in this world by the spirit of
- 136 ANTICHRIST through the children of disobedience—the ragers—
- 137 those who hate even the idea of CHRIST RULING THE EARTH —
- 138 sends his "Judas goats" into the world to "lead the sheep to
- 139 slaughter..." but these GOATS cannot lead the CHIEF
- 140 SHEPHERD'S SHEEP for they hear only HIS VOICE and
- 141 FOLLOW HIM —
- But the lost sheep are easily duped and they giggle at the gyrations
- of the Judas goats, they snicker at their perversities, and unnatural
- behaviors that defy nature and nature's GOD, fascinated by their
- open defiance to the CHIEF SHEPHERD they carry even their own

- 146 children to sacrifice their innocence, their human dignity, and
- 147 distort their natural instincts, damage their soul's conscience, and
- 148 make them FOOD FOR THE ROARING LION who seeks to
- 149 devour them.
- 150 To conclude this segment, which is intended to prepare you for a
- proper discussion of whether this is a time to call for a convention
- of states—first, understand that only a very small minority actually
- 153 embrace this. The magnifying glass of corporate media, including
- 154 FOX, makes it appear larger than it is. Only a bit over 3% of the
- 155 population practices homosexual behavior, a significantly smaller
- 156 percentage go into the tranny movement, and only a handful of
- very perverse straights endorse the outlandish behavior put on
- display right now. But there are a great many cowards today, and a
- 159 great many that are following Satan's Judas-goats to their own
- destruction because they want to be popular, "in with the in-
- 161 crowd," hip, cool, fashionable, moving with the trend—not
- 162 realizing the trend is merely a fabrication of Satan controlled
- 163 media. What would the spirit of Antichrist do with an opportunity
- 164 to re-write the Constitution? Hold on through the break! I'll be
- 165 right back!
- 166 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
- 167 at the Lighthouse, your brain masseur, and Paul Revere's lantern
- lighter, lighting the lamps in the church belfry arch, signaling the
- 169 enemy is on the march, an enemy that would steal from us our
- 170 liberty.
- 171 There is growing interest in agitating for the states to invoke
- 172 Article V that provides a way for the people to essentially fire the
- 173 Congress, at least to overrule it, and make amendments to the
- 174 Constitution that will, ostensibly, FORCE GOVERNMENT TO
- 175 BECOME ONCE AGAIN OF, BY, AND FOR THE PEOPLE.
- We now KNOW that Congress will never impose term limits on
- 177 itself. I agree with DeMint, that NO ONE SHOULD BE IN

- 178 CONGRESS FOR 20-30 YEARS.3 We now know Congress will
- 179 never limit their power to TAX and SPEND us into oblivion. We
- 180 know that Congress will never give up their ability to provide
- 181 EXEMPTIONS to themselves from the laws it passes on the people
- like the Pelosi loophole allowing her family to exploit INSIDER
- 183 TRADING opportunities, and exempting themselves from
- 184 Obamacare. Article V was written for such a time as this when the
- 185 PEOPLE are being OPPRESSED by BLOATED GOVERNMENT
- 186 INTRUSION into virtually every facet of our lives. But, is this the
- 187 time to use it? Let's talk about that, or at least get the conversation
- started. Here is a resource to help you get started.⁴
- 189 Let's begin by pulling out my Pocket Constitution and reading
- 190 Article V. "The Congress, whenever two thirds of both Houses
- 191 shall deem it necessary, shall propose Amendments to this
- 192 Constitution, or, on the Application of the Legislatures of two
- 193 thirds of the several States, shall call a Convention for proposing
- 194 Amendments, which, in either Case, shall be valid to all Intents and
- 195 Purposes, as Part of this Constitution, when ratified by the
- 196 Legislatures of three fourths of the several States, or by
- 197 Conventions in three fourths thereof, as the one or the other Mode
- of Ratification may be proposed by the Congress; Provided that no
- 199 Amendment which may be made prior to the Year One thousand
- 200 eight hundred and eight shall in any Manner affect the first and
- 201 fourth Clauses in the Ninth Section of the first Article; and that no
- 202 State, without its Consent, shall be deprived of its equal Suffrage in
- 203 the Senate."
- 204 It provides for amending the Constitution, and the part we are
- 205 particularly interested in is the provision allowing the PEOPLE to
- 206 bypass Congress and call a Convention of States.

- 207 Sometimes this is called a "Constitutional Convention," and often
- 208 abbreviated as Con-Con. Many calling for the states to invoke
- 209 Article V are sensitive to the concerns some have that a
- 210 Constitutional Convention will allow the possibility that the entire
- 211 Constitution can be re-written and totally destroyed. So they prefer
- 212 to refer to this as a Convention of States. But the fact is,
- 213 Constitutional Convention is perfectly appropriate, first, because it
- 214 is an action afforded to us by our Founders IN THE
- 215 CONSTITUTION, so it is CONSTITUTIONAL. And second, it is
- 216 about AMENDING the CONSTITUTION, which makes in
- 217 CONSTITUTIONAL. And third, the concern is a legitimate one,
- 218 recognized as valid by none other than Justice Antonin Scalia.
- However, Scalia also said he thought the danger of that happening
- 220 is minimal, and the risk reasonable.
- 221 That is because while it requires 2/3 of the states to trigger Article
- 222 V, whatever amendments are passed by the convention must be
- 223 ratified by 3/4 of the state legislatures or state conventions. That
- 224 meant it takes 34 states to invoke article V and 38 states to ratify
- 225 whatever amendments are passed in the convention. We will look
- 226 more closely at the ratification clause in a moment.
- Here is how this would look. The legislatures of at least 34 states
- 228 would have to independently call for a convention of states. And
- 229 right away we have one of the hurdles we face getting this done.
- 230 EVEN THOUGH THE CONSTITUTION DOES NOT
- 231 STIPULATE the states must all apply for a convention for the same
- 232 reason, or to address the same concerns, THAT IS WHAT THOSE
- 233 WHO HAVE INTERPRETED IT HAVE DECIDED MUST BE
- 234 DONE.
- 235 So, right off the starting line, a CONGRESS and JUDICIARY, (the
- 236 executive is not part of this proceeding) but the CONGRESS and
- 237 JUDICIAL branches, jealous of protecting their power OVER THE
- 238 PEOPLE, impose an UNCONSTITUTIONAL barrier by asserting

- 239 34 states must agree on what topics they want addressed at this
- 240 convention. This is the reason that we have had as many as 41
- states call for a convention, and over 475 applications from one or
- 242 more of these 41 states have been sent to Congress BUT
- 243 CONGRESS, UNDER THE PROTECTION OF JUDICIAL
- OPINION, has REFUSED to invoke Article V.
- I see NOTHING in the Constitution that requires the 34 states to
- 246 apply for a convention in the same or equivalent language, or for
- 247 the same reasons or concern. THEY MADE THAT UP! It's not in
- 248 the language. You see, to these wicked rulers, it does not matter
- 249 what the Constitution says, or does not say, what matters is who
- 250 has the power to decide what it means.
- To explain how they get away with this, consider. There is, as Scalia
- 252 himself observed, a possibility that triggering a convention of states
- 253 COULD lead to a rewriting of the entire Constitution, even a
- writing away of our 1st and 2nd amendments. He did not think it
- 255 was a likely concern because it does not seem likely that the
- 256 necessary 38 states would agree to ratify any amendment so radical
- 257 that effectively erased our 1st-10th amendments. But I beg you to
- 258 pause and consider the political environment we are in right now.
- 259 Does anyone doubt that is exactly what use would be made of a
- 260 convention of states where the agenda was not expressly limited?
- And this is the problem. Some states have applied for invocation of
- 262 Article V for expressly limited concerns, and stipulated this clearly.
- 263 This is because they don't want an open forum to rewrite the
- 264 Constitution. This is how the Congress has been able to refuse to
- 265 call for a convention of states and claim there are not enough states
- in agreement about what to address to qualify.
- 267 But there are 31 to date, there are 31 qualifying applications,
- three more will trigger Article V.
- 269 But that is not the only hurdle we face.

- 270 Then comes the selection of delegates. Will the States Legislatures
- 271 appoint citizen delegates, or will the states vote on citizen
- delegates? If the delegates are bound to act merely as proxy to the
- 273 State Legislature, there is little point in voting for citizen delegates.
- 274 So while it removes the power from our Congress, and invests this
- 275 power in the hands of the State Legislatures, you see what a
- 276 situation we have in California. So far there are more red than blue
- states, and no matter how many delegates are sent, each state gets
- one vote, so it is hopeful that the amendments passed would be
- what is truly needed to straighten out this mess.
- Here they are. First, TERM LIMITS. Second, TAX LIMITS. Third,
- 281 SPENDING LIMITS. Fourth, BORROWING LIMITS. Fifth,
- 282 barring Congress from exempting itself from laws they pass on the
- 283 citizens: like insider trading, sorry Pelosi and your drunkard
- family; or how they exempted themselves from Obamacare, as two
- of many examples.
- 286 So, suppose these get passed out of Convention and sent to the
- 287 States for ratification.
- 288 The Ratification provision offers two paths. State Legislatures may
- 289 ratify the Amendments, or Conventions called by the States for this
- 290 purpose. The Congress decides which mode will be used. This
- 291 could get stalled in Congress forever. Filibuster, or procedural
- devices might be used to keep a vote from the floor, all sorts of
- 293 wicked machinations by these wicked people could be, and almost
- certainly WOULD be used by these jackals.
- 295 This second procedure, ratification by a convention of delegates
- 296 was used to pass the 21st amendment, which repealed the 18th.
- 297 This was to allow the Legislatures political cover from blowback
- over this action. I'll examine this action later as an example of how
- 299 YOU WILL NOT ELIMINATE POLITICAL INTRIGUE by
- 300 invoking Article V you will agitate the wicked into egregious
- 301 efforts to use it to TAKE away our LIBERTIES.

I'm not saying we should not invoke it for fear of what liberals will 302 303 attempt to do with it — truth is if we don't do something, we are headed straight into a break up of the Union and or a second 304 revolutionary WAR. Article V is certainly preferred to open war in 305 our streets—it provides for the PEOPLE to exercise their RIGHT 306 OF REVOLUTION without the necessity of taking up arms. But 307 308 you had better be prepared for serious political war — because, as much as I admire Jim DeMint, his statement that, "This should not 309 310 be a partisan, left-right, Democrat, Republican issue. This should 311 be a who controls your life issue—You, or the Government," is 312 naive. Everything is a right versus left issue, everything is about 313 political power of this or that party, everything is about DEEP STATE versus the PEOPLE, and one side will make certain this 314 315 issue will be cast as a them versus us fight to the mattresses.

I've got more to say on this; we will kick it around during tonight's 316 live visit — for now, let me conclude by explaining what is 317 ultimately what makes all of this a NON STARTER. Until we 318 restore ELECTION INTEGRITY, none of this matters. So long as 319 those devils can steal our elections, THERE IS ABOSLUTELY NO 320 321 RECOURSE LEFT — please, I beg you, hear me now — it's ballots 322 or bullets. One side knows that, and they have taken our ballots 323 daring us to turn to our bullets. Don't fall into that trap! DEMAND 324 THE MACHINES BE REMOVED FROM OUR ELECTIONS AND 325 THE LAWS ARE OBEYED. Restore election integrity, and THEN, 326 and I'll explain more later, but THEN will be the right time to 327 move on Article V — and BRING THIS GOVERNMENT BACK 328 UNDER THE PEOPLE, and hopefully, the PEOPLE will II 329 CHRONICLES 7:14 our way BACK UNDER GOD.
