- 7 CA Konnech, Wisconsin's Racine County, the vulnerability of our
- 8 voter registration database and government portals for overseas
- 9 voting—we've got a lot to be concerned about and this WAR for
- 10 our right to VOTE in a fair, honest, open and transparent election
- 11 is far from over. And I'll read the LIGHTHOUSE BAPTIST
- 12 CHURCH DECLARATION to Gov. Newsome, SOS Padilla, Pelosi
- 13 and Carbajal. And ...
- 14 You know what, I've got so much here, I can tell you right now we
- 15 won't get through it all so let's get started:
- 16 It's time for your Brain Massage®:
- 17 [TRUTH]
- 18 Election 2022 "They" want to make it about their hatred for
- 19 Trump! "We" want to make it about our love for America! Today
- 20 I'll offer my Election 2022 assessment and predictions.
- 21 I've often explained what I mean by "they" and "we" in brief, and
- 22 in my immediate context, you probably think I believe they are
- 23 those who believe in protecting a fabricated RIGHT of a mother to
- 24 CHOOSE to murder her baby while in the womb. You likely think
- 25 I believe "They" are identified as those who believe, or at least
- support the belief, that a man can be a woman by the mere choice
- 27 to be one, and a woman can be a man by merely choosing to be

- one. My guess is most of you suppose by "They" I'm talking about
- 29 those who believe calling someone by their preferred pronouns is
- 30 the polite and supportive thing to do. My guess is many of my
- 31 listeners think by "They" I mean those who believe human behavior
- 32 is driving climate change and that the government medical
- 33 establishment is looking out for our best interests and would never
- 34 lie to us about masks and vaccines and stuff like that. Many likely
- 35 think by "they" I mean to identify those who think open borders
- 36 are the "Christian" thing to do, you know, entertaining strangers
- and so forth, or that "they" refers to all who believe in and support
- 38 policies purported to make it as easy as possible to vote, even if the
- 39 policies admittedly create vulnerabilities that we know have been
- 40 exploited by some who want to steal our elections. I could go on,
- 41 but I think you get the idea.
- 42 Some of you will be surprised to hear me say that while I strongly
- 43 disagree with all of that—the "they" and "we" paradigm is not
- 44 divided between those who believe all that nonsense and those of
- 45 us who don't.
- 46 What actually divides us is the sad truth that those who do
- 47 subscribe to the nonsensical notions I mentioned unfortunately are
- 48 generally also those who believe WE DO NOT HAVE A RIGHT
- 49 TO OUR OWN OPINION if it disagrees with theirs. They
- 50 believe they SHOULD "Cancel" us, remove us from the debate,
- 51 deny to us the divinely appointed rights of free speech, free
- 52 assembly, the right to "redress our grievances," and even our
- 53 RIGHT TO VOTE.
- 54 When "they" encourage policies that facilitate voter fraud, they are
- denying to us our right to vote. Consider the second amendment
- issue as an example. You'll need to follow closely.
- 57 They think guns are dangerous and that if you limit the number of
- 58 guns in the hands of the people you will lower the number of
- 59 violent acts committed by guns. No, really, "they" consistently

- 60 ascribe violence perpetrated by someone with a gun to the
- 61 existence of the gun itself.
- 62 So while they are forced to deal with the SECOND
- 63 AMENDMENT, which is the LAW of our LAND, and which
- 64 acknowledges our natural RIGHT of self defense extends to the
- 65 RIGHT to keep (own) and bare (carry) arms, they seek to
- 66 RESTRICT the exercise of that RIGHT in every way imaginable.
- 67 They have laid law after law after law upon us all intended to
- 68 CONTROL and RESTRICT our RIGHT TO KEEP AND BEAR
- 69 ARMS.
- Much of this is from the point of view that guns are dangerous, and
- 71 they must be kept and carried responsibly. We can debate that
- 72 later, but that is the rationale behind making laws that make it
- 73 difficult to exercise our inalienable right of self-defense that of
- 74 course is protected by the SECOND AMENDMENT.
- 75 Now, the Constitution provides to every American CITIZEN the
- 76 right to vote. This also is premised upon recognition that
- 77 governments derive their just power from the CONSENT of the
- 78 GOVERNED—something recognized by GOD and revealed to us
- 79 in Scripture. Israel was the only nation that provided for the
- 80 peaceful transition of power, and where GOD HIMSELF granted to
- 81 the people the liberty to choose their own leaders. This can be
- 82 shown throughout Israel's history but no where is it made more
- 83 clear than in His LAW of kings given by Moses in Deuteronomy 17
- 84 where He said, "thou shalt ... set him king over thee ..." and He
- 85 instructed them to identify among the people the man GOD shall
- 86 choose, and gave them specific criteria to guide them in their
- 87 CHOICE: a natural born citizen, who has demonstrated a life of
- 88 restraint, and character, who was God fearing since, according
- 89 to GOD, any who would rule over men must be JUST and rule in
- 90 the FEAR OF GOD but notice, God gave it to THEM to "SET" a
- 91 king over them if they chose to do so. Now read Hosea 8:4 where

- 92 God complained against Israel because for many generations they
- 93 "set up kings, but not by Me" He said.
- 94 So we have a GOD given right to exercise our FREEDOM to
- 95 "CONSENT" to Who will "rule over us." And we were warned
- about being careful about this matter. Anyone who has studied the
- 97 Scriptures will appreciate the seriousness of this matter, the
- 98 responsibility of this every time GOD moved to JUDGE a nation
- 99 for it's sins, HE pointed to the rulers as bearing the greatest
- 100 responsibility when He destroyed Israel, He pointed to the
- 101 wickedness of it's first king, Jeroboam. When He finally destroyed
- 102 Judah, He pointed directly to the wickedness of king Manasseh.
- 103 Who we choose as rulers in our land is without any contradiction
- 104 the number ONE most IMPORTANT decision we make in every
- 105 election.
- 106 And yet, when it comes to this Constitutional RIGHT, in the name
- 107 of "protecting" that RIGHT, "they" want to make it as easy to
- 108 exercise that right as possible. "They" want to make it as convenient
- as possible, to remove any and all things that could even imagine
- might be contrived to be an obstacle. And we have gone along with
- 111 that because, of course, we have no objection to every citizen of
- age, to join us in the exercise of this MOST IMPORTANT CIVIC
- 113 RESPONSIBILITY.
- 114 But, my friends, there is no Constitutional protection of
- 115 CONVENIENCE it is a RESONSIBLE right that requires CARE
- 116 to PRESERVE. Now, here is the point.
- 117 WE have a CONSTITUTIONALLY STIPULATED RIGHT TO
- 118 VOTE, but we do not have any Constitutionally stipulated RIGHT
- 119 to CONVENIENCE. Of course, we have no civic interest in
- making it unnecessarily inconvenient. And I certainly agree, that if
- 121 anyone attempted to construct a law that would make it

- 122 unnecessarily inconvenient, I would regard that an effort to
- obstruct the exercise of that right.
- When "they" make laws that unnecessarily restrict our second
- amendment rights, laws that only the law abiding will respect, such
- interference infringes upon our RIGHT of self-protection.
- 127 But the same "they" object to any law we recommend intended to
- 128 protect the point of our right to vote, to CHOOSE our rulers to
- 129 protect that RIGHT against having it stolen by thieves who abuse
- our election laws, even arbitrarily change them almost at a whim,
- and illegally, by the way, and establish laws that LITERALLY
- 132 BLOW A HOLE in the security and integrity of our elections, rules
- 133 that facilitate fraud, that actually aid and abet election fraud —
- 134 RULES THAT ALLOW THE WICKED AND UNSCRUPULOUS
- 135 TO LITERALLY STEAL our votes, to cancel our voice.
- 136 The RIGHT to VOTE is a serious civic RIGHT and
- 137 RESPONSIBILITY we must implement and enforce laws that
- will protect the sanctity of our right to vote! Rules and laws that
- protect access to the vote must be balanced against the greater need
- to protect the sanctity of the vote.
- 141 The reason the demoncrats can say, with a straight face, that 2020
- was the most secure election in our history is actually very simple.
- 143 It's what Biden said I don't need your vote they had 2020
- 144 virtually signed sealed and only waited for delivery Biden said
- they had constructed the most elaborate election fraud system in
- 146 history. And it was all done in the name of making elections
- 147 "convenient." Convenience to vote cannot be allowed to become
- 148 convenience to steal an election; convenience to the voter cannot
- 149 be allowed to make it convenient to steal our elections —
- 150 convenience of that sort will, and actually in the minds of many,
- 151 has made elections IRRELEVANT. It's become SELECTION Days
- instead of ELECTION DAY —.

- And, the dirty little secret is, "they" aren't actually interested in 153
- 154 making elections convenient.
- 155 We have called for Election Day to be declared a national holiday!
- This would give voters an entire day to exercise their right to vote. 156
- It would also give that day due recognition of its importance. 157
- 158 Election Day deserves to be recognized as a joyous day in which we
- 159 exercise the most IMPORTANT CIVIC DUTY of every citizen. As
- important as day as July 4th, Independence Day for it was 160
- Independence Day that established our RIGHT to CHOOSE all our 161
- RULERS a restoration of the RIGHT to "set up kings," or to 162
- 163 DEPOSE THEM — without resorting to violence.
- It's HUGE! But that's a "convenience" they resist. Early voting 164
- should be from 6 am to 9 am on ELECTION DAY. 165
- Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor 166
- 167 at the Lighthouse, your brain masseur, and Paul Revere's lantern
- lighter, lighting the lamps in the church belfry arch, signaling the 168
- 169 enemy is on the march, an enemy that would steal from us our
- 170 liberty.
- CA Konnech scandal, an election software producer that kept 171
- election poll worker data, and we later learned, other voter 172
- 173 registration data, on servers in CCP controlled CHINA — you
- know about that, right? The CEO of Konnech, Eugene Yu, was 174
- arrested and charged for this crime But did you know that in 175
- 2010 Konnech was contracted by the Department of Defense to 176
- create online web portals for FVAP.gov. This is the Federal Voter 177
- Assistance Program it's where Military and Overseas Citizens 178
- can go to VOTE. An Iranian whistleblower revealed how Iranian 179
- 180 hackers were able to access voter registration databases in
- 181 something like 40 states, no, here it says "over 40 states," and they
- 182 took that data and used it to create fake military ballots, and fake

- overseas ballots on this site. We have found folders containing
- 184 faked overseas/military ballots for forty states in the Alaska
- 185 folder alone there were found over 130k faked ballots. Here it is,
- 186 134,728 ballots. Maybe this explains how it is that overseas
- 187 balloting doubled from 2016 to 2020, and in some states almost
- 188 ALL military ballots went to Biden. The tool the Iranian
- 189 whistleblower used is downloadable from the Internet by anyone
- 190 it's called sqlmap and it's an injection tool used by hackers to
- test penetration into websites.
- 192 Here is a sample of the "THEY" approach to vulnerability
- 193 problems. Wisconsin's Racine County, a group of concerned
- 194 citizens formed Honest, Open, and Transparent Government —
- 195 HOT Gov. it's founder used the dob and name of the Mayor and
- 196 a State Assembly member, went into Wisconsin's MyVote site and
- 197 changed the registration address—their ballots were sent to him.
- 198 He took them, unopened, to the Sheriff, and the Wisconsin
- 199 Election Commissioner filed charges against him she said the
- action did not prove fraud, it only proved he committed a crime.
- 201 Later, in Wisconsin, a deputy director for the Milwaukee Election
- 202 Commission, allegedly, sent three military ballots to the home of
- 203 State Representative Janel Brandtjen, an outspoken critic of the
- 204 compromised election system in Wisconsin. She turned them over
- 205 to the Sheriff, and offered a statement saying she believed someone
- 206 was trying to point out how easy it is to commit voter fraud within
- the Wisconsin election system. This is possible because Wisconsin
- does not require voter ID or even registration for military to vote.
- 209 How did the Election Commission respond? They explained that
- 210 it's against the LAW to do this, and the fact that someone can
- 211 commit a crime does not mean the system is vulnerable.
- 212 Can you believe these people? Contrast their attitude toward the
- 213 second amendment and our right to vote. It's stunning, and it
- 214 always goes in one way toward INFRINGEMENT UPON THE

- 215 PEOPLE'S RIGHTS. We lose access to our second amendment
- 216 rights by government overreach passing restrictive laws that do not
- 217 serve to stop criminals from using guns to kill people but
- 218 actually facilitates it because it reduces the chances they will
- 219 encounter someone with the ability to defend themselves.
- And when it comes to elections, they refuse to pass common sense
- laws that protect the sanctity of our elections and that aid and abet
- 222 those criminals intent on stealing from the American people their
- 223 right to ELECT their representatives infringing on our sacred
- right to vote by CANCELING our vote with fake ballots.
- Okay, LBC moved in its capacity as the HOUSE of GOD, the
- 226 PILLAR AND GROUND OF THE TRUTH, holding the KEYS OF
- 227 THE KINGDOM, and being AMBASSADORS for CHRIST to
- 228 form a DECLARATION regarding election integrity to Newsome,
- 229 Padilla, Pelosi and Carbajal a local State Representative for our
- 230 district.
- 231 This was sent Monday evening I expect it arrived today. Here it
- 232 is!
- 233 "The Lighthouse Baptist Church in assembly with a quorum
- present, the members exercising their authority under Jesus Christ
- as by Him made kings and priests unto God, and by Him given the
- 236 keys of the kingdom, and in their official capacity as Ambassadors
- 237 for Christ, do solemnly declare:
- 238 Those who would rule men must be just, ruling in the fear of God
- 239 (II Samuel 23:3).
- 240 Upon this we call for the following that justice may be served:
- In view of the arrest of Eugene Yu, CEO of Konnech, an elections
- system software provider, and the revelations that said company
- 243 maintained sensitive election data on servers within CCP
- 244 controlled China in direct violation of their contract with LA
- 245 County, the church in assembly affirm:

The Konnech election systems software scandal arising from the arrest of Eugene Yu, CEO, collapses whatever confidence might have remained in CA elections, already burdened with questions about irregularities exposed in 2000 Mules, True the Vote, and Mike Lindell, et al.

Furthermore, the repeated reports of election fraud in CA elections, such as the recent arrest of a California city councilman, with six others, charged with election fraud in Compton,

The discovery of 300 recall ballots and multiple California drivers licenses in a felons car in Torrence, CA.

The San Fernando Valley scandal where multiple voters were informed by Election Officials that they already voted, and in Woodland Hills where election officials reported this was happening all morning on the day of the recall election.

In light of the fact that the above presents only a small sampling of the reasons for our concerns, all of which creates deep distrust in the most fundamental civic right of Californians, the right of consent in government, expressed through the fair, honest, right to vote:

We demand government officials charged with a fiduciary responsibility to protect this essential right do all things reasonable to insure our legitimate votes are not cancelled by fraudulent voters, or malfeasance on the part of election officials.

Therefore, the Lighthouse Baptist Church, in assembly with a quorum present voted unanimously to express a vote of NO CONFIDENCE in CA elections as currently conducted and demand the following remedies:

We call for automatic hand count of ballots for every race in the 2022 midterm election and as standard practice thereafter.

275 We call for full forensic audits of all voting machines used in 276 every election in the state of California. 277 We demand any company providing election software and/or 278 machines for use in CA elections be required to cooperate fully 279 with forensic examination of their machines and software, 280 including any routers attached to them in any way (wireless, or 281 otherwise), any memory sticks used, etc. must be made available 282 for examination by third party experts hired by a citizen's 283 commission formed by a bi-partisan select committee. 284 The above is to be implemented immediately for the 2022 285 election. 286 For every election following, we call for the following 287 additional measures: 288 We call for voter ID. 289 We call for paper ballots and same day voting. 290 We call for an end of mail in balloting, with the exception of 291 absentee ballots for military or shut ins. Those claiming a health 292 condition should have a doctor's signature similar to when 293 requesting a handicap placard. 294 We call for an end of universal mailing of ballots. 295 We call for an end of automatic registration. 296 We call for an end to ballot drop boxes. 297 We call for voter rolls to be updated by purging all non-active 298 voters leading into every major election. 299 We insist all responsible public officials act in good faith to 300 restore confidence by vigorously taking the above steps to insure a 301 fair and honest election in every county of this State. This is followed by a STATEMENT OF BIBLICAL AUTHORITY: 302

303 Jesus Christ is KING and all mankind are His subjects 304 (Matthew 28:18; Luke 19:12-23). 305 Jesus Christ is Head of the Church and has given to His 306 Church the "keys of the kingdom" (Ephesians 5:23; Colossians 307 1:18; Matthew 16:16-19). This gives to His disciples kingdom 308 authority to act in this world as ambassadors for Christ (II 309 Corinthians 5:20). 310 Jesus Christ assembles with His disciples when two or three 311 are gathered to exercise this kingdom authority (Matthew 18:20). Jesus Christ has made His servants "kings and priests unto 312 313 God" (Revelation 1:5-6). 314 Governments derive their just authority from the consent of the governed (Hosea 8:4). The PEOPLE derive their just and 315 316 inalienable rights from their Creator (Declaration of 317 Independence, the endowment clause) 318 Governments are instituted under GOD's ordaining 319 authority, which expressly limits their authority to act as "ministers 320 of God," divinely appointed agents dedicated to serve the best 321 interests of the people, which interests are first and foremost served 322 by protecting them from violence against their divinely endowed 323 rights, by executing wrath against those that do evil (Romans 13:1-324 6), as that word, evil, is understood within the historical context of 325 its use by our Founders and from within the context of the 326 Scriptures in which this declaration regarding the purpose, extent, and limitation of governments are stipulated. 327 As our Founders acknowledged, when governments turn 328 329 against the public good, and deprive the people of their God-given 330 rights, and fail to execute wrath against those that do evil, but 331 protect them, and turn the sword of civil justice against the 332 righteous, such have stepped out from under the protection of 333 divine ordination, become the enemy of GOD, and His Christ

- (Psalm 2) and joined themselves with those "powers" we are
- instructed to "wrestle against" (Romans 13:1, 4; see Ephesians
- 336 6:12—21). In other words, such no longer enjoy any appeal to
- divine right of authority to support their actions.
- We declare the command of God to all in public office, and in
- 339 private life, to repent before GOD and believe on the Lord Jesus
- 340 Christ (Acts 17:30; 20:21).
- We command all who would rule men to take heed to the
- 342 counsel of the Spirit of GOD through David: "He that ruleth over
- men must be just, ruling in the fear of God" (II Samuel 23:3).
- Thus, His servants at Lighthouse Baptist Church of Santa
- 345 Maria, CA met in assembly, deliberated on the above matter, and
- issue this declaration in Jesus' name, in accordance with our
- 347 authority under Jesus Christ.
- I have lit the lamps in the Church belfry arch and now you let me
