- 1 Segment.01 Hello. I'm Dr. Jerry Scheidbach, pastor of the
- 2 Lighthouse Baptist Church in Santa Maria, CA—and your brain
- 3 masseur—get ready for your brain massage.
- 4 My Christmas gift—one of them, is a tower of wooden blocks
- 5 stacked crosswise that rises a little over a foot tall. It sits on my
- 6 desk. It's a game where each player takes turns pulling a block from
- 7 the stack and whoever pulls the block that collapses the tower loses.
- 8 I wondered what I might do with this, and it occurred to me that
- 9 it's rather like the metaphor of the TOWER OF BABEL, that has
- 10 become a symbolic representation of Satan's effort to pull the world
- 11 together into a one-world-government out from under God and
- under the power of Satan in defiance of CHRIST.
- 13 So, I decided to set it up on my desk and each day, when I get to
- 14 my desk, I pull one block from the stack, and one day, I know, I'm
- 15 going to remove the block that will collapse the entire tower. It
- 16 encourages me because I know that every time Satan gains
- 17 sufficient influence in the world to pull mankind together into a
- 18 one-world government out from under God and in rebellion with
- 19 him, GOD intervenes and destroys the tower, and breaks the power
- 20 of Satan by destroying whatever structure or structures of rebellion
- 21 he is erecting in defiance to Christ today, it's the Deep State,
- 22 with its Swamp, and network of strategically placed children of
- 23 disobedience who operate under spirit of antichrist to carry out
- 24 Satan's designs in the earth to KILL, STEAL, and DESTROY. The
- 25 key operating principle is the LIE. These children of disobedience
- are the tower builders.

- 34 Today, the children of obedience are charged with the task of
- 35 taking down the Tower brick by brick, or block-by-block. God sent
- 36 His SON, Jesus, the CHRIST OF GOD, who planted in this earth
- 37 HIS CHURCH, the HOUSE OF GOD, the PILLAR AND
- 38 GROUND OF THE TRUTH, and equipped His disciples with the
- 39 armor of GOD and the SWORD OF THE SPIRIT, which is the
- 40 TRUTH, the WORD of GOD, also likened to a HAMMER, and
- 41 with it, in the NAME of JESUS, we assault the tower built by lies
- 42 and bring it down, block by block so every day after my
- devotions, I come to my desk, and remove another block, and pray
- 44 for the day this current effort to pull the world out from under

- 46 Cause, that's how it works, my friend. It seems to be moving so
- 47 slowly, and it appears no matter what we do, no matter how many
- 48 lies we expose, and how much TRUTH gets out the tower
- 49 continues to stand proud and arrogant against our efforts but
- one day, one day the last LIE supporting the tower will be removed
- and the tower will collapse—stay faithful and true!
- 52 Okay, my friends; it's time for your brain massage!
- 53 [TRUTH]
- 54 Doocey asked Biden about the classified documents he pilfered,
- and kept in his garage with his corvette. Biden explained, "well, the

- 83 got a slap on the wrist. What? Well, let me explain! He was
- 84 Democrat.
- 85 These documents are concerning Ukraine, Iran, and the United
- 86 Kingdom.⁴ Clearly, Biden removed these on purpose and with
- 87 purpose—Ukraine, Iran, and the UK hmmm!

- propaganda machine of the shadow government that has usurped
- power in America is being challenged.
- 164 All right—just about the time I think the exposure phase is done,
- and we can move to the EXECUTION phase, just about the time I
- 166 think, we have what we need, let's LOCK THEM UP —deeper and
- darker secrets are dislodged from the muck and come popping up
- to the surface! Hold on through the break. The Brain Masseur will
- 169 be right back!
- 170 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
- 171 at the Lighthouse, your brain masseur, and Paul Revere's lantern
- lighter, lighting the lamps in the church belfry arch, signaling the
- 173 enemy is on the march, an enemy that would steal from us our
- 174 liberty.

I learned some things today that challenged me to consider whether the threat we face to the people's right of free speech is the most concerning problem we face, or is it the people's right of consent—I think these are interrelated! - shot during discussions about whether it should be foisted upon
- 257 the public."11
- Really, I'm way past my time here and must close. Have you heard
- of Katherine Watt? See her substack here.¹² She is a paralegal who
- 260 worked with various small law firms handling mostly
- 261 constitutional cases for years and turned her legal research skills to
- 262 examining the question: what is with this nonsense going on with
- 263 COVID? Skilled at legal research and examining contracts, she
- 264 took a long and in depth look at the contract between the DoD and
- 265 Pfizer to produce, manufacture, provide and distribute a vaccine
- 266 ostensibly intended to treat COVID-19 disease. Recently, that
- 267 contract has been released via a FOIA request (read, demand).
- 268 The way the contract was presented to the public, however, is far
- 269 from what the documents actually reveal. To the public, the
- 270 contract was for Pfizer to provide a vaccine that "effectively
- 271 prevented SARS-CoV-2 infection ... and that met the safety and
- 272 efficacy regulatory standards of an FDA-EUA authorized or FDA-
- approved vaccine." [IBID]¹³ To finish today, I'll have to simply
- 274 make statements supported by documents footnoted in my show
- 275 notes. But, here is the thing.
- Way back in the forties and fifties, lawmakers began concerning
- 277 themselves with emergency powers for the presidency.¹⁴ But in
- 278 1983, under Reagan, the Public Health Emergencies section of the
- 279 Public Health Services Act, was great expanded to concentrate
- almost total dictatorial power in the office of POTUS in the event

- 281 he declared the nation was in a state of emergency. [IBID-
- 282 Katherine]. This law was written in such a way once an emergency
- 283 was declared, neither the courts nor the Congress could reverse it
- or interfere with the powers of the POTUS. [Of course, this is
- 285 unconstitutional—but neither Congress nor the federal court has
- 286 challenged. The fact is, Congress has no power to give away its
- 287 representative responsibility to anyone or any body—to leave the
- 288 people with zero representation!
- 289 Multiple Acts of Congress have moved us forward in the effort to
- 290 give the POTUS the same emergency powers he has in a war, or a
- 291 natural disaster to a declaration of a medical, or health
- 292 emergency.¹⁵ This is very dangerous, as we have witness these last
- 293 two going on three years. Every one can see a war, and a natural
- disaster, but the "invisible" enemy is another thing altogether. They
- 295 lied to us—repeatedly! This does not work for something like a
- 296 virus.
- 297 For example Jackson Brooks worked for a testing lab working
- 298 for Pfizer doing clinical trials on the Pfizer vaccine. She witnessed
- 299 they were not following proper procedures and protocols and
- 300 alerted her company. They were not interested. She alerted Pfizer,
- 301 and they were not interested. Assuming, since the contract was
- 302 with the government, the government would want to know the
- 303 vaccine was not being properly tested, she sent a message to the
- 304 FDA. She was fired the day after it was received—the FDA was not
- 305 interested?
- 306 She filed a suit, now referred as Brooks vs Pfizer and presented her
- 307 case. She alleged that Pfizer was not meeting the terms of its
- 308 contract with the Department of Defense. Assuming the contract,
- 309 as represented by Pfizer and the DoD to the public was the contract

- 310 Pfizer was fulfilling with the production of the vaccine. It came out
- in court that, surprise, that is not the case.
- 312 Pfizer presented their OTA that's a three letter word for cheat
- 313 the American people—it stands for Other Transactions
- 314 Agreements a category where agreements are made that by pass
- 315 the usual public protections for the public on pricing, competition,
- 316 access, including in connection with COVID-19 vaccines and
- 317 treatments. It allows the company to have a sort of private
- 318 arrangement with the government so that, in this case, Pfizer was
- 319 actually under NO CONTRACTED AGREEMENT to conduct any
- 320 clinical trials at all.
- 321 So, why put on the show of conducting a vaccine trial? Because the
- 322 people would not understand having zero scientific assurance of
- 323 the safety of the vaccine and would balk—and we all know they
- 324 wanted everyone to get the shot—this is VERY IMPORTANT to
- 325 them. On the other hand, knowing the shots were causing
- 326 problems in what preliminary trials were done on this technology
- 327 before COVID became a thing, they did not want to present
- 328 negative evidence and so, because the law requires for the FDA to
- 329 approve an emergency use authorization, the director must have
- 330 some scientific basis to make the authorization—IF AVAILABLE.
- 331 So if no such clinical trials are "available" because unfinished, or
- incomplete? The director can legally authorize the EUA.
- 333 Then we find this little statement in the contract with Pfizer that
- 334 explains what Pfizer creates will be for military and for civilian
- 335 uses.
- 336 And we find that the DoD insisted it be privy to all
- 337 communications between Pfizer and their contractors and other
- 338 bio companies and with FDA, or NIH, or any other government
- 339 agency —. In short, we discover that the DoD involved itself in a
- 340 controlling role throughout the process, and that the DoD exerted
- influence over FDA and other agencies to tow the line—and we

- find out that Pfizer is in bed with China, and that the DoD needs to
- answer some questions why they would contract with a company
- 344 so interconnected with the CCP to produce what is being talked
- 345 about, treated, discussed, as if it was a bio weapon packaged as a
- medical treatment. What is going on here?
- 347 At this point, this FOIA revelation simply raises these questions—
- but it might, it just might answer a lot of questions also. We'll see!
- 349 But just about the time I think we have found the bottom of this
- swamp, I discover that, nope, not quite yet.
- 351 Those who have taken the jab are no doubt beginning to become
- 352 increasingly concerned and nervous all these suddenly dead
- scenarios the literally hundreds of young people who have died
- of sudden onset myocarditis, the multiple reports of blood clotting,
- 355 and the slow drip, drip, drip of truth from the pharmaceuticals
- only as we squeeze them with all our might to get one admission
- 357 after another Okay, the vaccine does not protect against
- 358 GOVID, okay, so it does not actually reduce likeliness you'll get it,
- okay so it does not actually assure you wont end up in the hospital,
- 360 okay so Ivermectin does help after all, okay so it very likely did
- 361 originate in a lab, and okay, myocarditis is a problem associated
- with the jab, okay so blood clotting is associated with the vaccine,
- 363 okay this has got to stop. Some in the FDA are waking up to this
- 364 nonsense, those who knowingly participating in this are going to
- 365 be in so much trouble—those medical professionals who are
- attacking the doctors of conscience who bucked the system, do you
- 367 not see where this is going?
- The Nuremberg trials broke through some established assumptions
- and said, for one example, using the excuse you were just following
- orders does not excuse you from crimes against humanity.
- 371 The argument that, well, we had an OTA, and we were operating
- 372 under an EUA technically, according to the letter of this paper,
- 373 see, right here, you can't hold me accountable for knowingly

- 374 releasing a dangerous product to treat a disease 95% of those
- afflicted with it recover—I simply have to shut it down here so I'll
- pick it up Saturday night, Lord willing!
- 377 But those worried about this mess remember that GOD is greater
- 378 than every effort Satan might exert to destroy us get to a church
- where there is faith, get anointed with oil and have the elders pray
- 380 over you turn to GOD.
- 381 I'll be in my pulpit tomorrow and I'll see you in church.
