- 26 The value of a "summary judgment." What is a "summary
- 27 judgment"? A summary judgment is a court ruling in favor of one
- 28 party and against another party without requiring a full trial.
- 29 Summary judgments may be issued on the merits of an entire case,
- or on some particular issues germane to it.
- 31 I ran into a situation like this once. It was the worst possible
- 32 conditions for driving—it was morning, but the rain and fog made
- 33 it impossible to see and no sane person would drive their car
- 34 unless they absolutely had too, and then, slowly and with their
- 35 head lamps and running lights ON. I had to.
- I sat in my Celica, my lights were on, had my flashers on because I
- 37 thought it would help, but as I thought about it, I did not want
- 38 anyone thinking I was intending to remain parked there, so I set
- my blinkers indicating an intention to pull from the curb.
- 40 Straining to see, and listening, but all I could see was sheets of rain,
- 41 and all I could hear is the roar of the storm—so I pulled carefully
- 42 from the curb and CRASH.
- 43 This guy was driving in such weather, without his lights on,
- 44 destroyed the front end of my car. I asked him if he saw me, and he
- admitted he saw my lights, but he assumed I saw him coming.
- In court, the judge ruled in his favor—even though I provided the
- 47 weather report, and argued he was at fault for failing to drive
- 48 responsibly the judge said that there was no law requiring
- drivers to turn on their lights in rainy weather—this is way back in
- 50 the late 70s early 80s. So, he ruled summarily in favor of my
- 51 opponent and against me, on that one particular single fact—it
- was simple, for the judge. There was no law requiring drivers turn
- 53 on their lights in weather conditions that compromise visibility —
- 54 but there is a law against driving into traffic when another car
- 55 occupies the lane where you enter it. That was a summary
- 56 judgment the whose case was decided without consideration for

- 57 the details of the case, that did not matter to the judge, because to
- 58 rule according to law, in that case, meant ruling against common
- 59 sense. I could have appealed and would likely have prevailed, but
- 60 the cost in time and dollars it just did not add up! Funny how
- 61 these things work out! Within that same year, I was rear-ended by
- 62 some kid who was paying more attention to his girl friend than to
- 63 the cars stopped at a red light in front of him. His father owned a
- 64 body shop. We settled! But, anyway!
- When a universal law, or principle is clearly violated no matter
- 66 how the particulars of a case might line up on either side of a
- 67 question it may be summarily decided on the ground of that
- 68 universal law. As a king and priest unto GOD, and Ambassador for
- 69 CHRIST the KING of all the EARTH I intend to pass summary
- 70 judgment upon Fauci and the whole bunch.
- 71 There is no argument Fauci and friends can present that will allow
- 72 them to wriggle out of their share of responsibility for the millions
- 73 that died during COVID—
- 74 He encouraged and used his position in his government salaried
- 75 job (in excess of 400k per year, the highest paid bureaucrat in
- 76 America) he used his position to direct taxpayer dollars to fund
- 77 "gain of function research," conducted by Ralph Baric, at the
- 78 University of North Carolina labs in the Department of
- 79 Microbiology and Immunology. Their work involved manipulating
- 80 virus DNA to enhance infectiousness and lethality. The idea was to
- 81 "get ahead of evolution," or the competition trying to prepare
- 82 biological weapons they tell us it was for national security

- 93 the scandal revolving around Daszak's insistence the coronavirus

- 97 Wuhan and exercised oversight of the operations related to that

- 99 A Chinese scientist they call the "Bat Lady" a CCP virologist —

- created in the language of the policy statement, and he continued
- 114 the coronavirus enhancement research in the Wuhan lab —


