51 to be UNNATURAL.<sup>4</sup> What changed his mind—about both these 52 things?

53 While I'm on Rubin and chinking the armor of some notables, I 54 should point out that Rubin's mentor and close friend, and beloved 55 conservative, Dennis Prager, has also voiced support for this 56 lifestyle choice. 74 Or, how about you speak to your half-truth dodge of allegations
75 you watched torture take place while at Gitmo<sup>8</sup> and failed to report
76 it—in fact, the prisoner testified you laughed it off.<sup>9</sup>

Apprentice reality show, Stephanie Clifford (the given name of 103 104 porn star Stormy Daniels) was, by her own admission, angling for a spot on the reality show.<sup>10</sup> They met in 2006 at a golf tournament 105 in Lake Tahoe.<sup>11</sup> Daniels claims they had an affair, or a tryst—but 106 with a twist. 114 None of this came out publicly until 2011, when Clifford does a "kiss and tell" to In Touch Weekly-Trump's attorney, Michael 115 Cohen, threatens legal action on behalf of his client, and the article 116 is pulled. Then, late in Trump's campaign, Stormy threatens an 117 "October Surprise" — to go public with her story. Cohen, Trump's 118 attorney at the time, was working the problem. He secured a loan 119 on his house, and funneled the money to her through a 120 corporation called Essential Consultants. 121

122 Clifford signed an NDA (Non-Disclosure Agreement) in exchange for the 130k. This was late in 2016. She pulled her story from the 123 Daily Beast, and Fox News decided to shelve it - part of the 124 problem was that Daniel's story is convoluted. First, Clifford 125 126 admits she slept with Trump to get a spot on the Apprentice, but 127 she never got her spot. She cannot prove the allegation Trump 128 invited her to the Beverly Hills Hotel, or that Trump implied he 129 wanted to sleep with her, or that Trump offered to cast her for his show, or that — and this is the inexplicable part — she turned him 130

down for sex, implying that was the reason Trump called her backand said he could not guarantee a place for her on his show.

She was having sex with him to get the gig, it's offered to her for sex and she turns him down — and on top of all that, Trump is denying he ever had her in that natural way. [IBID 11].

the prestige he needed to represent his people and inspire them to freedom. He became a real estate tycoon, and, just as he planned, with this prestige he began speaking out against the CCP.
