- 25 The J6 videos "released"? Really? First, why did Elon give them to

- 30 And in the you've got to be kidding me department Biden

- 49 The Trans movement is insanity and empowering a rising
- 50 viciousness why are so many of these Tranny types, and
- 51 homosexuals so angry and paranoid? The pressure created by
- 52 acting contrary to nature is extreme, creates intense resistance to
- 53 reality but reality WILL NOT YIELD and this generates serious

- 106 Scears, Summer Elliott, and Steven Sherman, Zackery Crissell,
- 107 Wayne Niles, all of Elmira, Anthony Hawn of Holly Hills, FL,
- 108 formerly from Elmira, Kayla Montgomery of Olean; Aaron Labar
- 109 of Pittsburgh New York, and Ashley Shaffer city not named.<sup>4</sup>

- 110 New York has some of the weakest laws protecting minors from
- 111 sex traffickers—in the area of Elmira and these surrounding cities
- 112 there are a troubling number of reports of missing persons —
- 113 In a related article, "6 people face charges in child sex trafficking
- 114 and prostitution ring at Bronx hotel"<sup>5</sup> some former employees of a
- 115 Bronx, New York hotel.
- 116 And why has there not been a massive MSM blitz on this? Why are
- 117 there not multiple investigative journalists pursuing this story?
- 118 Why is the story an "untouchable"? I'll tell you why the pedos
- 119 have burrowed deep into our government!
- 120 Marjorie Taylor Green came out with evidence that the Bidens
- 121 have been involved in human trafficking in Russia and Ukraine.
- 122 So, let's conclude the first segment: have you read the
- 123 MarcoPolousa report? Garrett Ziegler, former Trump White
- 124 House staffer, prepared a 634-page report on Hunter Biden's
- 125 laptop.<sup>67</sup> He sent the report to 4,000 recipients, including every
- 126 member of the House and Senate, White House staff, the US
- 127 Attorney offices, and every contact found in the laptop.

- 135 So, you see what I mean? It's overwhelming! Believe me, I could
- 136 not get to all that is going on—the ENEMY has come in like a
- 137 FLOOD. God promised He would raise a banner against this
- 138 enemy. Remember, GOD shows up when His people are at the Red
- 139 Sea with an army bearing down on them with nowhere to go but
- 140 across the water. GOD shows up when Goliath stands in the
- 141 battlefield mocking the saints. But He always SHOWS UP, and He
- 142 always shows up ON TIME! However, you need to be ready to
- 143 follow when he holds out his rod over the sea, and support the
- 144 David's throwing their rocks.
- 145 The number one issue we face right now that's allowing all of this
- 146 boils down this, our ELECTIONS have been hijacked so let's
- 147 take a look at that issue on the other side of the break. Hold on, I'll
- 148 be right back.
- 149 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
- 150 at the Lighthouse, your brain masseur, and Paul Revere's lantern
- 151 lighter, lighting the lamps in the church belfry arch, signaling the
- 152 enemy is on the march, an enemy that would steal from us our
- 153 liberty.
- 154 In the first segment, I attempted to give you a sense of how
- 155 overwhelming it is trying to keep up with all that is going on right
- 156 now. I have been feeling this for some time, as I've noted
- 157 repeatedly. It's impossible to keep up with battlefield
- 158 developments. It's like trying to tread deep water in a storm
- 159 pushing 50 footers over your head every seventh wave. [Well, that's
- 160 a sort of a myth. Read this article to understand where that comes
- 161 from.<sup>10</sup> As a kid, we would count seven, but sometimes we would

use nine — and it was not a bad indicator of when to expect a bigone. Anyway...]

I hope you took my advice and took hold of GOD's promise
through Isaiah — "When the enemy shall come in like a flood, the
Spirit of the LORD shall lift up a standard against him" (Isaiah
59:19). The word translated *standard* here is *noosah* (**DDD1**)
which speaks of being made to flee, or put to flight, and not *nace*(D2) which refers to a banner, like a flag. The idea here is that the

- 170 SPIRIT OF THE LORD will make the enemy flee—he raises this
- 171 *standard* against him—that is, the enemy! The words are distant
- 172 cousins—I don't know, like twice removed, or something. It's
- 173 appropriate to say God sends a champion that scatters the enemy,
- 174 and it is reasonable to assume that champion will march under
- 175 some banner.
- 176 And like I said, at the end of segment one, we did not take the full
- 177 measure of the depth of this flood: for example, I did not touch on
- 178 the COVID vaccine front Dr. Jane Ruby put together a
- 179 devastating report showing the too coincidental to be coincidence
- 180 evidence that the current spike in cancer deaths is triggered by
- some EVENT, and the most likely EVENT is the mRNA vaccine
- 182 roll out.<sup>11</sup> The data is disturbing! First, this is something I
- 183 remember virologists expressing a concern about way early on.
- 184 Second, the rise in cancer cases tracks right along with the increase
- 185 in the vaccinated population, and is apparently a phenomenon
- 186 among the vaccinated. (Here is an article addressing the concern
- 187 the mRNA vaccines, introducing Spike Proteins into the blood,
- 188 might cause cancer. The author concludes in the negative, but
- 189 you'll understand why the concern after reading this article.<sup>12</sup>)

- 190 This week they are changing authorization for vaccines.<sup>13</sup> The
- 191 massive increase in cancers following the vaccine roll out does not
- appear to bother the FDA. Things have changed. Used to, the FDA
- 193 would shut down a vaccination program for only 50 deaths. Now,
- 194 with well over 19,000 preliminary reports of death among those
- 195 who received the COVID-19 vaccine, the FDA is ready to make
- 196 getting the jabs even easier, and to include more age groups.<sup>14</sup>
- 197 The FDA is literally working to facilitate Moderna and Pfizer-
- 198 BioNTech to get more people jabbed more quickly! To me, with all
- 199 I've researched on this, it seems as if they see the truth is getting
- 200 out there and people are becoming increasingly hesitant to take the
- jab. Do they want to get as many jabbed that are 6 months old and
- 202 up before their gig is up?
- 203 And in this notice from the FDA, they continue to play the
- 204 language game referring to these Moderna and Pfizer shots as
- 205 "authorized," I think purposely suggesting they are FDA
- 206 approved—when in fact, it's EMERGENCY USE
- 207 AUTHORIZATION and that is not, at least it did not used to
- 208 be, represented as FDA APPROVAL.
- 209 Maybe that's because saying they have EMERGENCY USE
- 210 AUTHORIZATION might create a problem, since, well, maybe no
- 211 one told the FDA that the EMERGENCY is OVER. Biden signed
- 212 Bill ending the Covid-19 national emergency April 10.<sup>15</sup> It had
- 213 been extended in February to end May 11, but Congress pushed it
- 214 forward a month.<sup>16</sup>

215 Dr. Ruby shares a video in which BioNTech founders show their

216 excitement to announce the launch of their mRNA vaccine as a

217 treatment for "cancer." While the FDA are pushing to make it

218 easier for people to get the booster shots—it just so happens that

219 we are experiencing a huge SPIKE in CANCER.

- 220 I don't know if this is just coincidental irony but it does seem
- 221 weird that we have some serious virologists expressing concern
- that the hyper production of Spike protein caused by some of the

223 mRNA vaccines can cause cancer problems, and after the roll out

of the vaccines we have a huge, this is not an insignificant spike in

- 225 cancer cases it's like double, one country reported a threefold
- increase it's so shocking it is impossible it is not linked to some
- event and now, the people who created the mRNA vaccine, the

founders of BioNTech, are practically giddy about using their

- 229 mRNA vaccine as a treatment for CANCER??? Does this not seem

- 252 Dominion.<sup>17</sup> Do you understand this case?
- 253 It's absurd. Dominion sued FOXNews claiming FOX reported on

the election scandal involving the machines PURPOSELY TO

- 255 HURT DOMINION.
- 256 It was a defamation case and that requires PROOF of MALICE. It's
- a bar very hard to reach, especially against a NEWS
- 258 ORGANIZATION.
- 259 All FOX did was re-report a news story already in circulation it
- 260 was NEWS, simple as that. If a news agency can be sued for every
- story it relates that could be perceived to cause damage to
- someone, or to some company, it would be impossible to report on the neuro
- the news.
- All the Russia Gate nonsense that went on for five years, if there
- 265 was ever a case for DEFAMATION against news agencies, Trump
- 266 has got one. Nothing is more obvious to any of us than that the
- 267 MSM maliciously repeated the Russian Dossier story for one and
- 268 only one reason: to hurt Trump, period!
- 269 But for FOXNews to relate a story circulating in the public domain
- about the vulnerabilities of the DOMINION voting machines, and
- 271 putting that story in the context of what the DEMOCRATS were
- saving about voting machines back in 2019, and get a load of what
- Warren, Klobuchar, and other said then: in a letter to Dominion,
- they raised concerns about "reports of machines 'switching votes,'

- 304 FOX is the fox in the Patriot's hen house. And by the way, I said
- 305 that several years ago! In fact, I have a Brain Massage out there in
- 306 which I presented the question relative to FOX do we have a

- 308 ridiculously early. That all by itself tells you where FOX was at on

- 313 The effort to stop TRUMP is so intense, these people are willing to

- 320 I'll touch on two of them, and you'll see why I'm concerned they

- 332 mothers. But the process by which we come to complete abolition
- 333 of abortion is disputed. Some say it must be fought state by state —

- 336 one.
- 337 Another way to compromise Trump's support base arises from
- 338 Trump's perceived soft on homosex position. Trump was the
- 339 President that appointed the first openly gay person to a cabinet-
- 340 level position.<sup>19</sup> A recent statement by Don Jr. indicating an
- 341 apparent cave in to the sin of homosex and the LGBTQ agenda —
- 342 with a sort of whatever you do in your personal life is your business
- 343 type approach, is potentially a problem for a significant chunk of
- 344 Trump's base. We'll see!
- 345 I've warned about this! I think Trump needs to pay attention to
- 346 what happened to Anheuser-Bush and some make-up company —
- 347 I forget the name. I can't understand any women supporting this
- 348 Tran movement—allowing men to call themselves girls and invade
- 349 their privacy even coopt their athletics. Now Trump is openly
- against this nonsense, but the level of anger being raised among
- 351 Christian Patriots, and the concern that the Sodomites are
- 352 gathering at Lot's door, will heighten concern about this issue.
