- 1 Segment.01 Hello. I'm Dr. Jerry Scheidbach, pastor of the
- 2 Lighthouse Baptist Church in Santa Maria, CA—and your brain
- 3 masseur—get ready for your brain massage.
- 4 MISSING OATHS, and a CULTURE of LIES.
- 5 I'm at 32k feet, examining the other side of clouds, returning from
- 6 a visit to Ham's Ark Encounter and Creation Museum in
- 7 Kentucky. If you have not been, make plans it's awesome! If you
- 8 have, and it's been a while, time to return! This is our second visit!
- 9 It's our 50th anniversary! We'll go to Arizona next, and then to
- 10 Monterey, before we return to settle back into our routines.
- 11 This will be a special show—I'll discuss three things. First, the
- 12 fascinating prophecy in Daniel that points to the transhumanism
- 13 movement we see developing right now. Second, the illegitimate
- 14 government operating in America right now and I'm not only
- 15 talking about a stolen election! Wait for it! And third, biblical
- 16 versus humanist culture and why American culture is in the virtual
- 17 toilet right now!
- 18 It's time for your BRAIN MASSAGE!
- 19 [TRUTH]
- 20 I'll pick up on my examination of Trump next week! We discussed
- 21 the LGBTQ thing last time. I'll address the "COVID war" and rush
- 22 to vaccinate next. I said at the beginning of this "they" were setting
- 23 a trap. These quacks knew the vaccine would not work, Birx said
- 24 so. And there's more! They set Trump up to take the fall but I'll
- 25 show why it will fail! Haman built gallows intended for Mordecai,

- 26 but GOD had other plans. (That might be a bit inside for some of
- 27 you, but I'll explain it next week.)
- 28 Today, I'm going to talk to you about something I think you will,
- or at least that you should find interesting, and deeply troubling at
- 30 the same time. Some of you are hearing Trump say he will be back
- 31 in the White House sooner than you think! Have you heard that?
- 32 He has said it repeatedly, and most people, it seems to me, don't
- know how to listen to Trump. He means it!
- We'll talk about the fact that the current regime in the White
- 35 House is totally illegitimate, and without authority, and I'm not
- only talking about the stolen election it's something else too;
- 37 you'll be "not surprised"! Know what I mean?
- 38 But first, anyone who thinks the patriots have no plan to stop this
- 39 train wreck orchestrated by the Deep State is mistaken. Whether
- 40 the plan works, well, that's up to GOD!
- 41 I pray every day, and often through the night no, really, through
- 42 the night, and one of the things I pray a whole lot about is for a
- 43 DIVINE INTERVENTION a Tower of Babel level capital I
- 44 capital N, T, E, R, V, E, N, T, I, O, N a major reach of the HAND
- 45 OF GOD from Heaven to Earth to shake down the latest version of
- 46 Nimrod's tower—the globalists dream of a one world
- 47 government—gathering the world together in defiance of GOD's
- 48 LAWS, to throw off the bands and cords of CHRIST the KING —
- 49 and GOD is COMING! The KING is COMING and the Tower
- will be destroyed and the enemy scattered.
- 51 Karl Schwab and his false prophet, Haarrari Youvall, and their
- 52 transhumanist dream of organic machines, humanoid-robots,
- 53 promising the next evolutionary leap from mere humans made in
- 54 the image and likeness of GOD to being little gods, fulfilling the
- 55 promise of Satan, but actually enslaving mankind by their
- technocratic despotism, erasing the "God-gene," breaking the male-

- 57 female binary, and destroying family units, ending humanity as
- 58 GOD designed it it's going to fail!
- 59 They cannot "mingle" the "iron" with the "clay" Daniel foresaw
- 60 this attempt to mix the machine with the man. It was depicted in
- 61 Nebuchadnezzar's dream image, when he noted the mixing of
- 62 "iron" with "clay": "And whereas thou sawest iron mixed with miry
- 63 clay, they shall mingle themselves with the seed of men: but they
- shall not cleave one to another, even as iron is not mixed with clay"
- 65 (Daniel 2:43). It's a very enigmatical verse, but as I have taught over
- 66 the years, some of these strange prophetic Scriptures will become
- 67 increasingly clear to us as we approach fulfillment.
- 68 Iron, the chemical element of Atomic number 26, with the
- 69 elemental symbol Fe, is, according to my onboard dictionary, a
- 70 material "much used ... in manufacturing, especially in the form of
- 71 steel." It is evident to everyone that machines are, in the main,
- 72 manufactured from steel, and the prophecy is that "they" will
- 73 attempt to combine this metallic humanoid with the fundamental
- 74 element of organic biologic life the seed of man is
- 75 represented by this business of "mixing iron" with the "seed of man.
- 76 But it will fail: "they will not cleave one to another," as a man and a
- 77 woman cleave and become one flesh they will fail to eliminate
- 78 the DIVINE DESIGN of PROCREATION. They will fail to create a
- 79 biologic machine. They will attempt it, and being deceivers, they
- 80 will fake it, but they will not achieve it. They will finally get so far as
- 81 to make an "image" talk, and demonstrate sentience—but it will be
- 82 an illusion.
- While Christ's SPIRIT is present to restrain the spirit of antichrist,
- 84 "they" will not succeed to set up the image of the Beast, or construct
- 85 their dark tower—WE ARE IN THEIR WAY! They know this!
- 86 And their hatred of us grows—but though the gallows they
- 87 construct are intended for us, GOD HAS ANOTHER PLAN!

- 88 More on this amazing prophecy from Daniel in an upcoming Bible
- 89 study at the LIGHTHOUSE. I teach on biblical prophecy Sunday
- 90 mornings at 9:30 AM.
- Now, about Trump's repeated statement that he will return to the
- 92 White House sooner than you think.
- 93 Biden officials are imposters who swear no allegiance to the United
- 94 States: get a load of this interview on Brighteon with Atty. Todd
- 95 Callender and assistant Lisa McGee.
- 96 Todd represents those disabled by the COVID vaccine. His
- 97 organization is called Disabled Rights Advocates and his website is
- 98 dradvocates.com. His firm represents cases on the question of
- 99 whether those receiving the vaccine become chattel, or property, of
- 100 Pfizer, or Moderna??? Contact them through his web site:
- 101 dradvocates.com. Also go to vaxchoice.com, advocating for
- 102 informed consent. Lisa researches issues related to informed
- 103 consent and the Pfizer, Moderna, Johnson and Astra jabs.
- 104 In this interview, they reveal a finding that Attorney General
- 105 Garland, Secretart Of Defense Lloyd Austin, do not have a loyalty
- oath on file. There is no properly filed record they have sworn
- allegiance to the Constitution of the United States.
- 108 If this is true, these officials are not legally holding power. You
- think it's a mere technicality that none of Biden's Cabinet members
- 110 have a legally binding oath of office on file with the Federal
- 111 Register?
- 112 The backstory: Todd and Lisa kept running into very strange
- things as they pursued research to support their cases filed to press
- 114 the question whether these mRNA vaccine patents actually create a
- 115 hybrid human that becomes property of the vaccine patent holders.
- 116 Yeah, this is a real thing, and a legitimate legal question that is
- raised by the language of the patents held for the mRNA vaccines.
- 118 Some of this I brought to your attention a bit back.

- 119 After Todd filed against the Department Of Defense, his team
- 120 noticed very strange conduct on the part of the DOD: for example:
- the DOD argues that the shots are outside public or civic scrutiny
- 122 or jurisdiction because they are weapons, military "counter-
- measures," against a biological attack.
- 124 As they pressed this, and the team became increasingly uneasy
- about the unconstitutionality of all of this, and the strong sense
- that persons in our own DOD were representing the interests of
- 127 foreign governments, namely, China, were involved in treasonous
- activity, which would be a violation of the oath of office required of
- 129 all Federal officers and military personal above a certain rank, Lisa
- decided to use the Freedom of Information Act (FOIA) to see
- 131 whether or not Mr. Austin (Secretary Of Defense) had registered
- under the foreign agents registration act, and this led to an enquiry
- whether he had a valid oath of office on file.
- 134 The DoD stalled! It took nine months to get the information. So
- 135 Todd and his firm were gearing up to sue, to compel the DOD to
- 136 release these records, and "we received notice from Mr. Austin,
- 137 and, astoundingly, the ENTIRE BIDEN CABINET effectively, to
- our very great surprise, we were notified that none ... have a valid
- oath of office on file. None had the affidavits of oath of office filed
- 140 with the Federal Registry.
- 141 Todd explained that this is a violation of LAW: 5 USC 3331 and
- 142 3332 Not one of Biden's Cabinet members had a valid oath of
- office on file with the Federal Registry they were ALL either
- 144 defective or missing entirely.
- Okay, so someone forgot to have their oath of office notarized —
- 146 but the ENTIRE CABINET?
- 147 Todd said without this oath of office on file, there is no other way
- 148 to prove there is a duty for this person support and defend the
- 149 Constitution.

- 150 And of equal concern, without this duly filed, they have NO
- 151 AUTHORITY TO serve UNDER THE CONSTITUTION.
- 152 This law comes out of the Civil War era.
- 153 The statute reads that if this is missing, if there is no NOTARIZED
- oath, or a sworn affidavit of oath of office on file, then ALL OF
- 155 THEIR ACTS ARE VOID AB INITIO (that means, from the start).
- 156 They become ACTORS, without actual authority.
- 157 This includes the VP.
- 158 So Todd's firm filed a Writ of Quo Warranto that is a demand to
- 159 SHOW YOUR AUTHORITY.
- 160 When you ask an officer to show his badge, or you take his badge
- number, you are asking for proof of their authority to act.
- 162 Todd filed their complaint, their writ of quo warranto, with US
- 163 Atty, Matthew Graves, assuming he had real authority to act. The
- 164 reason they did not file with the US ATTY GENERAL, Merrick
- 165 Garland, is that his oath of office is defective, not only is his oath
- not notarized, it shows no appointment date.
- 167 Then, by the time they sent this claim off to the US Atty, Lisa
- received notice that Matthew Graves also has a defective oath of
- office. It's like none of the se clowns have a bonifide oath of office
- 170 why? And why would the Federal Registrar be so neglectful and
- ignore this LEGAL REQUIREMENT?
- 172 BY THE WAY, THE US ATTY. GENERAL'S OFFICE IS
- 173 RESPONSIBLE FOR PROSECUTING THE 16 POLITICAL
- 174 PRISONERS.
- 175 HOW IRONIC that Oath Keeper founder and president, Rhodes
- was sentenced by these jackals to 18 years in prison for alleged
- 177 crimes against the Federal Government.

- 178 Todd's firm decided to do everyone, and they began getting
- 179 immediate push back. They testified they were sent on a rabbit
- 180 chase. Very early on, they said, "we realized something is very
- 181 wrong here."
- 182 Why would they not have their oath of office? Every appointee
- must file his or her oath of office with the federal registry either
- notarized or by an affidavit sworn under penalty of perjury. By law
- 185 this must be done within 30 days of their appointment. Is this
- merely a dereliction of duty, or is this on purpose?
- 187 How serious is this? Well, apparently, it's of sufficient concern to
- them to want to stop letting this information get out to the public.
- 189 RECENTLY FOIA HAS CLOSED THE FEDERAL REGISTRY
- 190 FROM FOIA REQUESTS. WHAT???? How can they do this?
- 191 Closed the door to protect the secrecy.
- 192 What about Trump's Cabinet? Todd and Lisa were told they could
- 193 not grant access to those because they are archived for his library
- and they will be released when processing is completed. You've got
- 195 to be kidding me?
- 196 As the team continued digging around, they discovered this is
- 197 RAMPANT throughout the government. And after further
- research, they figure it probably goes back to 1963. In that year, the
- 199 Communist Manifesto, called the Naked Communist, was read
- 200 into the CONGRESSIONAL record. In that manifesto, the
- thirteenth agenda item of the Communist Party's plan to destroy
- 202 America was to ELIMINATE the OATH OF OFFICE.
- They do not want the conscience bound to any oath.
- 204 Later that year, Kennedy was assassinated November.
- 205 Todd and Lisa claim they are finding this throughout the Federal
- 206 Govt. almost every key player in the Deep State does not have a
- legal oath of office on file with the Federal Registry.

- 208 Even in the military, officers 06 and higher are missing their oaths
- 209 of office: in the military? Really?
- 210 Even the federal courts are affected. The Chief Justice of the US
- 211 District Courts, James Bolsberg, has a defective oath of office on
- 212 file. Todd and Lisa say they are having a difficult time finding a
- 213 court presided over by a judge who has a proper oath of office on
- 214 file!
- 215 The most common problem is the oath is missing notarization, or
- 216 sworn affidavit. In many cases the language of the oath is
- 217 changed—did I mention that the language is a subject of statute,
- but they substituted in their own stuff; it's like they are adlibbing
- 219 their oaths of office.
- And, another "by the way," a ceremonial swearing in DOES NOT
- 221 COUNT LEGALLY, IT'S A FORMALITY. So when Myorkas was
- 222 challenged to present his writ of quo warranto proof of
- 223 authority and the Federal Registry stalled, and his office
- 224 hemmed and hawed and they finally got a response an AP
- 225 article covering his swearing in ceremony that does not count.
- 226 The fact is, this Satanist has no oath of office on file with the
- 227 Federal Registry—NONE!
- 228 Kamala swore them all in. Every one of them switched the wording
- 229 on the verbal reciting; she used an incorrect, inaccurate oath. I
- 230 think Todd said she made the oath a question rather than a
- 231 declaration? Maybe it was Lisa.
- Now, we know these people are incompetent but is there no one
- 233 anywhere in the Bureaucracy that knows what the rules are and is
- superintending this? Here is something I know about bureaucrats
- 235 they are bull dog fastidious about the "rules." Rules and
- procedure is their entire LIFE! They are also career minded! If you
- 237 find a bureaucrat going squirrely with the rules, you have a
- 238 bureaucrat protecting their career—from someone over them that

- has an agenda! Bet on it! It's a sure thing. No way there is not one
- 240 bureaucrat in the Federal Registry who is fully aware of this,
- irritated by it, but whose concerns are suppressed. They know the
- legal significance of a failure to file a proper oath of office. I'm done
- 243 playing this "what a coincidence" game!
- 244 At what point does "coincidence" equal "criminal conspiracy"?
- Todd said yeah, maybe one person maybe fails to get his or her
- 246 oath notarized, and he suggests that however, when you have a
- 247 pattern involving literally every key Federal appointee, extending
- into the military, then you begin to be concerned about treason, he
- 249 reasoned: IF EVERYONE IS MISSING THEIR OATH OF
- 250 OFFICE, THERE IS NO PROOF OF DUTY —
- 251 IT'S A DODGE THEY CAN'T HANG FOR TREASON IF
- 252 THEY NEVER DECLARED AN OATH, SO THEY CAN ONLY
- 253 BE HELD ON IMPERSONATING AN OFFICIAL.
- 254 But, I have a couple of questions about this. First, I understand
- 255 bureaucrats and bureaucracy I've dealt with them and so have
- 256 you. Every bureaucracy has persons specifically positioned to
- 257 watch for exactly this sort of thing a signature is missing, a
- 258 notary is missing, an affidavit is missing, the language is wrong —
- 259 these people are tasked with making certain every i is dotted and
- 260 every t has a properly positioned cross bar. There is no way this
- 261 many cases of sloppy record keeping goes this long unless it's by
- 262 DESIGN!
- 263 I want people in uniform to understand that while they are
- 264 working under an oath, those leading them ARE BOUND TO NO
- 265 OATH.
- 266 So you have 1.4 million people ordered to take a jab. It was an
- 267 illegal order. Someone not bound by any oath gave this illegal
- 268 order.

- 269 Myorkas is engaged in acts of treason, and should be prosecuted
- 270 and tried for treason but, according to Todd, without an OATH
- of OFFICE, all you can get him for is impersonating an official.
- Well, I suppose that's the argument they will use, but that won't
- 273 work remember Nuremberg, I was doing my duty did not cut it.
- 274 Participating in human, weapons, and drug trafficking under color
- of law for the benefit of a foreign power is treason—period!
- Okay, need to wrap up this point. If we can't get redress before our
- 277 courts, where do we go go to a state that IS LEGITIMATE.
- 278 Todd mentioned Col. Pete Chambers, in Texas, but the only Col.
- 279 Pete Chambers I found is filing suit against the government for
- 280 drumming him out of the National Guard because after
- 281 experiencing vaccine injury himself, he warned fellow soldiers of
- 282 the potential negative side effects of the vaccine. So, I don't
- 283 understand how this Col. Chambers could deputize someone to
- arrest these people. Frankly, this was something that caused me to
- pause and think, is this whole thing a red herring? It could be! It's
- that crazy out there.
- 287 But, according to Todd, the friends of our liberties are working on
- a way to begin challenging the authority of these renegade federal
- 289 employees and start making arrests RIGHT NOW!
- 290 He sid, "We are going to find out who has the oath and who does
- 291 not we will NAME and SHAME."
- 292 Articles of surrender to China have already been drawn up in
- anticipation of a formal surrender to CCP. Do a search on Articles
- of surrender to China, and see what you get. Yikes! Here are a few
- articles you should read: "Should we surrender to China now to get
- 296 it over with?" America surrenders to China." "China is preparing

- 297 for war and the West is preparing to surrender."<sup>4</sup> "China is
- 298 rehearsing for when it overtakes America."5 "Why is Biden
- 299 appeasing China?"6 Answer: "Joe Biden wants a 'new economic
- 300 world order.' It's never looked more disordered."<sup>7</sup> Real answer:
- 301 "Comer Reveals Biden Family Members Receiving Payments from
- 302 Chinese Energy Company."8 And "Biden Administration China
- 303 Ties Reveal Deeper Disturbing Truth."9
- 304 Thousands of CCP agents moving into US through borders,
- 305 surface to air missiles, and shoulder mortars passing across the
- 306 border. Preparing an attack from within.
- 307 MEANWHILE: an entire air wing of the US army is down,
- 308 grounded, which will deprive Americans of close air support. The
- 309 fourth Hague Convention, states when the attacker controls
- 310 substantial government functions, the WAR IS WON.
- 311 How much of our government does China already control! Will it
- 312 come down to a ground war on our own soil to hold wrest our
- 313 liberties out of the hands of these traitors?
- 314 Who do they work for?
- Well, we wont have time for a break, so let's wrap it up!
- 316 BIBLICAL Culture versus humanist culture pretty easy to see
- 317 American culture has pretty much collapsed into decadence which

- 318 puts us on a self-destruct mode, exactly as planned in the
- 319 Communist Manifesto I mentioned earlier.
- 320 Biblical culture is misunderstood and misrepresented by many
- 321 who call themselves Christian. I'll have time for only one example.
- 322 Former U.S. Senator for Missouri from 2007-2019 DEMONCRAT
- 323 Claire McCaskill says, "Jesus would not support 'everyone walking
- 324 around with weapons of war." I don't know if McCaskill claims to
- be a Christian, but she sure does like to use the Bible to support her
- 326 wicked perverse notions like same sex marriage, 10 and gun
- 327 control.<sup>11</sup>
- 328 This is because Jesus was a PEACEFUL MAN, and said, "I believe
- 329 very firmly that Jesus would be shocked at what our country is

- Luke 22:38 And they said, Lord, behold, here are two swords. And
- 343 he said unto them, It is enough.

- 344 However, some elements of biblical culture continue to prevail —
- and it's mostly in the area of NATURE.
- 346 The LGBTQ thing is just not taking hold in the general public, and
- 347 not even among our youth.
- 348 Americans are not buying!
- 349 Here is a story of some boys a Lakeridge High School in Lake
- 350 Oswego, OR that demonstrated their protest against placing
- 351 feminine products in their designated restrooms.
- 352 They vandalized, repeatedly vandalized, these machines In a
- message to the parents, the school wrote: "In the last weeks, we
- have been combating vandalism in the boy's bathrooms. Students
- 355 have been taking the tampon dispensers down and placing them
- 356 <u>inside the toilets</u>. We would like your help in stopping this form of
- 357 vandalism."
- 358 Oregon House Bill 3294 is called the Oregon's Menstrual Dignity
- 359 Act. It passed into law in 2021. It requires all schools to provide
- 360 "menstrual products in gender-neutral, male and female
- 361 restrooms."
- Looks like we might have begun to cross the line into TEA PARTY
- reaction to these stupid, intrusive, insulting laws coming from the
