- 49 HAVE THAT POWER the purse strings are placed under the

- 51 President can just completely destroy the Constitution. That's good
- 52 news. Way to go court!

- Hopefully, this portends a conservative inclination in the court as
- 54 we anticipate some massive election fights to reach the court soon.
- 55 Let's examine the question are gays a problem we should be
- 56 concerned about? Very honest men, conservative, and God fearing,
- 57 often take the position that homosexuals are not our problem.
- 58 They point out that it's only a small fraction of that community,
- 59 the militant activists types, that concern us. This is a legitimate
- 60 question, and God fearing Christian Patriots need to sort it out
- 61 from within a biblical world-view.
- 62 I heard it again from a conservative I respect Gays aren't our
- 63 problem! O, really?
- 64 Okay, I get the point Trump, and some other conservatives are
- 65 trying to make with this. In a show awhile back, I mentioned that
- one of the challenges facing Trump with his Christian base is his
- 67 attitude toward homosexuals. It's disconcerting to Christians when
- he talks about how proud he seems to be to have their support, and
- 69 the fact that he was the first President to appoint an openly gay
- 70 cabinet member. Why make a point of this?
- 71 I mean, would we make a point of appointing a whoremonger to
- 72 our cabinet—would we say, oh, looky here, I've overlooked the
- 73 sexual proclivities of this serial fornicator—you might appoint
- 74 someone who has that predilection, but would you boast about it?
- 75 You pick the best guy for the job, and most applications to enquire
- 76 as to sexual proclivities so you don't wrap up a hire in
- 77 statements that advance some immoral behavior, like, see, I like
- 78 whoremongers too. I don't subscribe to the value that jumping
- 79 from one bonus hole to another that might be a bit inside for
- 80 some of you jumping from one guy to another, or from one girl
- 81 to another, is something to be promoted in society, to be singled
- 82 out and made a point of when hiring someone so why make a
- 83 point out of hiring someone whose sexual proclivities violate some
- 84 other divine LAW OF GOD?

- 85 I do understand! But do you get what I'm saying? Do you really
- 86 want to promote this lifestyle choice? Or are you really making a
- 87 statement that you buy in to the "born that way" myth. That's been
- 88 totally debunked the Queers don't even like it. It was useful for a
- 89 while to put opposition to their behavior off balance like it's just
- 90 a fetus was used to advance abortion. No one bothered to check
- 91 and see that fetus means little child, but bobble heads are like that.
- 92 They think emotionally, not rationally.
- 93 Homosexual behavior most certainly ought to be regarded with
- 94 contempt and disgust. It is a deadly behavior reducing the life
- 95 expectancy of homosexuals to roughly half that of normal men.
- 96 It's blatantly contrary to the laws of GOD, and to NATURE
- 97 ITSELF. Romans 1:26-27 clearly states the behavior is not only
- 98 contrary to God's laws, like adultery, and fornication, and incest,
- 99 and child abuse it goes farther and crosses another barrier.
- 100 Homosex violates the nature barrier it's against nature. When
- 101 one behaves contrary to ones own nature, it necessarily causes
- damage. The Bible makes it clear those who engage in this behavior
- 103 receive in the body the "recompense of their ERROR which was
- 104 meet" (Romans 1:27). If you want to read about the destructive
- 105 consequences of engaging in this behavior, I provide a note here
- 106 that will take you to the information.<sup>5</sup> The sources include the
- 107 Journal of the American Medical Association, American Family
- 108 Physician, and others, like the Council on Scientific Affairs.
- 109 It's a deadly behavior, and this breach of nature breaks open a
- 110 whole host of related errors. You are seeing it play out before your
- eyes. Now pedophilia is being called a natural attraction.

- 112 A meme is circulating saying Facebook allowed an ad to run that
- depicted an adult with a little girl, and saying "Pedophilia is a
- 114 natural sexual orientation."6 I spoke to this on Wednesday night
- from my pulpit, and I warned I had not vetted the meme. However,
- I went with it because I know for fact this is being said right now,
- and some are attempting to introduce this idea into our culture.
- I did get a chance to vet that, and sure enough, it's a fake ad. It did
- 119 not run on Facebook, and TED did not endorse the ad. So, what's
- the story?
- 121 The ad was created from a stock image to bring attention to TEDx
- 122 conference that featured a speaker who gave a "controversial
- presentation" on the subject of "Why our perception of pedophilia
- has to change."<sup>7</sup> Change to what? Well, here it is, "pedophilia is an
- 125 unchangeable sexual orientation."8 By the way, TED refers to
- 126 Technology, Entertainment, and Design, and the organization
- 127 sponsors conferences on these subjects. TEDx is a loosely
- 128 associated branch off the popular TED talks, and provides a
- 129 platform for private persons to do a TED like conference. So what
- happened is this. Some folks who objected to the TEDx conference,
- created this meme as a way of bringing attention to it. Apparently,
- 132 they did not understand the distinction between a TEDx and a
- 133 TED talk. Then the meme was posted on Facebook, but not as a
- paid advertisement. So now that we got all that cleared up.
- 135 The acceptance of the unnatural behavior of homosexuality,
- something God calls an abomination, opens the door to accepting
- other perverse behavior, such as pedophilia if you argue that
- 138 homosexuality is an unalterable sexual orientation, then well,
- 139 you get the point. When are they going to argue that rape is
- another unchangeable sexual orientation? Well, that's going to far.

Really? - 167 OKAY, and if you subscribe to the broken window principle —
- 168 how about you object to breaking the window of natural sexual
- 169 behavior in order to stem progression to these more outrageous
- 170 evils.
- 171 And yet a Christian who shows up and reads some Scripture at a
- 172 Gay Pride event is arrested for indecent and indecorous behavior.
- Okay, let's take a short break. I'll be right back!
- 174 Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor
- 175 at the Lighthouse, your brain masseur, and Paul Revere's lantern
- lighter, lighting the lamps in the church belfry arch, signaling the
- 177 enemy is on the march, an enemy that would steal from us our
- 178 liberty.
- 179 I pledge my unwavering support for the President—Donald J.

- 225 Wuhan Lab and offering assistance to the bat-lady and her

- 227 and took over the work already being done in advance of the
- 228 release of this virus to cash in it's a mess folks. It's a mess of

- autoimmune disease, PANDAS, or PANS, or with epilepsy among
- 251 the Amish. Nor do you find any of this in children that were not
- 252 vaccinated. The US government has known this for decades but,

- 283 But at 37:56 he begins talking about China's abuses against
- 284 religious liberty. And I was stunned that he talked about the
- 285 Muslim oppression against the Uyghur, and the Falun Gong, which
- 286 is a Hindu sect, at length, mentions the Buddhists, and does not
