22 Democrat version of justice.⁵ If a picture can be trusted to offer any
23 insight into character, the guy looks like a gangster. No, really!

48 indictment.⁸ And, sure enough, nowhere does it say Jack is asking
49 for the death penalty. But no one said it did!

50 What people are saying is that this charge can carry the death
51 penalty if convicted. But the Associated Press looked at this and
52 concluded it's false. Mostly because Jack said so. But in their effort
53 to debunk this as a rumor, AP actually shows why it's in fact a
54 possibility. Melissa Goldin, writing for Associate Press, explained
55 "One of the four charges — conspiracy against rights — can be
56 eligible for the death penalty, but only if the violation results in
57 death or other aggravating factors."⁹ Melissa explains that the
58 indictment does not hold Trump responsible for any deaths. Well,

220 found in these masks are Streptococcus pneumonia,
221 mycobacterium tuberculosis, meningitidis, sepsis — read this
222 article, the list goes on. "Half of the masks were contaminated with
