testified, under oath, that Ghislane told her to accompany her upstairs. She said, "We went into a closet and pulled out the puppet, the caricature of Prince Andrew." pride"<sup>15</sup> — which flamingo finds himself lost in gender confusion until he meets the "quirky Gaylebird" — right, very subtle — and Gaylebird guides him on a "journey to a fulfilling life" — I've not read the book written for children but I can guess from the title, and the gist that it affirms transing trends.
