autopen while he was abroad.9 A deep dive into this question revealed that it started with Eisenhower, but was then limited to use for signing Christmas cards, that sort of thing. Obama is the first I could find who used it to sign a Bill while he was abroad - "2011, President Obama authorized the autopen to sign an extension of the Patriot Act while he was abroad, with the decision documented through White House communications."¹⁰ There was a legal look at use of the autopen in 2005. The Office of Legal Counsel (OLC) examined it and determined it was Constitutional so long as the signature reflects the President's intent. "This means the president must be aware of and agree to the document being signed." Furthermore, as if sensitive to the seriousness of this, it continues: "This authorization could be recorded informally (e.g., a memo or email) or through verbal confirmation to trusted aides." However, there are no standardized forms or processes stipulated by law. Since Obama "documented" his authorization, there is at least precedent for officially documenting the President's approval for use of the autopen - and reason would dictate in the case of pardons, Executive Orders, or Legislative Bills, such documentation would be considered appropriate. The magnitude of potential abuse is such that something must be put in place to govern this going forward.

Looking back at Biden's use, the questions to be asked are what documentation is available to establish that Biden did, in fact, authorize the signing of these legal documents. What we do know is that, according to the Speaker's own testimony, Biden was unaware that he signed at least one Executive Order he was asked about. to constitute or reconstitute the idea of an educated human being."¹⁷ (See Interview with Michael Knowles, Daily Wire, and Max Eden, expert on Education and scholar with the American Enterprise Institute.)¹⁸ Bloom struggles to find hope in this circumstance, one he faced in 1987, lightyears removed from the abyss into which Harvard, et al, have taken the souls of the last three or four generations, feeding these soulless ghouls into every American Institution, an abyss the walls of which enclose them providing nothing to break their fall, a morass of emptiness, where the only meaning, the only sense of living is found in sensuality, where common sense is lost in mindless, even pointless political passions — Knowles described how far removed Bloom's assessment is from today's condition this way, Mick Jaeger is Beethoven compared to Cardi B,"¹⁹ and her ideological spawn and new fab, Kesha²⁰ and Max Eden described as "Rock n Roll is Bach

compared with TikTok."²¹ Adding, "TikTok is owned by the CCP and used to barbarize our souls, to make evil things catchy and fun, and thereby to transmit vice into virtue."²² What would Bloom say today? I hear him groaning in Nietzsche's despair—interpreted by him as "good is dead," but clinging to hope, he concluded, that although all form of real learning is lost, he said, "vanished" and that "One cannot and should not hope for a general reform" of our institutions of learning, nevertheless, humanity continues, and one might "hope that the embers do not die out."²³

My own summary of Bloom's indictment against Harvard, and her sisters is this. The so-called Enlightenment extinguished the light by postulating the mantra of the Enlightenment was "dare to know," that knowing begins with "doubt," requiring "denial" of old certainties, denial of "faith."

This, like every entrenched lie, has enough truth in it to give it shelf life. Truth is the only thing that can give life to a lie. Every lie depends entirely upon truth to survive. The best lies have the greatest amount of truth in them. Satan's ruse in the garden was not an outright lie — worse, it was a deviation of truth: Eve spoke truth, God has said in the day we eat of the tree of the knowledge of good and evil we will surely die, and Satan LIED, "thou shalt not surely die" and impugned God's character, saying, the only reason God has withheld this from you is this, He knows that if you eat of that fruit, "your eyes will be opened" (enlightened) and, "ye shall be as gods, knowing good and evil."²⁴ His premise was false, though the statement was true — the day they partook, God Himself

acknowledged, "Behold, the man is become as one of us, to know good and evil."²⁵ It's a very old lie, from the father of the lie.²⁶

THINK. It was God's intention that man should be like Him—"Let us make man in our image and after our likeness."²⁷ He put the tree there within their reach. Love gave to man a choice to love or to lust. He gave them a command, and if they loved Him and obeyed, He would have invited them to partake as an act of Love. But they did not show the character of His Son, Who would not think it "robbery to be equal with God"²⁸ but instead He would give it up, and become like man to redeem man from his fall, to be made as man, and finally to be made to be sin,²⁹ and because He never sinned, death had no claim on Him, and He arose that He might provide salvation from Satan's Lie, and finally raise us in His likeness.

Bloom could not see this. He knew it was a lie, but he did not have the cure—the TRUTH that makes us free is in the WORD, Who was with God and was GOD and became flesh.³⁰

The promise of "enlightenment" premised on rejecting TRUTH was a lie: it is not true that the mind, to be free to find truth, must begin with a rejection of TRUTH, and must be pursued with no prejudices or bias.

On the other hand, thinking that rejects truth wherever it is encountered, that has a "bias" against truth — that is a different kind of prejudice — the idea that to find truth we must begin by rejecting GOD, that is resisting truth is antithetical to truth. It's coming from the REJECTION OF TRUTH - which is virtually always motivated by a LOVE FOR THE LIE — these love darkness more than light because THEIR DEEDS ARE EVIL.
