Anyway, I can hear you! Yeah, tethering a pedo to a millstone is one thing, but we are talking about arresting mothers, and fathers who were here illegally and sending them back to their native country. My point is that when, to justify mass deportations, we avoid talking about those here illegally who have not been violent, we inadvertently send the message that those here who are not violent offenders are somehow legitimate.

We need to make the case repeatedly, like we were doing at first, that anyone here illegally needs to be returned to where they legally belong. PERIOD! The "mercy" is that they have been told to leave voluntarily — they have been extended a "space to repent," so to speak. They can leave! If they refuse that gracious and merciful offer, they will be arrested, detained, and shipped back to where they belong. It's. simple! "Get back, get back, get back to where you once belonged." (Hehe. Right, I don't think Paul was thinking about illegal entry back then.) But that is our message: GET BACK TO WHERE YOU CAME FROM.

Look, I understand the whole "violent illegals" categorization for priority targeting, but the fact is, everyone who is here illegally has committed a crime of "violence." I'm not saying that the violent breaching of our borders is equivalent to the violent raping of our children. That's why, by the way, that I believe those convicted of heinous crimes, like rape, murder, or sexual assault, with enhanced penalties when it involves children—I say these fiends should be sent to El Slavador, if they'll take them, or executed by electrocution or, okay, fine, death by injection. They must give up what they took and face the consequences for their theft. In this case, we are gracious — they have violated our laws to take the privileges of citizenship: jobs, government services, including medical benefits, and so forth. Things that are ours, and they take them from us. They steal from "our house."

there is no statute of limitations on illegal entry into the US. Many CCP spies have infiltrated, and they use a variety of "covers" for their espionage. (Here is an ex CIA officer that talks about the key role eateries play in spycraft).<sup>5</sup> Length of time in the country is not a legal criterion for citizenship. His family can go with him back to China, if that's what he wishes. The Court held that the actions of President Andrew Johnson were in conformity with laws duly passed by the Congress, and that he therefore was acting within his discretionary executive powers, "not subject to judicial restraint."<sup>32</sup> Chief Justice Marshal would likely call this action, this behavior of the District Courts, "an absurd and excessive extravagance."<sup>33</sup>

The offending Courts are undermining the Constitution by their absurd and excessive extravagance." Encroachment of District Courts into the Executive Powers violates the PEOPLE's RIGHT OF CONSENT —we did not vote these judges to take over the Executive Branch, we gave that job President Trump.

Senator Grassley, Judiciary Committee Chairman, has introduced a Bill to "Rein in the Lower Courts."<sup>34</sup> Courts are limited to adjudicating specific cases; they don't create Law. Grassley pointed out that some District Courts "have repeatedly chosen not only to decide the cases before them, but also to issue orders derailing executive policy nationwide.<sup>35</sup> Historically speaking, this is a relatively new development in the courts, and it's past time to stop it.<sup>36</sup>
