Misspeak? That’s her claim. But really, she had not verified what exactly was on her desk before she trotted out with her overly enthusiastic statement? Seemed unprofessional to me.

And what about the truckload of material—thousands of videos—turns out Epstein was the only one depicted performing vile and lewd acts with minors. Thousands of videos of Epstein!

However, Trump has appointed individuals to key positions who are truth-oriented, and they lack the stomach for lies and obfuscation. But Bondi wears a Cross. Her religious affiliation is Scientology.¹⁰

It's like Israel! Remember that Paul said, “they are not all Israel, which are of Israel” (Romans 9:6). All of Israel are legitimately called Israel; nonetheless, there was an acknowledgement that not all called Israel are Israel — and while people might identify themselves as Christians because they profess Jesus as Christ, and identify with “Christianity” — not all who are called Christians are Christians. I don't know Bondi, I've never talked to her about her faith, but I understand she subscribes to something called Scientology.

Scientology is eclectic, and like all eclectic religions, it claims to embrace all views, including “Christianity.” EXCEPT: Scientology rejects the exclusivity of traditional Evangelical, or biblical Christianity.

Would you agree that it is highly likely Cindy McCain and her husband, Senator John McCain, ran in some pretty high-level circles—well, let's see. Epstein became “news” beginning in October of 2002, when the New York magazine published an article titled: “Jeffrey Epstein: International Moneyman of Mystery.”¹⁴ The following year, Vanity Faire published, “The Talented Mr. Epstein” in March.¹⁵ However, Epstein became “famous” as the guy who flew Clinton on “International trips,” starting in 2002. Investigations into his perverse use of underage girls broke in 2005-2006.

Finally, too much pressure built, and it became known by the general public, and he was arrested in 2006 for trafficking and using underage girls.

We learned later that these girls were recruited and provided to him by Ghislaine Maxwell, who is sitting in jail for 20 years, thinking about her trafficking career, and missing the exciting days of Epstein Island.

Back then, the Justice Department in Florida was so “afraid” of Epstein that they conceded to give him a very controversial sentence — 18 months in jail, with work-time release, and then he was freed five months early. Oh, and he only had to register as a sex offender for one year. This was a plea deal that took something like, well, the word is “several” down to one count of soliciting a prostitute and one count of solicitation for sex with a minor. We know, however, that there were SEVERAL girls involved in this case—he got a pretty sweet deal. Why? Would it be because he’s such a beloved fellow? Did Epstein have friends in, uh, “low places”? Were the DOJ and FBI “afraid” of him? That was Acosta, former US Attorney for the Southern District of Florida, who was responsible for overseeing Jeffrey’s 2008 plea deal. He said he was told Jeffrey “belonged to Intelligence,” and he was instructed to “leave it alone.” No one ever “fact-checked” that one! No one has denied Epstein’s connection with Intelligence—recently, when Bondi was asked back, she dodged the question, pulled a Jen Psaki: “I’ll circle back to you on that one.” So much for transparency!

Who told Bondi to “leave it alone”? That’s what she’s trying to do.

How did Dershowitz win such a sweet deal for his friend and client, Epstein? Dershowitz was his attorney and will tell you all about it.¹⁷ And one thing he will tell you is that he “saw the list.” However, the deal included a gag order on Dershowitz, forbidding him to discuss

the evidence presented in court against Epstein. He will say this much: Dershowitz said he has seen the names of high-level public personalities who were Epstein's clients. Yep! Dershowitz can't reveal the names because the judge in Florida, Deborah Dale Pucillo of Palm Beach County, put a gag order on him—is that who gagged him? He didn't specify. Might you look more carefully at those? Anyone with funny money stuff going on? Surely, Epstein kept financial records of income and outgo — where did his money come from and where did it go?

Wouldn’t it be prudent to follow up with the victims and attempt to ascertain if they can or will identify any of these predators? And if there is no video evidence implicating specific persons engaging in abuse of minors, what does that do to the Hanson theory that Epstein was blackmailing them? How could he do that without some “evidence” condemning these people? If Epstein were blackmailing anyone, or if our CIA or Israel’s Mosad, or England’s MI6 were using his material to control “assets,” there would have to be evidence to support their leverage over them — if that evidence is mysteriously missing, the entire matter becomes tracking down who tampered with the evidence — Mr. Dennehy and perhaps some of those FBI workers in the Southern District office who hailed him as a hero for hiding the Epstein files from Bondi!
