This is a Bill introduced by Rep. Maria Elvira Salazar (R-FL) and Rep. Veronica Escobar (D-TX). The purpose of the Bill is to establish a comprehensive Border policy, and it contains a lot to commend it to conservatives. The controversial part of the Bill is under the heading: “Legal Status Programs for Undocumented Immigrants.”

Of course, flags are thrown on “legal status” and “undocumented immigrants.” You see, it’s a “Dignity Act,” so we can’t use such undignified expressions as illegal aliens. Until you are willing to identify the problem honestly, you are not going to get support from MAGA patriots who are sick and tired of glossing over this issue. The people we are talking about came into our country illegally. That’s a crime! It’s not “immigration.” Immigration refers to the process by which someone comes to a country legally. Trespassing is the nicest way to characterize someone crossing our borders illegally.

American patriots were imprisoned for years on a charge of “trespassing” on their own Capitol grounds. And this, even though Pelosi’s Capitol police waved them in—so, I don’t think foreigners who were illegally “waved in” by Biden, and the Democrats, should be called “migrants,” much less immigrants.

As for “legal status,” they need to confess their sin, and repent — to repent would require them to self-deport and apply for citizenship legally.

If you want to address the ridiculous barriers to applying for citizenship, let’s talk.

There are several good suggestions in this Bill for addressing that issue. However, waving a wand over them, chanting DIGNIDAD, is not acceptable. I’ll get to that in a moment.

This Bill expressly addresses the Biden invasion period from 2020-present. It states that they receive an automatic 7-year deferred

action. It requires a criminal background check, and penalties for illegal entry include an initial fee of \$1,000 and installments of \$6,000 over 7 years. Good standing in the community must be established. They can renew indefinitely, but cannot become citizens. Those who do not qualify for this have two years to self-deport.

So, I don't have to labor on why MAGA patriots are not having it. But the RINOs love it.

Oh, and the name of the Bill **Dignity for Immigrants while Guarding our Nation to Ignite and Deliver the American Dream**. If that sounds a bit too contrived, it's because it is. It's constructed from the Spanish word for dignity, which is DIGNIDAD.

The whole idea of *dignifying* breaking and entering into our country, by stealth, and ignoring our laws—and, by the way, I didn't see anything in this about marching with the Mexican Flag, burning the American Flag, hanging with La Raza, or other take California back for Mexico groups being automatic refusal and triggering immediate final order for deportation.

I don't think it's a good idea to put a statute of limitations on the crime of illegal entry.

I totally believe in mercy and respect the dignity of every soul. That does not mean we dignify bad behavior or reward it.

It's a bit insulting to name this DIGNIDAD for another reason. While most of this comes from Mexico, a whole lot of our problem is from Iran and even China. But your rules are going to apply to everyone who crossed Biden's border during the Biden invasion.

There are exceptions, and some provision should be made to hear individual cases and rule equitably. For example, if you have someone who would be deported, say, to Iran, where they are almost certain to be executed for their faith because they are not Muslim, I think special consideration needs to be afforded to

someone like that. The illegal entry cannot be ignored, but that would be a case for the fines and protections mentioned in this Bill.

Voice Over: There must be more to life than having everything.

Donald: Yes, there is, but I won't tell you what it is.

Jeffrey: Nor will I, since I also know what it is.

Donald: We have certain things in common, Jeffrey.

Jeffrey: Yes, we do, come to think of it.

Donald: Enigmas never age, have you noticed that?

Jeffrey: As a matter of fact, it was clear to me the last time I saw you.

Donald: A pal is a wonderful thing. Happy Birthday — and may every day be another wonderful secret.

So that's the letter.

Yeah, that's just not Trumpian at all! So, where do we begin?

Breaking — the Wall Street Journal reporter who wrote the Epstein hit piece on Trump is connected to the founder of GPS Fusion. GPS Fusion is the company funded by Hillary Clinton and the DNC to produce the Russia hoax.¹⁵ So, let's start there.

First, Joe Palazzolo worked for a publication called Main Justice, where he covered legal and DOJ-related stories. Mary Jacoby, the wife of Glen Simpson, the co-founder of GPS Fusion, founded Main Justice. It was not a huge publication (9 writers)¹⁶, and he is named as “Key staff” (IBID), also, the online publication was

accessed regularly from DOJ computers, “indicating a targeted audience within the justice department” (IBID). Anyway, his political bias is clear, and the chances that Joe and Mary interacted regularly are appropriately assumed.

Oh, and Joe has a Pulitzer for his coverage of Trump’s alleged, and now debunked, crime of paying hush money to a porn star out of campaign funds. I think this was the Stormy Daniels thing!

Anyway, I agree, the letter does not sound like Trump today! It does not sound like the guy who banned Epstein from Mar-a-Lago. Or the guy who dismissed that pervert from his limo and kicked him to the curb.

sexual advances lost their suits. Trump points to these as vindication against the charges that he is a sexual predator.

The point of concern about this is that the current revelation opens our champion to renewed attacks from the Access Hollywood tape.

So, regarding the Epstein Birthday letter. The issue is, there it is! In Ghislaine's birthday gift to Epstein. However, the fact is that Trump broke ties with Epstein, distanced himself from the man, and barred him from Mar-a-Lago.

It's very clear and well known that he despised Epstein. We have a public record of Trump's behavior, and nothing suggests any correspondence to this sort of juvenile, "seventh-grade" behavior.

Now to the main point. Trump calls this the Epstein Hoax.

The evidence of tampering with the Epstein files and records is conclusive. Look at this report by Bongino on the "missing evidence" that was taken from Epstein's safe.¹⁸ He is not buying it! FBI-procured evidence doesn't "disappear." He worked with evidence gathering and processing, and explains it, and when he does, you have to agree, no way evidence gets "lost," as in, oops!

groups. He is responding to a pattern of discrimination against Christian tourist visas for evangelical missionaries.²³
