position regarding the full and complete release of the Epstein files.⁹

Bondi announces Joint Task Force Alpha, describes it as the “tip of the spear” of justice coming after traffickers.

Joint Task Force Alpha recently took major enforcement actions: 12 defendants were charged with operating a massive illegal smuggling ring—they were bringing illegal aliens from Cuba into the US, for profit. They coached their “clients,” including children, on how to get past border agents. They charged up to 40k for each trafficked child and adult — they used Zell to transfer over 7 mil. on this particular scheme and possessed over 18 million dollars.

In Vermont, Norma Lorenzo was indicted for working with Canadian co-conspirators from Guatemala, Honduras, Mexico, and El Salvador—children were transferred to private residences in Vermont — police began encountering illegal aliens from 97 different countries, including China, Pakistan, Iraq, Iran, Afghanistan, North Korea, and Yemen— all enemy countries!

In Texas, Joint Task Force Alpha secured the extradition of three men from Guatemala, charged with what Bondi called a “mass casualty alien smuggling event.” A Semi Truck hauling at least 160 illegals crashed, killing more than fifty.

Again, this week, in Texas, four were charged for smuggling unaccompanied children into the US from Mexico; these “monsters” drugged unaccompanied minors into a THC-induced sleep when passing through customs. That’s what you do when shushing does not work! One child was overdosed and had to be hospitalized.

I grew up in the 60s. We saw a lot of that during our involvement in Nam. I had mixed feelings about it—flag burning, I mean. I wrote a few war protest songs, but they weren't America-protest songs. I thought the whole America thing was very interesting and made sense—during Civics in Jr. High, I was impressed by our system and felt strongly that it was obviously organized around sound principles — the consent of the governed, truth, justice, the American way — for me, I could see the obvious effort to build a respect for an protection for justice into the system. I liked it! Martin Luther King's *I Have A Dream* speech, 1963, seemed to reflect the noblest aspirations of our government as founded!

So all the talk about America being unjust didn't make sense, but that we had some bad people within the system corrupting it — that I saw clearly. Anyway, I felt like the system we inherited was good, but that some people didn't get it! And those people were bad.

My point is, I never turned against the government as founded!

So when someone burned a flag in the streets during a protest, it seemed like a dumb thing to do. The FLAG represented the antithesis of what they were protesting—I didn't think it made sense to attack the symbol of the freedoms they used to express their objections. Nevertheless, I did accept the argument that free speech included speech against the government, that in fact, a redress of grievances was specifically included in the first amendment, and while I always thought it was hypocritical to attack the flag in the name of free speech, I was unwilling to say it should be against the law to express political speech in that way, even though, at the time, I was naive enough to think these people were on the side of liberty for all even while burning the only flag that symbolized that ideal.

Here is a brief history of flag burning. The first instance was on May 10, 1861, in Mississippi, during the Civil War. This was about one

month after Mississippi joined the Southern Rebellion and seceded from the Union. It was a clear statement of separation from America as founded—a repudiation of the federal government under Lincoln. It was an act of War against the United States.

We saw no more of that until 1919, in the aftermath of WWI. There was considerable worry about the incursion of radical leftism into America, communism had raised its ugly visage in Soviet Russia, and agitators for communism, Marxism, began stirring trouble among workers in the US, creating what is called the first “Red Scare.”¹¹

The shift from flag burning being directly connected to calls for the elimination of America, the destruction of America, you know, a symbolic call, a rallying call to destroy this country, to being viewed as merely an act of protest exercising the fundamental right of “free speech” began in 1931, when California had a law forbidding flying the red, or Communist flag. A California teacher at a summer camp in San Bernadino, CA that was run by a communist affiliated organization, led the campers to raise the Red Communist Flag and recite the “worker’s pledge”: “I pledge allegiance to the workers’ red flag, and the cause for which it stands, one aim throughout our lives, freedom for the working class.”¹² California then was more American than Communist, more Red, White, and Blue — and had a law prohibiting the display of the Red Flag as a symbol of opposition to organized government, an invitation to anarchic action, or as an aid to seditious propaganda. [IBID.]

The Supreme Court of 1931 voted 7-2 under Chief Justice Charles Evans Hughes, saying that prohibiting the raising of this COMMUNIST FLAG on American Soil violates free speech protections.

In 1932, most States had flag-desecration statutes, but in 1967, a large anti-Viet Nam war demonstration included flag burning, and in 1968 the Flag Protection Act was passed, making it a crime to mutilate, deface, burn, or trample upon the American Flag.

Now, here is the kicker! In 1969, some American war hero, named Sidney Street, burned the Flag that covered his father-in-law's casket, and he burned it in protest against the killing of the civil rights leader, James Meredith. He was outraged by this, and took his flag and burned it in Brooklyn, NY—he was arrested and charged. His conviction was thrown out by the Supreme Court but the Court held back from ruling against New York's law against desecration of the flag. The Court threw out his conviction because, it said, "the record did not clarify whether Street was punished for his words or his act of burning the flag." His words were protected free speech, and since the conviction did not distinguish between his words and the action of burning the flag, the court overruled his conviction.¹³

So, that's the history! Are you surprised? Many of you probably are surprised to learn that the historical background of flag burning is directly connected with insurrectionists, communists, anarchists, and people who hate America. It has never been merely an expression of political opposition to some policy. Its first instance was an expression of a call to war against the U.S.. In the second instance, it was connected with the communist flag being raised up against the US flag. The Anti-War demonstrations that included flag burning were likely instigated by Communists, but carried out by many who thought they were protesting the War, not understanding that, as ill-advised as was that war, it was a war against Communist aggression, and burning the American flag took the wrong side of that issue while attempting to make another

VAERS reports,” and when rudely interrupted with an arrogant haughty spirit, repeating his question, Kennedy said at the time Trump was leading this nation, very ably, through this COVID crisis, Kennedy said “that particular vaccine, which perfectly matched the virus that was circulating then, and I have no idea how many lives it saved, but it saved quite a few.”

The facts show that during the period following Trump’s first term, several boosters were released. Here is a report put together by Sharyl Attkisson back in 2006.¹⁹ She reported that, over a 20-year period from 1980 to 2001, flu shots for seniors were heavily promoted, and their use increased from 15% to 65% by 2001.
