It's time for your Brain Massage®:

Rule by the consent of the governed is a biblical principle and a divinely endowed right. Elections are sacred, and those who encroach upon this fundamental right are traitors of the first order.

governments derive their just powers from the consent of the governed.

It's a biblical principle for this present world. When Adam received the “Dominion”³ over the land, sky, and sea, all born of Adam are, collectively, joint heirs of the dominion. Mankind shares in common the dominion over the fish of the sea, the fowl of the air, and the creatures that dwell over all the earth. God was their only KING.

Jon Hook served under Obama and Biden as co-chair of Internal Investigations. He likely participated in crafting the policy that allowed the DOJ to stretch the language of a little-used Obstruction Law (identified as 18 U.S. Code § 1512) to prosecute Protesters for obstructing federal proceedings.
