Assembly Bill 495 allows non-biological related persons to fill out a form (called the Caregivers Authorization Affidavit) affirming they are an adult with “an established familial or mentoring relationship with the child or a familial relationship with a relative of the child.”<sup>2</sup>

What is a *familial* relationship? Anyone claiming a connection with the family without regard to any legal or biological connection, as a friend, a neighbor, who is considered “part of the family,” or who is willing to make that claim!

Literally, anyone could make this claim and act in locus parentis — in place of the parent.

What proof of relationship is required to file this affidavit? I checked, according to this Brave AI query response, NONE!<sup>3</sup>

Here is the response with attendant documentation:

“The Caregiver’s Authorization Affidavit under California AB 495 is not submitted to a government authority for approval. Instead, it is presented directly by the caregiver to institutions such as schools, childcare facilities, or healthcare providers when authorization is needed for enrollment or treatment.

“The affidavit does not need to be notarized or filed with any court or agency. The caregiver signs it under penalty of perjury, affirming they are caring for the child and are authorized to make certain decisions. These institutions are required to honor the affidavit in good faith, without verifying its contents, as long as it appears complete and valid.”

Block in California,” was particularly insightful, see it here,<sup>8</sup> another FRC article, here,<sup>9</sup> a summary of the law by State Senator, Aisha Wahab, here,<sup>10</sup> in case you are interested in Snopes’ take on this, I provided a link here,<sup>11</sup> and here is an assessment prepared by Digital Democracy.<sup>12</sup>]

How does one obtain this form? Brave AI responded:

“Caregivers obtain the affidavit form directly, typically from school or healthcare offices, or online through state resources. No third-party approval is required to use it.” [IBID]

I asked: What notice is given to the Parents?

Answer: NONE: “Parents are not required to be notified when a Caregiver’s Authorization Affidavit is created or used under California AB 495.”

The law allows an adult caregiver—such as a relative or even someone with a "mentoring relationship" with the child—to sign the affidavit and authorize medical care or school enrollment without parental consent, notification, or signature. Multiple sources confirm that the bill contains no requirement for parent notification, and institutions like schools and healthcare

providers are protected when acting in good faith on the affidavit, even without verifying parental awareness.

Anyone can make the assertion without providing any proof. They do so under the penalty of perjury — and we all know how effective that sort of thing is with their “gun laws.” The only people who would be concerned about that are the people you don’t need to be concerned about.

I asked: Is the person completing this form required to show proof of their status or relationship to the child, or even proof of their identity?

Answer: “No, the person completing the Caregiver’s Authorization Affidavit under California AB 495 is not required to show proof of their identity or status.” [IBID]<sup>13</sup>

“According to multiple sources, the affidavit does not require notarization, background checks, court review, or verification of identity. Institutions like schools and healthcare providers are not obligated to verify the caregiver’s relationship to the child or confirm the validity of the identification provided. The law allows authorization based solely on the signed affidavit, with no requirement for the institution to investigate further.

“Some sources note that a caregiver may provide a Social Security number or driver’s license number—but not the actual card—and there is no obligation to confirm its authenticity.” [IBID] It’s optional and not verified!

Setting aside any concern we might have about the influence of human traffickers being embedded within our government's child protection services, as revealed a while back by RFK, this law

provides loopholes so large other illegals, like Jashanpreet Singh, could drive their own 18-wheeler Mack truck through, destroying the lives of children for years to come. Read Singh driving his Mack Truck into slow-moving traffic, killing three, in this article posted on the Homeland Security website.<sup>14</sup> He got his license courtesy of Gavin Newsom's Department of Motor Vehicles, which issues Commercial Driver's Licenses to illegal aliens. As I read this, I thought someone could complete this form and usurp the parents' rights, exposing the child to danger before the parents even realize what's going on. This Law is liable to abuse, and the abuse is going to fall, ultimately, on the children.

The Democrat CA Assembly, Senate, and Governor's office failed our children—AGAIN!

We need to break the hold of these unreasonable, inept, and I mean just plain incompetent lawmakers from our State and get sharp, intelligent, reasonable people running this state. This is a case in point — Celeste seems to be someone who truly wants to help. Segment.02 Hello. Welcome back! I'm Dr. Jerry Scheidbach, pastor at the Lighthouse, your brain masseur, and Paul Revere's lantern lighter, lighting the lamps in the church belfry arch, signaling the enemy is on the march—an enemy that would steal from us our liberty.

It looks like everybody's talking about the pain of the shutdown, and angst about Trump “destroying” the White House.

I would much rather talk about the prophetic implications of Israel's latest moves on the West Bank (West of the Jordan River, northwestward of the Dead Sea). So, allow me to address that in a very abbreviated statement.

Few give appropriate regard and attention the Jacob's last days prophecy in Genesis 49. Genesis 49:1 stipulates that the prophecy is for the Last Days. According to Joel, Acts<sup>15</sup> and Hebrews,<sup>16</sup> the Prophetic period called "The Last Days" began at Pentecost and continues through to the Coming of the LORD both FOR His saints, and then WITH His saints.<sup>17</sup>

We now live in the LAST DAYS, the period during which Jacob's prophecy is scheduled for fulfillment.

Jacob said that in the Last Days, Zebulun would occupy the sea coast near the shores of Sidon: "Zebulun shall dwell at the haven of the sea; and he shall be for an haven of ships; and his border shall be unto Zidon" (Genesis 49:13).

Which is a prophecy that began in Acts 2, which Peter declared occurs in the LAST DAYS: Acts 2:17 And it shall come to pass in the last days, saith God, I will pour out of my Spirit upon all flesh: and your sons and your daughters shall prophesy, and your young men shall see visions, and your old men shall dream dreams:

Zebulun never occupied a haven by the sea throughout the time Israel dwelt in her land from Joshua to Rehoboam, when the kingdom was divided, nor any time after. It has never happened. But it's going to happen, and it will happen during "these last days."

The implications are profound! It suggests the tribes will be identified again, as is predicted in Revelation 7, and sufficiently restored to her land so that Zebulun occupies territory presently held by Lebanon. That suggests a huge shift in the geopolitical boundaries of Israel.

Isaiah 2 and Micah 4 also come into play, signifying some other major developments in the Middle East, including a major peace deal allowing Jerusalem to be the Capital of Israel, only as an International City of Peace, at rest with all her neighbors, and extraordinarily prosperous (Isaiah 2:1-6). And yet, spiritually, she will be called Sodom and Egypt—for she will be overrun with idols (Isaiah 2:7-8; see Micah 4:5). An American-style policy of freedom of religion will prevail — Micah 4:5 — allowing multiple religions to live in harmony throughout the land. Babylon will be rebuilt, and become the economic center of world commerce. Rome will be the religious center of the world, and Jerusalem will be the center for Law and justice—it will be "peace, peace," when there "is no peace," but it will be a slight healing of the hurt of Israel and, I think, a time of extraordinary evangelism so that "this gospel of the Kingdom will be preached in all the world" (Matthew 24:14).

The events playing out before us right now portend these developments. Get ready for some major unrest that will break down resistance to these developments. In the end, it will be an economically driven peace that will usher in a period of unparalleled prosperity. Trump is the perfect leader for this Last Days transition. We live in exciting times!

Okay, let's look at what everybody else wants to talk about!

Complaining about the shutdown!

First, it's clearly misdirected, at least on the Left. I should say, the Left is trying with all their might to misdirect Americans about this and lay the blame on the Republicans.

White House in 1902, constructing the West Wing to separate executive offices from the private Residence.<sup>23</sup> Taft expanded the West Wing in 1909, and had the Oval Office built. [IBID] Wilson demolished the colonial garden in 1913 and replaced it with what we call the Rose Garden. [IBID] Coolidge did some significant renovations in 1927, where he replaced the wooden trusses with steel, rebuilt the roof, and added third-floor living spaces and offices. [IBID] Hoover remodeled the West Wing in 1929, created a partial basement, that had to make a mess [IBID]. Franklin Roosevelt made major expansions to the White House, added a second floor and enlarged the basement to the West Wing in 1934. He relocated the Oval Office to its current location. Then in 1942 added another story to the East Wing. [IBID] Truman oversaw the “most extensive renovation in the White House history from 1948 to 1952. It amounted to a ‘total reconstruction’ of the interior, and left only the exterior walls standing. [IBID]. Nixon converted the indoor swimming pool, installed for FDR, I think it was him, anyway, Nixon turned it into the Briefing Room in 1970. And he added a one lane bowling alley in 1973. Ford installed an outdoor pool in 1975 — that one was funded by private donations. [IBID] Carter installed solar hot water heating panels on the West Wing roof in 1976 — which were removed in the 80s.[IBID]. Bush modernized the situation room in early 2000s [IBID], Clinton restored and refurbished the Executive Mansion in 1993, then stole the furniture when he left, but that’s a different matter — by the way, no lefty had a problem with that! GW did some refurbishing, and Obama converted a tennis court into a basketball court — now Trump is building a Ball Room — and suddenly, lefties became aware of the White House as some sacrosanct building that should not be altered — and claim he is “destroying the White House.”
